Cotton Association Officers.

New Orleans, Jan. 15.—The Southern Cotton Association held its annual business meeting today with almost a full board sitting.

Harvie Jordan was re-elected president and Richard Cheatham was re-elected secretary. H. H. Hiatt, of Columbia, S. C., was elected treasurer and George T. Jester, of Corsicana, Texas, was chosen vice president in place of Mr. Peters, of Texas.

The salary of the president was fixed at \$5,000 a year. Secretary Cheatham's salary was raised from \$2,500 to \$3,000 a year. The salary of the treasurer was fixed at \$500 a year and the vice president is to serve without salary.

The salary of the general financial agent and organizer, F. D. Smith, who was elected, according to the suggestions of the mass meeting, was fixed at \$5,000 a year.

New Coast Railway System.

Norfolk, Va., Jan. 15.—The official announcement of the appointment of R. E. L. Bunch as traffic manager of the Norfolk and Southern and of the Atlantic and North Carolina, the latter controlled by the Norfolk and Southern, has been announced. Mr. Bunch was formerly General Passenger agent of the Seaboard Air Line, and at present is General Passenger agent of the Atlantic and North Carolina. The appointment is effective February 1st. He will take complete charge of the traffic departments of the two roads. This means that H. C. Huggins, general freight agent of the Norfolk and Southern, will be under his department.

POU'S FINE FIGHT

To Cheapen Goods to American Consumers.

Washington, D. C. Jan. 16.—Representative Pou made a splendid fight today to amend the Philippine tariff bill so as to give the President authority to reduce the import duty on the class of goods manufactured in this country which are sold at a lower price in foreign countries than at home. In a ringing three-minute speech Mr. Pou emphasized the importance of his subject and put the stand-pat Republicans in a very embarrassing light. Singular as it may seem, a large element of Republicans led by Mann, of Illinois, joined with the Democrats in applauding Mr. Pou when he concluded. The speech was one of the best the Congressman ever made.

The amendment offered by Mr. Pou was of course objected to on a point of order by the floor leader, Payne, and ruled out by the presiding officer.

In his speech Mr. Pou said in conclusion:

"Somehow it always happens, that whenever any bill is introduced here which helps the consumer there is always some little rule in the way of it and it seems impossible to get it before the House. I believe if you would give me time, and listen to me, I can show this amendment is not out of order, but from the former ruling of the Chair I confess I have but little hope, and therefore I conclude by saying I have introduced this as a last resort, in the hope that the Chair, having at heart the interest of the millions of people who are under the domination of the trusts and combines, will allow this amendment to come before this House. If I occupied your position, so help me God, I would put this amendment before this House if every other committee of the whole, and every Speaker of every Congress, had, from time immemorial ruled to the contrary. Your rules are a curse when they come between us and our duty to the people."—Raleigh News and Observer.

New Stock of \$7,000,000.

New York, Jan. 16.—Directors of the Tennessee Coal and Iron Company at a meeting in this city today authorized an issue of \$7,000,000 of new common stock of that company. This will increase the total of common stock of that company to \$30,000,000. It was announced that the proceeds of the new issue will be used in improving and developing the property of the company. The directors renewed an offer to accept the outstanding 2,483 shares of preferred stock and to give common stock in exchange therefor at the rate of \$180 a share for the preferred. A meeting of the stockholders of the company to pass on this action of the directors will be held at Tracy City, Tenn., on January 31.

Oxen Takes Place of Mules.

A well-to-do farmer came to town Saturday to buy some mules. But he bought two immense oxen instead. "You will see me driving them to town soon," he said, and continued: "Mules are so high that a man who wants to make a living instead of a show had better be looking for some other kind of power. Now the truth of the matter is, these oxen are better for wagoning than any mules that were ever hitched up, but people have become too proud to drive them. These eleven-hundred pounders cost me thirty dollars each, while mules that could do their work would have cost nearly six hundred a pair."—Monroe Journal.

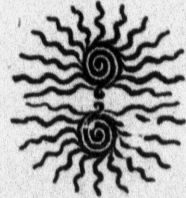

"Keep your hands out of the troubles in Europe," is the advice Senator Bacon's resolution gives to Uncle Sam.

Must be something very attractive about the office of governor in Georgia for all the newspapers men to be wanting it.

We cannot say what Jordan's ambition is, but whatever it is it will be done for if he lets the cotton fight be a failure.

If there were not so many people wanting to get something for nothing there would be fewer suits brought on flimsy grounds.

"Keep talking building and loan association until one is organized," remarked a man who would like to take stock in one. All right, here is another reminder that Greenville ought to have one and not be long about getting it.

Passenger trains being reported on time and then coming in two hours late is a deception and imposition on the public that should not be tolerated. It looks like railroad employes with any degree of intelligence should be able to give correct reports as to the time trains will arrive.

A French astronomer comes forward with the assertion that the inhabitants of Mars are much more highly developed than those on this mundane sphere, yet he says it is impossible for us to imagine what forms living being must take there. All of which goes to prove that the aforesaid astronomer knows nothing of what he is talking about.

It is the humane man who, when he comes to town in bad weather and has to leave his horse hitched in an open lot, brings along a blanket to spread over the animal for protection against cold and rain. We see a great many animals not thus protected, and the poor brutes suffer from exposure. As valuable as horses and mules are, it looks like their owners would be more thoughtful in caring for them from a financial standpoint, even if not prompted by feelings of humanity.

Learning the Cost of Producing Field Crops.

In 1892 and 1893, Prof. W. M. Hays, now Assistant Secretary of Agriculture, inaugurated a large number of experiments in crop rotation at the North Dakota and Minnesota experiment stations. These experiments are planned to run for twenty years at least, and the value of certain arrangements of crops in the rotation is already apparent.

Yields from the different rotations are carefully recorded, and the gross incomes are being determined. The real value of a certain rotation can only be accurately measured by net profit, however, as labor and cash expenditures will vary to an appreciable extent with the arrangement of crops in the rotation.

The cost of producing field crops cannot be determined, for practical purposes, on the experiment farms, because labor is too expensive and plot-work is not comparable to field conditions. Realizing this obstacle in the path of completing these rotation studies, the Minnesota Experiment Station, co-operating with the Bureau of Statistics of the United States Department of Agriculture, began in 1902 an exhaustive study into the cost of producing field crops in Minnesota under actual farm conditions. Special agents of the Bureau of Statistics were placed in three of the most representative farming districts in Minnesota. In each district fifteen or sixteen farmers were interested in the work, and agreed to give labor reports and all cash items and miscellaneous data relating to the production of the crops. The "route statistician," as the special agent came to be called, makes a daily visit to each of these farms and secures a report of all the labor performed the previous day, distributing it to the various crops and enterprises. Each year the farms are surveyed and a plat made showing the exact acreage of the crops, pasture lands, and waste areas upon which statistics are being recorded. Depreciation of farm machinery and harnesses, the cash rental value of the land, the cost of man labor and horse labor on the farm, are all being accurately determined and worked into the general problem of finding out what it costs the farmer to produce an acre of corn, oats, wheat, and hay.—From "Farming as a Business Enterprise," by Edward C. Parker, in the American Monthly Review of Reviews for January.

An Unjust Decision.

We get from the Macon Telegraph details of a remarkable libel suit brought against the New Orleans Picayune by a physician who won his case. The physician or surgeon employed the Lorenz method in straightening the limbs of a child. A grateful father told The Picayune the story and operator was congratulated and eulogized by both the paper and the father. The physician, however, objected to the use of his name in print, on the ground that it put him in the attitude of a quack seeking notoriety. The court below decided in favor of The Picayune, holding that no wrong had been done the plaintiff and that there was obviously no evil intent on the part of the defendant. But the Supreme Court of the State took exactly the contrary view and The Picayune has been mulcted. The essence of the higher court's opinion is found in the following paragraph: "The physician who, by inference, finds himself classed with quack-salvers will be entitled to a hearing, or, at any rate, should not be turned out of court, unless it appears that he is in error in thus contending."

Of all damage suits that have come to our notice—not even excluding those cases, in which railroads pay what amounts to blackmail—this takes the palm. The mere fact that there was no evil intent, but evidently only good will, toward the bone-straightener should have exonerated the newspaper. The decision is a little short of an outrage, if the case has been accurately stated, but as it comes from the highest court of the State the paper will doubtless have to pay up.—Charlotte Observer.

Mr. C. C. Moore's Plans.

Mr. C. C. Moore, president of the North Carolina Cotton Growers' Association, leaves to day for Raleigh on business connected with that organization. After attending the special meeting of the State executive committee Friday, Mr. Moore will leave for Louisville, where he has an engagement to speak. This is the beginning of his itinerary of the State, inaugurating the movement which has for its end the perfection of the organization. It is Mr. Moore's purpose to organize the State in the same manner in which he organized Mecklenburg county. Within a week or so, he hopes to have 10 men in the field cooperating with himself. He says that his platform will be "No increase in acreage."

Mr. Moore has been very much encouraged by the liberal responses which he has received from the business men in the way of donations to the State organization fund. He hopes to raise \$10,000 and already enough has been secured to assure the remainder. His trip to Richmond, Va., a few days ago was most gratifying. He received a large sum in cash besides a number of promises. Raleigh has already subscribed more than \$500 and the indications are that the fund will reach \$10,000 before long. Charlotte has given \$425 with the promise of much more. The local committee hopes to raise \$1,200 in this city.

While Mr. Moore is away he will likely visit Wilmington. He received a letter yesterday inviting him there, stating that many of the good citizens of that city were anxious to aid the farmers. Wilmington promises to rival Charlotte in her donations. Mr. Moore will not be back in this city until the monthly meeting of the county association which is to be held on the 3rd day of February.—Charlotte Observer.

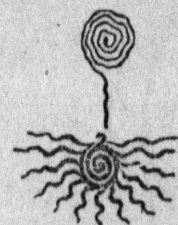

HIS FIRST LAW PARTNER.

An Alliance Which Gave Lincoln All the Responsibility.

Major Stuart, with whom Lincoln had joined forces, was not in his early years a well read or even an industrious lawyer, but he was popular and had an extensive if not very lucrative practice, which he was entirely willing to intrust to his new associate. Indeed, when the firm was formed he was so deeply engrossed in politics that he gave little or no attention to the law, and Lincoln had to assume virtually all responsibility for the business.

Of course if the procedure had been complicated or technical a novice would have speedily come to grief, but the character of litigation was very simple in those days, the precedents were few and far between and the legal forms exceedingly elastic. Lincoln met such difficulties as there were in his own way, asking as little advice as possible and exercising his ingenuity to bridge the gaps in his information when his partner was not available for consultation. The habit of standing on his own feet and doing his own thinking, which was thus forced upon him at the very outset of his practice, became his most notable trait. One of his contemporaries closely in touch with his professional life testifies that he never asked another lawyer's advice on any subject whatsoever. He listened to his associates and consulted with them, but he worked out his own problems, and there was never anything of the "brain tapper" about his relations with the bar.

The influence of this early training is plainly discernible in the remarkable self reliance and resourcefulness which he exhibited in his later years. New questions did not confuse him. He faced emergencies with perfect serenity, and he had long been accustomed to responsibility when he was called upon to decide questions of national import.—Frederick Trevor Hill in Century.

There is a lawyer of Baltimore who tells a story of how he secured a verdict in favor of an Irishman charged with assault with intent to kill. The lawyer secured his client's acquittal on the ground of temporary insanity. Counsel and client did not meet for several months after the release of the accused.
