Hens Smash Egg Trust.

New York, Jan. 18.—The wholesale price of fresh Western eggs has dropped from 30 cents a dozen to 21 cents since December. This is due to the spring-like weather in the South and Southwest, resulting in large increase in the production. Since Jan. 1, the receipts in the wholesale market have almost doubled, and as the demand had been restricted by high prices a heavy accumulation is the result.

It is estimated that about 550,000 cases of thirty dozen each of refrigerator eggs were being held at New York, Chicago, Philadelphia and Boston for higher prices. The result was disastrous, and these goods are now being pressed for sale at 15 to 18 cents.

On The Tree In January.

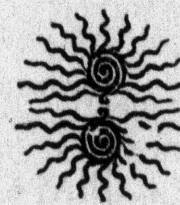

AS TO PUBLIC BUILDINGS.

The Government may have its own way of doing things and know what it is doing, but that is no reason why those with no voice in it may not do some thinking now and then on the way things are done and even be forward enough to offer suggestions for certain improvements or reforms.

Just now we have in mind public buildings. The reports of the proceedings of Congress show from time to time the introduction of bills to establish a public building at some place or other. These buildings carry with them appropriations of large sums of money and give room for more or less graft in the purchase of sites and construction of the buildings. It is true when the Government puts up a building it is well and substantially constructed, not so much consideration being given to the cost just so certain plans and specifications are carried out, and it goes without saying that in the majority of cases private individuals could have the same buildings put up for themselves at half what the Government pays.

These public buildings call for the outlay of such immense sums that only the larger places are fortunate enough to secure them, and it is considered a shrewd congressman who can get one or more in his district. A better plan for the Government would be—instead of appropriating a hundred thousand dollars or more for a single building and erecting them only in cities—to divide the money into smaller appropriations and erect more buildings. Every town that reaches the distinction of having a presidential postoffice ought to have a public building in which to keep the postoffice and transact any other business the Government might desire in connection with it. Fifteen thousand dollars would be a sufficient appropriation for a site and building for this purpose, so that where the Government now expends a hundred thousand dollars for one building in one town, it could erect six or seven creditable buildings in as many different towns. In the large cities a larger building might be required, but there is no occasion for lavish expenditure in them. The Government should have interest in the towns as well as in the cities, and some plan like this would be a good way to show it.

HAS A TON OF RATTLESNAKES

Dealer Down in Texas Sells Them by Weight.

E. F. Armstrong, a professional snake and wild animal collector, has more than a ton of rattlesnakes at his camp, situated near here. He sells his snakes by weight instead of by number. He is preparing to make a big shipment to northern and eastern points. He also supplies large quantities of rattlesnakes for a snake oil factory that is in operation at Corpus Christi, Texas.

Owing to the mildness of climate down here, he can carry on his work of capturing the snakes throughout the whole year. He has a number of assistants who are experts in capturing them. These assistants are Mexicans, who are thoroughly familiar with the habits and haunts of the rattlers which are always taken alive. Even those which are intended for the oil factory are not killed until just before they are to be put through the boiling process—Brownville (Texas) Dispatch.

Reaction Against Imperialism.

It looks like the reaction against imperialism had begun in earnest when we find such a stalwart Republican as Mr. Hale, of Maine, taking sides with Bacon and Rayner in their efforts to restore to the Senate its constitutional and traditional participation in the treaty-making power. It is true that encroachment of the executive upon the legislative branch began to take shape under a Democratic administration in 1893, but that administration was repudiated by the Democratic convention of 1896, and "Anti-Imperialism" was made the paramount issue in the Democratic platform of 1900. So that the record of the Democracy, in harmony with the impulse of its party principles, exhibits it as the opponent of executive encroachment. The accession of such a Republican leader as the Senator from Maine to the side of the anti-imperialists is therefore the more significant.—Fayetteville Observer.

In the course of a communication addressed to the editor of The New York Evening Post, relative to the presentation of "The Clansman" there, a resident of the metropolis says: "At the moment when the South stands in such sore need of Northern capital and Northern immigration it is unfortunate that a play which is to such an extent a libel on the best opinion in the South should be permitted to spread abroad false impressions in regard to the actual conditions there." As if Northern capital did not come to the South for the same reason the gold miners go to the Klondike!—Charlotte Observer.

THE GUILLOTINE.

How Its Deadly Work Impressed a Boyish Spectator.

A young man in Cologne had murdered his sweetheart and had been condemned to death. The execution, by the guillotine—for the left bank of the Rhine was still under the Code Napoleon—was to take place at dawn of day on a public square between the cathedral and the Rhine and before the eyes of all who might choose to witness it. The trial had excited the whole population to a high degree. Now the people looked forward to the final catastrophe with almost morbid interest. My locksmith guardian was of the opinion that neither he nor I should miss the opportunity of beholding so rare a spectacle.

Long before sunrise he awoke me, and together we went to the place of execution in the gray morning light. We found there a dense crowd, numbering thousands of men, women and children. Above them loomed the black scaffold of the death machine. Deep silence reigned. Only a low buzz floated over the multitude when the condemned man appeared on the scaffold, and then all was silence again. The sturdy locksmith held me up in his arms, so that I might look over the heads of the crowds in front.

The condemned culprit stepped forward. The assistant of the executioner strapped him to a board which extended from his feet to his shoulders, leaving his neck free. The victim glanced up at the ax, suspended from a crossbeam. The next instant he was pushed down so his neck lay under the gleaming blade. The ax fell like a flash of lightning, severing the head from the shoulders at a whisk. A stream of blood spurted into the air, but the hideous sight was quickly concealed from the gaze of the public by a dark cloth.

The whole deed was done with the rapidity of thought. One scarcely became conscious of the terrible shock before it was over. A dull murmur arose from the onlooking throngs, after which they silently dispersed. The scaffold was taken down and the blood on the ground covered with sand before the first rays of the morning sun shone brightly upon the cathedral towers.

I remember walking home, shuddering and trembling, and finding it impossible to eat my breakfast. Nothing could have induced me to witness another execution. — Carl Schurz in McClure's Magazine.

Where the Pins Go.

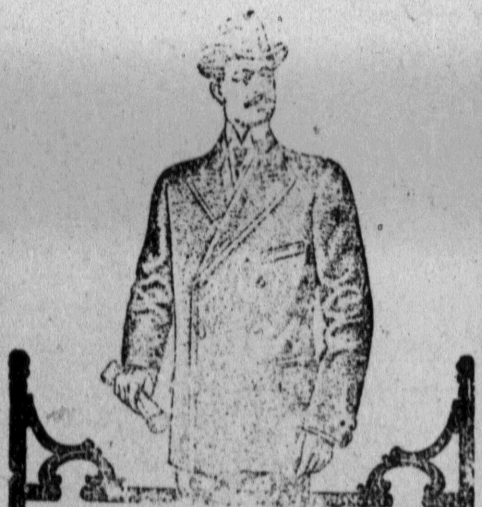
