TROUBLES COMING NEARER HOME.

Eruption in Dismal Swamp.

Richmond, Va., April 22.—A volcanic disturbance of considerable proportion occurred late last night in the embraces of the Dismal swamp near Norfolk. The mud in the swamp is boiling up, and rotting portions of forest and undergrowth coming to the surface. The wild denizens of the locality are fleeing from the swamp in droves, seeking safety upon the higher grounds. The vibration last night, while slight, was distinctly felt for a considerable distance. People living in the neighborhood of the swamp, in view of the recent horrible disasters which have visited other portions of the world, and especially San Francisco, have become demoralized. Many have sought refuge in Richmond and Norfolk. Others have crossed into North Carolina. All report fright at the shock and the natural phenomena which is taking place in the swamp itself. The mud in the morasses, heretofore placid, is boiling like a kettle and emitting steam and smoke from the exploding bubbles which arise on the surface. In places it looks as if millions of worms were working beneath the surface, turning over and over ceaselessly, keeping the slime in a continual state of agitation. Tadpoles, which inhabit the swamp in millions, show symptoms of uneasiness. Snakes and small animals are leaving the fastnesses of the swamp for higher ground. Fears are exhibited that an eruption which will mean the destruction of property and the loss of life is impending. Chief of Police Brinkley, of Suffolk, personally went into the swamp this morning for the purpose of satisfying himself that the rumors concerning the disturbance were true. He witnessed the phenomena, and reports the extent of the surface covered by the strange and unprecedented occurrence is spreading rapidly.

The fact that the animals are leaving that portion of the swamp in which the surface is disturbed leads many to believe that a change in the appearance of the swamp may be anticipated. There is considerable fright among the people.

OLD LEAP YEAR LAWS.

When Women Proposed Six Centuries Ago the Man Had to Accept.

In two countries, at least, and more than 650 years ago laws were passed which gave women the right of proposing marriage. These enactments went even farther than this. They also stipulated that if the man whose hand they had sought should refuse he should incur a heavy fine.

A searcher among the ancient records of Scotland discovered an act of the Scottish parliament, which was passed in the year 1288, which runs as follows:

"It is stant and ordaint that during the rein of his maist blisist Megeste, ilk the yead knowne as Lepe Year, ilk maiden ladye or baithe highe and lowe estate shall hae liberet to bespeke ye man she likes, albeit gif he refuses to taik hir to be his lawfolp wyfe, he shall be mulcted in ye um of aye dundis or less, as his estait may be, except and awis gif he can make it appeare that he is betrohit ane thier women, he then shall be free."

A year or so later a law almost similar to the Scottish law was passed in France and received the approval of the king. It is also said that before Columbus sailed on his famous voyage to the westward a similar privilege was granted to the maidens of Genoa and Florence.

There is no record extant of any fines imposed under the conditions of this Scottish law and no trace of statistics regarding the number of spinsters who took advantage of it or of the similar regulations of France, but the custom seems to have taken firm hold upon the popular mind about that time. The next mention of it is dated nearly 400 years later, and it is curious little treatise called "Love, Courtship and Matrimony," which was published in London in 1606. In this quaint work the privilege was thus alluded to:

"Albeit it now becomes a part of the common law in regard to social relations of life that as often as every leap yeare doth returne, the ladyes have the sole privilege during the time of continueth of making love either by wordes or lookes, no man will be entitled to benefit of clergy who doth in any wise treat her proposal with slight of contumely."

Up to within about a century ago it was one of the unwritten laws of leap year that if a man should decline a proposal he should soften the disappointment which his answer would bring about by the presentation of a silk dress to the unsuccessful suitor for his hand.

A curious leap year superstition is still to be met with in some parts of New England, and that is that during leap year the "beans grow on the wrong side of the pod."

N. C. TEACHERS ASSEMBLY.

Will Meet in Raleigh.

The complete program for the North Carolina Teachers Assembly June 12 to 15 is just announced by Secretary Connor. The assembly convenes the evening of June 12, the address of welcome being by Joseph G. Brown, of Raleigh, and the response by W. H. Ragsdale, of Pitt county. The principal speaker for the evening will be N. C. Shaeffer, superintendent of public instruction of Pennsylvania and president of the National Educational Association. Among the others down for addresses are Dr. John M. Coulter of the University of Chicago; Dr. Henry N. Snyder, of Wofford College, ex-Gov. A. J. Montague, of Virginia; Supt. B. C. Gregory of the Chelsea (Mass.) City Schools; Miss Celestia Parrish, director of practice, school of Georgia State Normal; Dr. F. C. Woodward, of Richmond College; Gov. R. B. Glenn, State Superintendent J. Y. Joyner, Dr. W. L. Poteat, Dr. C. Alphonso Smith, Dr. Chas. D. McIver and others of North Carolina.

Governor and Mrs. Glenn will receive the teachers at the mansion on Wednesday evening, June 13.

Man Held For Poisoning Chickens On His Own Land.

A rather unusual trial took place before Justice J. G. Cox Saturday afternoon in which Geo. Phillips, colored, of Contentnea Neck township, this county, has bound over to superior court on the charge of putting out poison on his own land to kill Hambrick Edwards', a neighbor, chickens. The defendant offered testimony to show that the plaintiff had been notified by the defendant that he was going to put the poison out if Edwards' chickens did not stop coming on his land and pestering him.

An act of 1905, private laws of North Carolina, makes it a misdemeanor to put poison out on your own land to kill animals or fowls, domestic or wild, in two counties in the State, but Lenoir is not one of them. Phillips was held on a charge of doing malicious mischief.—Kinston Free Press.

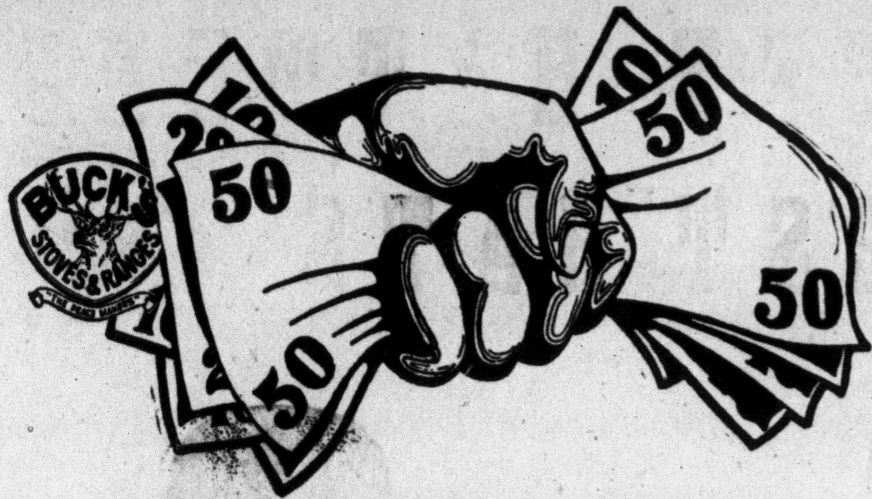

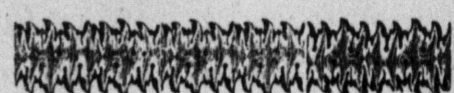

FOR CORPORATION COMMISSIONER

2nd. A reduction of freight rates to a point which will leave the railroads fair and reasonable dividends on the actual value only of their property, after excluding watered stock and bonds and exorbitant salaries.

3rd. Taxation of railroads upon the same valuation upon which they are entitled to earn dividends.

This is a good platform, and entitles Mr. Long to the consideration and support of every voter who favors the reforms he mentions. The State needs a corporation commissioner composed of that kind of men.

GATTIS-KILGO CASE NOT TO BE ARGUED.

Justices Connor and Walker of the Supreme Court, yesterday declined to grant a re-hearing in the Gattis-Kilgo case.

The petition for the re-hearing was filed in the office of the Clerk of the Supreme Court last December by Judge A. W. Graham, of counsel for Rev. Mr. Gattis, and the two Associate Justices had had it under consideration since that time. The petition was lengthy, covering about fifteen typewritten pages. —News and Observer.

LIGHTNING STRIKES TWICE.

Investigations made by the agricultural college at Guelph, Ontario, disprove the proverb that lightning never strikes twice in the same place. Of course the same building does not usually get struck twice, for it is not there to be hit the second time; but observations show that a number of buildings built successively upon the same spot have been struck. Indeed, some places are especially exposed to lightning, and where two barns in turn have been fired by lightning on the same ground, it is very unwise to build a third. Lightning is not like some disease germs, which, having run their course in a person, make him for a given period uninhabitable to other germs of the same kind. —Youth's Companion.

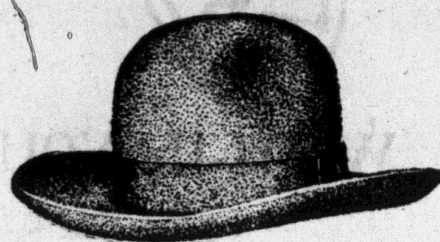
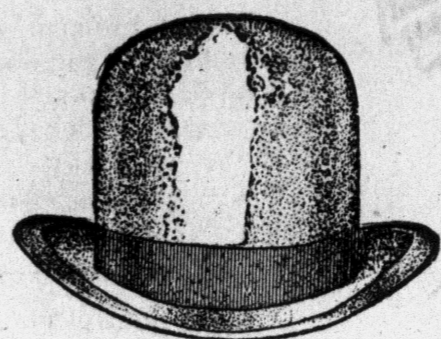

IMPOVERISHED BLOOD.

Symptoms of Anaemia and Treatment of the Trouble.

The chief symptom, at least the most obvious one, of anaemia is pallor. The skin is white, the whites of the eyes are even whiter than usual, the lips are light in color and the pink color of the nail beds is absent. But pallor is sometimes deceptive and may be present even when there is little or no real anaemia. This occurs in certain cases in which there is an unequal distribution of the blood, the surface of the body being poorly supplied, while the central organs are congested.

Other signs of anaemia are irritability of the heart, palpitation occurring on slight provocation; indigestion, loss of appetite, constipation, shortness of breath, nervousness, weakness and inability to do any hard work with either brain or muscles, swelling of the feet and ankles in the evening, headache, dizziness, ringing in the ears and sometimes spots before the eyes. All these signs point to an impoverishment of the blood, and the suspicion is confirmed by a direct examination of a drop under the microscope.

In the treatment of anaemia, which is very frequently a secondary condition, the first care is to discover and remove if possible the underlying cause. The cure is helped along, however, and hastened by certain measures which we may briefly enumerate. The diet of every anaemic person must be carefully looked to. It is usually the quality of the food rather than its quantity that needs regulating. Tender, not overcooked meat, milk, eggs and other albuminous articles are to be preferred to vegetables and starchy foods. The juices of fruits and of lettuce, celery and other salads, without the woody substance, are useful as promoting digestion and accelerating the nutritive changes in the body.

Next to food fresh air and sunlight are the most powerful stimulants to blood making functions.

All exercise that causes fatigue should be avoided, but a quiet stroll, a drive over smooth roads, and especially sitting or lying in the open air, occasionally in the direct sunlight, the head being protected, are of great value to the anaemic invalid. If sitting outdoors is impossible the chair or sofa should be continuously by a wide open window, and at night all the windows in the room should be open.

Cold douching or bathing is of great benefit, but the judicious adaptation of this curative measure to the individual needs calls for medical skill, as does also the prescription of iron and other blood making drugs.—Youth's Companion.

Sergeant Nolan has a small but active wife of whom he stands in considerable awe. One day the sergeant lost his quick Irish temper. The object of his wrath was a dog belonging to the wife of one of his superior officers. The lady overheard some of his statements and took him severely to task.

"You ought to be ashamed to say such things and to lose your temper with an animal," she said, while the big sergeant looked shamefaced and anxious. "I shall report your language."

"To—to her, ma'am?" faltered the penitent.

"To my husband," said the lady haughtily.

"So do, ma'am," said Sergeant Nolan cheerfully. "I well deserve it. I was only fearing you meant to tell my wife."

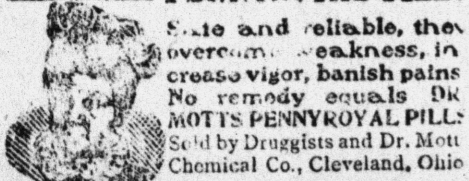

AROUND THE WORLD ON FOOT

Nicholas Georgis is a Roumanian traveler now in Africa, who is going around the world on foot. He carries a book signed by the various dignitaries of the places through which he has passed, and among others are portions in Arabic, Greek, Abyssinian—one page written by the Emperor Menelik, with whom he dined—besides numerous European languages. The traveler made his way through the Sahara desert, carrying eighty pounds of water on his back, and when this was exhausted he had to exist for many days upon roots alone. On the Sudan-Abyssinian boundary he was pursued by three lions and kept up a tree for three days, while farther back, at Nhamdih, through mistaking the White and Blue Nile, he lost his way and was attacked by cannibal pygmies. In the Sudan he found the sun's heat so unbearable that he traveled only at night, while during the day he lay with his water bags in a pit.

Elevated Road Hangs In Air.

To relieve congested traffic conditions in Berlin it is proposed to erect a monorail suspended electric railway, such as has been for some time in successful operation between Eberfeld and Barmen, Germany, writes Dr. Alfred Gradenwitz in Technical World Magazine. The passenger cars in this system hang down from a single overhead rail and have no support whatever underneath. Advantages of the system are its perfect safety, the fact that the superstructure is comparatively simple and does not shut out the light and air, as does an ordinary elevated structure, and the further fact that in operation the monorail cars are almost completely noiseless. It seems probable that the monorail suspended system will be adopted in the German capital.

The End of Importance.

The newspaper correspondents of Washington were having their biennial row over the election of the standing committee to represent them at the capitol in connection with the senate committee on rules and the speaker of the house.

Ex-Senator Chandler, always liking to be around where there is a row, came along and asked about the battle. He was given full information.

"How about So-and-so?" he asked.

"Oh, he has voted," was the reply.

"Well," said Chandler, "that eliminates him. The least important man in the world is the man who has voted." — Saturday Evening Post.

A Kiss and Its Penalty.

For kissing a stranger in a moment of exuberance an eighteen-year-old waitress at Tetschen has been sentenced to fourteen days' imprisonment. The offense took place at the railway station two nights ago, and the injured man complained at once to the police, and the girl was arrested. So impressed was the magistrate with the heinousness of the crime that he increased the severity of the sentence by ordering the girl four fast days in the fortnight and also directed that after completing the sentence she should be banished from Bohemia and sent to her home in Dresden.—Prague Letter to Pall Mall Gazette.

Resolutions Condemning Recent Outrages.

"At a meeting called by the Mayor of Bethel, there being present about seventy-five of the best men of the community, the following resolution was unanimously adopted:

Second, That we condemn without qualification this and all such acts of lawlessness; this being the record of the sort and for the same reason. The first was committed on the person of J. A. Manning, March 25th or 26th, and through fear kept secret until the attack on Mr. Teel April 16th, 2 o'clock a. m. Both live in the same neighborhood.

"Third, That we trust the perpetrators, one and all, may be apprehended, brought to justice and receive the full penalty of the law.

"Fourth, That we appeal to all good citizens and law abiding people to unite with us in our efforts to uphold the law and put down all disorder."
