### Supreme Court Defines Child Labor Law.

Raleigh, N. C., May 8.—The supreme court in its opinion this afternoon in the case of Rollins vs. Toba Co., from Forsyth, for the first time construes the child labor laws of this state. In this case a child under twelve years employed in a factory was injured and a damage suit was brought against the company. The defendant secured a non-suit in superior court, claiming that the accident was due to the child's negligence.

Justice Connor in writing the opinion of the supreme court finds the lower court in error. The fact that the employment of a child under twelve was in itself an illegal act, precludes the defendant company from the plea of contributory negligence on the child's part.

The effect of the opinion, which is lengthy, will be to make the mills or factories liable in case of accident to employes under twelve years, where the accident is due to the child's negligence or not.

### Washington Wants Jim Crow Street Cars.

Washington, May 8.—Some days ago Representative Hefflin, of Alabama, introduced a bill to require separate street cars in the District of Columbia for the white and colored race. Today he received the official endorsement of the measure from a local citizens association. He will urge the bill before the committee.

Yesterday afternoon news was received here to the effect that Mrs. Corbitt Davidson was accidentally shot in the back and killed at her home late Thursday afternoon by a bullet from an air rifle, which was in the hands of her 12 year-old brother, Henry Cobb, of that city. Mrs. Davidson was feeding chickens in the yard and the boy was shooting at sparrows, when a stray bullet from the rifle entered her back and penetrated to her heart. She died in less than a minute.—Elizabeth City Economist.

Oxford, N. C., May 8.—There was a terrific hail and wind storm in Granville Sunday night. Considerable damage was done in the country north of Oxford. Trees and houses were blown down on the farm of Mr. Tom Cheatham and on other farms.

## THE ALDERMAN.

### Hold Adjourned Meeting.

The board of alderman held an adjourned meeting Tuesday afternoon to complete business left over from last regular meeting.

C. D. Rountree was elected tax list taker for the town and graded school district, the compensation for listing the taxes and making out the books to be \$125.

A committee was appointed to purchase uniforms for the police officers.

The order made at the regular meeting to pay hands 10 cents per hour for sprinkling streets was changed and the compensation placed at 15 cents per hour.

S. J. Nobles petitioned for rebate of pool room license, action on it being deferred to the June meeting.

### Proceedings of the Commissioners.

The board of county commissioners were in monthly meeting on the 7th, all the members present.

Orders were drawn on the treasurer in the following sums: For paupers \$152.75; repairs to county home \$168.57; supplies for county home \$186.36; superintendent health \$25; smallpox \$13; jury tickets \$540.80; witness tickets \$230.67; court costs \$255.66; conveying prisoners \$44.15; medical examination of prisoner \$10; jail \$126.48; court house \$6.50; clerk court \$5.05; register deeds \$63.80; bridges and ferries \$311.23; general roads \$40.85; commissioners \$32.50; Belvoir roads \$99.95; Falkland roads \$22.70; Greenville roads \$319.91; county stock law \$265.44.

The treasurer and superintendent health filed their monthly reports.

J. H. Manker and J. S. Gardner, Swift Creek township, were permanently released from poll tax.

A public road was ordered laid off in Falkland township in accordance with petition filed at May meeting.

J. R. Spier was appointed to settle with the sheriff.

The sheriff was instructed to keep the jail and surrounding premises clean.

R. A. Tyson presented claim for damages to his property by the road hands. An arbitration committee was selected to appraise the damage done.

The board adjourned to Thursday, 10th, to examine the delinquent tax list.

### New Statement of Methodist Faith.

Birmingham, Ala., May 7.—At today's session of the Methodist Episcopal church, South, a resolution concerning the preparation of a new statement of the doctrine faith of Methodists, was introduced by W. F. Tillet and W. R. Lambuth, of the Tennessee conferences. It says: "While reaffirming our absolute faith in our articles of religion we do not believe that in their present form they meet the existing needs of our church as a statement of the doctrinal system of evangelical Methodist Arminianism. Believing that the different branches of world-wide Methodism that are presented in ecumenical Methodist conference, can, and should unite in the preparation of such a statement of our common faith as is needed, and believing that this conference should take such steps as may be necessary to secure in the early future the co-operation of other representative Methodist churches, we therefore request the college of bishops to appoint a committee of five members, which shall invite other branches of Methodism to unite with us in the preparation of such a statement of our faith."

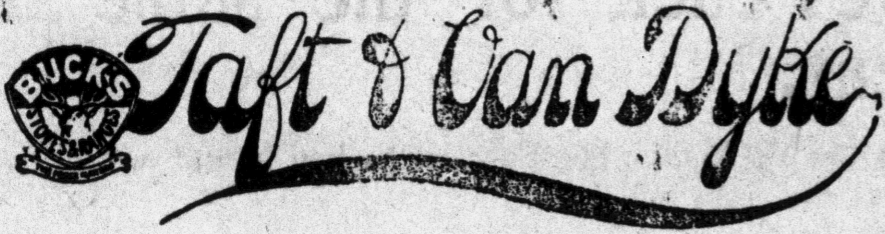

**A Warship Oredred to Guadaloupe to Protect Our Interest.**

Washington, May 7.—Guadaloupe, French Indies, is under mob rule, according to a dispatch received at the State Department today from G. Jarvis Rowens, the American consul at that point. His dispatch says the mob is in control and the authorities are unable to restrain it. Election troubles are the cause of the disturbance. For several weeks there has been rioting, which is supposed to have come to ahead yesterday, which was election day. While there are few Americans at that place, large quantities of American goods are stored there.

At the request of the State Department the Navy Department has ordered Commander William H. H. Scutherland, the senior officer in command of the fleet at San Domingo, to send a warship at once to Guadaloupe to protect American interests from the rioters.

Guadaloupe is really two islands, both of which are small. The American consulate is at Pointe a Pitre, on the eastern island, and the capital of the province is Basse-Terre.

Guadaloupe is about twenty-five miles from Santo Domingo.

**A POSSIBLE REMEDY.**

Anyone who keeps up with the courts at all knows that often much time is wasted and expense added owing to the sudden illness of a juror. This often necessitating another trial. In Germany, as we have remarked before, one or two extra jurors hear every case and if, for any reason, one of the regular jurors is incapacitated for duty the extra jurors take his place and the case goes on. It would be better, in our opinion, if the German idea in this respect were followed in our country.—Winston Sentinel.

**CONDENSED STORIES.**

**The Duke of Wellington Was Consistent, if Wrong.**

A characteristic story of the Iron Duke is told by Captain Philip Wyler, whose father was vice chancellor of Oxford university at the time. In his book of reminiscences just published by Pitman & Sons. As a member of the university the duke's duty was to read out at the commemoration the honors awarded to various scholars—and this list was necessarily in Latin. Thus the Christian name of those christened Charles was, of course, Carolus, with a short "o." The duke persisted in reading this name as Carolus, pronouncing the "o" long, until at last some official, shocked at his

ignorance, broke in with, "I beg your grace's pardon, but at Oxford we always call this word Car-lus."

"Oh, very good," replied the duke. "I'll remember in future."

Presently the name Jacobus occurred, which the duke boldly read as Jacobus, pronouncing the "o" short.

Again the don interposed. "I beg your grace's humble pardon, but we prefer to call that Latin name Jacobus, with the 'o' long."

"No, hang it!" said the duke. "You can't have it always your own way! If your reading of Carolus is Car-lus Jacobus must be Jacobus!"—Westminster Gazette.

**THE DOLLAR MARK.**

**Its Peculiarity in Being Written Before the Figures.**

Did it ever strike you as being at all peculiar that we should use the dollar mark (\$) before instead of after the figures in expressing the sum of 5, 10, 20 or any other number of dollars? We may say "25 dollars" plain enough for any one to understand, but as soon as we put the expression into figures and characters it is "dollars 25" (\$25) instead of 25\$, as it should be. Nor is this all that is peculiar in this connection.

In every country which has a written language and a system of coinage the abbreviation for the unit of value precedes the figures. In England the pound mark (£) is used in the same manner that the dollar mark is used in this country, while the same peculiarity is noticeable in Germany, where the abbreviation m. (for mark) appears preceding the number, just as the French abbreviation fr. (for franc) is used in France.

If abbreviations are not used the legend is more apt to be correct. We find that in Mexico they have a "2½ pesos" instead of "p. 2½," as one might expect, and in Newfoundland they have a plain 2 dollar piece. So, too, in France, where the abbreviation is not used, we find such pieces as "10 francs," "20 francs" and "40 francs." In Germany they have a piece marked "X thaler," which is all very plain, but the moment a clerk, bookkeeper or other person makes an entry or jots down a memorandum he tells you that it is a "th. X."

The English pound sign, which is believed to be the oldest monetary abbreviation now in use, is the old initial letter by which the Romans expressed "pounds," just as we use the "lbs." It has been suggested that we use our money abbreviation backward because the Romans in expressing "pounds" always said "libra decem" instead of "decem libra," the first being "pounds ten" and the latter "ten pounds." When their initial letter or character was used it always preceded the figures, thus "£10," instead of the reverse. Thus the whole world has got in the habit of doing these things backward.

**For Left Handed Musicians.**

Violins are adapted for the use of left handed players by reversing the order of the strings and the location of the bass bar and sounding post. Some left handed violinists, however, play upon instruments with the strings arranged in the usual manner. There are no left handed pianos. Guitars are made left handed simply by reversing the strings. With the banjo it is necessary to change the form of the neck on account of the short string. Left handed flutes are made, the location of the keyholes and keys being changed to the opposite side of the flute. There are made left handed cornets and occasionally a larger brass instrument, which are so constructed as to bring the pistons as convenient to the player as they are to the right handed player in the instrument as ordinarily made.

**Their Range of Talk.**

Challemel Lacour, the French statesman, used to tell a story about Schopenhauer, the German philosopher, whom he greatly admired. He had an appointment with him one day at a Frankfort hotel and found him just finishing dinner at the table d'hote. There were several officers at the table, and in front of Schopenhauer lay a gold piece. He said to the Frenchman as he rose and put the coin into his pocket: "I have had this gold piece on the table every evening for a month, having made up my mind to give it to the poor the first time these officers here spoke on some other topic at table besides promotion, horses or women. I have the money still."

**Unexpected.**

The street car conductor nerved himself for the approaching battle. "Madam," he said, stepping alongside the elderly passenger with the aggressive nose, thin lips and sharp chin, "you'll have to pay fare for that boy." "Certainly!" she answered, opening her purse and taking out a coin. "I expected to pay for him, sir. Do I look like a person that would try to beat the company out of 3 cents?" "Madam," he gasped, "you do! That's what fooled me!"—Chicago Tribune.

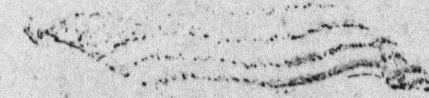

**THE AGILE TIGER.**
