## TO RECLAIM SWAMP LANDS

Representative Small has introduced a bill which may be of great importance in the drainage and reclamation of the swamp lands, particularly of Eastern North Carolina. Recently Representative Steenerson, of Minnesota, introduced a bill appropriating the receipts from the sale of public lands in certain States to the drainage of swamp lands in those States. The number of States which now have public lands is comparatively small. Mr. Small has redrafted this bill, making many substantial changes, the principal of which is that the funds can be used for draining swamp lands in any State whether having public lands or not. The bill provides that the United States shall be reimbursed by easy payments for the expenditure required in the reclamation. The bill of Mr. Small further provides that lands located in the State and susceptible of reclamation may also be drained under provision of the act at the option of said State.

As North Carolina still owns large bodies of swamp lands which are valueless after the timber has been removed, unless they can be reclaimed, it will be seen how the State could utilize this act for its benefit. These swamp lands in North Carolina are owned by the State Board of Education, and any improvement or enhancement in value would increase the assets of our public schools.

Mr. Small states that the idea is not at all impracticable, and that really conditions may be such in the near future as to result in the passage of the bill. Texas, which has no public lands as well as the delegations from other Influential States, is actively favoring this legislation. And why not? We are utilizing the proceeds of sale of public lands, and there is no possible reason why we should not use part of the same funds for taking the surplus water from swamp lands and, thereby, open up to settlement lands which will be infinitely more fertile and valuable.—Washington cor. Raleigh News and Observer.

## WILL DEVELOP EAST CAROLINA.

The Norfolk & Southern railway, the new coast system which will have its headquarters at Norfolk, will have its lines almost wholly within Eastern North Carolina. Some of the lines are old ones, so to speak, and others have just been built or are in course of construction, and it all means a wonderful development in the eastern coast country, which is practically an unknown land to the balance of North Carolina. It is a magnificent portion of the State, and some of it could only be reached from Wilmington by going to Norfolk or taking sailing vessels which can only touch the immediate coast part of the country.

The Norfolk Virginian-Pilot, of Wednesday says about the new system:

"Mr. Frank S. Gannon, the recently elected president of the Norfolk and Southern railway and its consolidated lines, was especially felicitous in his remarks at the banquet tendered him at the Virginia Club Monday night by General Manager Morris K. King. He expressed unbounded confidence in the possibilities and prospects of this port, and predicted that within a comparatively short time Norfolk would become the 'best South Atlantic port in every way.' He also expressed great confidence in the future development of the Eastern Carolina section traversed by the Norfolk and Southern and of which Norfolk is the natural outlet and gateway. This confidence, he declared, was not confined to himself, but was shared by some of the ablest and most farsighted financiers and business men in the country, as evidenced by the fact that the new Norfolk and Southern underwriting of sixteen million dollars was oversubscribed in six days, when money was at a high premium. He declared that it would be the policy of his road to hasten this development as rapidly as possible by co-operating with each and every community on the line in the upbuilding of its home interests. By such upbuilding it must be that Norfolk will profit greatly.

"Certainly there are many reasons why this section should develop, and develop rapidly, especially from an agricultural standpoint. It has the climate and it has the soil. The one retarding element, as pointed out by Mr. Gannon, is the scarcity of labor, but this is an element which can be removed in great measure at least by immigration, and Mr. Gannon bespeaks the co-operation of his road in securing this immigration. With this secured, and there is every reason to believe that the efforts of the Carolina and Virginia authorities to attract to these States immigration of a desirable class will be successful, the development of the Eastern Carolina section will advance by leaps and bounds, contributing in no small degree to the upbuilding of this port."

The new railroad system will to a great extent do away with the "corn-cracker" style of vessels which used to handle the eastern Carolina trade. Railroads, how-

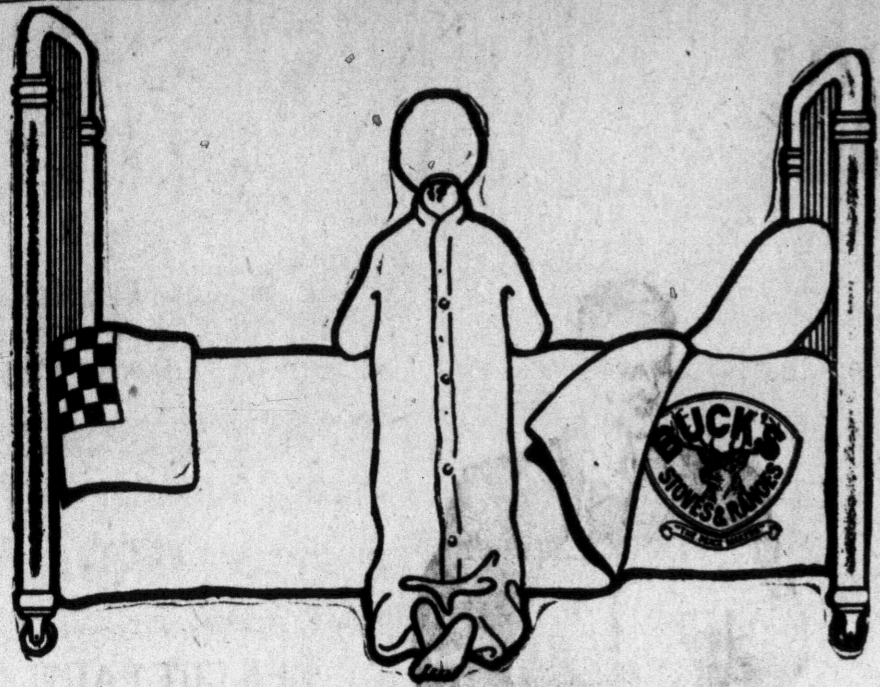

Just now the survey corps of the Raleigh & Pamlico found railroad is around and there is talk of the road being completed by the middle of next year. When that road gets in operation the company is going to need shops at some convenient place. Greenville is a good point for these shops to be located as there is between Raleigh and the sound, but it is not to be expected that the company is going to drop such a prize in our lap unsolicited. The merchants association, or a chamber of commerce or board of trade representing all business interests of the town, ought to be up and after just such things as this. The way for us to see some other town get them is to sit still and do nothing. It requires no effort to lose, but there must be activity to win.

**WASHINGTON LETTER.**

(From Our Regular Correspondent.)

Washington, D. C., May 17.—The tariff has come up in another guise or rather in an old disguise. A few months ago it will be remembered there was a threat on the part of the Secretary of War backed by the administration to buy ships and material for the Panama canal with the world as a market. All the infant industries of the United States set up a lusty squalling at this un-American business. The idea of buying anywhere for cheapness when by paying a double price the infants could be fed. Well in some way the agitation was silenced. The brave words of the Secretary of War proved to be an idle threat. American ships and American goods were bought and thousands of dollars more were paid than if they had been bought in the open markets of the world. Now it appears that some steam dredges needed for the canal be bought in Scotland for sixty or seventy thousand dollars less per dredge than in the United States

and Secretary Taft who has a frugal mind is after those foreign machines and is arguing that the Panama canal is not in the United States and is not affected by tariff restrictions and that the manufacturers of this country have no claims that the government in an enterprise like this need respect. The President in a letter to Congress states that the course of Secretary Taft has his full approval.

The Pure Food bill which passed the Senate some time ago and which it was supposed would go through the lower House without opposition is in reality opposed by a powerful lobby working night and day. All of the interests which will be injuriously affected by the passage of a bill against adulteration of food have combined to fight the measure and so far their fight appears successful.

While the movement against the drug trust which unlawfully controls and influences the price of drugs and patent medicines has its origin in Indiana, Attorney General Moody and others in the administration here are really back of it. The drug trust it is alleged have been guilty of violations of the Sherman anti-trust laws and the movement to break up the monopoly is one of the most beneficent movements of this administration.

This week has been one of sensations in the Senate in which Senators Bailey, of Texas, Tillman, of South Carolina, and Lodge, of Massachusetts, the President of the United States, the Attorney General and ex-Senator William E. Chandler were the principal figures. Tillman in his disgust and desperation over the alleged desertion of the President in an alleged legislative deal or conspiracy by which it was expected the Southern Senators would have the prestige of passing a drastic railroad rate bill accused the President of double dealing, bad faith, and mendacity and let out that he had told his plenipotentiary (ex-Senator Chandler) some ugly things about the senatorial constitutional clique as represented in that heavy legal triumvirate Foraker, of Ohio, Spooner, of Wisconsin, and Knox, of Pennsylvania. Senator Lodge was not in the Senate chamber during the mutterings of Senator Tillman but the echoes reached him from afar and rushing to the nearest telephone he got no less a person than Theodore Roosevelt at the other end of it. Hastening back to the Senate chamber Senator Lodge took the floor and amid great excitement, said that the President had just told him that the story alleged to have been reported by ex-Senator Chandler was unqualifiedly false. The President has been supposed to be in a very awkward position for everybody has believed that he said what Chandler said what he said about Foraker, Spooner and Knox. In short that he took no pains to conceal his thoughts. The President is nothing if not talkative and when he opens his mouth to talk discretion goes to the winds. His discreet friends do not report even the purport of half they hear him say much less do they repeat his exact phrasology.

#### King Edward's Bodyguard.

The English bodyguard of gentlemen-at-arms, which is the "nearest guard" to his majesty, is limited in numbers and composed of officers who have seen active service, who are of a certain height and under fifty years of age at the date of appointment. His majesty personally selects the officers who form his English guard, and the appointment is looked upon as a great honor. The gentlemen-at-arms receive pay, and they are called upon for duty on the occasion of all court ceremonies in London or at Windsor, but they are never taken away from England. Their mess is a very good one, and they constantly have the honor of entertaining royalties. The captaincy of the gentlemen-at-arms is a political appointment and carries £1,200 a year.

#### Lang Tells a Dog Story.

Andrew Lang tells this dog story, which, he says, comes to him on good secondhand evidence: "A gentleman had a Newfoundland dog of great intelligence. He had also a pair of carriage horses which were far too fat. He told his coachman to dock their corn. This was done, but the steeds were as corpulent as ever. The coachman suspected that some member of the Society For Promoting the Comfort of Animals was surreptitiously feeding the horses. He therefore concealed himself and watched. The dog came in, lumbered painfully up a ladder into the loft above the mangers and shook an open sack of oats therein, so that the cereal fell into the mangers. The horses looked up and were fed."

#### Don't Need Hooks and Eyes.

"The hook and eye is one product of civilization that oriental races cannot be educated up to," said a manufacturer who was discussing export trade. "Our firm made strenuous efforts to popularize hooks and eyes in China, Japan and India, but we had to admit defeat and retire from the field."

"We sell hooks and eyes all over the world, even to the Eskimos, but the orientals don't take to them. This is partly due to the mode of dress prevalent in the far east. Garments are cut to conform to the figure, of soft, clinging materials, and after the attire has been adjusted it is held in place by a sash twisted around the waist. Unlike our fashions, there practically has been no change in the national costumes of China and Japan in centuries. The nearest approach to the hook and eye in use there is a sort of garment fastener resembling the frogs on a military greatcoat, and even its use is not general."

#### ABUSE OF THE STOMACH.

##### Crime of Overeating and the Best Way to Avoid It.

The practice of consuming more food than is required for the nutrition of the body is a very old one. In order to correct it Hippocrates, about 400 years before Christ, advocated the omission of breakfast, a custom that has recently become popular in many places.

The harmfulness of overeating is not so much in the increased burden thrown upon the digestive organs as in the production of an excessive amount of poisonous matter which may become dangerous to life if retained in the system. The poisons are produced either by decomposition of the undigested food or through defective transformation within the organs and tissues.

Most injurious are the products of decomposing animal food—meat, eggs and shellfish—and since the kidneys are engaged more than other organs in the removal of this class of poison, the first indications of serious injury, are often found in them.

Before permanent organic disease has been produced, however, there are generally repeated evidences of poisoning of the system in the form of indigestion, headache, vertigo, neuralgic pains, rheumatism, gout or an indefinite sense of illness. Then the appetite fails, the sufferer reduces the amount of food and obtains relief. There may be, however, a sudden alarming attack resembling apoplexy and even more fatal in its result.

When an improvement of the health is recognizable after an accidental or experimental restriction of the diet it should be taken as an indication that the mode of living has not been altogether correct. But it is not always an easy matter to decide upon the best means of correcting the error. A change of diet may fail of the desired effect if it be too abrupt or too radical, and privation is not advisable in all cases. A certain bulkiness of the food is necessary both to comfort and to good digestion, and in many cases an excess is only a relative one. The abandonment of certain articles of food, with more complete mastication of others, is often better than a decrease of the entire quantity consumed. Sometimes indeed the difficulty can be overcome by the administration of laxatives, increased consumption of water and more active exercise. These things enable the system to utilize more fully the food that is eaten.

To determine intelligently the course of treatment in most cases involves an investigation of the digestive capability of the stomach and an examination of the functional integrity of other organs. It is generally more expedient therefore to submit the case to the physician than to be governed by abstract rules or the experiences of other people.—Youth's Companion.

#### Judicial Acumen.

The late Justice Daly of New York frequently enlivened the tedium of legal proceedings had before him by his kindly wit, says Harper's Weekly.

One day a suit was brought before him in which damages were claimed by reason of an assault. The plaintiff had been knocked down by the defendant and severely pommelled while prostrate. **THE BAGPIPE.**

**It is the Only Musical Instrument Distinctly National.**

The bagpipe of Scotland is the only instrument of which it may be said that it is distinctly national. The violin, the flute, the horn and other instruments are common to many nations, but the bagpipe is peculiar to Scotland, and, although it does not now occupy the position it once did, it is found in no other country.

In the days when the notorious Rob Roy committed his depredations, when the Vich Ian Vohrs lived securely in their highland fastness and kept up their dignified social position—in the stirring times of which Sir Walter Scott has told us—the bagpipe player was one of the important personages in the chieftain's retinue, and these may be considered as the palmy days of the instrument.

Within the region more strictly known as the highlands its shrill note was the first sound that fell on the ears of infancy. It charmed the rude Caledonians in times of joy and comforted them in scenes of mourning. It animated their heroes in battle and welcomed them back from their conflicts, and wherever their chiefs went if accompanied them, even to the grave.

The effect of this wild instrument on the highland soldiers is marvelous. Above the rattle of musketry and the turmoil and roar of the battlefield the inspiring notes of the pibroch have spoken encouragement to the highlanders and led them bravely forward. At the battle of Quebec, when the troops were retreating in disorder and the conflict had a most discouraging aspect, the general complaint was about the demoralization in Frazer's corps.

"Sir," said an officer, "you did very wrong in forbidding the pipers to play. Nothing inspirits the highlanders so much. Even now they would be of some use."

"Let them blow, then," said the general.

So the pipers started a well known air, and the highlanders rallied and bravely returned to the charge.

Some say that the bagpipe came down from the Romans; others, that it came through the northern nations of Scotland. At any rate, it seems to have always been one of the musical instruments of the Celtic race.

The pipe mentioned in ancient history was simply what is known as the shepherd's reed. After a time a bag was added and subsequently the drones or burdens. There are four forms of the modern bagpipe—the great highland bagpipe, which is blown by the player, the drones being placed over the shoulder; the lowland bagpipe, which is provided with a bellows for supplying the wind; the Northumberland bagpipe, which is smaller and sweeter in tone than the former two, and the Irish bagpipe, which is a much more complicated instrument.

Guessing games are always popular, especially when prizes are offered for the most successful competitor. At a recent party a type-written list of twenty-four "scrambled" words was given to each guest to straighten out, writing the correct word opposite the jumble. The list was taken from objects in the room, all of which were in plain sight. It included such strange appearing words as naoridn, otyper, epilarecf, dwniwo, okobs, cutiper, kesocboa, gru, tobeak, rutnica, etc., which, being rightly interpreted, became andiron, pottery, fireplace, window, books, picture, bookcase, and so on.

**Odor of Russia Leather.**

Everybody is familiar with the pleasant odor that Russia leather has, but perhaps few persons know to what the odor is due. It comes from the birch bark used in tanning the leather. Those who ought to know about such things say that the odor is a specific against moths and other insects and that a few books bound in Russia leather will keep a bookcase free from all such pests.

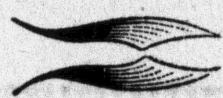
