History of the Progress of the I. O. R. M. in Greenville.

Withlacooche Tribe 35 of the Improved Order of Red Men was instituted at Greenville N. C. on the 23rd of April, 1903, with a charter membership of twenty one. Since that time one hundred and eleven pale faces have been adopted into the tribe. It has expended for the sick and distressed and other purposes \$1,336.72. It has in the wampum belt \$380.60, and over \$500.00 worth of regalia paraphernalia and etc.

It has recently fitted up a library and club room that is open every evening for the use of its members. From the influence of this tribe, tribes have been instituted at Falkland, Farmville, Snow Hill, Tarboro, Ormondsville, Winterville Grimesland, Williamston and Bell Haven with a total charter membership of two hundred and twenty nine.

In May, 1903, just three weeks after Withlacooche Tribe was instituted, it sent brother F. M. Hodges as representative to the great council of N. C. who was put on the committee on law. At the next great council in 1904 he was elected great Senior Sagamore, and 1905 Great Sachem, and after filling the honorable position with credit to himself, and the order, he was in 1906 elected Great Prophe, and Great Representative to the Great Council of United States. Brother S. T. White has also been honored by being put on the Great Board of Appeals.

This is surely a good record for our order, and on account of its grand objects, its splendid achievements, and the noble work it carries on, it should command the respect and admiration, not only of every Red Man, but of every patriotic American citizen. Let us as members of Withlacooche Tribe constantly strive to bind ourselves more closely in the totemic bonds of freedom, friendship and charity, the grand motto of our order. May the Council Brand that has been lighted within the walls of this Tribe burn forever, and with flame that shall never be dim.

May Red Men gather around its Council fires with hearts attuned in sweet sympathy for each others joys, and with loving care for each others woes. May they lay up lasting treasures of perfect service rendered and duty performed, in the spirit of freedom, friendship and charity.

In the name of Freedom, may all the impediments that bar the way to the glorious happiness the Great Spirit intended men to enjoy, melt away from the trail that all tribes of the earth shall follow.

In the name of Friendship, may the smoke of our fire arising to the Great Spirit, spread the sweet incense of Friendship wherever burn the Council Brands of our order, and fill our souls with loyalty, one for another.

And in the name of Charity, may the spirit of human sympathy and of helpfulness for all mankind ever be our guide.

GENERAL NEWS.

Happenings of Interest Over the Country.

Selma, Ala., May 19—A shock, supposed by some to be an earthquake shock, occurred in Myrtlewood, Marengo county, early today. The tremor lasted about half a minute and woke the residents of the town. No damage was done.

New York, May 19—Mrs. Jefferson Davis' condition was reported today as greatly improved, and it was said that she had spent the most comfortable night since her condition became serious. The family are now hopeful of a complete recovery.

Norfolk, Va., May 19—Irwin Tucker, president of the Saving Bank of Newport News, Va., committed suicide in his room over the bank in Newport News today just as Chief of Police Reynolds, of that city, open his door to arrest him upon a warrant charging him with defaulting in the sum of 10,000.

Washington, D. C., May 19.—The House today killed the bill making it a crime for any one giving out advance information of the official reports of the agricultural and other executive departments which was designed primarily to stop "leaks" on crop reports. The bill was tabled by a vote of 107 to 66, rejecting the conference report.

Valdosta, Ga., May 19.—Deputy Marshal Mack Dees, at Lenox, Ga. was shot and killed this afternoon by a negro whom he was trying to arrest. The negro was later killed by a posse who were trying to catch him. The negro was a desperate character and is said to have killed two negroes, a man and woman, at Tifton, several weeks ago.

TOO MANY FOREST FIRES.

Never have the people of this region seen timber so valuable or lumber so high. The supply of timber in our forests is being rapidly reduced by the increasing demand. It is already next to impossible to get such lumber as one desires and for such as can be had one has to pay almost fabulous prices. This being the case every precaution should be taken to preserve every acre of growing timber. No fire should be allowed in the forests, for every brush or sapling that is destroyed by fire cuts the supply of lumber that much for a few years hence. It is not uncommon to see forest fires burning along the railroad and even far away from the railroads, and every acre of land thus burned over is a serious loss to the owner thereof. He may not realize it now, but in a few years he will find that if the small growth in the forests had remained untouched by the fire, his supply of timber and lumber would be much greater. Then the burning away of the straw and leaves impoverishes the land, to say nothing of the loss in timber and lumber. Let our forests be carefully guarded and let the growth in them be saved.—Scotland Neck Commonwealth.

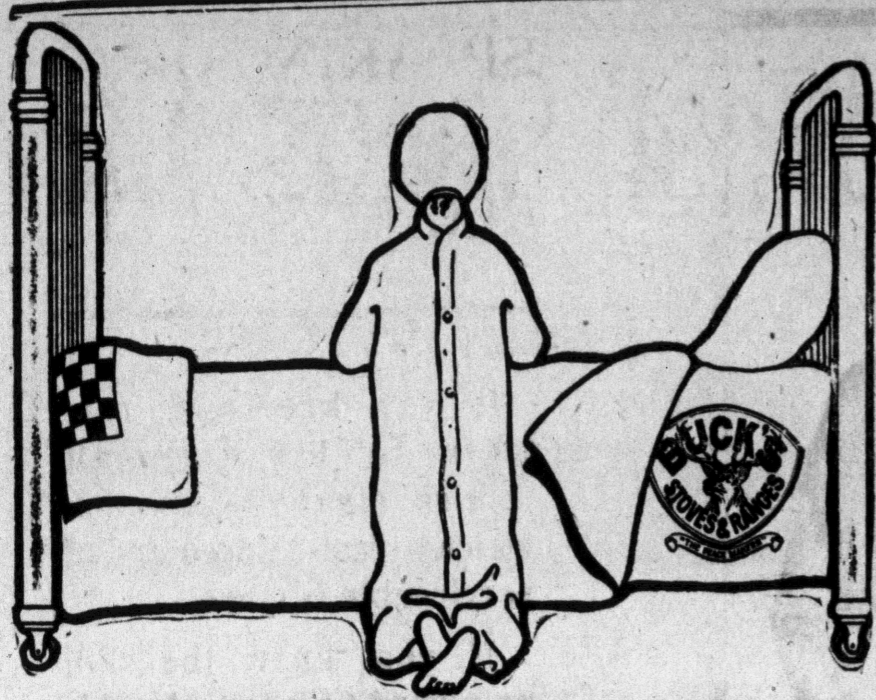

TO PROBE THE TOBACCO TRUST.

The Washington correspondent
of The Louisville Courier-Journal
sends his paper a story to the effect
that Commissioner of Corporation
Garfield is making an investigation
of the tobacco trust and "in some
quarters it is claimed that its result
will be little less sensational than
of the Standard Oil Company." Mr.
Garfield is not expected to make
his report before Congress adjourns,
but will probably transmit it to the
President during the summer. Represent-
ative Stanley, of Kentucky, has de-
voted much of his time recently to
a personal investigation of the
alleged trust and he declared that
he has information which will result
in the government's beginning pro-
secutions against the monster com-
bination headed by James B. Duke.
Speaking of the operations of the
tobacco combination, Representative
Stanley is quoted as saying that
in many instances the representa-
tives of the trust have sent for
independent manufacturers and
have demanded that they turn
over to the American Tobacco
Company 51 per cent. of the stock
of their companies. When they
refused they have been threatened
with destruction, and in more than
one instance the threats have been
made good. Continuing, the Repre-
sentative said:

"The trust, it will be shown,
controls the output of the licorice
paste, an essential ingredient in
the manufacture of tobacco. I
have copies of contracts indepen-
dent dealers have been forced to
sign in which they agree to take
but certain quantities of this ma-
terial and at certain time. In the
past five years the trust has in-
creased the price of this paste 500
per cent. Employees of independent
firms have been tampered with,
and the investigation will disclose
a shocking state of affairs. Duke
has made good his boast that he
would do for tobacco what Rockef-
eller has for standard oil. The
American Tobacco Company is the
sole buyer of leaf tobacco except
the Regle contract sales. It con-

trols the cigarette, snuff, smoking
and plug sales at 85 per cent. of
the entire business amounting to
half a billion dollars a year. The
trust has driven into bankruptcy
3,000,000 people dependent upon
raising tobacco and an additional
1,000,000 of dealers.

"As long as the trust continues
to oppose the bill taking the tax
of six cents off leaf tobacco,"
concluded Mr. Stanley, "I intend
to devote my time and energy to
exposing its methods, and I expect
to bring its officials to justice and
some to the penitentiary."

Many people in North Carolina
will be especially interested in
this movement against the Amer-
ican Tobacco Company, which has
done so much to make tobacco-
growing of little profit—barely
enough being paid in many cases
to induce farmers to continue to
raise it. There is no doubt that
the tobacco interests of the coun-
try are in the main controlled by
one gigantic concern, and its op-
erations will probably be found
as arbitrary as the standard oil or
in any other monopoly.—Charlotte
Observer.

WHEN HE QUAILED.

An old soldier is a mighty privileged person sometimes. And nowhere is this more clearly shown than at the Home theater. Out there if an old boy doesn't like the show he gets up and leaves. Not long ago "Richard III." was given at the home to an audience of varied and mingled emotions. One old man had followed the play breathlessly until it came to Richard's famous haunted dream. As the spectators began to file out behind the bed the old man leaned forward and gasped, "Good Lord, look at the ghosts!" and, grabbing his cane in his hand, he beat a hasty retreat. He had stayed by Richard through all of his wickedness, had hissed him when he had killed his relatives by squads and bunches, had gripped his chair hard to keep from going down and laying him out when he had ordered the murder of the princes—but this last was too much. When the ghosts appeared the man who had faced the cannons turned and fled. —Leavenworth Times.

Tree 6,200 Years Old.

The distinction of being the oldest living thing undoubtedly belongs to one of the giant trees, and many attempts to locate it and determine its age have been made. A century ago De Candolle found two yews, one at Fortingal, in Perthshire, and one at Hedsor, in Bucks, that were estimated to be respectively 2,500 and 3,240 years old. Both are still flourishing, and the older tree has a trunk twenty-seven feet in circumference. A gigantic baobab in Central America, with a trunk twenty-nine feet through, was thought by Humboldt to be not less than 5,150 years old. Mexican botanists believe that they have now discovered a life span even greater than this, and from the annual rings a cypress of Chapultepec, whose trunk is 118 feet in circumference, is assigned an age of about 6,200 years.

No Petit Larceny in England.

America still distinguishes between grand and petit larceny. In England the distinction, which has existed since Edward I.'s time, was abolished in 1827, and again—to make sure presumably—in the larceny act of 1861. If the property stolen did not exceed twelvepence in value it was petit larceny, and the punishment was whipping or imprisonment. If the property was valued at more than twelvepence the larceny was grand and the offense capital. In America today the valuation boundary between the two kinds of larceny varies from state to state, the manner of the theft also being taken into account in some instances. In New York the limit is \$25.—London Chronicle.

ALL OVER THE HOUSE.

Simple Way of Filling Pillows Without Loss of Feathers.

Select the pillows that are to be opened and with a large needle and coarse linen thread baste about one inch from the end of a pillow, commencing at the edge. Gradually slant to the required distance. Then slant out again at the other end, so that when the seam is opened your feathers are all still in the pillow. After ripping as far as the bastings go sew the opening of the other in like manner. Rip the second one the same as the first. Now pull out the bastings of both pillows, which releases the feathers, then work the feathers from one end into the other by pushing them through from the outside.

When all are transferred replace the basting in the pillow containing the feathers. Then separate them. Now you have your pillow filled and no feathers lost. Turn the edges in and sew up by over and over hand stitch, or run the end across by machine, and there you are. Pull out the basting.

Blanching Nuts.

The blanching of nuts is a process often thought difficult because not understood. The nuts should be covered with boiling water and should be allowed to stand for ten minutes, where they will keep hot, but not cook. Then drain them, plunge them into cold water and chill them. A knife must be used with English walnuts because of their serrated surface. Pistachio nuts are hard to blanch, and the water in which they soak needs to actually boil while they are in it, although they must not cook.

A Toilet Vinegar.

When the first warm weather gives the skin that disagreeably oily look a milk vinegar diluted with a little water and applied night and morning is efficacious.

Take of alcohol fifteen grams, tincture of benzoin fifteen grams and strong white vinegar fifteen grams. Mix and let stand for a week, then press through filtering paper.

Care of Linen.

The preservation of linen depends largely on the care taken in washing as well as in the mending of each article in daily use as soon as a worn piece makes its appearance.

In warm, sunny weather the linen cupboard or drawers should be emptied and their contents exposed occasionally to the influence of the air and sun.

Soiled Photographs.

Photographs that have become soiled or that are mounted on cards the edges of which are broken may be soaked off by placing them in water. This cleans them, but does not injure them in the least, and after drying thoroughly between blotters they may be mounted again on new cards.

Kindling the Fire.

If one insists on using kerosene as a fire kindler, better pour a pint or so into an old tin pail and stand as many corn cobs in it as the pail will hold overnight. The cobs will be thoroughly saturated by morning and are not so dangerous to use.

Scratched Varnish.

When the varnished furniture becomes scratched the spots should be gone over with a camel's hair brush and shellac varnish until they disappear. Nothing should be allowed to touch the places until the application is thoroughly dry.

Lamp Wicks.

To insure a good light wicks must be changed often, as they soon become clogged and do not permit the free passage of the oil.

Soaking wicks in vinegar twenty-four hours before placing in lamp insures a clear flame.

Dandruff Remedy.

Forty-eight grains of resorcin, one-fourth of an ounce of glycerin, diluted alcohol to fill a two ounce bottle. Apply to the roots of the hair by means of a medicine dropper or a small brush, and rub in well with the finger tips.

To Clean Plush Frames.

When plush photograph frames become faded and spoiled they may be freshened up with salt. Sprinkle the salt thickly over the plush, rub well with a soft brush, let it stand for fifteen minutes and then brush off.

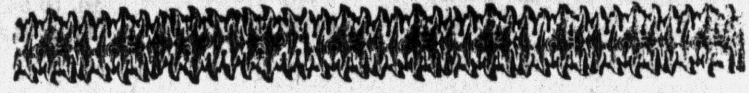

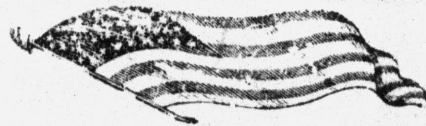

WHY THE LEFT EAR?

Everybody puts the telephone receiver to the left ear. No one in using the telephone ever listens with the right ear. It is always the left.

"Do we hear better with the left ear? Is that why we always use it in telephoning?" a man asked.

"No," the pretty telephone girl replied. "But the receiver, you see, is hung on the left side of the phone; hence you have to use the left ear, in talking unless you want to inconvenience yourself.

"But why is it hung on the left side?" she went on. "Was it hung there originally because the left ear had been found acuter than the right? Ah, no. The receiver was hung at the left so that the left hand could easily manage it. The right hand in the early days of telephoning had all it could do to turn the crank—around and around and around—ding-a-ling-a-ling-a-ling—don't you remember?

"Now the right hand is idle in telephoning. Therefore for any one desiring it it would be possible to hold the receiver to the right ear. The companies should take this fact into consideration, and they should hang the receiver not on the left or right of the instrument, but directly in front of it. Then we could use in telephoning whichever ear we preferred to."—Exchange.

A Wonderful Feat of Endurance.

All the automobile endurance contests are thrown into the shade by the remarkable performance of Emil Bouhours of Paris, who rode a bicycle 815 miles and 291 yards in twenty-four hours, at the remarkable average rate of thirty-four miles an hour. When one considers the delay and stops entailed in such a race it means that for hours the rider must have been pedaling his bicycle at the rate of fifty miles an hour and sometimes even faster than that. The old record for the time was 634 miles and 57 yards, or about seven hours slower than Bouhours' record. It is true that Bouhours was paced by a motor cycle, and for a large part of the time he made his own pace. The weather was intensely cold and seriously affected Bouhours in the last four hours of his riding. He says that under better weather and pacing conditions he would be able to cover 1,000 miles in twenty-four hours.—Leslie's Weekly.

Side Lights on the French Census.

France does not take its censuses as seriously as this country, though some Parisian wits are now paying fines for the gayety of their answers to the enumerators' queries. Some towns and villages set about swelling their population. Marseilles and Lyons were jealous about the second place among French cities. Whether they padded the returns or not does not appear, but Cassoulet-sur-Lot, a little town in the south, was anxious to bring its population up to 20,000, so that its magistrates could have their salaries increased by \$125. As only a few score of people were wanted, the affair was comparatively easy. Cassoulet jail was made the workhouse of a whole district, but entry was obligatory, not permissive, for all the tramps in the neighborhood. This drafting of citizens was successful.

The Solemn Back Bay Butler.

Some Boston editor intimated that Back Bay butlers made love to the housemaids. One of them has replied in defense of his class, and incidentally he shows how far culture has got down the back stairs of Boston society. He writes:

"I do not flirt with any of the female members of the household, and it is no exaggeration to say that I am not better than the average butler of the Back Bay, so far as morals are concerned. I have educated my boy in France and England and am now giving him a postgraduate course at an American college. Our feelings have been hurt by the article to which I refer, and we have undergone a great deal of mental suffering from the annoyance unwittingly caused us."
