THE WORLD'S TRADE.

The world's international commerce will aggregate fully \$25,000,000,000 in the year 1906, according to a bulletin of the Department of Commerce and Labor. By the term "world's international commerce," the bulletin explains, is meant the imports, plus the exports, of all countries of the world from which statistical trade reports were available. The figures given indicate that the trade between the nations in 1906 will be six times as much as in 1850, two and a half as much as in 1870, and 25 per cent more than in 1900. One interesting fact, says the bulletin, which an examination of the figures of average monthly trade of the principal countries of the world develops is that the United States now stands at the head of the world's great exporting nations. The average monthly exportations from the United States in nine months ending with March, 1906, is shown by the Bureau of Statistics figures at \$147,208,973; the monthly average from the United Kingdom for the same period \$143,574,912; the average from Germany during the twelve months ending with December, 1905, \$110,777,800, and the monthly average from France for the twelve month period ending with February, \$72,370,400. The fact that the United States can thus lead all other nations in the matter of exports despite our tariff wall which keeps their goods out is calculated to raise the query as to what we could do if unhampered by a protective tariff.—Charlotte Observer.

BOARD MEETING OF AYDEN.

The town aldermen met in special session May 18th, 1906.

J. J. Stokes, justice of the peace, administered the oath to E. G. Cox, mayor, also to M. M. Sauls, S. A. Jenkins, Sebron Cox, Stencil Hodges, R. W. Smith, aldermen.

R. W. Smith was elected clerk and Stencil Hodges treasurer.

Sebron Cox, health officer; his duties are to make a canvass of the town twice each month, from May to September inclusive, and if there is found upon the premises of any person, within the incorporate limits of the town, that in his opinion would endanger the health of any citizen, or should any person know of any such case to report same to said health officer, and they will be dealt with according to crime.

M. M. Sauls offered his resignation as commissioner which was accepted. J. F. Barwick was elected to fill said term.

Mayor Cox named the following committees:

Streets—S. Cox, S. A. Jenkins, J. F. Barwick.

Cemetery—J. W. Taylor, J. S. Ross, Stencil Hodge.

A petition was presented from the cotton buyers asking the appointment of F. Lilly as cotton weigher for this place, which was done, bond and term fixed as prescribed by law.

Jesse Cannon was appointed to list town taxes for 1906.

W. J. Hemby was elected assistant police.

The finance committee made report showing they had carefully examined and audited books of tax collector and treasurer, that found the treasurer books neatly and correctly kept and showed a balance in treasury, \$2,026 15, also F. Lilly, tax collector, had collected \$1,366, and had paid the same to treasurer, and also found \$34.49 delinquent.

Died.

ROCKEFELLER'S OIL PROFITS.

Estimated at \$113,500,000 Since January 1, 1898.

If, as has been reported, John D. Rockefeller owns 33 per cent of the capital of the Standard Oil Company he has received in dividends, since January 1, 1898, approximately \$113,500,000.

Statistics bearing upon the stupendous dividend disbursements of the great oil trust were made public in Wall street today, apropos of the Standard Oil Dividends of \$9 a share, declared yesterday for the past quarter. These figures showed that since January 1, 1898, the Standard Oil Company has disbursed to its stockholders \$341,043,000 in dividends, or nearly three and one-half times its authorized capitalization of \$100,000,000.

The company pays more in dividends to its stockholders than any corporation in existence. The United States Steel Corporation, when it was declaring dividends on its common stock, distributed more than the Standard Oil Company, but no dividends on steel common have been paid for two or three years: The dividend and interest payments combined of the United States Steel Corporation are, however, considerably in excess of the dividend disbursements of the Standard Oil.

Thus far this year the latter has declared about 24 per cent, or about \$24,000,000, in dividends to its stockholders or the same amount as was disbursed in the corresponding period last year.

The total dividends last year were nearly \$40,000,000.

FINGER RINGS.

They Are Circles of Sentiment With Histories Centuries Old.

Old as sentiment itself is the ring. Among the Italians of the sixteenth and seventeenth centuries it was customary for women to give to their lovers rings which contained their portraits. These rings were in the forms of two clasped hands, in which a golden spring concealed the picture.

Another quaint custom of the long ago was that of breaking a ring for betrothal. Such rings were fashioned for the purpose, being made of two twin circles, and were called gimmel rings, from the word gemelli, meaning twins.

A ring of pure gold she from her finger took,
And just in the middle the same there she broke.
Quoth she, "As a token of love you this take,
And this as a pledge I will keep for your sake."

The gimmel was also a favorite wedding ring for many years. Dryden thus describes it in "Don Sebastian:"

A curious artist wrought 'em,
With joints so close as not to be perceived,
Yet are they both each other's counterpart,
Her part had Juan inscribed and his had Zayda.

In the modern fondness for rings is seen a survival of the barbaric love of display, of superstition and of sentiment. The habit of loading the fingers with jewels, which Seneca condemned in his day, saying, "Our fingers are loaded with rings, each joint is adorned with precious stone," is still in favor with a class in whom the barbaric instinct is not yet exterminated, while many a modern belle would like to wear, as did the Empresses Faustina and Domitia, rings which cost \$200,000 and \$300,000. And she does often wear, as did her Roman prototype, "sardonyx, jaspers and emerald on the joints of her fingers."

Willing to Oblige.

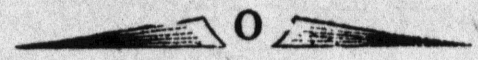

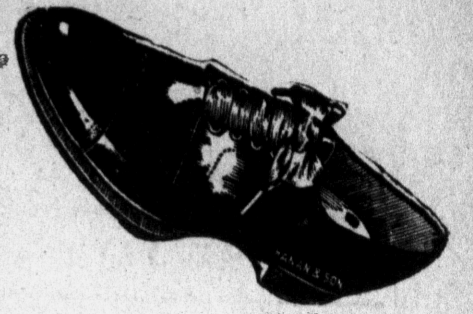
"Hello!" said the gentleman. "I thought you were deaf and dumb?"

THE INVENTOR OF CHESS.

His Price Seemed Modest, but It Could Not Be Paid.

An Arabian author, Al Sephadi, relates the following curious anecdote:

A mathematician named Sessa, the son of Dahar, the subject of an Indian prince, having invented the game of chess, his sovereign was highly pleased with the invention and, wishing to confer on him some reward worthy of his magnificence, desired him to ask whatever he thought proper, assuring him that it would be granted. The mathematician, however, only asked for a grain of wheat for the first square of the chessboard, two for the second, four for the third, and so on to the last, or sixty-fourth. The prince at first was almost incensed at this demand, conceiving that it was ill suited to his liberality. By the advice of his courtiers, however, he ordered his vizier to comply with Sessa's request, but the minister was much astonished when, having caused the quantity of wheat necessary to fulfill the prince's order to be calculated, he found that all the grain in the royal granaries, and even all that in those of his subjects and in all Asia, would not be sufficient.

He therefore informed the prince, who sent for the mathematician and candidly acknowledged that he was not rich enough to be able to comply with his demand, the ingenuity of which astonished him still more than the game he had invented.

It will be found by calculation that the sixty-fourth term of the double progression, beginning with unity, is 9,223,372,036,854,775,808, and the sum of all the terms of this double progression, beginning with unity, may be obtained by doubling the last term and subtracting the first from the sum. The number therefore of the grains of wheat required to satisfy Sessa's demand will be 18,446,744,073,709,551,615.

Now, if a pint contains 9,216 grains of wheat, a gallon will contain 73,728, and a bushel (eight gallons) will contain 589,784. Dividing the number of grains by this quantity, we get 31,274,997,412,295 for the number of bushels necessary to discharge the promise of the Indian prince. And if we suppose that one acre of land is capable of producing in one year thirty bushels of wheat it would require 1,042,499,913,743 acres, which is more than eight times the entire surface of the globe, for the diameter of the earth being taken at 7,930 miles, its whole surface, including land and water, will amount to very little more than 126,437,889,177 square acres.

If the price of a bushel of wheat be estimated at \$1 the value of the above quantity probably exceeds that of all the riches on the earth—Follies of Science.

John Boyle's Battle Run.

John A. Boyle, a Massachusetts man, took part in the civil war and liked to tell about his experiences. At a meeting one evening he told about the experience he had at the battle of Bull Run as follows:

"I saw the men drop their guns and run, so I dropped mine and ran, too, but I was chased by one of the enemy, who had his gun in his hand. I ran the fellow a good race for two miles, and then I stumbled and fell and was expecting him to come up and shoot me. He didn't come, so I looked around to see where he was, and to my surprise saw him sprawled out on the ground about two yards from me. I got up and looked at him and saw that he had died from apoplexy."

Boyle's hearers asked what he did next, and he replied, "I wept for the man that I had run to death."

Polite Reproof.

A lady once ventured to publicly reprove a well known London society man for his overfondness of good living. The gentleman made himself conspicuous by the way he gorged himself at a dinner to which he and others of the upper ten had been invited. To make matters worse, he was sufficiently unwise or thoughtless enough to attempt to excuse himself with the remark that "in eating well I praise the food," thereby using a well known quotation. It was an opportunity not to be lost by the somewhat disgusted and witty lady sitting at his elbow. "Really, sir," she observed, with a sweet smile, "you should not carry praise to the point of flattery."

CYPRESS WOOD.

Instances Where It Has Lasted Over a
Thousand Years.

The cypress is a notoriously slow growing tree, and its wood is just as notoriously durable. It is capable of not only resisting the action of the weather in a manner totally different from all other woods, but is wholly uninfluenced by immersion in water over a long period of years. It has many curious chemical properties, which hold its fibers and other constituents together so indissolubly that the ordinary changes which break down the tissue of ordinary woods are in the cypress wholly resisted.

Instances are known where the wood of the cypress has endured far more than 1,000 years, leaving it still in a solid condition, subject only to the attrition of the elements, such as the gradual wearing away one sees in exposed rocks. In the lower valley of the Mississippi a species of cypress is extremely abundant. And in New Orleans some years ago, while some men were excavating a trench, a cypress stockade was found which was erected in 1730 by the French as a protection against the Indians. Some of the pieces measured twenty-one inches in width, with a thickness of about twelve inches, and, though it had been buried for so many years, it was in perfect condition when exhumed, even the tool marks being still clearly visible.

By a series of experiments extending over many years it has been found that the cypress wood endures the varying conditions of greenhouses better than any other wood. Greenhouses exposed to all the vicissitudes of heat, moisture and changes of temperature show the cypress timber used in their construction to be practically unchanged after more than fifty years of use, and, being sufficiently tough for the purpose, it is probable it will come more generally into use for building where a wood of great resistance is required. Many old doors made by the early Spaniards in America are still as serviceable as ever, although exposed to a most trying climate.

Getting Rid of Visitors.

"Mamma wants two pounds of butter exactly like what you sent her last. If it ain't exactly like what she got before she won't take it," said a young boy to the proprietor in an East Germantown store recently. The grocer, his face wreathed in smiles, turned to a number of customers who stood by and remarked blandly: "Now, some people in my business don't like to come in contact with particular customers, but I sincerely say I do. I take great delight in serving them and try my best to secure for them what they desire. Just wait another minute, my little man, and I will fill your order with pleasure." The little boy, being thus encouraged to speak, admonished the busy grocer to "be sure and get the same kind of butter, because a lot of pop's relations are visiting our house and mamma doesn't want 'em to come again."—Philadelphia Record.

Having Fun With Judge Wait.

Several years ago Judge Wait, then a young lawyer in Boston, having an account to collect, wrote to the delinquent asking for payment and signing himself, "William C. Wait." The man to whom he wrote answered promptly with a witty note, saying he would be much obliged if the lawyer would change his name to "Will U. Wait." Mr. Wait, ignoring the facetiousness of the letter, wrote quite sharply, demanding an immediate payment of the bill, whereupon he received a short note in reply, saying that, after all, the delinquent thought the lawyer's name should be simply "Will Wait."—Boston Herald.
