## WRECK NEAR PACTOLUS.

### Conductor and Clerk Hurt.

There was an accident on the Atlantic Coast line Road this morning about two miles north of Pactolus and why it was not more serious is a mystery.

While the freight train running from Tarboro to Washington was on her way to this city and near Pactolus, for some reason the caboose turned over without one moment's warning. Due to this catastrophe, the conductor of the freight, Mr. Charles Whichard, was hit on the head and his body terribly and painfully skinned. Mr. Arthur Whitehurst, the clerk in the railroad office at Pactolus, who was also in the car, had his arm broken and his limbs bruised.

Both the conductor and the clerk, as soon as the freight reached this city, were taken to the Fowle Memorial Hospital, where the surgeon of the Atlantic Coast Line, Dr. S. T. Nicholson, dressed their wounds.

Engineer T. B. Tomlinson was at the throttle at the time the accident took place. Breaks were applied as soon as possible. The wonder is the accident did not carry with it death. Although the freight was delayed, she arrived in the city and left for Tarboro on time this afternoon.—Washington Messenger.

### Drinking Jamaica Ginger in Lieu of Liquor.

Negroes are not alone in drinking Jamaica ginger in lieu of corn liquor. White men and some boys are swigging it. They take a bottle pour out a small quantity, fill the glass with water and in a few minutes they are pretty drunk. The most of those that are now confirmed in the habit learned it from some of the old rounders. When they get drunk it is on liquor, but when they get out of liquor they hang on to ginger for a while as being the best they can get.—Greensboro Record.

### Acreage Report Doctored.

Washington, June 5.—Representative Ellerbe, of South Carolina, introduced a resolution to-day charging that the cotton acreage report of the Department of Agriculture issued yesterday giving an estimate of 28,686,000 acres, exceeds the amount actually planted, and is not warranted from the returns received by the Department from its corps of correspondents.

The resolution directs the Secretary of Agriculture to furnish the House at once the tabulated sheets showing the estimate acreage made by the seven classes of correspondents, namely: The field agents, the State agents, the country correspondents, the township correspondents, the ginners, the special correspondents and the individual farmer.

Mr. Ellerbe states that he has direct and positive information that this cotton report has been manipulated to the disadvantage of the South and alleges that no one of the three traveling agents "was in two States upon which they passed."

## A School House Built in This State Every Day in the Year.

The School Journal, of New York has an excellent article on North Carolina's public schools. It is illustrated with the pictures of the governor's mansion, the state capitol, the building for the blind, the Baptist university for women, etc.

The article states that the last five years have been a period of unprecedented progress in education. From 1900 to 1905, 1,459 new public school houses were built. In 1905 alone, 440 new houses were erected with an average value of \$425. During the five years ending June 30 1905, the total value of public school property increased from \$1,153,311 to \$3,203,141. During this period more than one school house a day for every day in the year has been built in North Carolina, value of public school property more than double, and expenditures for building and opening school houses increased nearly five fold, 1,259 rural libraries have been established, costing \$40,875 and containing 113,298 volumes. In addition to this 107 libraries have been established by private subscription.—Hendersonville Hustler.

The Record has no disposition to minimize the evils shown to exist in the big packing houses, but there is no occasion for throwing fits. There is an old saying that every one must, in the course of a lifetime, eat a peck of dirt, but many of us will come to the conclusion that we have gulped down more than our share. For instance—the good housewife insists on the cook drinking from a different glass or cup at the ice cooler, yet the cook—perhaps, sometimes—delves into the dough and meat with hands that are not half as clean as her mouth and no one knows the difference. There is a great deal of humbug about all of us.—Greensboro Telegram.

## COUNTY MATTERS.

### Proceedings of the Commissioners.

The board of county commissioners were in regular monthly session on Monday, 4th, all the members present.

Orders were drawn on the treasurer aggregating as follows: For paupers \$148 75; county home supplies \$181.06 repairs \$124 56; superintendent health \$25; bridges and ferries \$256.89; jail \$68 80; court house \$3 75; conveying prisoners \$17 95; jury tickets \$5.20; court costs \$2 87; blanks \$1; attorney \$75; register of deeds \$26.50; commissioners \$36.80; sheriff \$40.70; general roads \$50.10; Pactolus roads \$227 14; Greenville roads 71.28; county stock law 2,070.47; Belvoir stock law 118 22.

The treasurer and superintendent of health filed their monthly reports

The following changes were made in pauper list; Alex Greene added at 1. per month, John Pollard and family reduced to 2.50 per month, Alpha Letchworth increased to \$2.50 and William Bernard to 1 50 per month.

A. G. Whichard, constable of Greenville township, tendered his resignation which was accepted. Election of successor deferred until July meeting.

Joe McLawhorn was elected superintendent of roads for 12 months at a salary of 75. per month, assistant guards to receive same salary as heretofore.

The public road petitioned for at May meeting beginning at Maccon Moye's and running through to Plank road at Frog Level, was ordered laid out; also the road beginning at road number 39 and running through lands of W. J. Braxton and others to Kingston road.

Reports of commissioners in laying out roads previously ordered were made.

The following levy of taxes was made for the year 1906:

For county purposes 21 cents on each \$100 valuation of real and personal property and 63 cents on each poll.

All schedule B. and C taxes same as state.

For stock law in Greenville Falkland, Farmville, Beaver Dam, Contentnea and Swift Creek townships 20 cents on each \$100 valuation; in Belvoir township 50 cents on each \$100 valuation; Winterville 33 1/3 on each \$100 valuation.

For special school districts: Ayden 39 cents on each \$100 valuation and 75 cents on each poll; Farmville 20 cents on each \$100 valuation and 60 cents on each poll; Grifton 30 cents on each 100 valuation and 90 cents on each poll.

Public roads in each township 6 2/3 cents on each 100 valuation and 20 cents on each poll.

The committee appointed to assist in settlement with the sheriff and treasurer for taxes of 1905 filed report, which was accepted and ordered recorded. The report showed settlement in full. ### AFRAID OF THE DARK.

### Broke the Spell.

### The Heaviest Rails.

What are believed to be the heaviest rails in use on any steam railroad in the world are on the belt line around Philadelphia. They weigh 142 pounds to the yard. Concrete with nine inch girders is used, with heavy ballast to make a firm roadbed. One railroad official states that this section of roadbed will last for twenty-five years without repair. This would mean a material reduction in maintenance expense to the road using these rails.

### JUDGE PAGE'S LOST COAT.

Judge Calvin Page of Portsmouth, a leading member of the New Hampshire bar, has been prominent in New Hampshire politics for a number of years. A few years ago he was sitting in the rotunda of the Eagle hotel in Concord earnestly discussing the political situation with some friends. He had a very nice new overcoat, which he carefully placed upon the chair underneath him. Becoming interested in the conversation, he paid no further attention to the coat. A stranger standing near noticed that the judge was very much absorbed and, walking up to him, placed his hand on his shoulder and said, "Excuse me, sir, but you are sitting on my coat." The judge promptly arose and apologized, allowing the man to walk off with his coat. When the conversation was finished and the judge looked for his coat his remarks were rather emphatic.—Boston Herald.

### Points on Oysters.

When oysters are removed from more saline water to that which is less salt, says Dr. William K. Brooks, professor of zoology in the Johns Hopkins university, who has made the oyster a life study, they absorb water quickly and become plump, or "fat," but the fatness is nothing but water. The "fattening" of rivers, which are always near towns and polluted by sewage. Every "fattened" oyster is too suspicious to be eaten raw, and the outbreaks of typhoid fever which have been traced to oysters most clearly have been traced to "fattened" oysters. All the fresh water that a "fattened" oyster has absorbed is at once extracted by cooking, so that the "fattening" of oysters that are to be cooked is not only an unnecessary expense, but a fraud on the consumer, who is sold filthy water from the harbors of cities at the price of oysters.—New York Times.

### LAUNCHING THE LIFEBOAT.

At last modern invention has begun to grapple with the task of bringing the primitive method of launching a boat from a ship's side at sea to a condition more worthy of the twentieth century. The present system, clumsy in fine weather and one of deadly peril in storm, when alone the launching of the ship's lifeboat reaches its highest necessity, has been described as "a disgrace to marine engineering." M. Wehn, a Swedish engineer, has made an effort to remove the reproach. His apparatus, which has been subjected to many practical tests, has a hinge arrangement in the "chocks." The drawing of a bolt sets them free and permits the boat to glide outward, while there are horizontal arms to keep the boat from crashing against the ship's side. As passengers and crew can be got into it before it leaves the davits, the boat can be got clear immediately upon touching the water, which removes another of the great dangers of shipwreck.

### Italy's Wolf Hunter.

A modern Nimrod, a hunter of the old school, has just died in Italy. For half a century he made wolf hunting a business which kept him in comfort and left a margin for a "rainy day." Wherever there was a wolf to be destroyed Luca Chiaretti was called in, and many were his savage encounters and many the scars left upon his body as witnesses. His left hand showed the marks of some terrible rips, sustained in executing a royal commission from the present king's grandfather, the Victor Emmanuel of history, so long since as 1875. It was his ambition to capture the beast alive, and he closed with it for the purpose, but the wolf got his left hand in its jaws and tore it so furiously that with the maimed hand still between the animal's teeth he had to shoot it with his right.

London has put the ban on American canned meats and refuses to buy. Folks on this side of the pond would also do well to draw the line on the Chicago brand.

Gen. Nelson A. Miles says he tried to tell them all about this meat packing business seven years ago, but was shut up. He says he lost 3,000 soldiers from eating the stuff.

The mayor of Chicago wants the city to engage in the meat packing business on its own account. If his idea is put into execution, we hope the premises will be kept cleaner than has been noted of the enterprises composing the beef trust.

The sheriff of Wake county has resigned his office, giving as his reason that the fees were too small. ## PROFESSIONAL JEALOUSY.

It is not everytime that a newspaper hits both sides of a question at one stroke, but that is what the Statesville Landmark has done, and with apparent unconsciousness of having solved its own proposition. The last issue of the Landmark had this to say:

The State Board of Medical Examiners, at their recent meeting in Charlotte, passed a resolution to the effect that any physician who is an inebriate or a drug fiend to such an extent as to endanger the lives of his patients, his license to practice medicine shall be withdrawn. Good resolution if lived up to, but finding somebody to bring the charges and establish them will be difficult. Even physicians, when they know a brother physician, is unfit to practice for the reasons mentioned, will either try to shield him because "he is a member of our profession," or will be afraid to mention it lest their speaking should be attributed to jealousy.

We were just about to grab a pencil and say that as doctors were so bitterly jealous and usually ready to do anything they can against each other, that they were unlike lawyers and would not hesitate to report on a brother, but looking a little further the very next item in the Landmark covered the ground so thoroughly and so well answered the proposition in the first one, that nothing else needs to be said. Here it is:

"Professional jealousy" was the subject of an essay at the meeting of the State Medical Society in Charlotte last week. It was discussed by Dr. T. T. McMullan. We hope the paper will be printed, for we have some curiosity to see what a doctor has to say on this subject. We don't know anything that could be more timely in a meeting of doctors than a discussion of "professional jealousy." As professional men and as citizens there are no better men than the doctors, and yet the layman knows that, as a class, of all men living they are the most jealous of each other.

**To Salt Nuts.**  
Shell and scald them, leaving in the water for ten minutes or until the skins slip off easily. Shake in a towel and spread in the sun for an hour to get perfectly dry. Put them into a baking pan, stirring up well with a teaspoonful of melted butter. Set the pan in an oven when the nuts are all coated with the butter and brown very lightly, stirring often to cook them evenly. Turn into a colander, sift fine salt over them and shake and toss gently to free them of surplus salt and butter. Keep in a cool place.

**Gilt Picture Frames.**  
Gilt picture frames may be cleaned by mixing thoroughly one tablespoonful of melted soap with half a pint of boiling water. Add to these a wineglassful of spirits of hartshorn, and mix them well together. Apply this with a small, soft brush, and after allowing this lotion to remain on for a minute wash it carefully off with clean water, and dry the frame in the sunshine.

**Keep Blankets Clean.**  
To wash blankets allow a large tablespoonful of lump borax to every two gallons of soft warm water. Soak the blankets in this overnight, the white ones in separate tubs from the colored ones. Let the water cover them as they lie loosely in the tub. In the morning squeeze them, wring out with the wringer, rinse in clear, soft warm water, wring and hang on the line.

**Kitchen Helps.**  
Use soap and wood ashes to brighten pans and kettles that have been used over an open fire. Grease the upper inside edge of the pan in which chocolate is being made, and it will not boil over. Always place a knife which has been used in cutting onions immediately under the cold water spigot to prevent the odor from clinging to the blade.

**Drive Away Beetles.**  
Add a piece of rock alum the size of a large potato to a pint of boiling water and allow it to simmer for about half an hour. Paint over the places that the beetles haunt with the mixture. At the same time sprinkle the floor with powdered borax, and you will soon be rid of the pests.

**Freshening Veiling.**  
Souse in gasoline out of doors, shake gently and attach with many pins to the line in the sun, but not where the wind will stretch it out of shape, or, after shaking out the gasoline, spread smoothly upon a cloth, pinning down at the edges, and leave in the air and shade to dry.

**Hot Pot.**  
Line a deep pie dish with slices of raw potato, sprinkle with finely minced onion and parsley, then put in a layer of slices of cold meat cut into inch squares. Continue till the dish is full, leaving potatoes last. Bake slowly for two hours and serve.

**Soap Economy.**  
The pulverized washing powders last much longer if used from a talcum powder shaker. A baking powder can with holes punched through the lid may be utilized for the purpose.

**An Ideal Duster.**  
A soft chamois skin soaked in cold water and then wrung nearly dry is the ideal duster. It can be used on the finest furniture, and it will leave a clean, bright surface.

**A Laundry Hint.**  
A good way to make starch for dark dresses is to place lump starch in a pan and color a dark brown in the oven. Then make in the usual way.

**SANDPAPER BY THE MILE.**

One of the seven sandpaper manufacturing factories in this country is located in Hallowell and is now a part of the American glue trust, as glue forms such an important factor in the making of sandpaper.

This factory has been established for twenty-three years and was started by Benjamin Tenny, who originally started making glue at his own home in Farmingdale. The output of the factory is about 300 reams a day. There is used in the manufacture a ton of glue a day.

Instead of using sand for the paper, powdered quartz is employed, and this is obtained largely from Topsham and ground at the factory to suit the different kinds of paper. While some kinds of sand might possibly be used, little of it that is picked up at random would answer the purpose for which it is used at this factory.

Another article that enters into the manufacture of the sandpaper is garnet for the paper used in the shoe factories. Much of this is obtained from the Adirondacks. This garnet is ground, and it makes a paper of high quality.

Sometimes there is rolled off from the machines one piece of sandpaper three or four miles in length.—Boston Globe.

**Athletic Oratory.**

After every speech he delivers Bourke Cockran is a sore man physically. Any one who has ever seen him in oratorical action knows why he is sore. The old flagellant monks were not much more cruel to themselves than Cockran is to himself. His favorite gesture is to slap his thighs, and it is no love tap he gives them. It's a good beating. Cockran is one of the old school—muscular, desk pounding school of orators. If he could not hammer his desk and thump his thighs he would probably think his powers failing.

**Living on Cheese.**

The new treatment for bringing stout people to slim, elegant and comfortable proportions consists, in the first place, in eating all manner of cheeses, to the exclusion of all other foods save nonfattening biscuits, fruit and a limited quantity of meat once a day. The dining room was for the use of the guests only, and admission to it from the outside was by invitation only.—Buffalo Commercial.

His contention is that French must eventually become the universal language, because it is the cleverest of tongues and the most phonetic. He says also that it is the most adaptable of all the tongues, and is more universally read and used outside of its own borders than any other.

**ALL OVER THE HOUSE.**

**Neat and Inexpensive Screen For an Unused Grate.**

The problem of screening a grate which has been closed for the summer or of hiding the bare space below the mantel where a stove has been standing may be solved (for those who desire an inexpensive and pretty screen) by the following suggestions in a popular style of treatment:

A piece of matting of any solid color that will harmonize with the other furnishings of the room will be required.

This is to be cut of the right length to make a banner screen and hung from a rod upon the chimney beneath the mantel. In case the wall is flat, as where a stove has been in use, it may be tacked close up under the mantel and reach to the floor. It should, of course, be decorated to be at all ornamental. The lower edge may be turned up and caught in place as a hem with long, loose stitches.

**Banana Compote.**

Put three-quarters of a pint of cold water into a stew pan with four ounces of sugar and the peel of a lemon, and let it boil for five minutes and then simmer for a quarter of an hour.

Peel five or six bananas and then cut them into pieces about an inch in length, and put them into a fairly deep dish.

Strain the sirup, add the juice of an orange and a squeeze of lemon juice to it, and pour it while hot over the bananas.

When quite cold arrange the latter in a glass dish with the sirup, and cover the fruit with whipped cream or a thick custard, and scatter some unsweetened desiccated coconut over the top.

**For Hard Hands.**

Many people have naturally dry skin. The following treatment will soften it wonderfully: First soak the hands in warm water, and while still wet apply a small quantity of olive oil. Rub this well in till the skin has absorbed as much as it will. Then dry thoroughly. At night sleep in a pair of loose white gloves, which for ventilation should have the finger tips cut off and the palms punctured all over with a stiletto, lined with almond paste made by mixing in half an ounce of rose water enough almond meal to form a thick paste.

**Mending Table Linen.**

When a hole actually appears in table linen it must be either darned or patched, and darning is most satisfactory. If the tear or broken place is not large put the linen into an embroidery hoop and darn with soft mercerized cotton or get the flat linen thread if you can, which is made for the purpose of darning table linen. Either will be better than ravelings of the cloth, which were once thought to be the best for mending.

**To Transfer Printed Pictures.**

Take a small, cheap brush and a little bottle of ordinary turpentine. Paint the picture you wish to transfer with turpentine, then blot with a blotter, so that the ink will not run. Turn the face of the picture down on the paper you wish to transfer it to, and rub the entire surface hard with a smooth surface, and the transfer is complete.

**To Clean Marble Slabs.**

Get two ounces of washing soda and an ounce each of powdered pumice stone and chalk and pound them together. Make a paste of a little of this with cold water and spread on your marble slabs. Let it stay a little while and wash off with soap and water. All stains and dirt will come off with it.

**Metal Polish.**

Take half a pound of best prepared chalk, three ounces of turpentine, three ounces benzine and one ounce liquid ammonia and thoroughly mix together. Shake the bottle well before using, and apply with a sponge, allowing the mixture to dry before rubbing with flannel to polish.

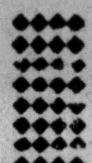
