MASONIC CELEBRATION.

Kinston Had Great Day Wednesday.

Kinston does not do things by halves, and that progressive town did herself splendid credit in the manner of entertaining the large number of visitors there Wednesday. Stores, residences and vehicles were gaily decorated with bunting flags and Masonic banners, and the words "Welcome" hung out everywhere. Thousands of people were in attendance, and notwithstanding the inability to get a special train to go over, Pitt county was well represented. Had our people known earlier that the regular noon train would reach Kinston in ample time for the exercises and how well the Atlantic Coast Line would handle them by special train to return at night, the number from here would have been many times larger.

A session of the Grand Lodge of Masons was held in the opera house before noon, and following this a great procession of Masons, military, firemen and citizens moved to the park surrounding the Robert Bruce McDaniel memorial hospital in East Kinston. Here an immense platform and harbor had been erected for the speaking, and with Dr. H. D. Harper, Sr., as master of ceremonies the program was carried out smoothly and interestingly.

Addresses of welcome were made by Mayor N. J. Rouse on behalf of the city and Mr. J. W. Granger on behalf of St. John's Lodge A. F. & A. M., which were responded to by Lieut. Gov. Frances D. Winston. Then the grand lodge laid the cornerstone of the charity annex to the hospital which had been erected to the memory of Mrs. Elizabeth Parrott by her sons, the Drs. Parrott. This was followed by addresses formally presenting the charity annex to the board of lady managers of the hospital and acceptance.

Then came the principal address of the day which was delivered by Gov. R. B. Glenn. This address was simply magnificent, both in expression and delivery. It was worth taking the journey to Kinston several times over to hear it. The heart of every North Carolinian who heard it swelled with emotions of pride at the noble utterances of our governor and the high tribute he paid to the state. The Judicial Convention of the Third district did itself honor in renominating Hon. Larry I. Moore, of Pitt, by acclamation. He is a native of Wilson county. TEN THOUSAND RED MEN COMING.

Preparing for a Unique Building at the Jamestown Exposition --Uniform Rank of Red Men's League on Camp Grounds.

(By Frank Eberle.)

Norfolk, Va., June 27.—On the beautiful grounds of the Jamestown Exposition, where in years gone by roamed the native red men of America, monarchs of all they surveyed, will be encamped 1,000 to 2,000 uniformed members of the "Red Men's League," who come to visit the exposition next year. In addition to the uniformed Red Men will be about 10,000 members of the "Improved Order of Red Men" at the exposition during Red Men's Day, September 12th. The red men of the time of Powhatan and Pocahontas have passed away and the pretty point of land, which was once their favorite camping ground, has been transformed into the Jamestown exposition grounds. The famous old live oak tree, wherein centuries past, the original red men held their powwows, stands like a grim sentinel. It has stood for nearly a thousand years, a connecting link between the present and the past.

Under this old oak tree Chief Powhatan and his Indian warriors often assembled, three hundred years ago. On Powhatan street, about three hundred yards distant, the Red Men's wigwam will be built in the time of the exposition. A site has been selected for the building by John W. Cherry, of Norfolk, chief executive of the Improved Order of Red Men, and Great Inchohnee of all the tribes of Red Men. It is now up to the Board of Control of the Red Men's League, to approve the selection made by the Great Inchohnee. This will probably be done at the meeting to be held in September, 1906.

The Red Men's building at the exposition will be unique and attractive in many ways. It will be an immense woodman's lodge, constructed with logs and decorated with trophies of the chase and all kinds of curios and Indian relics. Furs and skins will take the place of carpets and rugs and the entire building will conform as nearly as possible to the ideal hunter's lodge. This quaint building will be used by the Red Men as a reception hall, museum and resting place for the Red Men and their friends.

In the United States are more than 430,000 members of the Improved Order of Red Men. Many of them will visit the Jamestown exposition and the Red Men's building will be their headquarters. This order had a building at the St. Louis exposition, two years ago, but it was on a small scale and nothing like the commodious and handsome building to be constructed at the Jamestown exposition.

The uniformed members of Red Men will camp on the regular military camping ground. They will wear the old colonial uniform worn by the famous "Minute Men" of Revolutionary times and will present an attractive appearance.

ALL OVER THE HOUSE.

Appropriate Garnishes For Various Fish and Meat Dishes.

Slices of lemon for fish and raw oysters; also for veal and calf's head.

Red beets cut in ornamental shapes for roast meat and boiled beef.

Currant jelly for game and also for custards and bread puddings.

Tunnel for macerel and salmon, whether fresh or pickled.

Carrots cut into ornamental forms for boiled beef, either hot or cold.

Use the tiny sprigs of celery tops for salads and cold meats.

Sliced eggs, showing both the white and yellow parts, are nice for chicken salad.

Spots of black pepper alternating with red on the fat side of the boiled ham, which should be uppermost.

Parsley is the garnish most universally used for all kinds of cold meat, fish, etc.

Horseradish for roast beef and for fish in general. When used for fish slices of lemon alternate with the little heap of horseradish.

Washing Woolens.

To wash blankets so they will retain their first freshness use soft water and plenty of it. Make a strong suds of soap, and in it immerse the blanket, previously shaken free of dust and dirt. Never rub the soap directly on the articles. Wash with the hands. Never rub on a board. Rinse through several waters, having each hotter than the one which precedes it. This is the one great secret of the process. The heat expands the wool and keeps it soft. Shake out well, pulling the edges straight, and dry quickly. Wash all woolens the same way.

Souffle Potatoes.

For souffle potatoes boil six good sized potatoes in their skins, and when cooked peel and wash them quickly, and add one tablespoonful of butter and half a pint of cream, a teaspoonful of salt and a pinch of pepper. Beat until light and smooth. Beat the whites of four eggs to a stiff froth and stir gently into the potatoes. Heap the mixture on greased paper a spoonful at a time. Dust with grated cheese and bake a golden brown.

ORIGIN OF WEDDING CAKE.

Roman Maidens Carried Three Ears of Wheat to the Altar.

When in ancient or imperial Rome a maiden was wedded according to confarreation she always carried three ears of wheat in her hand, while over her head was broken a simple cake of far and mola salsa as a presage of plenty and an ample abundance of the good things of life.

In this primitive custom, then, we see the germ from which grew the elaborate plum loaves and daintily beribboned boxes of luscious richness that form so conspicuous a feature of our marriage feasts today.

The bridal wreath of an early English bride was likewise fashioned of bearded (and sometimes gilded) wheaten spikes, while on her return from church corn and other cereals were showered upon her and then carefully gathered up and consumed by the wedding guests. In this also we recognize a rude ancestor of a modern fashion—that of sending a newly married pair off in a small blizzard of hard, snowy rice.

In the course of time, however, the golden grain was ground and made into large, thin, dry biscuits, which were gayly shattered above the blushing maid's flowing locks and then distributed among the bystanders. To this day, too, in some portions of highland Scotland it is still customary for the best man and first bridesmaid to break an oatmeal cake over a young wife as she crosses the threshold of the first house entered after the marriage ceremony. This bannock is then partaken of by all the assembled friends and washed down with the Scotch whisky in which they drink the health of the bride and bridegroom and of their respective clans.—Lippincott's.

Toast Better Than Bread.

Toast is better as an article of diet than ordinary bread, says Health, for the simple reason that it is better cooked and therefore more easily digested. The toasting destroys the life of the yeast and eliminates some of the harmful products of yeast fermentation, and the action of the heat converts the starch into a more digestible substance.

FOR THE LITTLE ONES.

The Enormous Ice Mass Which Caps Greenland.

The largest mass of ice in the world is probably the one which fills up nearly the whole of the interior of Greenland, where it has accumulated since before the dawn of history. It is believed to now form a block about 10,000 square miles in area and averaging a mile and a half in thickness. According to these statistics, the lump of ice is larger in volume than the whole body of water in the Mediterranean, and there is enough of it to cover the whole of the United Kingdom of Great Britain and Ireland with a layer about seven miles thick. If it were cut into two convenient slabs and built up equally upon the entire surface of "gallant little Wales" it would form a pile more than 120 miles high. There is ice enough in Greenland to bury the entire area of the United States a quarter of a mile deep.

A Toilet Vinegar.

When the first warm weather gives the skin that disagreeably oily look a milk vinegar diluted with a little water and applied night and morning is efficacious.

Take of alcohol fifteen grams, tincture of benzoin fifteen grams and strong white vinegar fifteen grams. Mix and let stand for a week, then press through filtering paper.

Care of Linen.

The preservation of linen depends largely on the care taken in washing as well as in the mending of each article in daily use as soon as a worn piece makes its appearance.

In warm, sunny weather the linen cupboard or drawers should be emptied and their contents exposed occasionally to the influence of the air and sun.

PRICE TO GO OUT.

A. H. Price, of Salisbury, is to be removed as assistant district attorney of the Western North Carolina District and the commission in favor of ex judge Coble, of Statesville, as his successor, has already been made out. This is the report sent out from Washington by the newspaper correspondents. Tom Pence writes the News and Observer that Mr. Price wishes to continue in office until September 1st but will probably be allowed to do so. Coble, whom the President said was a good man will get his commission, which is already made out, in the near future.

"I am sick and tired of the Republican row in North Carolina and I intend to put an end to it."

This statement was made by the president of the United States to a party of North Carolinians to whom he broke the news that he had decided to put every officer in the internal revenue collection district of Western North Carolina under civil service regulations.

"The North Carolina Republicans seem to fuss over patronage and I intend to prevent the possibility of a scramble for offices as a result of the change in collector," was the substance of the president's statement in explanation of the remarkable order placing the entire force of the Western district under the civil service blanket.

As soon as George H. Brown, the new collector, has run the gauntlet of the senate and received a confirmation of his nomination, which took place Saturday, the president sent for him, requesting him to come to the White House with Secretary of the Treasury Shaw. The president spent some time with his two visitors, giving them his plans for putting the officers under the merit system. The president's remarks were complimentary to the new collector, whom he told to put the office on a business-like plane and to endeavor to elevate the standard of the revenue service in North Carolina. The executive was emphatic in his remarks and said to Mr. Brown that he expected him to carry out his views.

Mr. Brown was also requested to let the office remain in Asheville.
