CUTTING DOWN RURAL DELIVERY ROUTES.

Works Injustice to the People of North Carolina.

Some months ago this paper warned the Southern Congressmen that the Postoffice Department was making rules which would shortly reduce the number of rural delivery routes in this and other Southern States that are sparsely settled. Some of our Congressmen thought this paper "had saw a ghost" and gave out interviews saying that they had "assurances" that the abolition of routes and reduction of service would not be carried out. Later they found that these so-called "assurances" were too vague to rely upon. At that time this paper said that unless Congress took action the department would put in operation rules that would convert some daily rural routes into thrice a week or twice a week routes after Congressmen went home. The majority in Congress refused to do anything and the result predicted in these columns has happened. The Wilson Times of yesterday shows that the first blow has fallen in Wilson. We quote:

"We regret to announce that on the 15th of August two daily rural routes will be discontinued, the third and fifth, the third will be changed to an every-other-day service, while the fifth will be discontinued altogether.

"This is the beginning of the policy of the Postoffice Department to discontinue those routes that are not considered remunerative."

If all the postal service that is not "remunerative" were discontinued, much of it would be stopped. In fact there is an annual deficit upon the whole postal service paid by the tax-payers. The rural delivery service in North Carolina is new. The people do not live close together and all the routes cannot be "remunerative" for some years. And yet the people are entitled to the service. North Carolina pays tax to the Federal government and about all the returns that it gets from it is the postal service. For the department to insist upon such rules as will deny service in sparsely settled sections is to refuse to give to this State its fair share of rural delivery routes. All along there has been a hard fight to get routes in this State. Mr. Machen insisted that good roads must precede the establishment of rural delivery routes. If the government furnished the horse and buggy, it would have had some right to refuse to establish a route in a section where the roads were bad, but inasmuch as the carrier furnishes his conveyance, what business of the government is it whether the roads are good or bad? Some of the counties are building good roads and the establishment of the free rural delivery increases the disposition to be taxed for better roads. To deny routes, therefore, until good roads are built is putting the cart before the horse.—Raleigh News and Observer.

GODWIN GOT THE PLUMB.

Large Convention in Sixth District.

The Democratic convention of the sixth congressional district at Fayetteville, after an all day and all night, and part of another day, and taking ballots to the number of nearly five hundred, finally ended its labors this morning when H. L. Godwin received the nomination. There were four candidates in the field—J. A. Brown, H. L. Godwin, H. L. Cook and G. B. Patterson. It was a hard fought contest, every man practically holding his strength for ballot after ballot. Finally there was a landslide to Godwin and the thing was done.

AGAINST VACATIONS.

Russell Sage's declaration, made in 1904, that employes have no legitimate right to vacations, brought down upon his head one of the greatest storms of criticism to which he ever had been subjected. Ministers, professional men, even employes, spoke and wrote against his theory, and for a time the chief open discussions in newspapers throughout the English-speaking world were devoted to the subject.

"What right has a clerk to demand or expect pay for two weeks' time for which he renders an equivalent, not considering the serious inconvenience to which he often puts his employer?" the financier asked. The answers came in millions.

Among the things Sage said about vacations were these.

"I think the vacation habit is the outgrowth of abnormal or distorted business methods. I fail to see any thing legitimate in it. If a man will only take an interest in his work, love it, he will not need anything else to recuperate him, and men who learn to love their work invariably succeed. A man should work easy, be economical of his time, conserve his forces and not worry. It's worry, and not work, that makes the hair gray.

Suppose we were to reverse the conventional order of things and instead of the clerk demanding two weeks pay gratis, the employer should demand two weeks' work without pay as a condition of retaining the clerk in his employ, what a tremendous howl would go up!"

In 83 years, he said he had not had a vacation—didn't need one. He rested, however, on his 89th birthday.

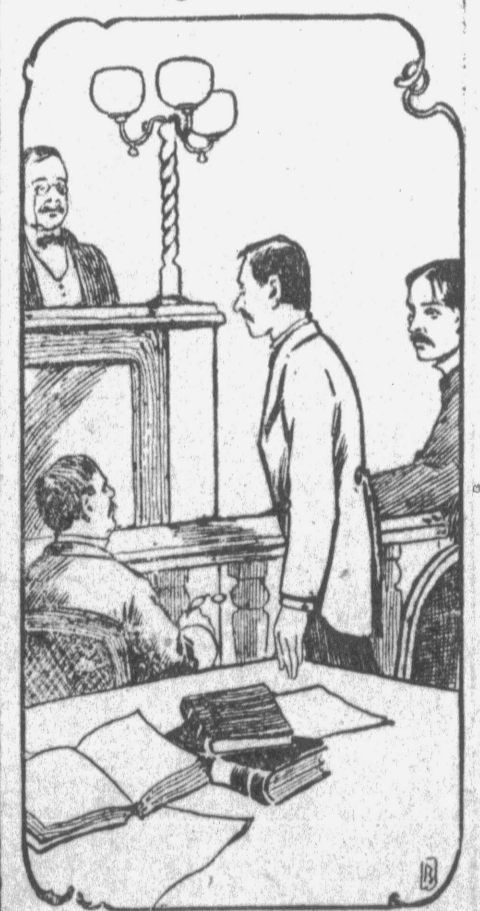
CONDENSED STORIES.

evidently he felt that the more challenging he and his lawyer did the better his case would go for him.

"Finally, though, his challenging came to an end. He announced that the jury was satisfied him.

"Your challenging is all over? We can now go on," said, with a smile, the attorney for the prosecution.

"The jury is all right," said the prisoner hurriedly and anxiously, "but I want to challenge the judge. I've been convicted under him several times before, and it's more than likely he's prejudiced against me."

SHERRY WINE.

How the Grapes Are Tramped Out and the Juice is Treated.

The vintage of sherry wine in Spain occurs between Sept. 15 and the last of October. After the grapes are cut they are left in the sun for two or three days, being covered at night to protect them from the dew. All bad and unripe grapes are separated from the bunches, after which the good grapes are thrown into large square wooden troughs, when men, bare legged and wearing heavy shoes with projecting iron nails, tramp out the grapes, and the liquid runs into an adjoining vat.

The residue of stems, pips and skins is put into another trough and, after adding water, is crushed with a wooden press. The pulp is used for feed for hogs. The liquid obtained, called "must," runs into another receptacle and is of an inferior quality. When the butts and barrels are filled they are put in the cellars, each barrel having a tin funnel inserted in the bung hole to permit circulation of air. These barrels must have a vacuum of at least four gallons to allow the wine to ferment without overflowing. After the fermenting period of about two months the clear liquid is transferred to other barrels carefully, so as not to disturb the sediment at the bottom. The barrels for the ultimate reception of the wine must be of white oak, perfectly clean and smoked with sulphur to prevent dampness. The barrels are then stored and carefully classified by experts and a name given to the wine in the different butts.

It always happens that different kinds of wine are obtained from the same grapes grown in the same vineyards and subject to the same treatment. From the same grapes come the mellow (hechos), light (finos) and bouquet (oloroso). Some of the wines are so bad that they are sold as vinegar or burned for alcohol. Alcohol of 95 degrees must be mixed with wine at the rate of twelve pints to the butt of eighty-five gallons for each degree of strength desired. To properly preserve wine it should have an alcoholic strength of at least 16 degrees, and as pure wine does not possess that it must be strengthened. There are some wines preserved in their natural state, but they are very few.

An Opinion of Justice Marshall.

Once as John Marshall, chief justice, was traveling toward Raleigh, N. C., in a stick gig his horse went off the road and ran over a sapling, so tilting the vehicle that it could move neither to the right nor to the left. As the judge sat thinking up a way out of the dilemma an old negro came along.

The jurist thanked him for the suggestion, backed the horse and, promising to leave a dollar at the inn for the good advice, went on his way. The negro called at the inn and found the dollar awaiting him. He took it, looked at it and said:

The people living along the rural routes should not relax their efforts to increase the business of their routes if they want them to continue in operation.

ONE OF PITT'S COMMISSIONERS SHOULD RESIDE AT THE COUNTY SEAT.

The recent heavy rains have so washed the dams, bridges and highways in many places as to totally stop all passage and traffic over them, and under existing conditions it is practically impossible to have these placed in repair until the commissioners have their regular meeting the first Monday in August and their attention called to it and their official order obtained before the work can be done.

In the meantime the public is compelled to go many miles out of the way and otherwise hindered and delayed. This speaks louder than any other argument in favor of having at least one commissioner at the county seat who should be authorized by the board to dispose of all such emergency cases. On at least three of the principal roads into Greenville the road work and dams recently built by the convict force has been so seriously damaged by the floods as to make passage impossible, and as this is the county work if it is repaired at all it will have to be done by order of the commissioners. As there is no commissioner living in Greenville, and no one seems to know who to apply to, this condition will continue until the first Monday.

Anticipating that some may conclude from our remarks that other sections are entitled to the same consideration as Greenville, we answer that if the wheel of fortune continues to turn it really seems that Greenville's time is now past due, as it has been quite a little while since she had any representation on the board. Besides, Greenville being the county seat and in touch with every section of the county, communication could be had from any part of the county very quickly and public business of any kind could be more easily facilitated. In the interest of all the people of the whole county we make the above suggestion. No one section of the county should be discriminated for or against in any matters pertaining to the public good.
