GOVERNOR GLENN FOILED ATTEMPT

Of New York Plotters to Get Hawley Pardoned.

HELD UP ON BOWERY.

Atlantic City, July 25.—Governor Robert B. Glenn, of North Carolina, discussed guardedly tonight the report of his having been held up by a gang of Tammany men in New York city and threatened with injury if he refused to sign a pardon for a Bowery swindler, who was serving a sentence in the North Carolina penitentiary.

The fact that a governor had been subjected to such an outrage has been suppressed carefully for a year for fear of creating undesired political prejudices.

The hold-up episode, as related by those close to the governor, occurred while he was the guest of Tammany Hall as one of the orators at the Fourth of July celebration last summer. Governor Glenn and Lieutenant-Governor Sanders, of Louisiana, another guest, at the conclusion of the ceremonies were invited to join a party going to Coney Island.

There was a deliberate effort, according to the governor, to get him drunk, several of the party being intoxicated. The governor, however, had been discreet and was unaffected. They stopped at Henderson's restaurant and wine was ordered.

Scarcely had they seated themselves when one of the men—a district leader it is said—drew from his pocket a legally drafted pardon in favor of a gold-brick artist named Halsey or Halstead, then doing time at Raleigh, North Carolina, but whose headquarters were between the Battery and Fourteenth street.

Attempt Made to Get Pardon.

Thinking the governor was sufficiently jovial to sign anything by that time, the leader remarked:

"Just a favor, governor. We would like you to sign this and let that man come back to New York."

Governor Glenn told the leader that a petition had been presented to him just before he left home for that man's pardon; that he had looked into the case, and had decided in the negative. He was sorry, but he could not reverse himself then, even to oblige his hosts. The man is reported to have become ugly, and shouted that the Governor would not get out alive if the pardon was not signed. Some allege that a revolver was brandished.

The governor rose from the table and said:

"If I have any friends in this crowd I wish they would come on this side of the table, for there's likely to be something doing here pretty soon."

"I'll stand by you' Governor," responded Lieutenant Governor Sanders. The remainder of the party assumed an attitude of helpless intoxication.

"Now, gentlemen, do your worst," is the reported challenge by Governor Glenn. "I'll see you in hell before I'll sign that pardon."

The gold-brick swindler died in prison a few weeks ago, and his wife applied to the governor for permission to take the body from the State for interment. In recounting her efforts to obtain freedom for her husband she confessed she had arranged to have the governor invited to New York and so overwhelmed with kindness that he could not deny her a pardon.

"The truth of the matter was this," said the governor last night. "After making an address at the Tammany meeting. I went out with a party of men to see the town. They were not Tammany men, so far as I know, but they did try to get me drunk."

"Afterward I learned that these men had been engaged by the wife of the man in our penitentiary to get me drunk so that I could be lured to sign a pardon."

"Instead of begging or requesting me to sign a pardon, they made an immediate demand, and they were downright insolent about it, too."

"Well, suh, I just picked up my hat, turned on my heel and walked out. I cannot tell you who they were."—New York American.

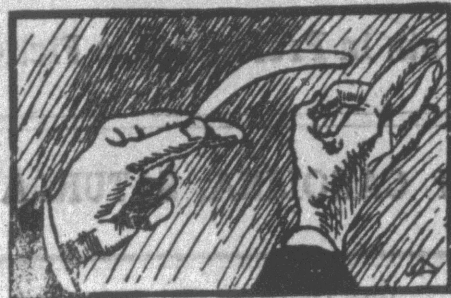

White Eggs and Nests.

Dr. Alfred Russel Wallace once endeavored to show that the birds which lay white eggs deposit them in holes in order to conceal them, and he invented explanations for certain exceptions to this rule. But it is now believed that the interpretation is quite otherwise—that certain birds lay white eggs because they nest in holes and not that they nest in holes because they lay white eggs. Colored eggs would become practically invisible in these dark places and would be in jeopardy of being overrun by the bird when entering the nest and broken or would, when the space was large enough, be in danger of rolling away from the sitting bird and so fail to obtain incubation. By their whiteness such faint rays of light as gain admittance to the nest are reflected by the white shell, and consequently no eggs escape the attention of the sitting bird.

"Of all the matrimonial trafficking in the age of chivalry the ways of widows," says a writer in an English magazine, "are at once the boldest and most comprehensive. As a rule their methods seldom resort to blandishments. It is remarkable when tenderness is an item in their bargain. Speed was their maxim. It was one that King John honored, for he profited by it. Yet one of the rarest exceptions in the way of delicacy to these commercial negotiations has evidently been prompted by a widow who had quite an exceptional lover. In 1206 William de Landa, either one of the most famous of the crusaders or his son, offers 50 marks and a palfrey for having to wife Joan, who was the wife of Thomas d'Arescy, if he may be pleasing to the said Joan." The sheriff is instructed to ascertain the widow's wishes, "and if the said Joan shall be pleased to have him for a husband then the sheriff shall cause William to have seizin of Joan and her land," both of which he obtained in the name of gentle love and the faith of a true soldier. It is fitting that the name of one of the men who led the assault of Acre should be preserved in such a record as the above. He was in truth a very perfect knight.

"One of the most rampageous of the northern English borderers manifested the like delicacy. Young Walter de Umfraville, son of Gilbert, had left a widow, Emma, presumably in the very blush of her charms. Peter de Vaux had fallen at her feet, but he declined to obtain her in border fashion, and this fact is the earnest pledge of the chivalry of his love. If he would not steal her he was bound to buy her, and coin with the De Vaux was always a scarcity. So he offered the king 5 palfreys for her 'if she wished it,' and with what would read as a graceful acknowledgment of the borderer's pure chivalry John absolutely drops the commercial from his reply and simply orders Robert Fitz Roger, the sheriff, 'to permit it to be done.'"

FORMOSA HEAD HUNTERS.

The mountainous interior of Formosa is inhabited by a race of blood-thirsty savages, whose chief delight is to sally forth on head hunting raids. Few strangers (the exceptions being some intrepid Japanese explorers) have ever penetrated far into the wild mountain country which is the home of these savages.

They appear to be akin to the Dyaks of Borneo, but no definite study of their language or habits has yet been made, though interesting details will be found in Consul Davidson's voluminous book on Formosa. For hundreds of years the tribes, eight in number, have withstood their enemies, who have never been able to penetrate to their fastnesses. It remains to be seen what success the more systematic Japanese will achieve.

It seems almost incredible that the station of a military force should not be safe from the raids of these head hunters, but it was the case a few years ago. At that time a post of the Japanese and made off with a score of heads.

Their most usual method is to stalk the Chinese of either sex when they are engaged in tea picking. The savage creeps up unobserved to his victim, transfixes him with his spear, secures his head and is lost in a moment in the neighboring jungle.—Macmillan's.

In some matters Greenville sleeps over her opportunities and awakes to a realization of it when too late. This has been experienced several times in the past, and is about to occur again in regard to a park. No town of consequence fills its proper sphere or does its duty by its citizens without having some place of public recreation. Those citizens able to afford it, or having the time to spare from business can readily go to the mountains, seashore or springs for recreation. But how about the multitude who cannot afford to do this, the large per cent. who have to stay at home and toil on year in and year out, and by the fruits of whose labor the more prosperous are enabled to get away from the turmoil for a rest spell? Greenville has neglected this until the opportunity has well nigh slipped out of reach. Even now there are only one or two suitable sites available, and a chance to get them will soon be gone. Something should be done without delay along this line.

Glass That Keeps Out Heat.

An Austrian inventor, Richard Szigmondy, is reported to have made a new kind of window glass whose chief peculiarity is that it prevents the passage of nine-tenths of the heat of the sun's rays. It is well known that ordinary window glass allows nearly all of the heat derived from the sun to pass through, but, on the other hand, intercepts all heat coming from nonluminous sources, such as a stove, or the heated ground. This is the reason why heat accumulates under the glass roof of a hothouse. If covered with Szigmondy's glass a hothouse would, it is claimed, become a cold house, since the heat could not get into it. One advantage set forth in favor of the new glass is that a house whose windows were furnished with it would remain delightfully cool in summer. But in winter perhaps the situation would not be so agreeable. — St. Louis Post-Dispatch.

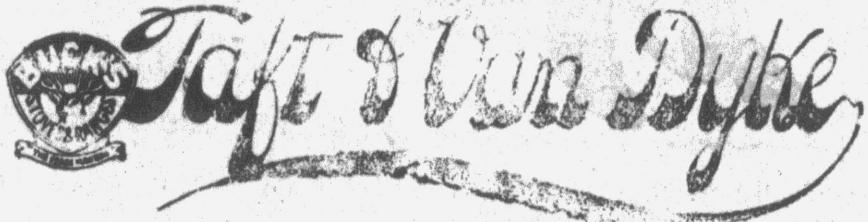

FOR THE LITTLE ONES.

Geographical Game That Requires Quick Thinking.

The players are seated in a circle or around the room, and one takes a handkerchief and, throwing it at another, calls "Europe!" A time-keeper begins counting ten rather quickly, and the person to whom the handkerchief was thrown must name some place, river, mountain, person or thing connected with some country of Europe before number ten is reached. It may be arranged that the person answering correctly puts the next question. If incorrect or unable to answer a forfeit must be paid.

The players must be wideawake for often the one who throws the handkerchief will look at one while throwing in quite a different direction.

The game may be made more difficult as well as interesting by taking special countries, and for older players a century may be given, and the famous characters belonging to it must be quickly thought out.

Phosphorescence.

Decayed wood and especially peat have occasionally been observed to evolve a faint light, and even some flowers have been remarked to give out brilliant flashes of light during a warm summer's evening. This light, emitted without apparent heat, is termed phosphorescence. Various animal substances become luminous before putrescence has begun and especially the flesh of certain fish, of which the most remarkable are carp and sole. Herring, lobsters and crabs often emit a phosphorescent light. Most familiar of all phosphorescent objects to boys and girls is, however, the phosphorescence of living animals, such as the firefly and glowworm. The hundred legged worm, found in decayed poplar wood or under lime, bricks and pots in the garden, emits flashes of light when irritated by a little water.

Boiling Without Fire.

Do you know that it is possible to boil water without fire and without the use of any chemical? All you have to do is to put the water in a pail—it may be ice water, if you choose—and stir it with a wooden paddle; if you stir long enough it will "come to a boil." But just here is the crucial point of the operation—you will have to keep on stirring for about five hours. Boys and girls therefore are not advised to make the experiment unless they are in need of some rather strenuous exercise, long drawn out. If any feel brave enough to try it, it might interest them to watch the gradual warming of the water until it gets so hot that the hand cannot be held in it and finally begins to boil.

An Amusing Experiment.

A simple kaleidoscope may be made by any boy or girl by taking a straight lamp chimney—an argand one is best—and painting the outside of it black. If you make a pinhole in a piece of paper and hold it at one end and look at it through the other it will appear as a number of circles of light. It is the cylindrical surface that reflects and causes this. If now you fasten two pieces of glass at one end of the chimney, placing between them beads and bright colored bits of glass so that they may move as you turn the chimney, you will have as good a kaleidoscope as you would care to buy.

Wireless Across the Pacific.

Mr. Marconi used a ten inch induction coil, giving a spark three-quarters of an inch long, in his early attempts to communicate across the English channel by wireless telegraphy. His masts were 150 feet high. To provide for commercial communication across the Pacific ocean between San Francisco and Honolulu, a gigantic induction coil fifteen feet long is being built, which will give a spark fifteen feet long, and as thick as a man's body. Two thousand miles of fine silk insulated copper wire are used in the coil, with more than a ton of beeswax and paper for additional insulation. Its potential will be about 50,000 volts. The masts from which the impulses will be sent out are twin towers, 1,000 feet high, on the very apex of Mount Tamalpais across the Golden Gate from San Francisco. The antennae—3,000 pounds of heavy copper wire—will thus be nearly 3,000 feet above the waves which wash the foot of the mountain.

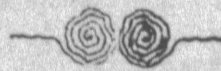
