## RAILROADS DELAY FREIGHTS.

### And Cause Much Inconvenience to Consignees.

It is a poor rule that will not work both ways. If a car load of freight arrives at the station and is not unloaded within a specified number of hours, the railroad company charges the consignee demurrage for every day the car remains unloaded. On the other hand if the railroad delays the shipment for days or even weeks in transit, the consignee must submit to it regardless of the loss or inconvenience sustained by the delay. If the law allows a transportation company to collect demurrage from a consignee, it should also give the consignee redress against the transportation company for needless delay of shipments.

We can cite a few instances that will show the carelessness of transportation companies in handling freight. Last spring The Reflector had some machinery coming from a New England point and it all left the factory in one shipment. Part of it reached Greenville two weeks before the remainder of the shipment arrived, and the delay would have been longer but for a telegraphic tracer which found the missing parts stowed away at Pinner's Point unnoticed.

Some weeks ago a Greenville gentleman was going up the State to spend some days. When the train he was on stopped at Norlina he saw a car load of machinery standing on the side track. Feeling interested in machinery he stepped out to look at it and noted that it was addressed to a firm in Charlotte. Coming back ten days later he saw the same car of machinery standing in the same place, not having been moved in all that time, and there is no telling how much longer it waited before going on to its destination.

Sometime ago Mr. R. Greene had the machinery shipped for his ice plant here and this was delayed for weeks in transit, causing him much inconvenience and loss.

On the 7th of July machinery with which the Greenville Water and Light Commission is to install day electric current, was shipped from Chicago and has not yet arrived.

These are just a few of such instances as are of common occurrence, and there seems no reasonable excuse for them. The transportation companies ought to be made liable for such needless delays.

### More Large Tomatoes

No one has yet matched those two large tomatoes, weighing 3 pounds, brought The Reflector by Mr. A. A. ## ROW AT GRIMESLAND.

### Only One Man Assisted Officer.

On Saturday night Policeman T. J. Talley tried to arrest a negro, Sherman Grimes. He resisted the officer and was joined by his father, Tom Grimes, and his two brothers and was about to escape. When the officer cried upon several white men to assist him, Dr. Jones alone responded to the call of the officer.

Dr. Jones received a severe blow from Sherman Grimes. Several of the negroes drew their knives and closed in to attack the officer and his assistant, when Mr. Talley, in defence of his life, shot Sherman Grimes in the abdomen and Tom Grimes in the hip. The negroes then attacked Mr. Talley and cut him very dangerously about the back and shoulders.

It is probable that Sherman Grimes will die. Up to the time of this writing (Monday morning) no arrests has been made. Another miserable failure of the town government preserve order.

#### To Boil Salmon.

Carefully wash the piece of fish and see that it is quite free from blood inside. Tie it in shape, if necessary, with tape; place it in enough boiling water to just cover it. To each quart of water add one tablespoonful of salt. Bring the fish quickly to the boil, skim it and draw it away to a cooler part of the stove to simmer till done.

To see if it is done pass a skewer close down by the bone right into the fish. If it passes in perfectly easily it is cooked enough. Usually about eight to ten minutes is allowed for each pound of fish to be boiled.

#### Terms Used In Cookery.

To break flour is to mix in gradually a small quantity of cold liquid, stirring it until it is smooth.

To bind a mixture is to add milk or eggs to make it hold together.

To burst rice is to put it on in cold water and bring it to a boil. This bursts the grains of starch.

To parboil is to boil anything until half cooked.

To scald milk is to bring it almost, but not quite, to a boil.

To shred suet is to cut it with a sharp knife so thinly as to be almost scraping. The suet should be so thin as to curl up.

#### Choosing a Cantaloupe.

The first point to be considered in buying cantaloupes is weight. A heavy melon is always a good melon if sufficiently ripe, and the best test of ripeness is the odor. A ripe cantaloupe is always fragrant and spicy. The furrows of muskmelons are worth noting. If the surface is rough and the furrows deep the melon is sound and sweet. If the color is too green it is apt to be underripe, and if yellow it is mushy. A very smooth surface indicates that the melon is overripe.

#### Warm Weather Tonic.

For the everlasting tired feeling that is bound to come during hot weather when the appetite apparently goes on its summer vacation and the system needs building up there is nothing more nourishing or beneficial than olive oil and grape juice. The proportions are one dessert spoonful of olive oil to four of grape juice, taken after each meal. If it is agreeable the amount may be increased to a tablespoonful of oil to four of grape juice.

#### Dough For Rib Roast.

When your rib roast is nearly done make a nice dough of one cup of sour milk, a scant teaspoonful of soda, one teaspoonful of salt, shortening the size of an egg and sufficient flour to thicken well. Roll about one-half inch thick, cut several inch gashes in the same, place over your roast and bake twenty minutes without uncovering.

#### Mint Vinegar.

Put crushed mint leaves in a wide mouthed bottle, then fill up with good cider vinegar. In three weeks pour off clear into another bottle. This is fine for flavoring purposes when fresh mint cannot be had and almost a sure cure for headache when bound upon the forehead.

#### Care of Pianos.

A small bag of unslacked lime placed inside the piano will prevent the springs from rusting. This is particularly good for a piano that is in a house which is closed for the summer.

GREENVILLE A FINISHED TOWN.

But She Would Not Stay Finished.

Greenville is an old town. Many, many years it has nestled here on the banks of Tar river, much longer than the memory of oldest person now living runneth back to. Generation after generation has come upon the scene of action, filled its allotted space in the niche of time and passed on. One characteristic of these succeeding generations is that they seem to regard Greenville as a finished town. In other words they lived, apparently, in their immediate present, regarding the town as large enough for them and their surroundings, and giving little or no thought as to the needs of the generations to come after them.

In spite of this idea Greenville has gradually gone on lengthening her cords, extending her borders and increasing her population, and if some who passed away no longer than half a century ago could return and behold what is here their astonishment would exceed that of Rip Van Winkle when he awoke from his long sleep and gazed on the transformations before him. In their day they thought the town was finished and would never be any larger.

In the years immediately preceding and following the civil war Greenville's corporate area comprised about twenty five blocks. That is there were five streets parallel with the river crossed by five other streets running north and south. Even in this area there was considered to be such an abundance of room that houses were far between and business was scattered. There was a store on Pitt street at the top of the hill approaching the river bridge, another about the corner of Washington and Fourth streets, one on the corner of Greene and Second streets, a store and coach shops at the corner of Pitt and Third streets, one or two stores about the corner of Cotanch and Fifth, a few stores here and there on Evans street and the old hotel on Cotanch street in later years known as the Macon. These were thought to be enough for all time and to the people of those good old days the town was finished.

So well satisfied were the people of that day and time with the abundance of room and the size of the town, that one of the prettiest sections, all between Front

street and the river, was abandoned to negroes. In most towns today lying on a river the river front is looked upon as a most desirable location, both for residence and business, but not so in Greenville. What is more beautiful than a residence on an elevation commanding a view of the river? Yet that idea has never taken hold of Greenville and no effort has been made to redeem from its unsightly environments what could be made the most attractive portion of this town.

There was some change in other directions, however, as the years rolled by and another generation came on. The idea was conceived of having the business of the town more concentrated, and this was followed by the building up of that portion of Evans street between Third and Fifth streets with business houses. Some held up their hands in horror at the suggestion of removing the bones of ancestors buried in the old graveyard in the heart of this sector, but the idea of advancement prevailed and that location was transformed into a block of business buildings.

In the course of time as more people came to the town there was a looking around to extend the corporate limits and have other residential sections. Some lots were sold in Skinnerville and a few houses were built out there, but some of the folks with the finished town idea shook their heads at the thought of the town ever getting out there. They lived to see it differently. Then what was known as the Clark field got on the market. But the finished town bobbed up again and a large section of this property on Pitt street and back into what is now called "Little Washington" went to colored people and another good location for residences in later years was lost.

Then Forbestown started in and some residences began going up over there, to be met with that same finished town prophecy again that the town would never get far in that direction. But it went just the same until South Greenville became a big part of the town. Yet while this was building another section west of Pitt street, by getting filled up with cabins and shanties was lost to future desirable residential purposes. If that and the Clark property had been held with this view it would have brought good prices for nice residences.

In the meantime at intervals after the war there would come up talk of a railroad for Greenville. There were always advocates of a railroad, while on the other hand there were opponents, the latter bringing up that same overworked finished idea that the town was big enough and "didn't need a railroad no how." But along in the latter 80's the railroad came and the town kept right on growing.

And when the movement started to have a tobacco market in

Greenville, even that met with opposition. The finished town adherents wanted the farmers surrounding us to plant only cotton as a money crop, declaring it would ruin the town and the county both if the farmers went to raising tobacco. Despite the croakings of this class the tobacco market came right along, and as a business builder it is worth more to Greenville in one year than the cotton crop ever was in five years.

And so things went on, the finished town folks always butting in with their ideas only to see them butted out by the spirit of progress. Then here comes some who declare that even yet Greenville was too far behind the times and must have water works, electric lights and graded schools. This was preposterous to the finished town mind. Going to tax us to death with bonds. Don't need any public improvements. Our fathers traveled the streets by the light of smoky kerosene lamps and they are good enough for us. Our children are entitled to no better educational advantages than we had. If a house gets on fire bring water from the river in buckets, and if you can't put it out let it burn up. Away with your bonds and improvements. But they did not down at their bidding and the bonds and improvements are both here.

Once more. Along with physical improvements some thought must be given to the morals and safety of both the present and coming generations, and the movement started to rid the town of the numerous breeders of intemperance, poverty and crime—the open saloons. That was the finishing blow to kill the town dead for sure never to be brought to life again. But the bar rooms have gone, and though Greenville is yet sleepy in many ways she is anything else but a dead or finished town.

The story might be carried further, but this is enough to illustrate the point. Is it a dream or the imaginations of fancy? Not at all. It is a true picture of conditions as they have existed. Every step that has been taken for the improvement and betterment of the town has met its opponents. It has been so through all the past generations and will be so to the end. In spite of this Greenville goes forward, not spasmodically, yet gradually and steadily, and some of these days will be aroused to the reality of her possibilities. Other things are needed and will come along in their course. The finished town croakers had as well make up their minds to keep out of the way and cease their efforts to block the wheels of progress.

Yet the courageous and devoted horse, so steadfast against the dangers he knows, is a prey to a hundred terrors of the imagination due to illusions, mainly those of sight, for shying, the minor effect of these illusions, and "bolting," in which panic gains complete possession of his soul, are caused, as a rule, by mistakes as to what the horse sees and not by misinterpretation of what he hears. It is noticed, for instance, that many horses which shy usually start away from objects on one side more frequently than from objects on the other. This is probably due to defects in the vision of one or other eye.

In nearly all cases of shying the horse takes fright at some unfamiliar object, though this is commonly quite harmless, such as a wheelbarrow upside down, a freshly felled log or a piece of paper rolling before the wind. This instantly becomes an illusion, is interpreted as something else, and it is a curious question in equine neuropathy to know what it is that the horse figures these harmless objects to be. When Russian ponies first began to be shipped to England they usually objected to pass near a donkey. This reluctance was explained on the hypothesis that the ponies seldom saw donkeys in Russia and mistook them for bears.—London Spec-

tator.

Tundra is a native word signifying the vast expanse of swamp and marshland, interspersed with numberless stagnant lakes, which extends for thousands of miles across the arctic zone in Siberia. From May to October the settlements are completely isolated by this vast ocean of swamp. The tundra section of the proposed railway line Harry de Windt, the explorer, estimates would cost about \$100,000,000, for every wooden cross tie would have to be imported into this treeless country.

**His First Great Caricature.**

Caran d'Ache, the famous French caricaturist, gives this account of his first caricature. One day while serving in the army as a young man he called on M. Detaille, the famous military painter. "Detaille," he says, "received me kindly and advised me to go on. 'But before I give you a definite decision go back to barracks and draw me something fresh,' said he, 'and bring it to me next week, and I will give you an opinion.'" Caran d'Ache went back to barracks and attempted to draw the regimental scullion. Impossible! "As long as the idiot stood there looking at me with his mouth wide open I could make nothing of him, so, with absolute injustice, I gave him two days' 'cells' for being such a fool and gave it up. Next day on a piece of writing paper I drew my scullion from memory!" And so Caran d'Ache's first great caricature was made.
