MEETING OF COTTON ASSOCIATION

Raleigh, N. C. Aug. 20, 1903.

Township meetings for cotton farmers are called to meet at their respective meeting places in each cotton growing township in the State at 3 o'clock p. m. Saturday the 25th inst. These meetings are for the purpose of obtaining accurate information as to crop conditions, quantity of cotton now being held in the townships and any other information that will be of benefit to the Southern Cotton Association. Also to select delegates to attend the county meetings to be held at the court house Saturday Sept. 1 at 12 o'clock, or the usual hour, for meeting.

President C. C. Moore expects to attend the meeting of the presidents of the several divisions of the S. C. A. at Hot Springs, early in September and wants accurate information as to the crops &c for that occasion, therefore please mail all reports so as to reach the undersigned not later than Sept. 3. These reports to be of value must be accurate, giving exact conditions. A report that is not accurate is worse than no report, for it is misleading. We want to know the exact condition.

Every person who is interested in the welfare of the Southern Cotton Association, or who is interested in the continued success of the Southern cotton farmers and the prosperity of the South is invited to attend these meetings and use his influence to make them the most successful yet held.

Unless the cotton farmers get together and make a firm stand we may look for lower prices for cotton. One cent per pound off from the price means a loss to the farmers and to the South aggregating \$60,000,000.00. A decline of two cents per pound means a loss of \$120,000,000.00. Are our farmers prepared to accept this loss willingly? Do our merchants think the South would be better off by taking from her such sums of money? Do our manufacturers think they would do more business with this amount of money withdrawn from circulation? If these people do not think the farmers have too much money and that lower prices for cotton will mean the enrichment and betterment of the South then let them encourage the movement to get the farmers together for better prices. Only those who think we are already too wealthy or who are willing to sell their cotton for 8 or 9 cents per pound should refuse to attend these meetings.

At these meetings membership fees, the bale levy and other things of importance to the association should be attended to. The association is in need of funds to carry on the work which is so important at this time. Remember the dates of the meetings.

Done at our City of Raleigh the 16th day of July, in the year of our Lord one thousand nine hundred and six and in the one hundred and thirty-first year of our American Independence.

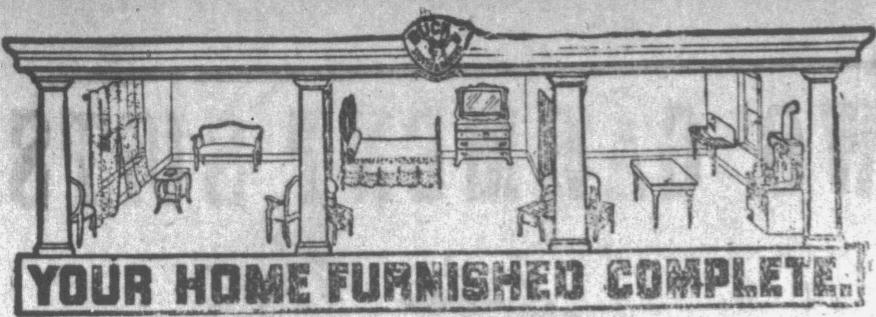

ISSUE BONDS FOR ROADS.

Just now this county's greatest need is good roads; and they will never get much better under the present system of working them. When the people realize the fact that the interest on a bond issue sufficient to build a system of good roads will not take as much money out of their pockets annually as they are now paying in taxes for poor roads, they will favor the issuing of such bonds. With bonds the entire county could have good roads in a short while, but unless such a step is taken the people will continue to bear the loss and tax bad roads impose upon them. Nothing would develop the county more and increase its wealth faster than good roads.

WHERE THE FAULT IS IF THERE IS FAULT.

It is just as well for people who say that lynch law is the result of the failure of the courts to convict and punish offenders, to pause, examine the ground they stand upon and analyze the meaning of their words. It will be conceded by everybody that the judiciary of North Carolina is corruptible; that almost without exception our judges will rule fairly upon evidence and charge juries fairly, according to the law and evidence. It is the duty of defendants' lawyers to fight for them, even to the grave; this is allowed them by the law and the public; it is expected of them, and nothing less is expected. Where, then, does the responsibility for the miscarriage of justice lodge? Obviously with the juries. The people. Thus we have the argument, followed to its conclusion, that the people turn felons loose and then get mad about it and lynch other felons for fear they will turn them loose, too. It is a grave imputation upon the citizenship of a State to say that its juries cannot be trusted to convict criminals and they must be punished, if at all, by the mob.

In the news columns of yesterday's paper a man whose name is not given is quoted as saying that if he had \$25, he would not be afraid to kill any man in this country"—name of county not mentioned. The speaker perhaps did not weigh his words. If he did he meant that the people, the jurors, of his county are purchasable—not a very choice population to live amongst.

Argue the miscarriage of justice in the court house, up one side and down the other, and it all comes back to this, that whatever the courts are they are as good as the people. The people constitute them and the voice that speaks through them, for justice or justice as the case may be, is their voice. "Like master, like man;" like people, like juries. The gentlemen quoted could not claim that the body of the population of his county love truth and honor and justice while admitting that justice is for sale in his court house for a fountain cannot send forth both sweet and bitter waters.—Charlotte Observer.

THEY SET BAD EXAMPLE.

The Nashville American wonders why "business men will permit gambling concerns to openly operate at their doors, inducing and enticing young men and old men to risk their money with them in the hope of getting rich quickly." One reason is that not a few "business men" are taking a turn at the wheel themselves and they not wish to have the concerns too far away. Most young men who are thus led astray follow the example of the gamblers who are "up in G" in the commercial world. If they would stop this future gambling, their employes wouldn't be tempted by their example.—Raleigh News and Observer.

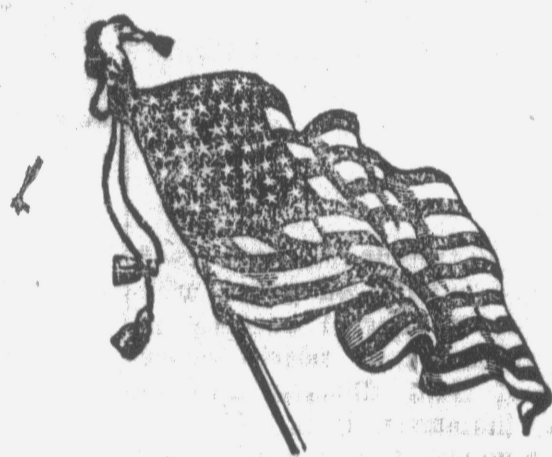

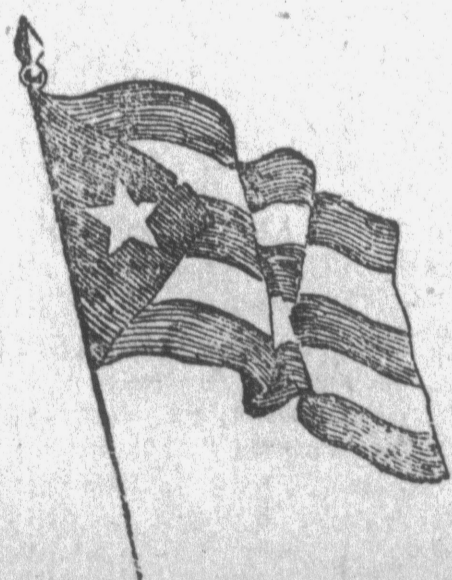
