HOMICIDE AT HIGH POINT.

George Meeks Slays Pleas Oaks and is Held Under a \$2,500 Bond.

High Point, Sept. 12.—At an inquest here this afternoon over the body of Pleas Oaks, who was killed this morning by George Meeks, there was sufficient evidence to bind the slayer over to court in the sum of \$2,500, which he was unable to give.

The homicide was committed early this morning in the southern part of the city. Meeks came up over and gave himself up and is now in jail.

The story of the crime, as learned from witnesses, is as follows: Pleas Oaks came to the house of Meeks drunk and engaged in an altercation with him. Oaks attempted to jerk Meeks off his porch when he was ordered off by the latter. Oaks struck at Meeks with a black-jack, which he had up his sleeve and fastened to his wrist. This is now on the dead man's person. He shoved Meeks inside his (Meeks) own door. Once inside Meeks reached for his pistol on the mantel and after ordering Oaks off the premises three times, shot him dead as Oaks was trying to brain him with a black-jack. Meeks' wife and Mr. Mike Morris were eye witnesses.

It is also learned that Oaks was trying to be intimate with Meeks' wife, this being the real cause of Oaks' presence there which led to the difficulty. —Charlotte Observer.

This is Sent Out From Raleigh.

From time to time the State papers have had something to say about that class of lawyers known variously as shysters and buzzards, who as soon as a person is killed or dangerously injured by a railway, rush to the house and get the case, oftentimes taking chances, charging no fee but agreeing to take half of the damages which may be received. Old lawyers, reputable men, are often heard to express surprise that these things go on and yet are loath to take the proceeding necessary to disbar people who do these things, but at last there is to be a test case, brought before the Supreme Court and pushed by an eminent lawyer, which will jar not a few of the shysters in North Carolina. The case is now being prepared and a lawyer who is behind it says something will drop and fall very hard.

Something may be done about this class of lawyers, but we doubt it, and it might be said in passing that if all the lawyers who solicit damage suit cases and bring them on contingent fees were disbarred there would be an astonishing decrease in the legal fraternity in North Carolina. The class is much larger than the general public suspects. —Statesville Leader.

SCHOOLS OPEN.

Fine Prospects of Good Work.

County Superintendent W. H. Ragsdale tells us that the schools of the county are beginning to open and so far prospects are most encouraging for a year of splendid work along educational lines.

The Quinerly school near Centerville opened Monday in its new building with a considerably larger enrollment than was reached during the whole of last session. There is also one more teacher for this session than last. Miss Bettie Wright, of Coharie, is principal and has charge of the higher grades; Miss Pair, of K-ny, has charge the intermediate grade, and Miss Ada Morris, of Virginia, the primary grade and music. The patrons and teachers are delighted with the prospects of the school.

The graded school at Bethel also opened Monday with a large attendance of pupils and full corps of teachers. Prof. McCall, of Lexington, is superintendent, and teaches the 9th and 10th grades. Miss Lucy Manning, of Bethel, has the 7th and 8th grades. Miss Bertha Waldrop, of Hendersonville, the 5th and 6th grades; Miss Blanche Mayo, of Bethel, the 3rd and 4th grades; Miss Elizabeth Jones, of Bethel, the 1st and 2nd grades; Miss Willis, music department.

WALKS UNDER WATER.

Wearing Odd Device, Judge Lawton, of Geneseo, Takes Fifteen Minutes Stroll on Lake Bottom.

Geneseo, N. Y., Sept. 10.—At the annual Livingston county picnic at Long Point, Conesus Lake, fully 20,000 persons witnessed Judge Reuben P. Lawton, of Geneseo, walk under water with a new contrivance with which he has recently experimented.

Although the demonstration was a success, the inventor still refuses to allow anyone to inspect the device, saying he has not yet perfected it.

After the judge adjusted the device, which covered only the face and left the top and back of the head exposed, he waded into deep water until completely submerged. A flag that he carried at the end of a pole gradually came closer and closer to the water and then moved along on a line parallel with the shore. After fifteen minutes the judge emerged from the water and took the device off of his face.

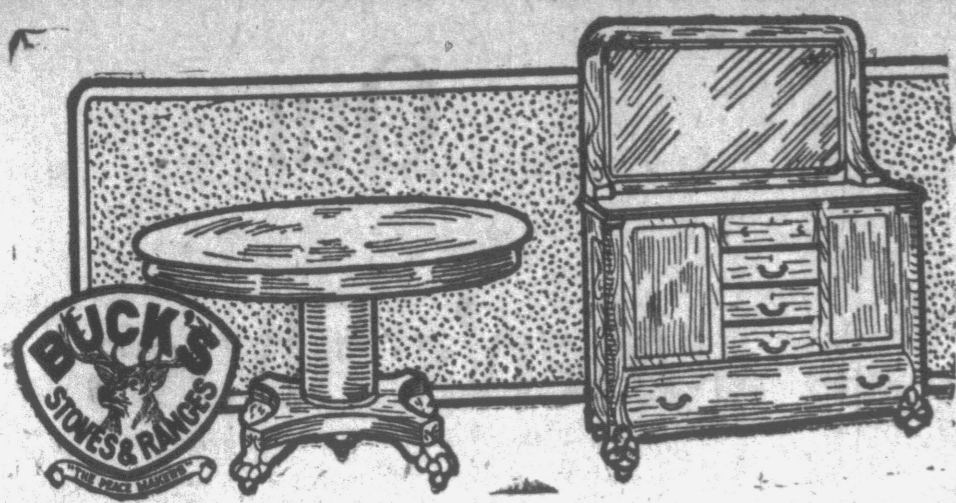

INSANITY AND PROSPERITY.
In view of the oft repeated discussions on the questions whether insanity is more prevalent than formerly, and if so what are the causes for that condition, the statement made by Dr. Charles G. Hill, physician in charge at Mount Hope retreat, in the sixty-third annual report of that institution, is interesting. Dr. Hill in speaking of the reasons for any possible increase gives, among other things, "the prosperity of the period." He says: "If there is a marked increase of insanity at the present time I believe that by a thorough research, consisting not only of a survey of the mental symptoms, but an investigation with microscope and chemical reagent of the tissues, fluids and secretions of the body, it could be traced in a great part to the prosperity of the period—the luxurious indulgence, the dissipation, the departure from the old standard of rectitude and the moral deterioration made possible in all conditions of society to a greater or lesser degree."—Baltimore American.

The Lazy Worm.

A large district in the middle of Porto Rico with a population of 100,000 is afflicted with "the lazy worm," and official efforts are being made to improve the inhabitants' condition. A hospital has been established at Albionito, with an endowment of \$15,000, and will do what it can to check the ravages of this minute reptile, of the existence of which the old time native Porto Rican never had the slightest notion. Last year an American medical officer, Captain Ashford, treated 4,500 cases, and nearly all of them were cured. As a result the population are aroused to much enthusiasm, and the afflicted are applying in great numbers for treatment. Heretofore the malady has been deemed incurable.

STRAY TAKEN UP.

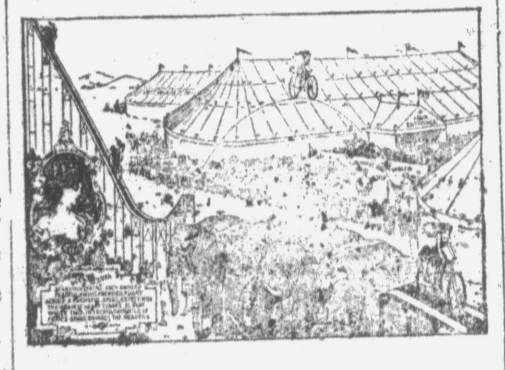
