## SUPERIOR COURT.

### September Term in Session.

The following cases have been disposed of since last report:

Gat Morris, assault with deadly weapon, guilty, sentenced three months in jail to be assigned to roads.

Joe Applewhite, carrying concealed weapon, pleads guilty, fined \$20 and costs.

Alfred Crandall, assault with deadly weapon, guilty, judgment suspended upon payment of costs.

Simon Hooks, assault with deadly weapon, not guilty. In another case against same defendant he was found guilty and sentenced to 60 days in jail to be assigned to roads.

Joe Hobgood and Walter Griffin, assault, guilty, Hobgood fined \$20 and half the costs, Griffin to pay half the costs.

Frank Hyman, assault with deadly weapon not guilty.

Frank Davis, escape from prison, pleads guilty, judgment suspended during good behavior.

Frank Davis, larceny, guilty, sentenced 3 years in jail to be assigned to roads.

W. G. Hyman and Eddie Barnhill, affray, having plead guilty Hyman was fined \$20 and costs and Barnhill \$25 and costs.

Ed Wortington for malicious burning was sentenced 4 months in jail to be assigned to roads, and in a case of burglary against same defendant judgment was suspended during good behavior.

James Bell for house burning was sentenced to the penitentiary for 10 years, and in two cases for larceny judgment was suspended during good behavior.

John Lewis Williams for assault with deadly weapon, was sentenced to 4 months in jail to be assigned to roads.

William Ward for assault was sentenced to jail for 3 months to be assigned to roads.

## Suffer Second Fire Loss in Three Months

Enfield, N. C., Sept. 21st—For the second time in the past three months the property of Mr. J. B. Dunn, has been ravaged by fire. On the morning of July 4th his residence on Dennis street was completely destroyed, entailing a loss to him of something like two thousand dollars. Again on Friday morning his saw mill about four miles from Enfield was burned. His loss in this instance is estimated at about five hundred dollars. Mr. Dunn says that the fire was probably occasioned by the door of the furnace being left open and the wind which arose during the night blowing the sparks to the shavings around the mill, thus spreading the flames to the mill sheds. The fire occurred about 3 o'clock in the morning.

### Friendship That Counts.

### Bargain Days.

A plan for drawing trade to a town that has been successfully worked at several points might be adopted to advantage in our town. The plan is as follows: An agreement was reached between all the merchants whereby they offered special sale certain days, each merchant selecting some special line of goods upon which he made a lower price than usual. Thus one dry goods merchant would sell gloves at a special price, while another would offer bargains in dress goods. One hardware merchant would reduce the price on plows. Every line of business which was presented and care was taken that no conflicts occurred. Prizes were then offered to the farmer bringing in the best load of grain of the hardiest baby and the bargain day was extensively advertised in the surrounding country, the names of the merchants and their special sales being in all cases stated. The farmers responded in a most gratifying manner and the merchants were well pleased with the plan. The idea has already been carried out in several cities.

An ancient custom is yet maintained in Russia at the Christmas season, in which the festivities of the day are made to play a permanent part in the lives of those who are chief in the frolicking.

Some person of importance in the district announces that the annual fête will be held at his house. Thither, at the appointed time, hasten the young men of the countryside; thither come, no less eagerly, but with decorous tardiness, the maidens of the place. There are dances and songs, games and feasting, but all else is but the prelude to the great event, when chance is made the handmaid of love. At the arrival of the proper hour the hostess gives a signal and withdraws into an apartment, accompanied by all the girls. The lasses are ranged upon long benches, where they pose, a tittering phalanx of freshness and beauty, with naught in their smiling affability to suggest that a scratch on blooming cheek might reveal the tartar.

The hostess is supplied with long strips of broad cloth, and with this she straightway muffles each and every maiden. She twists it deftly over and about the head until hair and features are hopelessly veiled; she winds it about the neck, the shoulders, the waist and on until the sprightly and lissom figure of the girl is merged in the rude outlines of a papoose.

This is the preparation. The action follows, when one by one, in an order determined by lot, the young men of the party enter the room. Each in turn approaches the veiled row of loveliness and examines it. Eyes and ears are useless; touch is everything. The puzzled suitor seeks to penetrate the baffling folds and locate the personality of his idol. When at last he has made his choice he is privileged to remove the swaddling clothes and behold the identity of his prize. Then is the consummation—the moment of rapture or despair when soul answers soul in the love light of the eyes or when disappointment speaks in the stifled sigh or shows in the averted eye.

It is the law of custom that this twin should become man and wife. If the custom is broken a heavy forfeit must be paid by the unwilling person. But it is rarely that happiness falls in the result. Chance, it is well known, is open to a bribe. And the lovers who would fail to offer her bribes would hardly deserve happiness. 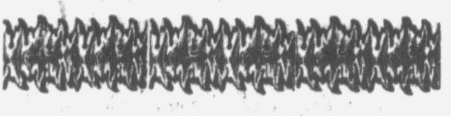

**Scarcity of Hickory Wood.**

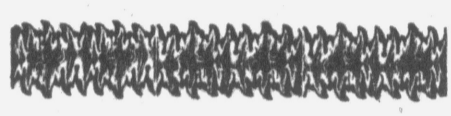

## THE LAW OF ENTAIL.

Some of the Evils of Perpetuating Great Estates.

One of the chief sources of dissatisfaction with Great Britain among our Revolutionary forbears was the law of entail which prevented the distribution of estates, created a wealthy and privileged class and deprived every other class of hope and ambition. Even Lord Bacon said that money was like a compost heap, which grew more and more offensive until it was distributed, but then produced everywhere fertility and beauty.

Entails are not prohibited in the constitution of the United States, but they are abolished in Illinois and in almost every other state either by constitutional provisions or by statute. It is the sense of the American people that they are contrary to public policy and inimical to freedom.

It is important that there should be laws against entails, for otherwise we should certainly have them in this country. The instinct which originated them in England centuries ago is firmly fixed in human nature and is as powerful among men of large estates today as it ever was. Whenever one of them dies and his will is published we discover that the strongest desire he had in death was to preserve his fortune intact and pass it on unimpaired to his descendants. He bequeaths the bulk of it to as few people as possible and even then puts it in the hands of trustees, so that it may continue under one management and retain its unity as long as possible. If the law permitted it, he would bequeath it all, just as his ancestors did in England or some other European country.

The evil of keeping a large fortune intact is just as great when it is involuntary, and the evil all grows out of the fact that the man who inherits a fortune is an entirely different character from the man who makes it and that the fortune itself in the hands of its founder plays an entirely different part in civilization from what it does in the hands of his progeny.—Chicago Chronicle.

### Unexpected Honesty.

"The other day," said the clubman, "I came across a case of pure honesty and downright conscientiousness. One of the members of our club gave the janitor, a colored youth of about seventeen, a quarter for some personal service and said, 'Take this and go to the theater.' Next morning, to his great surprise, the boy returned the money to him, saying he had not been able to use it. Pressed for an explanation, the boy said he had asked his mother about it, and she advised him not to go to the theater, and as he had not used the money for the purpose it was given he felt that it did not belong to him. I do not know what followed, but I am sure the boy will lose nothing by his conduct."—Washington Star.

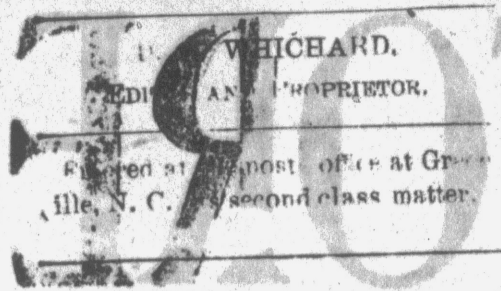

That was a terrible disaster at Hong Kong, China, in which 5,000 lives were lost and \$20,000,000 of property destroyed.

Bank burglars are somewhat bold in Michigan. A gang of eight, heavily armed and masked went to a small town in broad daylight where they attacked and robbed a bank of about four thousand dollars.

The Greensboro correspondent of the Charlotte Observer suggests that State Superintendent J. Y. Joyner is mentioned as the probable successor of the late Dr. C. D. McIver as president of the Normal and Industrial College. Before being chosen to his present position Prof. Joyner was connected with the Normal and Industrial College and was a co-worker with Dr. McIver. He is thoroughly familiar with the work of the institution and perhaps no man in the State is so well qualified for this position. Should Prof. Joyner be chosen as president of the college it will leave a vacancy as State superintendent, and in that event there is not a better man in the State to succeed him in the latter office than County Superintendent W. H. Ragsdale, of Pitt.

WE ARE ONE.

Geographically the State of North Carolina is as different as any two States in the Union, but in love and loyalty for the commonwealth we are all one. The writer occupies a favorable position to judge of these matters. Living in the Piedmont region he travels widely through the eastern and western sections and mingles with the people of all. It is pleasant to know that the same spirit animates all North Carolinians, no matter where they live and the same high purpose to strengthen the State and make it what it should become - one of the foremost of all the great sisterhood. We are not perhaps, as vain as our noble neighbors of Virginia, nor as boastful as our South Carolina friends, but in all matters affecting

the honor and glory of the State we are practically solid, and as many defenders should rise up if her good name were assailed as could be found either to the North or the South of us. We never speak of our State as "Carolina" as is the custom among our South Carolina brethren, for do we look with compassion upon those not born in Virginia, as the manner of some, but in sturdy State pride we dare say that the North Carolina people are not surpassed by those of any other section anywhere. The old taunt that "North Carolina is a strip of land between two States," is no longer in vogue. The world knows better. Our people have built their cities, improved their farms, established their manufacturing plants and, best of all are educating their children. So long as we maintain our solidarity and stand shoulder to shoulder we shall be able to hold our own and keep pace with the strongest and most progressive of our sisters. Shame be to the man who underestimates the State, or who would breed discontent and sectional feeling among our people. We be brethren. United we stand, divided we fall. From Murphy to Manteo our common purpose must be to make old North State glorious.—Charity and Children.

"Medical science has not yet penetrated the secret of spotted fever," said Dr. W. W. King, passed assistant surgeon in the public health and marine hospital service.

Dr. King has just returned from a several months' study of the disease in the Bitter Root valley of Montana.

"There are many baffling characteristics about spotted fever," said he. "In the first place, the disease is only known in a few valleys in the west. It is exceedingly dangerous, but not even prevalent where it occurs. For instance, in the Bitter Root valley there were ten cases this year, with eight deaths.

"A peculiarity of the disease is that it appears only on the east side of the Bitter Root valley. People on the west slope have never been affected.

"Many theories have been advanced regarding the transmission of spotted fever, none of which has been proved. For instance, some of the people maintain that the wood tick spreads the disease in the same manner as the mosquito does yellow fever. ### ALL OVER THE HOUSE.

Treatment For Patients Suffering From Sunstroke.

In case of sunstroke immediate treatment must be given to remove excessive heat. Get the patient to a shaded spot, remove the clothing and bathe the body, face and head in ice water. Lay ice in towels on head and neck and over the wrists. Rub spine and surface with it. If able to drink give all the cold water the patient can take, but never stimulants. In case of sunstroke the face is red and the head and body hot and dry. In case of heat exhaustion the face is usually pale and the pulse rapid and feeble. In this case give the patient rest in a cool, well ventilated room and administer stimulants gradually. Persons addicted to alcoholic drinks are much more susceptible than others to sunstroke and exhaustion.

### THE MOB OF 1848.

Dramatic Climax That Awed the King of Prussia.

When the disturbance of 1848 broke out in Prussia the king, Frederick William IV., issued many proclamations. They denounced those who protested against the old state of affairs and urged a constitution as "a band of miscreants, mostly foreigners," and informed "my dear Berliners" that he would never grant a constitution.

The actual fighting, however, when for days his troops took barrier after barrier, only to be opposed after each as resolutely half a block farther down the street, soon changed his attitude, and he announced concessions. The troops were sent from the city.

When the soldiers had marched away from all parts of the city solemn and silent processions moved toward the royal palace. They escorted the bodies of those who had fallen in the battle. The bodies of the slain were borne aloft on litters, their gaping wounds uncovered, their heads wreathed with laurels and immortelles. So the procession marched into the inner courtyard of the palace.

The litters were placed in rows on the courtyard floor, and around them stood the multitude of men with pallid faces, begrimed with powder, smoke and blood, many of them still carrying the weapons with which they had fought during the night, and between them women and children bemoaned their dead.

The king was loudly called for. He appeared in an open gallery, pale and dejected, by his side the weeping queen.

"Hat off!" the multitude shouted. And the king took off his hat to the dead below. Then a deep voice among the multitude intoned the old hymn, "Jesus, Mein Zuversicht" ("Jesus, My Refuge"), in which all joined. The chorus finished, the king withdrew, the corpses were lifted up again and the procession moved away in grim solemnity.

It was a terrible humiliation to the crown, at the same time a pointed answer to the king's address, in which the fighters had been denounced as a band of miscreants. Had there been such among them Frederick William IV. would hardly have survived that moment when he stood before them alone and defenseless and they fresh from the field of blood, with guns still in their hands. But at that moment their cry was not "Death to the king!" nor "Down with royalty!" but "Jesus, my refuge!" — Carl Schurz in McClure's Magazine.

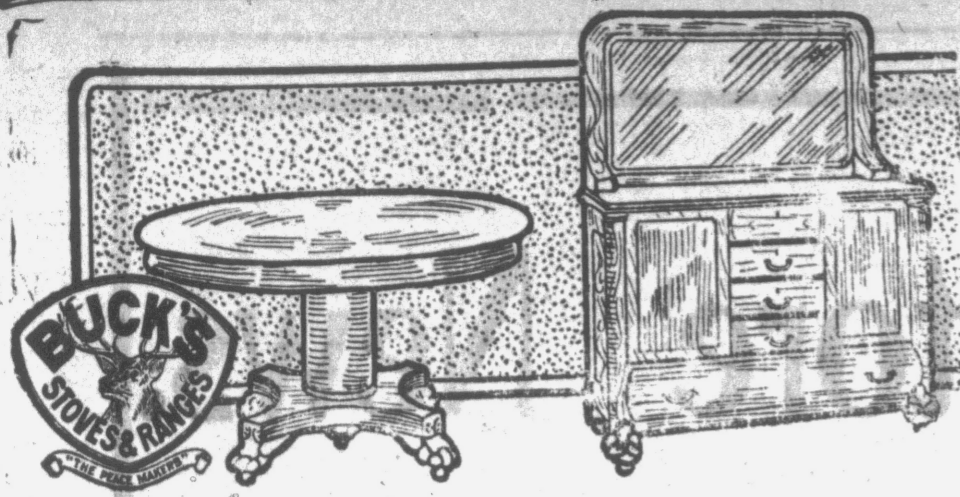
