## WHITE CAP CASE.

### Motion for Severance Allowed and J. K. Barnhill First Put on Trial.

(Continued from Yesterday)

B. F. Ward and Bob Parker were first of neighbors to arrive. Cannot say how many were in the party assaulting my house. We took lanterns and guns and went out to where the parties had been. Saw signs where they had come up to old house with buggies and unhitched; followed tracks where they had walked from my house to the old house where buggy tracks were. It is about 100 yards from my yard to road. We followed buggy tracks in direction of Hickory Grove, at cross road the tracks turned towards Oakley. The defendant at that time lived at Oakley. My son and another party also followed tracks of one buggy that went in another direction from cross roads; that track went up to Offie Barnhill's gate.

After making investigation in my room I found two hats and one cap; one of the hats was shot through. Several switches were found in yard. The door to my room had an ordinary knob lock; when they burst open the door it broke one screw in the lock and drew out the others. Entrance from front porch is direct into my bedroom. Two beds and cradle were in the room. The parties to reach me had to go across my wife's feet, as I slept on back of bed.

Cross examined—I have not told any person I did not recognize any of the parties attacking me. A number of names were called to all of which he answered no. I gave The Reflector an account of the attack a few days after it occurred; did not tell editor I did not recognize any one. Mr. Ward and Mr. Biddick came to my house soon after it occurred. One of the horse tracks followed was specially marked like a mule footed track. I did not say that track was made by Bill James' horse. I never said it was a Bethel and Conetes crowd that made attack on me. Never heard my wife tell any one a red bearded fat man was in the crowd. I never told that J. E. Barnhill was dead. I did not report that Briley was shot in stomach. Did not say I put the pistol against J. K. Barnhill's body and fired. It was dark and I could not see who it was against. The match was struck by my wife after the shooting. Two men were in the room when match was struck, don't know how many were first in the room. I did not tell Zeb Whitehurst that if he would testify against Barnhill and Briley he could go free and get money besides. I never tried to overhear Whitehurst and his brother talking in Hotel Bertha. A detective was hired to come and work on the case.

I went to bed about 8:30 o'clock the night of the attack. It was a dark night until about 1 o'clock. There were marks on faces of men in room showing they had been smutted as if made with a burnt cork; a cork was found in yard next day. I was sitting on floor and the men were on each side of

me holding my hands and trying to get pistol from me when my wife struck the match. I have not discharged any of the States witnesses. I did not abuse Mrs. Julia Ward for telling anything myself and wife had said. I have talked with some of defendants witnesses but never threatened any of them.

In the midst of the cross examination court took a recess to 3 o'clock p. m.

Upon reassembling of court Monday afternoon the cross examination of W. J. Teel was continued.

I did not tell J. A. Staten that I did not recognize anybody. Have said my wife did not recognize anybody. Have never said the parties blew out the matches as fast as my wife struck them. I did tell Mr. Staten that the parties had something on them about the color of an Indian. I carried the hats and caps to Bethel and showed them, but not for the purpose of seeing if they belonged to any one in Bethel. I had already found out who the cap belonged to. (He exhibited hat with four holes in it and with a pencil showed how all the holes were made with one bullet.)

I have known Barnhill since he was a boy, it has been some 10 or 12 years since he moved from my neighborhood, but had seen him frequently. Have also seen Briley at times. I did not see particularly how they were dressed that night, except as they run off from my house; they either had on jumper jackets or had their coat tails in their pants; Barnhill did not have anything on his head as he ran off. I did not tell John Webb or J. F. Brinkley that I did not recognize any of them. I did not tell Tom Nelson during recess of court today that some one blew the matches out as fast as my wife struck them. I did tell him that I had been told by another party that Barnhill had said I could not recognize him by the matches because he (Barnhill) blew them out as fast as my wife struck them. I did not tell any one that one of the parties were driving a gray horse. I told Mr. Reddick that a man told me that he (Reddick) had said I had told him I did not recognize anybody. Reddick said bring that man to me and I will tell him that he told a d—n lie.

(Drawing is shown witness purporting to be location of his house and roads and from this he explained how he followed the tracks.) The sun was an hour high when I got to Offie Barnhill's. He told me he did not go any where with his buggy that night. I asked him if any one had driven his horse the night before. I told him his horse had been driven from my house to his house that night. I did not tell him that if he said to the contrary I would take his word for it. He said there was a harness print on the horse.

I did not tell Tom Whitehurst that I did not want to convict certain of the parties. I did tell Tom that if Zeb Whitehurst would tell the truth about it: I would do all I could for him.

Re-direct examination—(Shown hats and cap.) These are the ones I found in my room near bed. (Sack is shown witness.) This

sack was found by my children near my house. After I tracked buggies, I went to Oakley; found Barnhill at Mr. Nelson's in bed. It was about 1 o'clock p. m. Briley and Walter Woolard lived near Sheppards' mill, about 5 miles distant.

Re-cross examination—I went to Nelson's house in Oakley and saw Barnhill in bed asleep. I ate dinner at Nelson's. Did not say anything to Barnhill.

MRS. W. J. TEEL.

I am wife of witness preceding me. I remember night of trouble. No one but family was in our house. A crowd broke open door, rushed in room, crawled over my feet after my husband. I screamed when door broke open and called the boys up stairs to come with gun. Mr. Teel shot 4 or 5 times. When they pulled my husband off of bed I got off too and went to mantle and got two matches which I struck. By light of match I saw two men have my husband on the floor. One of them looked me straight in face and shut his eyes to keep me from recognizing him. He was a smart-faced broad man. I said "what are you doing here you scoundrel?" The boys run down stairs with gun and handed it to Mr. Teel already sprung. He went out on porch with gun, I started to ring farm bell, but one of the boys got to bell first. (Then with a book she illustrated location of house and room in which they slept. It was with some emotion that this testimony was given.) I did not recognize any of the parties but Mr. Teel told me right away that he recognized Barnhill and Briley. The hats and cap were found in our room. The sack was found outside with the switches.

Cross examination—Mr. Manning, Mr. Ward and Mr. Reddick are our nearest neighbors. Mr. Ward came there. I do not recall any conversation with him or making any statements in his presence. Mrs. Ward came to my house early that morning and we had some conversation. I told her they might have been slightly disguised, do not remember saying anything to her about hats and cap, nor of telling her I did not recognize any of them. I have talked with Mr. Reddick, never made statements to any one about any of the parties having red chin beard. We live about 2 1/2 miles from Hickory Grove church, service was held there the Sunday before this attack, many people passed going to church.

I did not notice clothing of parties making attack, was too excited, the man who looked me in the face looked like something had been struck across his face. The other man was full faced with mustache and dark place on his chin. I am related to one of the defendants, Charlie Wynne; my husband is related to Zeb Whitehurst.

CARRIE TEEL.

I am 11 years old and daughter of J. A. Teel. I got the sack and carried it to the house; it was hanging on a wire fence near path leading to house.

J. I. JAMES.

I remember the occasion of breaking in Mr. Teel's house. I

saw defendant Barnhill that day, said he was going to Hickory Grove. I also saw him at Oakley that day coming from the old mill, and going in direction of Hickory Grove. I first saw him about 8 or 9 o'clock, next about 11 o'clock. I heard his (Barnhill's) gate open after dark that night. I told him I had fed his horse, he said I will give him more fodder. I sometimes helped in Barnhill's bar on Saturdays.

\*Cross examination—Saw him going to Hickory Grove that morning, next time I saw him he was also going toward Hickory Grove. I live at Oakley and Barnhill left his horse and buggy in my stable. Do not think either was taken out of stable that night. I saw Barnhill about dinner time next day. He was lying on platform.

Re-direct—He might have been coming from Sheppard's mill when I saw him Sunday, as people travel that way. Buggies might have passed that night without my hearing them.

T. M. WILLIAMS.

I live 2 miles from Parmele and 4 from Oakley. I remember date that assault was made at Teel's. Briley came to my house that day, he came that morning and took dinner. In the afternoon Barnhill also came to my house. He told Briley he wanted some words with him and Briley went out and talked to him. Barnhill then left going towards Oakley. It is 12 miles from my house to Sheppard's mill. Briley left my house between 7 and 8 o'clock that evening and went towards Oakley; he would have gone home that way. He hitched up his horse before supper.

Cross-examination—Briley came to my house alone. I suppose he went to see a young lady who was visiting at my house. Barnhill came from the direction of the church and left in the direction of his house. My family was present when Barnhill called Briley out. Briley had a dark horse.

CLYDE CARSON.

I remember date Teel was attacked, I was at Oakley at my sister's, Mrs. Nelson, Barnhill, Zeb Whitehurst and Charlie Wynne boarded there. I got there about dark. I went to John Jenkins about 8 o'clock and saw Barnhill and Whitehurst at the latter's gin house putting a buggy away. I left Mr. Jenkins about 10 o'clock and returned to my sister's. Did not see anything of Barnhill there. I did not go to bed before 12 o'clock and Barnhill not any one else came in the house during that time. (Cap was shown him) To best of my knowledge it is Barnhill's cap. I saw him wearing it around Oakley. I got up before sunrise next morning. I saw Barnhill and Whitehurst on bed and saw Wynne on the railroad. On my way home met my father and others at cross roads about one mile from Oakley tracking buggies; I saw the tracks they were following. I told them they need not go further toward Oakley. They then took another fork of road and followed tracks to Offie Barnhill's

my father are cousins, live a mile apart. I looked in room where the boys were in bed. They were under the cover. I saw him wearing the cap at Oakley at the tournament, some other boys wore caps. I also saw him wearing it around his bar in Oakley. Nelson's house is across railroad from Barnhill's bar. I slept in room next to railroad and heard vehicles cross railroad during the night. (The cap was submitted to the jury and hair was found inside of it about a hole in top of cap. Sock was also submitted.)

W. E. SWINDELL.

I am a fish and ice dealer in Washington. I shipped ice to Barnhill at Oakley on April 14th, it was first shipment made to him this year. (Sack was shown witness.) That is a bag we shipped ice in.

Cross examination—I cannot say that this is the identical sack that ice was shipped to Barnhill in on April 14th. Ice was shipped to other points in same kind of sack. Sacks are tagged with consignee's name on tag.

W. J. Teel was recalled and said the sack was not where his little girl found it the day before the attack, and he had never seen it before she found it. I did not put the hair in the cap, it was picked up in my room.

MISS FANNIE CARSON

I know J. K. Barnhill. To the best of my belief the cap shown is his. I saw him wearing it tournament day.

BEN JENKINS.

I was at Oakley the Sunday night Teel was attacked. I went in Barnhill's bar a little after sunset. Second time there I saw Barnhill, Briley, Whitehurst, Woolard and Wynne. (all of these are defendants) It was 9 o'clock

Cross examined—It was also a grocery store where the bar was, I do not remember Briley getting a box of tobacco to carry home. I live in Oakley and it was nothing unusual to see the crowd there on Sunday night. I heard no unusual talk. Lum Wynne went there with me. I think Woolard got off the train coming from direction of Washington.

Re-direct—Briley's horse was tied at the door when I went in.

G. G. WHITEHURST.

I reached Teel's house about 3 o'clock night of trouble. I found door broken open, he showed me hats and cap, and where pistol ball had struck ceiling. We took lantern and followed foot tracks out to old house where buggies had been stopped. Teel, Carson and myself followed the buggy tracks that went toward Oakley, tracks were distinct and looked like had broken dew. At Grindool at forks of road other buggy tracks cut into same road and we followed all on towards Oakley. One buggy track went up road and turned around. We followed on nearly to Oakley and met Clyde Carson and then turned back and took another track that went to Offie Barnhill's. Teel told me he knew who two of the parties were. He said one of the parties lived way below Stokes. He said they were Barnhill and Briley.

Homemade Cement For Mending Broken Glassware.

The best kind of glue for clear glass is made from a solution of two ounces of isinglass and half a pint of gin poured into an open mouthed bottle and set in the sun until it dissolves. It should be shaken well every day and before being used should be strained through a clean lawn cloth. When ready for the gluing the broken glass pieces should be well washed in hot suds, especially on the edges, dried, and then with a small camel's hair brush the cement should be put on the edges of both pieces, and when they are nicely fitted together rubber bands or clean strips of cloth should be bandaged tightly around them to hold the edges well together until the glue dries. If the cement has been properly made the break should really not be visible when dry, for the reason many cracks look jagged when mended is because the edges have not been well joined and, bubbles of air getting in, reflect the light, making the ragged, broken lines glaringly apparent.—Boston Traveler.

Care of Linoleum.

To keep linoleum nicely have a pint bottle, in it put a quarter of a pint of turpentine and three-quarters of a pint of linseed oil; mix both together thoroughly and always shake the bottle before using. Apply a very little of this to the linoleum and rub it in thoroughly. Then polish with dry, clean dusters. Constantly wash out the cloth used for applying the oil or there will be no polish. Never wash linoleum. If it gets dirty, rub it over with a damp flannel only.

The Empress of Byzantium.

Apropos of the Spanish queen's new title, Queen of Jerusalem, there is a claimant to that designation living in London, Princess Christofero. She lives quietly in West Kensington and is married to an Englishman and has sons in the English army. She calls herself Queen of Jerusalem and Empress of Byzantium. Although not rich, she keeps up a certain state and receives her adherents seated on a dais and with a canopy above her head. The members of the various royalist societies know her well. She attends the special services at the old chapel of St. Mary-In-the-Wardrobe, in the city, and heads the Jacobite procession, which once a year deposits wreaths on the statue of Charles I.

Ginger Beer.

Pour a gallon of boiling water on one pound of loaf sugar, half an ounce of ginger and one ounce of cream of tartar. When nearly cold add a tablespoonful of yeast. Strain, bottle, and in six hours it will be ready for use. If root ginger is used, boil it in the water for twenty minutes.

Treatment For a Cold.

When suffering from a cold avoid eating much solid food. Take soft foods, such as bread and milk, farinaceous puddings and soups; also warm drinks to produce perspiration, such as gruel, tea and cocoa. Coffee should be avoided for a few days.

Healthful Mouth Wash.

Tincture of myrrh should be used frequently as a mouth wash. It helps greatly to harden the gums and sweeten the breath, besides keeping the teeth healthy. The mouth wash should always be used at night and again in the morning.

Orange Frosting.

One large orange (juice and rind), the yolks of two eggs beaten to a froth and powdered sugar, enough to spread nicely.

Cross examined—I was trying to borrow some money, not the first time I had done so. I was not mad with Barnhill because he did not lend it to me. I was not summoned until special term of court.

Teel has never asked me what I would testify to. I once talked with Barnhill about it. I am an insurance agent. The companies have not had lawyers to collect money out of me for premiums collected. The company had ordered me to take up certain policies, I went to the party and gave my check for return premiums, the parties did not surrender the policies. I am also clerk in post-office, have never been turned out of it; was accused of taking \$35.

Re-direct—I am still clerk in postoffice, did not take the \$35. of which I was accused. My father is postmaster. The policies I was ordered to take up were on property of Barnhill and Nelson. When check came back four months later I did not have money to pay it.

### JOAB WHITEHURST.

I live between Stokes and Oakley. I saw Barnhill Monday morning early, saw Barnhill and Charlie Wynn in buggy going toward Stokes. Also saw Barnhill Sunday morning going toward Stokes, I was there at Mr. Harris. Did not talk to Barnhill. The direction he was going was one way to go to Sheppard's mill.

Cross examination—When I saw them returning from Stokes they they had hay in buggy.

**DOES THE DOG REASON?**

Authentic Instances That Seem to Warrant That Conclusion.

A dog I owned suffered a great deal with indigestion. The least indiscreet diet would bring on these attacks, and as they occurred very frequently I had a large bottle of medicine always on hand and kept it on a shelf in his kennel. The dog seemed to have acquired a thorough comprehension as to the relief bringing quality of that bottle. Whenever he was ill and food was placed before him he would scent it, walk away without touching it, then turn to the shelf and, gazing steadily at the bottle, indicate plainly his wants. He took the medicine without the slightest balking, which is rather exceptional, as any one who ever tried to dose a dog will agree.

This dog when let out would never disturb anything in the poultry yard, but the moment a stray chick lost her way into his yard the savage got the better of him. He would catch the unfortunate straggler, kill and devour it, leaving only a few feathers as evidence of the "murder." Punishment always followed. The remnants of feathers were shown to the dog so as to impress on him his wrong doings and make the cause of the punishment clear to him. From time to time young chickens would be missing, and all efforts to locate the guilty one were vain. The dog's yard was always scrutinized, but nothing found.

My best broilers were disappearing at a rapid rate, and I decided to have the dog watched. Soon he was caught in the act and the mystery solved. The moment the dog had finished his meal he scratched the feathers in a heap and carried them with his teeth to a corner of his yard, where he buried them. The dog had the most embarrassed and helpless expression at the time he was caught that I ever noticed on a dog. An extra severe punishment was dealt out, and I do not know if the mortification of being trapped or the punishment did the work, but the dog was cured from that moment on.

The related observations show reasoning in order to accomplish something for a set purpose. I believe that animals possess the quality in some degree, more or less, according to their mental development.

In the last case described the dog's instinct led him to catch and kill the chicken, but memory told him that punishment would follow if found out. He reasoned that by hiding the evidence of his guilt he would escape punishment for his actions, which he understood to be wrong. The very fact of being able to discriminate between right and wrong and trying to check the consequences of the latter shows the necessity of thinking and therefore of reasoning power.—S. L. "Cheer up, George! If your heart is really broken we can stop at a repair shop."

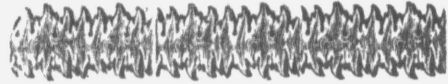

**How Pendulums Began to Swing.**

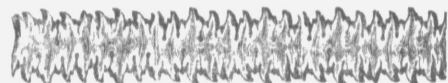
