## SERVANTS IN PLENTY.

The servant problem has been a very perplexing one in this section of the South for some years. Not only are servants scarce but the majority of those in service are incompetent and impudently independent. There is no reason why this condition of affairs should continue indefinitely. The housekeepers have the remedy in their own hands. During the latter part of October a steamship is to arrive at the port of Charleston direct from Bremen with five hundred selected immigrants—farmers and their wives and servant girls and boys.

Already the people of one town in South Carolina have engaged seventy-five domestic servants. It is probable that all of this first cargo of five hundred people will readily find homes in South Carolina, but the steamship will bring other cargoes and in time every home in North Carolina can be supplied with servants. The change to white hired help is bound to come in time. The Southern housekeeper might just as well prepare herself to face the problem now. The people who will be brought over by this Charleston steamer are of the very best class, and now is the chance for those who want good servants or good labor, to speak up.—Charlotte Chronicle.

Congressman Small, who has taken the most active part in the promotion of the proposed inland waterway between Norfolk and Beaufort, is quoted to the effect that the special board appointed to consider the subject has reported to the chief of engineers of the army that the plans for the waterway, involving an expenditure of \$3,500,000, are entirely feasible. ## SUPT. SMITH EXPLAINS

EDITOR REFLECTOR:

Contrary to your statement in Tuesday's issue of The Reflector, I beg to state that the State textbook law does apply to the graded school here, and everywhere else in the State except Charlotte.

The school is growing older and more carefully graded. This state of affairs necessarily requires more supplementary books. Almost without any exceptions, all the books now in the possession of the children, and used last year, will be used during this year. It is absurd to suppose that we can fit children to books; we must adopt books to the peculiar needs of each grade. When the proper time comes, the same readers, histories, etc., that were used last year as supplementary matter will be used again.

We are going to invite the principals of all the schools in Pitt county to unite with us and use the same supplementary text books so that we can get a reduction in prices, thereby saving the people every cent we possibly can.

To have a first class school we must have books. I fully invite comparison of the number, kinds and prices of books used here with those of any other first class graded school in North Carolina.

## BUTLER LIED.

### Details of Dress That Are Insisted Upon by English Masters.

At many schools uniformity of dress is insisted upon. It is surprising how much the casual visitor is impressed by trifling details of dress, and if boys were given much latitude in this respect the impression would not always be a good one. Black coats and waistcoats with black ties always look tidy and respectable, and are frequently the rule. At Harrow boys over a certain height are allowed to wear "tails," which, however, do not look well with straw hats. The Harrow straws are familiar to most people, having a crown of hardly an inch in height; these are worn all the year round, a custom which prevails also at Winchester. At Eton top hats are the usual headgear, and one is sometimes treated to the spectacle of a boy clad in football things surmounted by a top hat.

At some schools one is struck by the enormous variety of caps worn by the different boys, every house having its own colors for the different school games. When clothes are changed for football or cricket this is reasonable enough, but under ordinary circumstances the neatest uniform is some dark suit with black ties, the members of the various school teams being possibly allowed to wear their colors as a mark of distinction. At many schools the boys are compelled to wear cap and gown, the prefects in some cases having the distinction of tassels to their mortarboards. At Bradfield and Radley the boys wear gowns, and at Winchester all the "collegers" were compelled to do so, but a mortarboard is very heavy to the head, while a gown is rather a hindrance to a boy, though it may help to keep his clothes clean.

It is customary for prefects or monitors to carry walking sticks as a mark of distinction, and in the old days at Winchester prefects used to wear cowlers or "cow shooters" as an especial mark of dignity. At Harrow a boy's great ambition is to get his "fez," which in appearance is much like a smoking cap with a long tassel, but which confers a great distinction upon the wearer. Brown boots are not generally allowed at school. All these various little details of dress are most rigorously enforced by the boys themselves as well as by the masters, with quite regimental exactness.—Baily's Magazine.

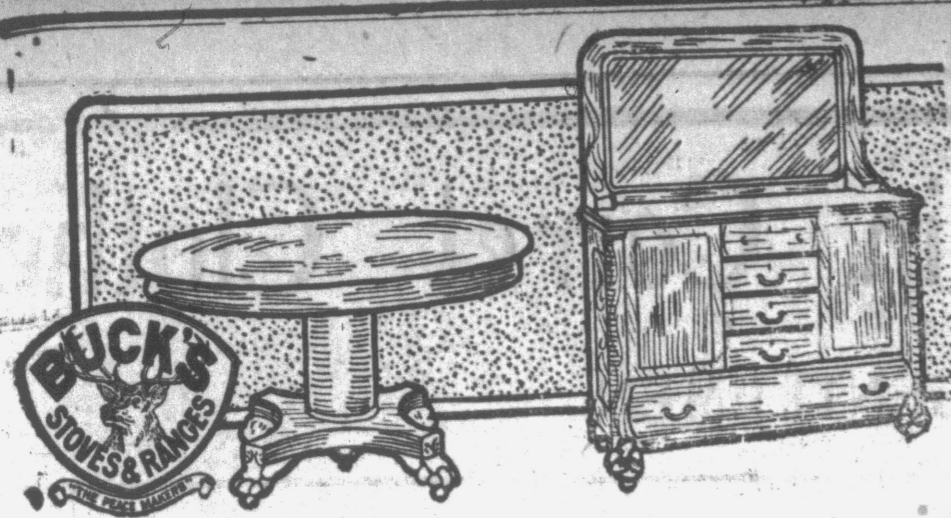

BUTLER'S SPEECH.

Of course those who hold different political views from [Marion Butler and went to hear his speech in the court house Tuesday, expected him to say things they did not believe or agree with, yet they were looking for a better speech than they heard. Taken all together it was a poor effort, falling far below a man of his opportunities and reputed ability. In fact it was the same Butler of fusion days, and his speech was in the main given to praise of President Roosevelt and the Republican party and abuse of ex President Cleveland and the Democratic party. He discussed no issues whatever.

After dealing awhile with National matters in which he charged that the Democratic party had never kept a promise and claimed that the Republican party had fulfilled every pledge, he turned to the State government. About all he could do in the latter was a comparison of the Fusion administration of 1898 with the Democratic administration of 1905, reading a lot of figures of expenditures in the two years on which he made the sweeping charge of Democratic extravagance without giving any explanation whatever of why the figures in the latter year were larger. This part of his speech was almost identical with that delivered by United States Attorney Harry Skinner at the recent Republican county convention, yet lacking Mr. Skinner's eloquence and oratorical ability.

Mr. Butler could not close without taking advantage of the opportunity to pat himself on the back. He went into his own record somewhat, making the great boast with thumbs stuck in armholes of vest and body thrown back that in all his life he had never committed a dishonest act. And the audience smiled. The speech made no converts to Republicanism in Pitt county.

The colleges themselves are down on hazing, and the recent action of freshmen at the University and Trinity is calculated to bring the brutal practice into disfavor with the students.

If Greenville does not get up and hustle it is her own fault.
