

### COASTAL WATER SUPPLY.

#### The Government Interested in This Matter.

Washington, N. C., Oct. 5, 1906.  
EDITOR REFLECTOR:

You will observe by the appended letter from Mr. M. O. Leighton, acting chief hydrographer, that the U. S. Geological Survey is now engaged in making a study of the ground-water resources of the coastal plain of North Carolina. This is a subject of the greatest importance to tide-water North Carolina. The conservation of the public health, particularly in the prevention of malarial and typhoid fevers, is absolutely dependent upon an abundant supply of pure water for domestic purposes. Investigations have conclusively demonstrated that the only reliable source of pure water along the coastal plain of the entire Atlantic seaboard is to be obtained from deep bored wells. This must be the source of public supply for towns and cities and also for the rural sections. This fact cannot be too strongly impressed upon our people. The one obstacle in the progress of Eastern North Carolina is the presence of malarial diseases. Malaria does not exist to the extent believed by the residents of other sections but still it does prevail sufficiently to give color to the prejudice existing against us. It is unquestionably true that good water and right living will constitute an immunity against any form of malaria in Eastern North Carolina.

An abundant supply of suitable water for industrial purposes is of only secondary importance and a sure supply for these purposes must also come from the subterranean streams.

Those who have heretofore sought a water supply in the towns and on the farms met with difficulties. They had no information to guide them as to the locations which would probably afford a satisfactory supply of drinking water or the quality of same and much money has been invested and disappointments encountered as the result of this ignorance upon the question. The chief hydrographer solicits inquiries from interested parties and local advice regarding the work of investigation which is now proceeding. I hope that owners of factories, the municipal authorities of the several towns, as well as intelligent farmers, will not hesitate to communicate freely their wishes or any information which they may have in hand upon this subject. They may write direct to me and I will take pleasure in forwarding their communication.

The director of the United States geological survey writes me that while this work has been heretofore prosecuted slowly, that plans have recently been perfected to complete the investigations within the present field season, and, if possible to publish the report during the coming winter.

I will thank you as a matter of public information to publish this letter, and also the enclosed letter from the acting chief hydrographer.

Sir:  
The United States geological survey, through its hydrographic branch, is making a study of the ground-water resources of the coastal plain of North Carolina. This work includes (1) a search for the various water-bearing strata to ascertain the depth below the surface at which they occur in all parts of the region, and (2) a determination of the quantity and quality of water obtainable and its availability for use as domestic supply and in the industries.

As you are probably aware, the ground waters of this region are among the most valuable of its resources. The cities, towns, and industrial plants are largely dependent upon wells for their supplies, yet there has been no systematic study of the fundamental conditions, and lack of information concerning them has been responsible for the waste of many thousands of dollars in searching for good waters at localities where none are procurable. Moreover, industrial growth of many kinds is dependent upon the availability of waters of particular characters, and the commercial development of the region has undoubtedly been hampered by the meager information concerning the character and amount of the available well waters.

A large amount of geologic material has already been collected, the depths of the water-bearing strata have been determined at many points, and it is expected that sufficient additional data will have been collected by the field men this summer to enable the publication of a report during the winter. So far as possible this report will be divested of technical details, and it will be so prepared and arranged that the readers may obtain from it acute information concerning the quantity and quality of the available water supply at any locality and the industrial purposes for which it is peculiarly fitted.

It is often difficult to determine just what direction investigations should take in any region, and local advice, especially that given by interested parties, is needed. As the entire congressional district represented by you is comprised within this coastal plain area, it is hoped that you will take active part in the work and aid the bureau with your recommendations.

### ARGENTINE COWBOYS.

The Southern Gaucho Wears the Biggest Trousers on Record.

Our friend the gaucho is as much in evidence along the line to the west, as to the south in Argentina. He still sticks to the inevitable poncho, but he has discarded the chirpa, a blanketlike garment that the southern gaucho wears around his legs, or bombachos, which is the name for absolutely the largest trousers on record.

The bombachos in the first place were, I believe, brought to Argentina by the Basques. The things went straight to the heart of the gaucho, and he adopted them at once. Only he has steadily insisted on amplifying them, until today one leg of a pair of bombachos will house a small family. There is no particular point of utility to be urged for these wind bags, but they serve to make their wearer a conspicuous figure when he rides into town, which is reason enough for the gaucho.

The recado or saddle used in the west is much the same as in the south. It consists of a couple of smooth pieces of wood to be laid on a blanket behind the horse's withers. Over these several, thicknesses of fleece or soft blankets are strapped, a pair of stirrups thrown over the whole and the recado is ready for use. This sounds like a crude arrangement, and such it often is. Nevertheless I have heard a number of Englishmen who have used it claim that the recado gives a knee grip in the soft blankets that insures a seat more sure than that possible in any saddle of hard leather.

The most inseparable companion of the gaucho of the west is his ribenka, or whip. This has a heavily loaded handle about a foot and a half long, which terminates in a thick single or double throng of rawhide of the same length as the handle. The handle is sometimes covered with hide or, again, heavily inlaid with silver. A blow from the handle of a ribenka will fell a horse, and a cut from its lash will tear open a gash in the flank of a tough skinned mule.

The gaucho of the south fights with his knife in one hand and his folded poncho in the other as a shield. The western gaucho substitutes the ribenka for the poncho and must make a far more formidable opponent. His great facon, or knife, reposes most of the time in his belt. His ribenka never leaves his hand during the day, and at night he sleeps with the throng of it about his wrist. — Los Angeles Times.

### Mistletoe of the Druids.

Mistletoe for centuries has been one of the most important factors in Yuletide decorations, its use dating back as far as the days of the Druids. The mistletoe of the Druids is Viscum album. It is a true parasite, existing on the sap of other trees and never at any time is in contact with the soil. It grows freely on apple, pear and plum trees, on poplars, thorns, maples and basswood and rarely on the oak. It is said that the only sacred mistletoe of the Druids was that found upon the oak. The propagation is by the seeds. These are covered with a translucent, gummy substance. They are placed in position by birds, which, in trying to rid their beaks of the sticky seeds, rub them on the bark. The seeds which are deposited on the east or north side of the tree grow more rapidly than those on the south or west.

### The Janizaries.

The janizaries are unique in the history of the world. Nothing like them has ever been known in the constitution of any state. We think of them somehow in association with the mamelukes of Egypt, but, though there were some points in common between them, they differed widely in their character and aim. The mamelukes, though originally a race of slaves, founded a sovereign dynasty in Egypt, but the janizaries, even at the height of their power, never ceased to be soldiers, and they maintained throughout all their history the proofs and symbols of their lowly origin. They made and unmade sovereigns, but they never aspired to the high positions of state and were content to fill their original posts. Not one of their number ever occupied the throne of Turkey, and the whole corps acted ostensibly only as its guardians.—St. James' Gazette.

### BELLS ARE VERY ANCIENT.

They Were Known to the Egyptians Before the Exodus.

Bells were well known to the Egyptians before the time of the Jewish exodus. In the description of Aaron's sacerdotal robe mention is made of the fact that upon the hem of the garment there were bells of gold, alternating with pomegranates of blue, of purple and of scarlet: "A golden bell and a pomegranate, a golden bell and a pomegranate, upon the hem of the robe around about. And it shall be upon Aaron to minister, and his sound shall be heard when he goeth in unto the holy place before the Lord, and when he cometh out, that he die not." Hand bells were in common use all over the ancient world. The earliest use of bells in churches was for the purpose of frightening away the evil spirits which were believed to infest earth and air, and the earliest curfew was rung at nightfall to rid the neighborhood of the village or town and church of demons.

Most old churches of Europe have a small door on the north side, and at certain points in the service this door was opened, and a bell was rung to give notice to the devil, if he chanced to be present, that he might make his exit before the elevation. By the command of Pope John IX. church bells were rung as a protection against thunder and lightning. The monument of Persena, the Etrurian king, was decorated with a bell, which tinkled in the breeze. The army of Clothaire raised the siege of Sens on account of a panic occasioned among the men by a sudden chime from the bells of St. Stephen's church. The largest bell in the world is in the Kremlin at Moscow. Its weight is 250 tons, and the value of the bell metal alone, not counting the gold and silver ornaments which were thrown into the pots as votive offerings, is estimated at \$36,565, or about \$332,825.

### Of Different Minds.

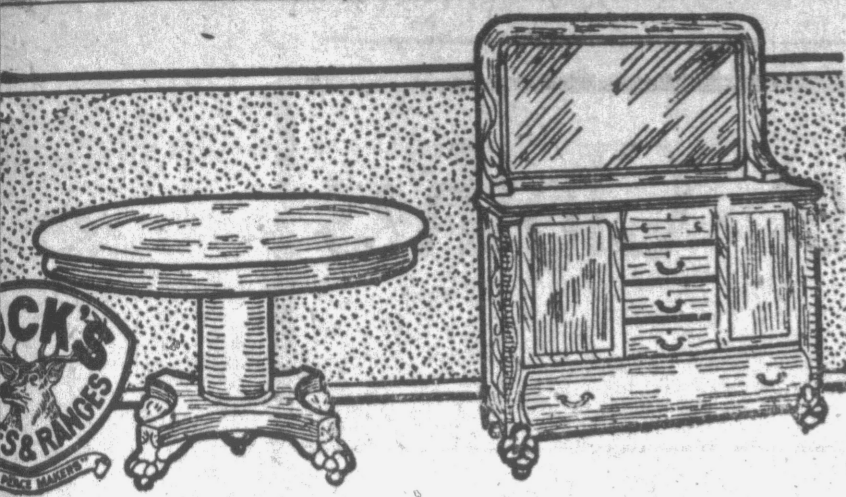

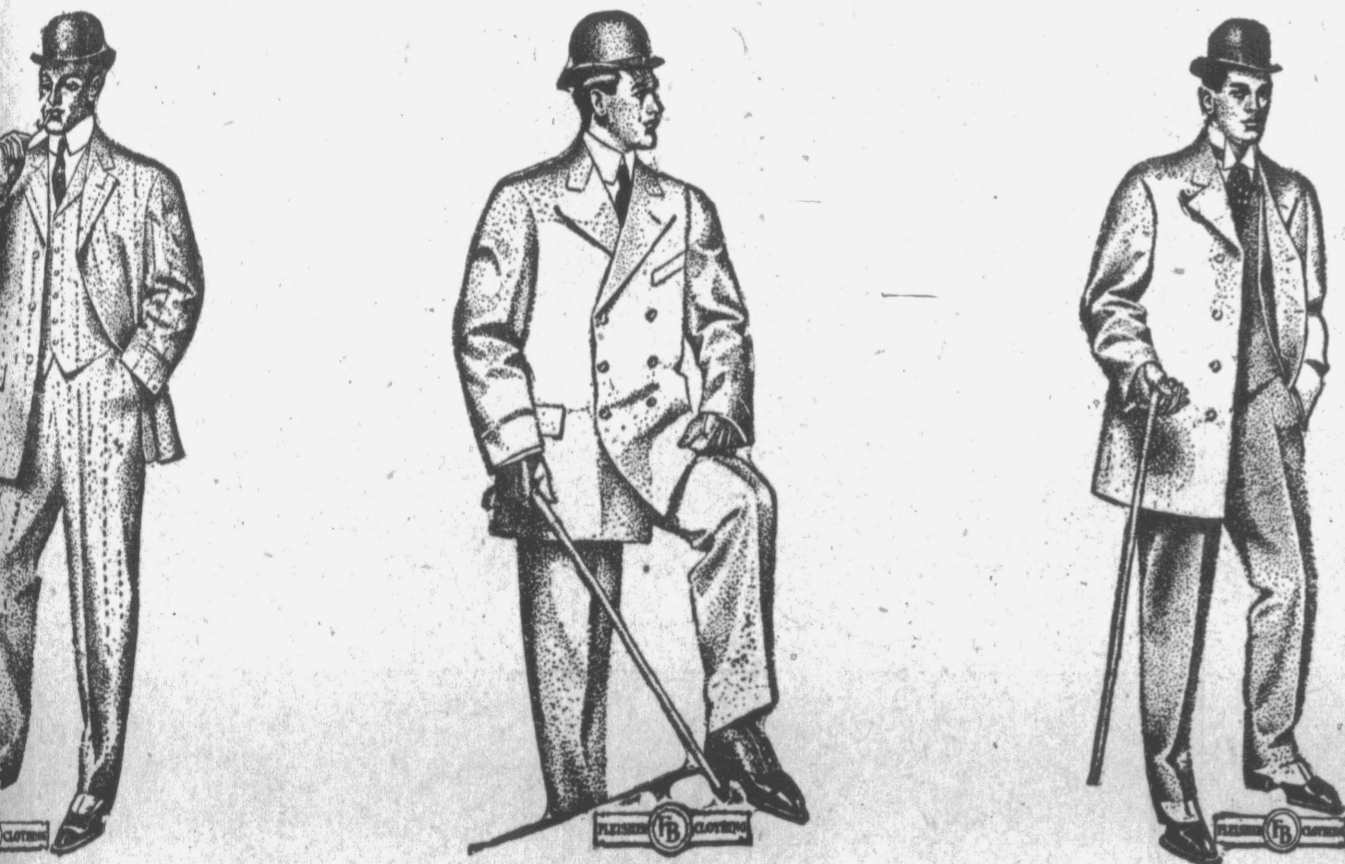
