

FIRED AT RANDOM.

A Constable Shoots Wild and Wounds a Negro in the Wrist

Tarboro, N. C., Oct. 6—Just after ten o'clock last night as a loaded excursion train on the East Carolina road was getting out of town a negro passenger from Macclesfield was shot through the wrist while in the act of climbing up into the car, by a man named Vance Belcher, of Farmville, a constable of that town and brother to its mayor. Eye witnesses say that Belcher was standing in the baggage car where there were several persons and pulling out his pistol began shooting at random out of the car door when he hit the negro. The negro says he does not know who hit him. Belcher was not drunk and no good excuse was given. Engineer Carpenter seized hold of Belcher, who resisted, saying he had not done any shooting, but, and he drew his pistol, "I will shoot you if you don't turn me loose." Carpenter replied that he was not afraid of that and held on to him until police took him into custody.

On appearing before the mayor Belcher denied that the pistol which the police had was his and exhibited another which he pronounced his. Policeman answered that the last time he was here he had three pistols along with him and that he had more than one this time. Next he claimed that he thought he had a right as constable to carry pistols. The mayor then advised him as so the jurisdiction and powers of a constable and without further delay placed Belcher under a \$200 bond to appear before him for trial this morning.

Bond was given by L. W. Tucker Sheriff of Pitt county. Today however Belcher failed to appear and a *capias* has been sent to Pitt county for his apprehension. Belcher was already bound over to the next term of court in Pitt county for a pistol duel he fought six weeks ago with Policeman Hinton in the streets of Farmville. At that time he was arrested on a warrant by the chief of police and was taken before his brother, the mayor, who bound him over to court.—Raleigh News and Observer.

Sheriff Tucker advises us that Belcher did not forfeit his bond as the case was continued until Friday of this week. He also says that the police officer of Tarboro represented the case to him different from the foregoing account in the News and Observer. Had it been as published he would have refused to be bondsman for Belcher.

ROBERT M. MOYE.

Died Saturday Afternoon in Philadelphia.

There were many sad hearts in Greenville when a telegram came from Philadelphia to his father, Saturday evening, announcing that Mr. R. M. Moye was dead.

For sometime Mr. Moye had been in feeble health, and a few weeks ago went to a hospital in Philadelphia hoping the treatment there might benefit him. His condition became such that his brother, Dr. E. A. Moye, went to Philadelphia last week to be with him. He continued to grow worse until the end came at 3:30 o'clock Saturday afternoon.

Robert McKinnee Moye was 34 years of age, and a son of Mr. E. A. Moye. He was an exemplary young man and enjoyed the highest esteem of all who knew him. Possessed of a kind nature and genial disposition, always conscientious and upright, ever true and loyal, he was a general favorite with every one. He was an enthusiastic Pythian and had filled with fidelity nearly every office in the lodge here, being Past Chancellor at the time of his death. He was also a member of the Odd Fellows, having joined that fraternity a few months ago, and was a zealous member of the Christian church.

In the year 1900 Mr. Moye married Miss Lillie Barnhill. The wife, herself an invalid, the father, Mr. E. A. Moye, one brother, Dr. E. A. Moye, and one sister, Mrs. J. L. Carper, survive him. These have the heartfelt sympathy of every one in the community in their sorrow.

The remains, accompanied by Dr. Moye, reached Greenville on Sunday evening's train, and were met at the depot by both the Pythian and Odd Fellows lodges in a body and escorted to the home of Mr. E. A. Moye.

The funeral service was conducted by Rev. D. W. Davis in the Christian church at 2 o'clock this afternoon, the interment following in Cherry Hill cemetery. At the grave the burial service of both the Pythian and Odd Fellows was held. The pall bearers from the Pythian lodge were Messrs. H. W. Whedbee, R. L. Carr, J. S. Moorrig, J. N. Hart, A. B. Ellington and C. M. Jones, and from the Odd Fellows lodge Messrs. J. C. Tyson, E. H. Evans, T. R. Moore, H. B. Harris, C. E. Roundtree and D. D. Overton.

Among the numerous floral tributes were beautiful designs from both the lodges and from many sorrowing friends.

CRUISER N. C. LAUNCHED

Takes Water Beautifully at Newport News.

Newport News, Va., Oct. 6—The armored cruiser North Carolina was successfully launched here shortly before noon today in the presence of fully 10,000 people, many of these being down-homers. On the launching stand were Governor and Mrs. Glenn, the members of the governor's staff in full uniforms and officials of the army and navy. With Miss Rebekah Williams Glenn on the sponsors' stand where her matron and maid of honor, Mrs. W. H. Arrington and Miss Lillian Thompson, both of Raleigh. The attendance on the stand was limited to 100 persons.

Excursion boats from Norfolk and Portsmouth brought great crowds who remained on the boats in the harbor in order to get a better view of the event. When all was in readiness General Manager Post, of the Newport News Building and Dry Dock Company, gave the signal, the timbers under the great weight groaned audibly and with a slight quiver the huge hull started down the way. Grasping the gaily decorated bottle of wine Miss Glenn dashed it against the ship's side saying "I christen the North Carolina."

Gathering momentum with each second the ship slid easily and gracefully to the end of the way and plunged into the water amid the cheers from the spectators and a noisy welcome from the swarm in harbor. In another moment a pigmy tug had seized the big ship and moored her to the dock and the launching was over. The Governor and Miss Glenn were cheered as they left the stand and many crowded forward to shake hands with them.

Following the launching the Governor and his party were driven as the guests of the ship yard officials to the Hotel Warwick, where they were at luncheon.

After Corporations.

BATTLES IN THE BLOOD.

An interesting record of what may be called, somewhat fancifully and yet with a certain degree of truth, the battles that occur in the blood of a fever patient between noxious and benign micro-organisms was presented at a recent meeting of the Royal Microscopical society by Dr. Bernstein. The patient in this case was suffering from malarial fever. The observations were made at intervals of a few minutes during a period of five hours. The defenders of the patient's life were a kind of leucocytes, which destroyed the malarial parasites. A leucocyte would engulf a parasite, which would then be seen undergoing a process of disintegration inside the leucocyte, and only the pigment granules were left. Afterward other leucocytes would approach and absorb even these granules.

Futures of the Eiffel Tower.

The future of the Eiffel tower is now becoming a topic of serious discussion. It has been a familiar object to the holiday makers of the world for some years now and in 1910 was to become the property of the city of Paris. This fact raised the question as to whether by that time the tower might be regarded as having accomplished its destiny and as ready for demolition. Scientists, however, like it as a point of observation; others aver that it acts as a lightning conductor for half Paris, and military engineers consider it a useful and ready made station for wireless telegraphy. Under the influence of these strong credentials the city fathers have prolonged the Eiffel tower agreement till 1915.

Voltaire's Body.

It is probable that the remains of Emile Zola will be allowed to rest in peace in the Pantheon, whither they are now to be transferred in honor of his fight for Dreyfus and justice. Some of his illustrious predecessors, however, have suffered another fate. The body of Mirabeau, buried in the Pantheon in 1791, was turned out when Marat was placed there in 1793. Later the remains of Voltaire and Rousseau were subjected to similar indignity, one version being that they were removed in a sack one night and ignominiously disposed of in the open country. According to another version, Voltaire's body was removed during the "Hundred Days."

The Spread of Leprosy.

Leprosy is increasing in both North and South America. Colombia, where there were only 400 lepers forty years ago, is said to have 40,000 now, and many find their way into the United States. Such a medical authority as Dr. Ashmead, who was formerly chief medical adviser to the government of Japan, says the increase is alarming. When leprosy is brought into a new country it takes fifty years for the seeds to take root, and it becomes epidemic after some 200 years. It has been shown that mosquitoes are active in transferring the bacilli of leprosy.—Chicago News.

Fruition.

Sir Anthony MacDonnell expressed the belief the other day that the coming year would see the fruition of those hopes which the best Irishmen had for many years entertained. A correspondent of the London Times observes that "the misuse of this word (fruition) is one of the commonest errors of educated persons. It is supposed to have something to do with fruit, whereas it comes from the Latin and means enjoyment. Fructification or fructuation means 'fruiting'. The Oxford Dictionary points out that the use of 'fruition,' in Sir Anthony's sense, is a common modern error."

State Lotteries.

State lotteries add to the incomes of foreign governments. In Italy they bring the government in a sum of nearly £2,500,000 a year. In Prussia the profits of the public lottery amount to no less than £4,250,000. The Dutch government gets the nice little sum of £50,000 profit out of its lottery. Portugal makes about £70,000 in this way and Denmark a profit of £58,000. In Brazil, where the government does not itself run the lottery, but collects a tax on the receipts of private lotteries, the amount realized is £17,000.—London Queen.

A WHOPPER CAUGHT.

Monster Whale Captured Off This Coast by Fishing Steamer Wharton.

The Star yesterday received a communication signed by Capt. George Chertough, at Southport, in which it is stated that the fish-steamer Joseph Wharton, of the Cape Fear Fisheries Company, at Old Brunswick, had just towed in there at 6 o'clock a monster Wright whale, captured on the outside while looking out for menhaden the night before. The whale measured about 75 feet in length and its estimated weight is 90 tons or 180,000 pounds, the largest on record as having been captured off this coast. The giant mammal was taken up to the fisheries and will be cut up for fertilizing purposes. Capt. Chertough says this is the second big fish caught by the Joseph Wharton's crew this season.

Whales have been brought in off Southport before, but nothing like the size of the one by the Wharton yesterday. It is to be regretted that in the above communication received by Capt. Chertough he did not give more particulars of the remarkable capture.

Rules For Care of Bathroom and Its Appurtenances.

If the bathtub is of zinc instead of enamel have it painted with enamel paint as speedily as possible, as it is more sanitary and avoids the constant polishing of the metal. The porcelain tubs will get streaked, even if carefully wiped out after every bath, and it becomes necessary every two or three days to scrub them with soapy brushes dipped in borax or soda in order to remove these defacements. The same method will be required in keeping the washstand in good condition. A flannel cloth dipped in gasoline or kerosene will answer this purpose excellently.

The faucets, pipes and metal rods for towels must be polished once a week with polishing paste and a flannel cloth, rubbing until a shine is produced and wiping off with a dry one afterward.

Household Helps.

When broiling steak try brushing it over with butter and flour to keep the juice in.

If freshly cleaned tiles are rubbed over with paraffin they will keep clean for a long while.

A few drops of lemon juice added to scrambled eggs while cooking will improve them.

To remove fly specks from varnished surfaces use equal parts of water and skim milk warmed.

Discolored china baking dishes can be made as clean as when new by rubbing them with whiting.

Larded Halibut.

Have the halibut steak cut an inch thick and larded by drawing matchlike strips of firm salt pork through, so that they will stick out on both sides of the fish. Heat a frying pan, put in the fish and as the pork fries the fish will cook. Turn once and serve on a hot platter. Sprinkle with lemon juice and spread with a little butter which has been creamed and mixed with a teaspoonful of finely chopped parsley.

A Silver Hint.

If the box containing silver polish, a small bottle of alcohol, soft flannels, chamois skins and brushes be kept in some convenient place in pantry or kitchen it is a trifling matter after each meal to rub the few pieces of silver discolored by egg, salad or what not. By this means the weekly silver polishing may be lightened or done away with.—Harper's Bazar.

For Stains on Wood.

If the wood is unpolished apply spirits of salts to the spot, then scrub well with soap and water. For polished wood drop a very little sweet spirits of niter on the stain, using a fine camel's hair brush for the purpose. Immediately afterward rub on a little sweet oil and polish with a soft duster.

Rust Stains on Linen.

Soak stained linen all night in very sour milk. Rinse with clear water in the morning and lay in the hot sun. Wet every hour with lemon juice. At night soak again, rinse in the morning and repeat the sunning process until the spots are effaced, when wash in the usual way.

Ironing Linen.

Be careful at each ironing to fold the table linen a new way if possible, as it wears first in the folds. A good plan is to purchase an extra half yard of tablecloth and after a time cut off the extra length. This brings the creases in a new place.

To Cool the Oven.

If you are baking anything and the oven gets too hot put in a basin of cold water instead of leaving the oven door open. The cold water cools the oven, and the steam rising from it later prevents the contents from burning.

Bleach For Sunburn.

An excellent bleach for sunburned arms can be made from one pint of rosewater, one ounce of lemon juice and one-half an ounce of borax. Shake well before using and apply after bathing the arms with warm water.

Cleaning Zinc.

The best way to clean zinc is to dip a piece of cotton in kerosene and to rub the article to be cleaned with it until all the dirt is removed. Rinse with hot water and dry with a clean cloth.

MEDICINAL PLANTS.

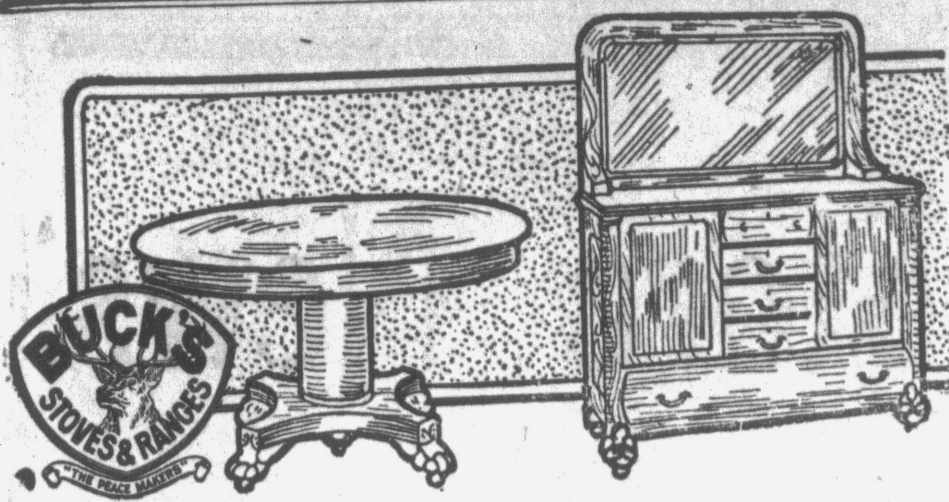
They Were Cultivated In Gardens In the Elder Pliny's Time.

After the discovery of the medicinal properties of plants it must have followed in course of time that representatives of the species to which remedial properties were attributed should be collected and grown in some place conveniently and readily accessible, as need demanded. The last step did not immediately follow, however, since among the conditions which were earlier supposed to influence the potency of medicinal herbs, the locality in which grown and the mysteries attending their collection were of the greatest importance. The first authentic record of the introduction of medicinal plants into cultivated plots of ground dates no farther back than the time of the elder Pliny, 23-79 A. D., who writes of the garden of Antonius Castor, at Rome, in which were grown a large number of medicinal plants. This step may have been taken much earlier by the Greeks, Chinese or Mexicans, however.

Later the Benedictine monks of northern Italy paid great attention to the growing of remedial herbs and devoted an important proportion of the monastery gardens to this purpose. This practically was also carried beyond the Alps, and in 1020 a garden was in existence at the monastery of St. Gall, in Switzerland, a few kilometers distant from Lake Constance, which contained sixteen plots occupied by medicinal plants. A garden of this character was founded in 1309 at Salerno and another in Venice in 1330. In 1309 the Benedictine monks founded an academy called "Civitas Hippocratica" at Monte Cassino, in Campania, which appears to the writer to be among the earliest schools, if not the first school, of medicine and established in connection with it a "physic garden."
