The bride was dressed in white Duchess satin trimmed with point lace and pearls and carried a shower bouquet of lillies of the valley. "Mary Smooth was arraigned in Essex Market court today, fined \$1 and locked up because she didn't have the money. She is a negro woman and was accused of being a black witch.

"When arrested she wore a cape. She said it was made from the skin of a dog, which was one of seven pups, each of which had seven toes, and all of which had been born in a graveyard in North Carolina, at 11 o'clock at night, under the lee of a monument to a man who died at the age of 44 years.

"The technical charge was one of disorderly conduct. It is alleged that she frightened the residents of 366 Cherry street. The complaint was Mrs. Sadie Sabatkin

"Saturday afternoon Policeman Delaney was in Cherry street when Sadie Sabatkin ran to him, saying that a witch was in the house putting spells on the tenants. Delaney found that the 'witch' had already put a spell on Sadie's brother by means of hitting him on the head with a horseshoe which she carried as a charm. With the charmed horseshoe the 'witch' was just then making hypnotic passes at a few others. She was standing on a hot stove and five women and four men were attacking her.

MORE LAND THAN WE THOUGHT WE HAD.

The United States Government Survey has just issued from Washington a bulletin which represents the result of the conference and co-operation of the land office, census office and geological survey in an effort to determine what constitutes "the area of the United States." The absence of standard measurement for ascertaining the area lead to a discrepancy between the tables of the census office, made in 1887, and those of the general land office, arranged in 1889. The results of the co-operation of the departments is that the area of the United States proper which is given as 3,026,739 square miles, has been increased over the census figures by 1,118 square miles. The bulletin gives the area of Alaska of 500,848 square miles; the Philippines, 115,026; Hawaii, 6,449; Porto Rico 3,435; Guam 210; Samoa 77, and the Panama Canal strip 474 square miles.—Wilmington Star.

PRÉSIDENT MOORE COMING.

He will Again Take the field and Address the Cotton Farmers of the State.

By order of the executive committee President C. C. Moore will at once again take the field in the interest of the cotton association. Among the places at which he will speak are: Kinston—Nov. 29. Greenville—December 1.

It is highly important that these meetings shall be well attended, especially by the cotton farmers. After the speaking Mr. Moore desires to have a conference with the officers of the association in each county he visits. This conference is for the purpose of getting in closer touch with the various officers of the county divisions and to inaugurate some plan by which more effective work can be done.

The association has accomplished a great work. The present price of spot cotton 11½ cents in Raleigh for the best grade is a silent testimony of the value of the association to the farmers and an index to its importance as a factor in the continued prosperity of the South.

Nor should the monthly meetings, December 1, be lost sight of. At every court house in the cotton growing counties there should be a larger gathering of the cotton farmers of the counties to take part in those meetings and by their presence show their loyalty to the association.

From now until the State meeting in January is but a short while, but by united action much can be accomplished and an impetus can be given to the association at that meeting that will mean much to our people

He knew nothing of the uses of sulphur.—New York Press.

Mrs. Small was loud in her expressions of praise.

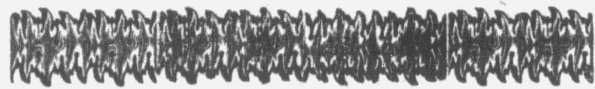

SHODDY LEATHER.

"It's a fierce age, this," sighed the shoemaker. "They are making shoddy leather now. It's worse than shoddy wool. They buy up all the old boots and shoes, and they throw them into a big machine and grind them into a coarse powder. Whir-r-r goes the machine, and in at one end fly the old shoes, while out at the other gushes a chocolate colored dust. This dust they mix with about 40 per cent of melted india rubber, and the mixture they press out as thin as pie crust under huge rollers, applying a pressure of 10,000 pounds to the square foot. They color it afterward and put it on the market. It is used in cheap shoes. The man who had sole and heel you for a quarter is buying a lot of it. Shoddy leather—wonderful stuff. Wear? How does it wear? Why, man alive, nobody wants it to wear. The idea is to make you use it up as quick as possible and then come back again for more."

Too Good a Citizen.

A sad wife writes complainingly to the editor of the household department of a popular magazine that her husband is altogether too good a citizen and wants to know if there is any cure for it. By degrees the county, the town, the church, the poor and the Young Men's Christian association have encroached upon his hours out of business until now she sometimes feels that she needs an introduction to him. He is busy every evening, being a model citizen. Elementary Life Cells.

Professor Ledna of the Nantes Medical school asserts that he is able to produce elementary life cells. He styles them "living cells," because when placed in suitable conditions they increase and multiply. The professor's researches began with the lowest forms of inorganic matter contained in fluids and after observing their maternal powers of reproducing their own tissues set himself to work to try to reproduce the process. This he says he has succeeded in doing. A professor of botany to whom the process was exhibited is said to have taken the artificially produced cells for those of real vegetation. Professor Ledna has not attempted to bring his cells into tissue or to give them roots.

The cankerworm's eggs are very small and very numerous, and it takes the bright little chickadee's eyes to find them, and when he has found them he eats them for breakfast, dinner or supper, it matters not which, and as he eats at least 250 for one meal, his every meal is a great benefit to the farmer.

THE FIRST LIGHTHOUSES.

They Were an Outgrowth of Beacon Fires on Headlands.

When ships are sailing upon the ocean the lights of heaven are their guides. Even in the dark ages, when the compass and sextant were unknown instruments, the seemingly motionless pole star hung like a beacon light in the northern heavens, and the rising and setting of the sun and stars distinguished the east from the west. When, however, ships came near the land the lights of heaven are not sufficiently safe to guide them. Rocks lie in their paths, unseen in the night; reefs and shoals spread under the water, while unsuspected currents sweep the frail craft all blindly upon these dangers.

Nevertheless, ships were sailed along dangerous coasts for centuries before a plain system of marking dangerous places was invented. Bands of robbers, or, as they came to be called, "wreckers," would hide themselves somewhere near the haven sought by a richly laden vessel and, after overpowering the fire keepers, would extinguish the beacon fire on the night on which the ship was expected. Then they would light another fire near some treacherous reef. The mariner, sailing boldly toward the false light, would dash his vessel to destruction on the reef, whereupon the robber band would plunder the wreck and make off with the booty. —St. Nicholas.

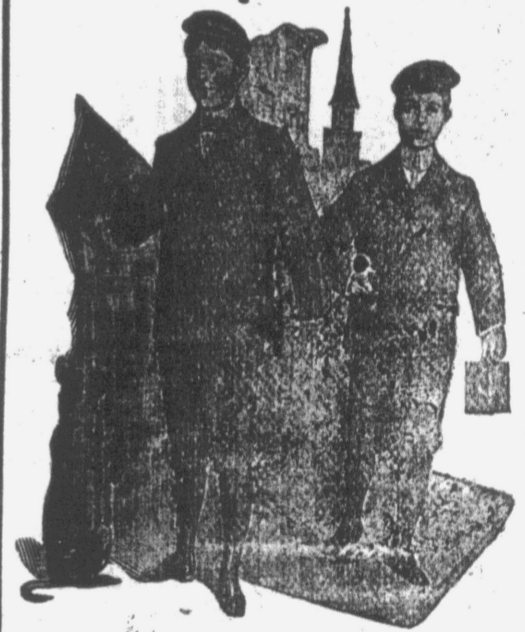

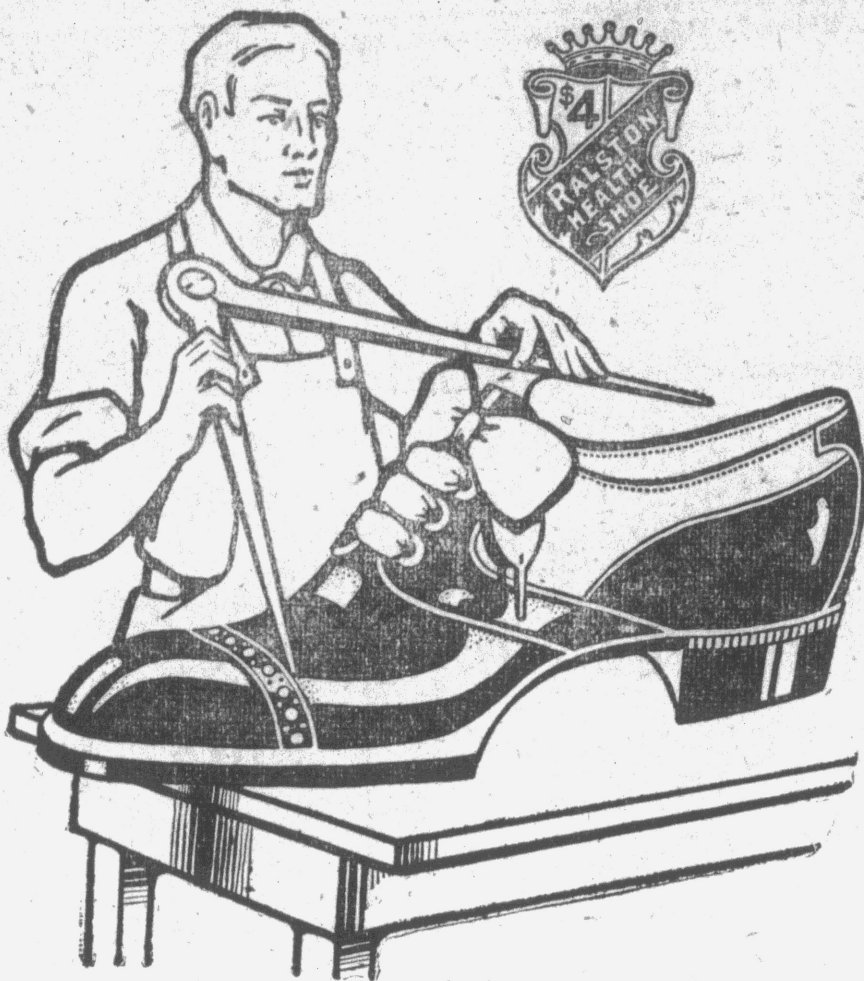
