

PITT GETS THERE.

Representative Laughinghouse Wins Out on His Bill.

The old saw, "he laughs best who laughs last," was Laughinghouse's amplified yesterday, and refreshingly. On Wednesday, the bill introduced by the able, handsome and aggressive representative from Pitt, Mr. Laughinghouse, providing that prisoners awaiting trial confined in jails, might, upon application to do so, be allowed to work on the roads until the coming of court, instead of pinning and lying in idleness in county jails. The bill at first seemed all right, and was about to slide through without friction. But Mr. Douglas, the very able, sincere and uprorious member from Wake, jumped on it, shedding tears almost over the possibility of this industrious motive on the part of an ignorant prisoner in going to work on the roads, injuring his chance of acquittal before a jury, when a hard hearted solicitor should ask the question, "Haven't you just come from working on the chain gang, etc.?" This produced a panic among many lawyers of the body, and there was a wild scramble to have their counties exempted. It went further. Many members sent up amendments calculated to bring ridicule on the measure. In the rush and rustle, Mr. Douglas directly twanged an arrow, by moving to table the bill, and before anything could be done to stay its onward course, the legislative missile struck the bill dead.

But yesterday, Mr. Laughinghouse introduced his little bill again, making it apply only to the county. Wednesday, as he stood towering in his place, gazing in astonishment, if not disgusted surprise at the panic over his little bill and the ignominious death, he made a fine picture for the legislative artist. The expression on his countenance then might have made unnecessary the emotion the picture was designed to portray, for every lineament of that strong, brave physiognomy suggested Pucks thought, "What fools these lawyer mortals can be."

But yesterday, the same gentlemen stood there, as silent as before, but the fierce, astonished look was replaced by a benign, half smiling purse of the lips. It was a finer picture of a finer emotion than the one of the day before. Like unto the expression of pride with which a grandfather lovingly contemplates the gambols or the prattle of his latest born grandchild, so was that of Mr. Laughinghouse yesterday when he viewed another scene his little bill produced. Instead of a rush and rustle of amendments fluttering to the speakers place, asking to have counties excepted, the rush, this time was to get backed onto the Pitt county bill.

First came the big old county of Guilford, then followed Mecklenburg, then Lawyer Bickett, of Franklin, hitched this fine old county on and then there followed an avalanche until over twenty counties had taken advantage of this law, which a practical farmer and business man had evolved and stuck to; until he got it for his own people, in spite of the world, the flesh and the devil.—Raleigh News and Observer.

A party of gentlemen, lovers of good wholesome amusement, were discussing the above query. One suggested that perhaps the average "Popular Price" show was nothing but a cheap show at cheap prices, that the reason this class of entertainment could be produced at remarkably low prices, is due to the fact that repertoire companies are composed of inferior talent, employed at low salaries. The above remarks were unintentionally overheard by a member of a certain "One Nighter" then playing the theatre. He remarked as follows: "I have traveled myself with repertoire shows, and if I had wholly my choice in the matter now I should still be with one; from the fact that traveling daily, with the toil and hardships that it incurs, makes an actor somewhat fatigued and disabled for honest, hard work. Here is where the actor with a repertory show has one advantage, as the majority of these companies play one week, instead of one night only at every stopping place. A manager of the "cheaper" show has one seventh of current expense to that of the "One Nighter" manager, regards to board bill, and transportation. He can amply afford to offer his performers just as handsome salaries as any other manager, by thus economizing in the other expenses of the show."

The party thanked the actor kindly for the information and probably has wider views regards the "cheaper attractions."—New York Herald.

PUBLIC ROADS.

The State Should Aid in Every Public Way in Building Highways.

Every encouragement should be given to the building of good roads. As I said in my inaugural address, mud, next to illiteracy, levies the highest tax on a State, and had roads, ere a curse, and a hindrance to the business, education and progress of a people.

A general up-to-date road law should be enacted, allowing any county or community to have the question of a bond issue for the improvement of roads submitted to the people; for the present law is not full or complete enough. One only has to look at the counties in the State that have, and those that have not, good roads to see what good roads mean for the growth and wealth of a community. Hence the State should aid a road building in every possible way, thus adding to its upbuilding and development.—Extract from Governor Glenn's Message.

KINGSTON HORROR GROWS.

Dead Between 500 And 1,200.

According to information received today the Kingston horror is growing. Communication with the island is partially restored, and every message that comes through brings fresh details of the appalling catastrophe. The number of dead is variously placed at from five to twelve hundred and the number of injured runs into the thousands. Ten thousand people are said to be homeless. The danger of famine has increased and with it stalks the spectre of pestilence. There is urgent need of supplies of all kinds, and energetic efforts are being made in this country and in England to send aid.

The business section of the city has been wiped out, and the estimates of damage range from \$10,000,000 to \$25,000,000. Among the dead and injured are a number of prominent English persons, and almost every dispatch adds a new name to this list. Eight Americans are reported as missing, and it is said that many tourists undoubtedly were crushed by falling walls in the shopping district. The American battleships Missouri and Indiana have reached the scene and American officers and sailors are standing by to render every assistance in their power.

A new horror is added to the situation by reports that the city seems to be slowly sinking into the sea. The contour of the bottom of the harbor entrance are said to have disappeared. The ships in the harbor are crowded with injured people, and the death list is being increased daily. Corpses lie in the streets, or are being thrown into trenches.

The fearsome extent of the appalling calamity that has visited the capitol of Jamaica has not yet been recorded to the outside world, and it is doubtful if even the people of Kingston themselves are yet aware of the full extent of the disaster that overwhelmed them last Monday afternoon.—Charlotte Observer.

APEX AND TOBACCO.

Company Chartered to Build Storage and Dry House.

Apex is one of the most progressive towns of its size in this section of the State. It is in the midst of one of North Carolina's very best tobacco growing sections, and her people, as well as those living in the surrounding country, are wide awake and enterprising.

A movement of no small importance is the one beginning some time ago to establish there a tobacco storage and dry house, well capitalized, where leaf tobacco may be stored by the growers and money obtained in loans thereon, a receipt from the house being available as collateral for loans. In this way tobacco growers who have tobacco and need money for it, will be enabled to hold the leaf for better prices. Few farmers, if any, have suitable storage houses to keep tobacco in proper condition for any considerable length of time.

The movement has resulted in the incorporation of a company to build and operate the house. Certificate of incorporation was filed yesterday by Apex Farmers' Consolidated Tobacco Company. The capital stock authorized is \$125,000 divided into 12,500 shares of the par value of \$10. The company may organize and begin operation when \$300 of the stock has been subscribed for. The incorporators are Messrs. A. T. Olive, W. H. Harward, A. B. Hunter, L. S. Olive, Percy J. Olive, S. S. Rogers, A. C. Hughes and J. R. Cunningham.

The objects as set forth in the certificate are as follows: "To buy, sell, handle and in any manner deal in and with leaf and manufactured tobacco; to manufacture tobacco into plug, twist, cigars, cigarettes, cheroots, smoking tobacco and any and all other forms; to own, lease, erect, maintain and operate tobacco warehouses for the handling and sale of leaf tobacco upon commission or otherwise, and also prize houses, stemmeries and any and all other houses or factories in or out of the State in carrying on a general tobacco business; to own, lease, erect, maintain and operate storage houses and to issue receipts for tobacco stored and to advance money or other credits upon such tobacco, which receipts shall be transferable and shall entitle the holder to the property stored, etc."—Raleigh News and Observer.

The company mentioned above is similar to the Farmers Consolidated Tobacco Company that has been doing a successful business here the last four years. In fact Mr. O. L. Joyner, originator and president of the company here, on request of the people of Apex went there and explained to them how the business of his company was conducted, and they adopted his plan in organizing this company.

It speaks well for the Farmers' Consolidated Company that their methods of doing business are attracting attention throughout the tobacco growing sections. It is really the most practical or-

ganization for their own benefit that we have known the farmers to come together in several other sections have made requests of Mr. Joyner to go and help them get started.

THE DEVILFISH.

The Ability to Change Its Own and the Water's Color.

"I was lying on a rock watching the movements of some land crabs which kept retreating from the water as the tide rose, when suddenly a crab dashed frantically from the water, and out after it galloped—there is no other word for it—a devilfish nearly two feet across," writes an observer from Avalon, Cal. "The animal continued the chase a short distance, lifting its tentacles in the air in a sort of overhead motion; then, finding pursuit hopeless, it withdrew with a peculiarly unpleasant, writhing, gliding motion characteristic of these animals. Upon reaching the water it stationed itself just at the edge, so mimicking the color of the bottom that when I glanced away and looked suddenly back I could not at once distinguish it. This devilfish had the appearance of a cat watching for mice, and when a crab was seen it would shoot out a long, attenuated tentacle and attempt to seize it. By carefully insinuating my way to the water's edge I quickly grasped the specimen and after a short struggle tore it from the rocks and secured it.

"At various times I had from three to five devilfishes in an enclosure where I could watch them change color and test their strength. In confinement, if the tank bottom was dark, they assumed various tints, generally a dark reddish brown, but the largest one was a tigerlike creature, about three feet across, with a ground of livid white covered with black or dark gray blotches, giving it a truly fiendish appearance, especially as the eyes were conspicuous and appeared to emit lambent gleams. The change of color was marvelous in its rapidity. In a special tank in which two of these prisoners were confined they occupied the corners, facing outward, with arms either coiled under or above them. At any offensive movement on my part, presenting my hand under water, the color scheme would change. A blush appeared to pass over the entire surface, and in a large squid I can only compare it to heat lightning—a rapid and continued series of flushing and paling, from deep brick red to gray.

"It was very evident that the animals differed much in pugnacity. Some did not resent my touching them; others merely threw a tentacle in my direction, while one never touched me, but directed its siphon at my hand under water and sent a violent current in that direction, apparently endeavoring to blow my hand away. It was fascinating to observe the range this water gun had and how by seeming intuition the devilfish could direct it at my hand as I slowly moved it about while attempting to attract the animal's attention in an opposite direction."

When Hoops Began.

When were hoops "in" for the first time? According to Strutt, "trundling the hoop is a pastime of uncertain origin, but much in fashion at present" (1801). Dr. Murray's dictionary, incidentally remarking that the original hoop affected by boys was a barrel hoop, gives no English reference to it earlier than 1792. But the hoop was well known to ancient Greek and Roman boys, who called it a "trochus" (wheel). Their hoops were made of bronze, and representations of them on gems show that they were driven by a little hook with a wooden handle, very like the modern boy's hoop stick. This was called by the Greeks "elater" (driver) and by the Romans "clavis" (key). Sometimes the ancient hoop had bells attached to it, and modern London may be glad to be spared at least that exasperation.—London Chronicle.

Unfortunate Omission.

One of the most singular instances of punishment for an oversight was that shown by the commitment of an almanac maker to the Bastille in 1717. It was made out by order of the Duke of Orleans, regent during the minority of Louis V. of France, and read as follows: "Laurence d'Henry, for disrespect to King George I. in not mentioning him in his almanac as king of Great Britain." How long this unlucky almanac maker remained in prison is unknown. The register of the Bastille, examined at the time of the revolution, failed to throw any light on the subject.

Beards and Battles.

Shaggy locks and patriarchal beards have proved highly inconvenient things on the battlefield. Does not history record that Alexander ordered the Macedonians to be shaved lest their beards should give a handle to their enemies? Peter the Great was also a friend of the barbers, for he not only ordered all ranks to be shaved, but caused officers to go about to cut off the beards of offenders by force.
