**Deterioration of American Railroads.**

We have had a long series of years of vast prosperity. The general business of the country has been able and willing to pay for the making of good railroads, for ample, modern equipment, and for prompt, rapid service. Furthermore, the shipping public and the investing public together certainly have paid over to the men in railroad control an amount of money quite sufficient to have given us a series of trunk lines like those of England Germany, with well-graded roadbeds, heavy tracks, permanent bridges, decent stations, ample terminal facilities, and good rolling stock and general equipment. For all these things our prosperous American public has not only been willing and able to pay, but has actually plunked down the money. What is the result? We have a small and select population of plutocrats who control our railroads and have somehow managed to put into their private pockets some hundreds of thousands of millions of dollars through their ability to skim the cream off the country's prosperity, while at least a hundred thousand miles of our railroad system has become unfit for the ordinary needs of current traffic, with rotting cross-ties, light rails, wooden trestles, instead of permanent bridges, sharp curves and bad grades surviving from the early period of railroad engineering, shabby and miserable stations, and a general incompetency in equipment and operation that has fallen to a stage of helplessness and despondency, where it has ceased either to apologize or to be ashamed.—From "The Progress of the World," in the American Monthly Review of Reviews for February.

**A NEGRO CAPTURED.**

**Runs From Officer and is Captured After a Lively Chase.**

As Deputy Sheriff S. I. Dudley came out of his home in West Greenville, Friday afternoon, to return to the office, he saw a negro about 50 yards down the street. Nothing unusual in his seeing a negro, and that in itself gave him no concern, but no sooner did this particular negro put eyes on the officer than he struck out in a run. This aroused Mr. Dudley's suspicion that the negro had done something and he decided to give him a chase, even if the negro did have a good start of him.

The negro went to dodging around corners making for the railroad, but the officer was the best sprinter and was gaining on him. The negro cut across Mr. E. B. Ficklen's lot just as that gentleman was coming out the door, and the latter seeing Officer Dudley following called to know if he wanted the negro caught. "Yes, catch him," the officer shouted back. Mr. Ficklen whistled up his dogs and with them put out after the negro. They were just bird dogs, but they made it warm for that coon as he burnt wind down the railroad, and brought him to bay about half way between Fifth street and the depot.

Officer Dudley escorted the negro to the sheriff's office. His name was Tom Bryant, and upon examining the records three warrants were found outstanding against him, one of them eight months old. Tom had been away from this section and had just come back. Being a fugitive he naturally thought the officer was after him on first sight and his running off gave him away. He was given quarters in jail.

**Tax Assessing Year.**

This is the year for tax assessing. The county commissioners are apt to appoint these tax assessors on the first Monday in April for each township. These men must be freeholders, and must have been residents of the township at least twelve months. It shall be the duty of this board to sit during the month of June for the purpose of assessing taxes for their townships. The laws say that they shall determine the value of each piece of property by its "true value," and expressly states that the value shall not be fixed at what the property would bring at "forced" sale, but what it would bring at a "cash" sale. The law is explicit, and if the assessors who shall be appointed will read the law they will be more careful in their valuation.

**INLAND WATERWAY BILL.**

**Simmons Pushes it in Senate.**

Senator Simmons has introduced a bill appropriating \$704,000 for connecting the Albemarle, Pamlico and other sounds and rivers with Beaufort inlet. The engineers who made the surveys under the provisions which Senator Simmons had incorporated under the last river and harbor bill, estimate that this connection by a 12-foot canal can be made by the expenditure of the amount mentioned. Of course this is a part of the much-discussed inland waterway, advocated by Mr. Small, and which received no recognition from the House committee. Senator Simmons is entertaining a lively hope that something will be done for the project when the river and harbor bill reaches the Senate.—Washington Cor. Charlotte Observers.

**THE LEGISLATURE**

**What the Law Makers Are Doing.**

Friday's session in the senate was marked with a long debate on the bill to put solicitors on a salary basis. After being amended so as not to become operative until 1909 it passed second reading. There were several new bills, but all of practically minor importance.

In the house there was a petition from Martin county asking that the homestead law be abolished; also a petition from citizens of Bethel, Pitt county, asking for a dispensary. Representative Jones introduced a bill to establish the dispensary. There were no bills of general importance among the new ones introduced.

A prophecy says that this year the rich will satisfy their wants at the expense of the poor. We thought that was the game that had been going on all the time.

The Alabama legislature failed to adopt a resolution endorsing President Roosevelt's actions in dismissing the negro troops. It was a matter some other States might have let alone.

North Carolina is not the only State that is after the railroads in the matter of rates. The Alabama legislature has passed a bill fixing passenger rates two and a half cents per mile.

It looks like Congressman Livingston's resolution to investigate the New York cotton exchange is going to amount to something. A sub-committee has voted unanimously to recommend that such investigation be made.

We do not believe that bill proposing to issue bonds for \$750,000 to build a new State capitol will ever get out of the committee room. It ought not to. Too many other things are needed worse.

The North Carolina General Assembly passing a divorce bill that was mainly for the benefit of one particular person to get a divorce, as was claimed by some of the members in their speeches of opposition to it, calls to mind that the Florida legislature once passed a law to enable a millionaire of that State to get a divorce from his wife because she was confined in an asylum, and he hastened to North Carolina and married another woman. Such divorce laws are wrong. The Bible lays down a rule for divorces, and there should be no other.

The railroads missed their chance two years ago when a bill was up in that legislature to make passenger fares two and a half cents per mile. If they had acquiesced to that rate we have our doubts if there would have been a single bill introduced in the present legislature looking to a reduction of passenger rates. But the railroads fought the matter vehemently then and won, so that the fight has to be made over this time, with the bills calling for even a lower cut in rates than was proposed two years ago. If the railroads should win this time—though it does not look probable that they will—the same fight will be on again two years hence. The railroads would save trouble and money by submitting to a reasonable reduction in rates and bringing the controversy to an end.

## THE DOOM OF VENICE

IT MAY BE TO LIE IN THE BOSOM OF THE ADRIATIC.

The Famous Bells of St. Mark's May Tell on Ocean's Depths Like Those of Old Port Royal—The Sunken Cities of the World.

It is believed by many that Venice is sinking into the Adriatic and that the gradually will disappear beneath the waters of the great lagoon from which her palace crowned islands arise. Other cities have gone that way before her, and ships now sail over spots which were once teeming with a populous life.

At the entrance to the harbor of Kingston, Jamaica, the original city of Port Royal lies fathoms deep beneath the blue and sunlit waters of the Caribbean sea. A narrow strip of land, on which are a small settlement and a fort, is all that is left of what was once the richest and wickedest town in the West Indies. It was the resort of pirates, who rested there from their depredations and made the city hideous with their revelry. But these pirates brought great stores of their loot to the city, and its commerce grew and flourished. Palaces and churches were built, a pirate often striving by a rich endowment of a church to square his accounts with heaven.

Throughout the greater part of the seventeenth century no town in the western world was so magnificent as to its buildings or so luxurious as to its habits as Port Royal. Then one day in 1692 the anger of the Lord shook the island of Jamaica, and the greater part of Port Royal sank beneath the sea, carrying with it hundreds of its inhabitants. Towers, churches, palaces and forts went down, many of them not tumbling in ruins by the shock, but sinking bodily beneath the waves.

On a bright day, sailing over the spot where Port Royal once stood, one can look far down through the clear water and see the remains of the city still standing there on the ocean bottom, with fishes swimming about among its towers and great tropical seaweeds waving from its sunken walls.

The negroes of Jamaica—and some white people, too—will tell you that before a storm the sunken bell of the great cathedral which went down with the city on that awful day in 1692 can be heard distinctly tolling below the waves, rung as a warning by the ghostly hands of the spirits of departed buccaneers which haunt the submarine city. People who do not believe in ghosts, but think they have heard the tolling of the bell, say the explanation is that when the city sunk the great bell of the cathedral was not thrown from its place, but still hangs as it originally did. The coming storm before it reaches Jamaica stirs up the waters of the Caribbean and sends in upon the shore deep waves, which roll through the sunken city and set the bell tolling.

Another sunken city of renown is Balae, that splendid resort on the Italian coast where Nero and Caligula "reveled and drank deep." A straggling village and heaps of marble ruins still stand upon the shore and bear the name of Balae, but the greater part of the city lies beneath the waters of the Mediterranean, and tourists from Naples go out there to gaze down into the waters and try to catch a glimpse of the submerged city.

The resort of all the wealthy nobles of Rome when Rome was mistress of the world, Balae was a marvel of luxurious splendor. Palace after palace was built on the shore, and architects designed magnificent structures extending out into the sea.

When Rome decayed and the Goths ravaged Italy, Balae was sacked by the invaders. Soon after the city began to sink. First the buildings which had their foundation in the water subsided beneath the waves, and then the sea made an attack on the land. Gradually the shore line receded, and the Mediterranean flowed through the streets where Hadrian had driven his imperial chariot and Horace had walked thinking of his next poem.

These promontories, crowned with grand towers and gorgeous palaces, were undermined and toppled into the deep until at last the major part of the splendid city was submerged. Its disappearance was not sudden, like that of Port Royal, and due to some convulsion of nature, but Balae went down to its death gradually, as Venice is said to be going.

In Holland the subsidence of the land has brought it about that many towns once populous are now covered by the sea. The old Roman camp at Brittenburg, after sinking beneath the waves, emerged again in 1520, only to disappear, and its remains now lie in deep water opposite the town of Katwijk. The original Katwijk itself now lies beneath the waters, as also are the original towns of Scheveningen, Domburg and Egmond. In fact, a succession of towns bearing these names lie now at the bottom of the sea, for they repeatedly have been rebuilt farther inland as the land sunk and the waves come in to take possession.

The Goodwin sands, large and dangerous shoals off the southeast coast of England, were once above the water and formed a flourishing estate the property of Earl Godwin. There was no city on the Godwin estate when it subsided beneath the sea, but several small villages went down to the deep when the tract of country gradually disappeared beneath the waters.

## CRAB CLAWS.

A Seville Tidbit, Eaten More For Fun Than For Sustenance.

Visitors to Seville see women carrying barrels full of crabs' claws, says a woman in the Paris Temps. The claws are cooked and people nibble at them more for fun than for sustenance, just as the Russians nibble sunflower seeds. But what is this crustacean? What becomes of the rest of him, especially if he is a crawfish, of his tail?

As a matter of fact the crawfish has no part in the business. The carrasquenas, as the claws are called, are taken from a salt water crab, the Gelasinus tangeri, which lives along the shores of Morocco, Spain and Portugal. Each little crab, with his one little wife, has a little cave for a home, and, adopting the Arab estimate of the other sex, he usually keeps his wife shut up inside the cave, meanwhile staying about the threshold himself and making a brave show with his big claws.

When the tide runs out the crab fishers prow along the beach looking for crab holes. Either the crab is stalking up and down seeking what he may devour, and thus showing whether he has fine claws, or he is still at home, and the size of his doorway indicates the size of the householder. In the one case the fisherman cuts off his retreat by blocking his front door with mud. In the other case he digs him out. Anyway, he deprives him of his pinchers and sets him at liberty—grow some more.

Right here appears the happiest feature of the whole affair, for the pinchers are not torn away from the crab at all. Instead he presents them to the fisherman—perhaps even with his compliments. It is a fact easily demonstrable that the crab can detach his claw by a muscular effort, thus making a hemorrhage, but leaving the stump in such condition that a new claw is soon grown. The fisherman simply takes Mr. Crab by the head, whereupon he lets go, leaving the claw with them and runs off home with out it. And as the claw is of any use to him or to anybody else in the water, he is not killed and edible, the fisherman naturally takes it home and sells it.
