

### GOVERNOR GLENN ON "THE CLANSMAN"

"I attended Mr. Dixon's play 'The Clansman' last evening, fearing from what I had heard that I would be disappointed and join with those who believe that the production of such a play would be of no benefit to our section. I am glad now that I went, for my views have undergone a complete change, and I unhesitatingly say that I wish every young man and woman in the South could both see and hear the condition of things through which their forefathers passed in the days of Reconstruction; for in so doing they would not only appreciate what they suffered, but likewise know the justness of their cause.

"It will do good also for the Northern people to study Southern conditions as presented in this drama. Mr. Dixon's play rises above his books. I heartily approve it, and believe it will do good. No respectable negro can take an exception to it, for it shows how kindly the true old servant was treated, and how only the ignorant, those who aspired to social equality or committed rape, felt the vengeance of those righters of wrong, the members of the Ku Klux Klan.

The play recalled to me many things I heard and saw while a boy; filled my heart with the feelings that then were uttermost in the minds of our people, and I thank God that peace has at last come and our country once more is prosperous.

"Success to the play is secured in the South and I believe it will be gladly received by the better class of thinking people in the North."

### RESOLUTION ON 1907 COTTON ACREAGE.

The following resolution was passed by the great convention of the Southern Cotton Association held in Birmingham.

"In view of the fact that a great many farmers have adopted the intensive system of farming, increasing the yield per acre and new territory each year is being planted in cotton that heretofore has not grown cotton, thereby increasing the production, therefore in order to maintain satisfactory and remunerative prices, we urge and recommend a full reduction of 10 per cent. of cotton acreage for the year 1907."

"We further recommend that the acreage so reduced be planted in food crops."

"We are sure that unless the farmers unitedly reduce their acreage of cotton that they will be confronted at the end of the season with equally bad, if not worse conditions than they were in 1904, when cotton went down to 6 cents per pound.

### GOVERNOR FAVORS EASTERN SCHOOL.

Sends Special Message to Legislature Urging that it be Established.

On Tuesday Gov. R. B. Glenn sent a special message to the legislature touching a number of important subjects. One of these was the proposed training school for teachers in Eastern North Carolina. That part of the message relating to the school is as follows:

"Gentlemen:—When I was inaugurated governor of the State, two things I promised faithfully to do: First, to see to it that no backward step was taken in the cause of education, but that everything possible would be done to advance the great work begun by my predecessor, Hon. C. B. Aycock, and second, that in all things I would try to encourage enterprises and developments that tended to the industrial growth of our State. I therefore send you this special message in regard to these two vital interests of the State. Large delegations from Eastern North Carolina are now before you, urging the establishment of a training school for girls, at some point east of Raleigh. They state with great force the need of efficient white teachers for their public schools, claiming that out of three thousand white teachers east of Raleigh, not over one third have had any training such as fits them to be teachers. They say they are making no war on the State Normal and Industrial college at Greensboro. On the contrary that every advantage possible should be given that institution by the State, in order to insure the better and higher education of our women, but they claim on account of expense and other causes, very few of the Eastern girls can attend the Normal, and that of those that do attend, 95 per cent. teach in the cities and towns and only 5 per cent. in the rural districts. They likewise show that the western girls are afraid of the climate and will not go east, thus causing a great lack of competent teachers in that section. They are here urging the establishment of a school of a lower standard than the Normal, and yet of a higher order than the country schools, and therefore ask for a training school where women can be taught how to teach, as well as be thoroughly grounded in the elements of a good practical education. They urge that they have paid, and still are paying a large per cent of the taxes necessary to properly equip and support the State Normal, and while not asking that one dollar be taken from its appropriation for their training school, yet they do ask that the rest of the State hear their petition, and grant them some relief from the conditions that now surround them.

"North Carolina is growing rapidly, especially educationally. The demand for teachers is increasing every day, and our country schools must be taught by competent or incompetent teachers, and the only way to insure competent teachers is to have them properly trained. Read my message to you at the beginning of this session, and you will see my estimate of the usefulness of the State Normal, and my earnest desire to give it all that is needed to make it one of the foremost—if not the foremost educational institution in the South—but while this is true, I can see no hurt to this great college in having another

school of a lower grade where instruction in practical teaching may be given, to the end that our public schools in the east be better equipped with thorough teachers.

"As I understand, they only ask \$25,000 for this training school, and this amount, in my opinion, could be advantageously spent in the east for a school, that while in no sense crippling the Normal, would be of great benefit to the cause of education. No friction or ill-will seems to exist against the Normal, but only the kindest of feelings. There is however one danger: If the eastern people continue to come as they do, session after session, asking help, and are refused because of the Normal, then human nature will assert itself and friction will occur that may prove injurious. It is my province only to lay the facts before you. Yours to decide whether the petition asked should be granted. I hope therefore that you will carefully hear all that may be said by the parties interested and then give them the relief asked for, if in your judgment it is a reasonable request and will result in ultimate good. The request strikes me as having great merit. Our State is large enough to keep up the Normal to its present high standard and still have training schools scattered over the State, that will remedy the wrong now suffered through incompetent teachers in our public schools, and though a western man myself, and deeply in love with the Normal and its great work in educating women, I can see no menace to that institution by granting a reasonable appropriation for a first-class training school somewhere in Eastern Carolina."

**YOU CAN'T STOP THEM.**

Jok Billings once said "I never argue or succumb." In other words when he saw a thing was coming he got out of the way and did not try to stop it. His motto might well be adopted by the people of this latter day to the saving of much needless worry. When the people make up their minds to bring something to pass it is mighty hard to stop them, and those who persist in throwing themselves in the way may expect to get run over. You can't stop an avalanche, nor can you check a determined people in a cause in which they are right.

This meditation comes up through observance of recent events. We have wondered why those engaged in liquor traffic have through the last few years tried to roll back the wave of temperance that was sweeping over the State. Just as well try to turn the course of a tornado with a straw. When the inevitable is coming it is best to submit to it.

The same can be said of other questions. The railroads had as well try to stop water from flowing down stream as to check the demand for lower freight rates and passenger fares. They are coming, and the more the movement is fought the greater will be the demand. They could save time and money by meeting the people with a voluntary reduction rather than make the fight and then lose out.

Another thing that is coming is the new county out of portions of Carthage, Harnett and Moore. A set of determined people on after it and it will be an issue in every campaign and before every legislature until it is established. As it cannot be stopped it is better to end the agitation by establishing the county and let the people interested get settled down to progress.

Just so about this movement for a training school for teachers in Eastern North Carolina. This is another of those things as sure to come as day follows night. Already it has been up before two legislatures, and if the present session should fail to establish it the next one will find it up with greater force than ever, and some opposing it will find themselves crushed before the avalanche. On and on the story might be continue with other things that are coming; for instance the extension of the corporate limits of Greenville, the reform of the jury system, the Laughinghouse fish bill, good roads, and so on ad infinitum. Yes, they are all coming.

Greenville and Pitt county are getting together for progress as never before.

Three weeks before time for adjournment the legislature is so busy as to be holding night sessions. And they are moving things. The session will make a record.

That was a graceful act of the house of representatives, Monday, when it adjourned for 10 minutes in honor of Miss Mary Lee, daughter of Gen. R. E. Lee. Miss Lee was escorted by a special committee before the speaker's desk and introduced. She expressed high appreciation of the honor.
