

## SEN. FLEMING ROASTS THE NEWS AND OBSERVER.

Lays It on for That Paper's Criticism of his Speech.

Senator Fleming of Pitt arose in the senate today and said: The amount of space given me on account of my effort on yesterday to stand by and defend the interest of the farmers, warehousemen and other interests of my county in this morning's News and Observer would seem a compliment, especially endearing the fact that the News and Observer has not heretofore been reporting me at all; but a careful examination of the false and slanderous insinuations contained in said paper show plainly to an unbiased mind that it was the purpose of said paper to cast aspersions upon my democracy and make me appear ridiculous to my constituents who read the News and Observer:

"I should not mention this matter here at all but for the fact that senators who heard what I said on yesterday seem to think that notice should be taken of the matter.

"I want to say to the senators on this floor that my constituents know my democracy, my honesty of purpose and integrity too well to allow anything that the News and Observer may say about me to shake their confidence in me. They know me and they know the righteousness of my fight on yesterday in their behalf, and they also know the News and Observer and they don't expect the News and Observer to give me a fair report any proposition, because they know I am above the control and dictation of the News and Observer or any other newspaper or person.

"They know and recognize me as a democrat of better and longer standing than the News Observer, and nothing that this paper can say will in any way affect their respect for me and their confidence in my democracy.

"To say that the report of what I said yesterday by this paper and its references to my attitude upon the question before the senate was unfair and unjust and contemptible in the sight of the decent and honest people who heard me goes without saying, and I shall content myself with the faithful and honest performance of my duty to my constituents in this senate, the News and Observer to the contrary notwithstanding." ## PROF. J. B. CARLYLE AT WINTERVILLE.

On Friday night, March 8th, in the chapel of W. H. S., Prof. Jno B. Carlyle, head of the department of Latin of Wake Forest College delivered one of the strongest and most eloquent speeches that the students and citizens of the town and community has ever had the pleasure of enjoying. He was at his best and held the large audience in almost breathless silence throughout his entire address.

His subject was: "The Man of the Hour" a theme which caught the ear of his hearers from the very beginning.

He reviewed the greatness of mediaeval and modern history by saying that the era of Martin Luther stood for intense religious enthusiasm, the Elizabethan for the revival of learning, that of Columbus for discovering, that of Washington for the achievement of liberty, that of the present for progress, prosperity and the winning of battle for democracy.

The man of today needs a broad intelligence; courage, faith and hope. Man must not only have the courage to do but the knowledge to do rightly.

The supreme duty of the home is to educate in the pursuit of knowledge for acquiring happiness, obtaining wealth, and a knowledge that will lift him up until he becomes in perfect harmony with all his surroundings.

The virtue that surpasses all others today is courage such as the Romans of old possessed. The supreme need of the hour is courage in our legislative halls, and in our highest courts where justice is meted out. By courage we take hold of the supreme trust of God.

Through faith, men have conquered nations, stopped the mouths of lions, put to flight armies and brought to pass the impossible with man. It was faith that caused Columbus to cross the Atlantic, Washington to fight for American independence, and Robt. E. Lee to call his men from the bloody conflict at Appomattox to the peaceful haunts of private life and there build up anew their beloved Southland. Just as the little willow that withstands the night torrent because it is deeply rooted in the solid rock beneath, even so it is with our men and women of today. Only those who are well grounded in the eternal principles of God are able to withstand the mighty torrent of greed and corruption of the present time.

Hope is to go forward. If like little dewdrops which falls from the mighty oak upon the rock and is soon parched, we sit down in despair, failure will be our reward; but on the other hand the dewdrop falls into the little mountain stream near the rock, then the creek and finally through the large river into the mighty ocean, even so we must enter the stream and go on to greatness.

Go to our legislative halls and there you will see that never in the history of the world are the powers of evil more strongly organized than at the present, while at the same time the powers of right were strongly arrayed against them.

At heart the people are honest. They have shown it in the manner in which they have risen up against the great insurance scandals, the dethronement of justice in our courts and the great flood of yellow journalism that has spread over our country. His closing appeal to the young men and young ladies to press forward in the battle of the value of such address can never be fully estimated.

## KEEP OUT OF DEBT.

As matters look shaky in Wall Street and business depression is generally foretold first from that quarter, it may be well for honest folk to take account of stock and see where they are at. There is no general appearance of trouble on the horizon of legitimate business, but it will be well to get out of debt until matters are more normal. There is such a boom on in prices that there must be some reaction and already the railroads are reducing expenditures and large building operations are being curtailed on account of the great cost of material.

Caution should certainly be observed until the next crops are assured, for we have been blessed with six fat years and experience shows that the lean years must follow. The high price of farming land in many States is based on present high prices of farm products and in many cases the price asked for farms will under the most favorable conditions only pay very reasonable interest and with lower prices and a shrinkage in crops would make but a very poor return on the investment. The farmer who is in debt might, if crops are poor, find himself in difficulties, and now therefore is the time to get out of debt, so as to be on the safe side if business depression arises.

As long as the trusts are protected by the tariff they will continue to charge high prices for their products, and with another Republican standpat Congress ahead there is but little probability of relief from trust exactions for the next three years, or until 1909, when the Congress elected next year will meet. So the cost of living is not likely to decline very much, unless a severe business panic occurs, which would cause factories and workshops to shut down or wages to be so reduced that the purchasing power of the people in the business centers would decline and so cause a tumble in prices.

Even under such distressing circumstances the farmer, who is out of debt is assured of a home and a comfortable living, and it may inconvenience him to adjust his living to a decreased income, but he will not be harnessed like his unfortunate neighbor who is in debt.

The Way an Expert With a Witch Hazel Bough Worked.

The inverted V twisted slowly until it was parallel with the earth or pointing straight out from the bearer.

He slackened his gait and moved ahead, while the telltale bough moved slowly down until it was pointing toward the soil. Now the "water witcher" had it so grasped that it was twisting in his fists, and the tender bark along the pliant ends was beginning to break, showing that some force other than muscular effort was pulling the bough toward the earth. When it pointed straight down, he stopped and heeled a mark in the grass.

Then he moved on, and very slowly the branch began to rise until at length it had returned to the perpendicular in its original position. The vein of water had been passed, and the witch hazel was no longer attracted.—From "A Water Witcher of Prairies," in Outing Magazine.

**TEACHER'S ASSOCIATION.**

Interesting Address by Prof. Carlyle. The weather was beautiful today and it brought out a large attendance at the meeting of teachers' association. There were more than a hundred teachers present and many who are not teachers. The exercises were exceedingly interesting and will be mentioned more fully by the association reporter.

A feature of the day was the address by Prof. J. B. Carlyle, of Wake Forest college, who after a witty and appropriate introduction by President McArthur made a speech that was inspiring and uplifting to all present. Prof. Carlyle's subject was "The school and the Community." He first mentioned the duties of the school to the community, that it should had in industrial life, in intellectual life, in social life and in spiritual life. Under each of these divisions he forcibly and eloquently portrayed the duties of the real teacher.

Then upon the duties of the community to the school he said the community should be constant and liberal in patronage—not stinting in praise, and should pay the teachers well, enlarging strongly on each of these points, Summing them up he said patronage is good, praise is better and pay best of all. "Patronage, praise, pay, these three, but the greatest of these is pay."

Prof. Carlyle's reference to the splendid educational progress of Pitt county and the great work of Superintendent Ragsdale was timely and appreciated. He is an earnest speaker on all occasions and his coming to Pitt county to speak will result in much good.
