

WOULD LIKE TO RUN A TOWN.

A New Solution Offered by a South Dakota Merchant.

A new solution of the municipal government problem has been suggested to the residents of Armour, S. D. One of them, a prosperous merchant of the name of Cantonwine, proposes to do the town business, all of it, exactly as a contractor might undertake to build a bridge or dig a sewer. Whether he proposes to fix and collect the taxes as well as spend them is not stated in the advices at hand, but he does offer to combine in his own person the activities of all its present officials and to run its public affairs, big and little, with no other help than of his own hired employees. Also, he promises to do this at an expense less than the town is now under and to do the work to the satisfaction of its citizens, under forfeiture of an adequate bond to that effect which he will give. The idea at first thought seems wildly absurd, and there would be, we imagine, a good many legal obstacles to overcome before it could be carried out, but it is not a bad plan, by any means, and probably its seeming absurdity lies in our long established habit of regarding public business as somehow different from private business, with some other object than the mere doing cheaply and well, of the things that need to be done. We have come almost to take for granted that town government not only is but must always be the task of politicians, all highly regardless of their own interests as distinguished from those of the town. There will be no doubt a desperate fear in Armour that if Mr. Cantonwine secured this queer "job he would make some money out of it. If he doesn't get it some other men certainly will make as much money or more, for the politician firmly holds that he must live and has a strong inclination to live well. Without at least a few regular town officials, however, it is hard to see how such a wholesale contractor could be held to responsibility or get his accounts properly audited. On the whole, we do not quite see how the novel scheme could be worked, and yet it does have its attractions.

The rural routes were established for the benefit of rural homes, or in other words the farmers. They have proven a greater benefit and blessing to the farmers than was anticipated by the most sanguine. A farmer who has once enjoyed the advantages of the rural mail service would hardly know how to live without it. It did not come to the farmer, however, until he had many times earned it. The farmers are our heaviest taxpayers. What property they have is in plain sight and is taxed, while the city gent, at least many of them, who deals in notes and bonds is enabled to hide his wealth from the assessor. For a quarter of a century the mail has been carried to the city home, not once, but many times each day. Finally the big heart of Uncle Sam has reached out to the men who feed the world.—Gastonia Gazette.

CIVIL COURT.

No Cases of Much Importance.

While this term of civil court is getting along well in removing cases from the docket, no great importance attaches to any so far disposed of.

Five divorces have been made, two of them for white couples and three for colored.

Quite a number of small cases have been non-suited.

Hyman Supply Co. vs W. J. Kittrell, plaintiff alleging that excessive homestead had been allowed defendant, was decided in favor of plaintiff.

Bernard administrator vs Morrill administrator was decided in favor of plaintiff.

J. L. Elks vs Robert Brown was decided in favor of defendant.

S. T. Hooker vs B. E. Parham was decided in favor of defendant.

W. H. Nichols vs W. H. Elks decided in favor of plaintiff. The amount involved in this suit was \$5.60, and the case has been in court three years.

One suit growing out of the recent selling of washing machine rights in this section was adjusted by the notes given in the purchase of such right being surrendered to plaintiff by defendant and further effort to collect the notes abandoned.

Peace Institute to be Sold.

The Raleigh Times says that within the next few days it is to be definitely decided as to what denomination will own Peace Institute—the Methodist church or the Presbyterian. The property at the present time is owned by a stock company, the majority of it being held by Dr. Dinwiddie, who has been president of the school for the past 17 years. After this session he does not expect to teach and is to dispose of his interest in the school. For the past year the Presbyterians have had under consideration the purchase of the property but when nothing was done an option was secured by parties representing the Methodist church. From what can be learned the Methodists will not endeavor to get the property unless the Presbyterians do not purchase it, in which case it will be bought for a Methodist college and will be owned by the Methodist church of the Eastern North Carolina Conference. The price asked for the property, it is said, is fifty thousand dollars.

NORTH CAROLINA AT THE JAMES TOWN EXPOSITION.

Among Other Things That Will Give Joy to North Carolinians Will be Our Splendid Educational Exhibit.

North Carolina's part in making the Jamestown exposition a great one is to be no small affair, and the odds are that Virginia will say, just as did South Carolina after the Charleston exposition, that North Carolina of all the States, excepting only the home State, did the most for the exposition.

The great crowds of North Carolinians who are going to Jamestown will find that North Carolina has a beautiful home at the exposition. Col. Joseph E. Fogue, the commissioner general for North Carolina at the Jamestown exposition, returned to Raleigh yesterday after a visit there in order to look over the field and see how the North Carolina building is getting on. He returned delighted with the progress being made on the State building, as well as with the general trend of affairs at the exposition grounds.

"North Carolina will have the handsomest building on the water front," said Colonel Fogue last night, "and the prospects are now that it will be about completed when the exposition opens. The building is now under cover and I tell you it is going to be a beauty. North Carolina will be proud of it and of the exhibit that will be made for the State. Our people are going in great numbers to see the exposition and all will be proud of North Carolina's part."

Major G. W. Hinshaw, of Winston-Salem, the secretary of the North Carolina commission, was in the city yesterday and in company with Colonel Fogue had a conference with State superintendent of public instruction J. Y. Joyner concerning the educational exhibit to be made. This exhibit will be a strong one and will especially show the rapid advance in educational affairs made in this State since 1800. It will likewise show the educational advantages offered in the State in the way of public and private schools, academies, colleges, teachers, training schools and the university. It will be an exhibit that will "do us proud" and it will be one giving the facts that none can gainsay.—Raleigh News Observer.

New Town Starting up.

The building of railroads through new territory develops new towns along their route. This is the case with the Raleigh & Pamlico Sound division of the Norfolk & Southern road now building through this section. Before the track gets there a town has started at Simpson, a point on the road 6 miles east of Greenville. HARRISON GUILTY.

Jury Rendered Verdict Last Night.

Elizabeth City, N. C., March 20th.—The jury in the case of Joshua Harrison, charged with the kidnapping and murder of Kenneth Beasley, the 9-year-old son of former State Senator Beasley, tonight rendered a verdict of guilty.

Court convened this morning at 9:30 a. m. in the fifth day of the Harrison trial. Solicitor Ward closed the argument in a speech of three hours length. His argument was one of the finest to be made in this court house. He reviewed the evidence in a powerful manner, which profoundly impressed the jury and the audience, who forgot their surroundings and applauded. One man was sentenced to jail by the judge for five days for applauding.

Solicitor Ward said: "I am confident that Kenneth Beasley is living and his mother will have him within six months."

He echoed the sentiments of a great part of the audience which has been greater today than any day since the trial began.

Solicitor Ward concluded his argument at 11:30 a. m. and Judge Allen began at once his charge to the jury, which he concluded at 1:25 p. m. The case was then given to the jury.

Million Dollar Fire.

Philadelphia, March 21.—Fire today at the plant of the Atlantic Refining Company, on Point Breze, destroyed property to the value of a million dollars. A number of employees were burned so badly that they had to be taken to hospitals. Burning oil was hurled over the firemen greatly hindering them in fighting the fire.

Sane or Insane?

New York, March 21.—The lawyers began their argument in the Thaw trial. Jerome argued strongly for a lunacy commission, while Delmas declares that Thaw is sane. The ending of the trial is not yet definite.

THE CROP OF 1906.

Report Shows 13,290,677 Bales.

Washington, March 20.—The final census report on cotton for the year issued today shows that 13,290,677 bales of cotton counting round bales as half bales, including linters, have been ginned.

The number of active ginneries this year is 28,703.

The 1906 crop is compared with 10,725,602 for 1905, and 13,679,300 for 1904. The average gross weight of the bale for 1906 is 510.7 pounds and the crop expressed in 500 pound bales is 1,576,226. The items entering the totals for the crop of 1906 are 13,099,927 square bales; 266,795 round bales; 57,352 Sea Island bales and 321,160 linters. The quantity of cotton estimated by ginneries and delinters as remaining to be ginned and included in the report of 1906 is 1,457,764 bales.

CHARLOTTE BANK OFFICIAL A DEFAULTER.

Charlotte, N. C. March 20.—With a seventy thousand dollar shortage left behind, Assistant Cashier F. H. Jones, of the Charlotte National Bank, is now supposed to be in the North or in some place of hiding rearing home. The defalcation was not made known until today, although Jones left town Saturday evening, taking with him a large sum of money, perhaps fifty thousand dollars. The defaulting official was active in church work here and bore a high and unspotted name. Speculation is believed to have been the cause of Jones' downfall. A reward of \$1,000 has been offered for his apprehension.

AGE OF ORGANIZATION.

This is the age of organization. Individual effort is good so far as it is able to go, and is commendable for doing its best, but in this time of hustle and push it is through organization that most is accomplished.

There would have been no railroads, no steamboat companies, no factories, no great telegraph and telephone systems, no large schools if individual effort only had been depended on to secure them.

Worse, far worse, was the fate of some unfortunate actors who in a popular melodrama had to drink a toast in (stage) champagne. In the ordinary way ginger ale does duty on the boards for that exhilarating wine, but on this occasion some fend in human form had filled the bottle with paraffin oil. "We dared not leave the stage till the fall of the drop," said one of those who took part in this unusual festivity to the writer afterward, but how we finished that act not one of us knows."

Natural Varnishes.

Fluid resins or oil from several different trees are extensively used in the Philippines as varnishes. One of them, called oil of supa, is a pale yellow liquid when fresh, but it becomes dark and viscous after contact with the air. Spread in a thin layer it dries slowly and forms a hard varnish. It is also capable of being burned in a lamp. Another natural varnish is balao, also called oil of apitong. It is white when fresh, but darkens after exposure and makes a very tough varnish. Oil of panao is a third variety, inferior to the others in its drying properties. Chemical analysis has shown that all these wood oils consist entirely of hydrocarbons known as sesquiterpenes.

Some Johnson Definitions.

An exhibition of the relics of Dr. Samuel Johnson in London recalled some of the remarkable definitions that remarkable man inserted in his dictionary. Among them not the least curious was the one given for "network," which was defined as "anything reticulated or decussated at equal distances, with interstices between the intersections." Popcorn is inexpensive and nutritious as well if not used to overindulgence.
