Warring on the Two Cent Rate.

Chicago, April 12.—Passenger and traffic officials are worrying over the question whether they can maintain higher rates on interstate traffic than the sum of the local rates in the various states. The rate between all important centres must be reduced from 15 to 39 per cent, if the states continue to pass laws making the maximum rate 2 cents a mile, and the through rates are based upon such state rates. The interstate commerce commission recently declared that whatever a through rate exceeded the sum of the local rates made between intermediate points, the commission would regard it as prima facie evidence that the through rate was excessive and unreasonable, and that the railroad would be obliged to furnish proof to the contrary to maintain such a through rate. Many of the leading railway lawyers believe the Supreme court of the United States would not concur in the opinion. Some believe that the highest court will decide that the State laws are constitutional because of their effect upon interstate traffic. Test cases soon will be brought in the western states with new 2 cents a mile laws. Several conferences have been held, but the only conclusion reached so far by the railroads is to fight in the courts every two-cent law which has been passed by a western state. If the roads win in the United States courts on every two-cent a-mile law which has been passed, the eastern roads will take steps to upset the 2 cent fare laws of Ohio, Indiana, Michigan and other states.

Gen Humphrey Succeeds Himself.

Washington, April 2.—The war department has announced that the president has reappointed Brigadier General Charles F. Humphrey as quarter master general of the army, to succeed himself, his old term of office expiring today. Colonel Earl D. Thomas, 11th cavalry, will succeed on the 18th inst. to Brigadier General Alfred C. Makley, the latter retiring on account of age.

New Jersey Legislature Takes Recess.

Trenton, N. J., April 12.—The New Jersey legislature took a recess today. It will reconvene on June 18 for the consideration of measures which may be voted by the governor during the recess. The senate passed a concurrent resolution providing for biennial instead of annual sessions.

New Stock Exchange Opens.

New York, April 22.—The produce exchange opened its new stock exchange today for beginning trading in industrial and mining stocks. The list includes as many as 75 industrial and 115 mining stocks.

New York, April 12.—At 11 o'clock this morning the Thaw jury was still out, having failed to reach a verdict. After forty-one hours of deliberation and balloting it is reported that the jury stands 10 for manslaughter and 2 for acquittal.

FIRE NEAR STOKES.

Residence of Mr. J. L. Roberson Destroyed.

A telephone message from Stokes brings information of the burning of the residence of Mr. James L. Roberson near that town between 12 and 1 o'clock Thursday night. No particulars were given as to how the fire originated. The building was entirely destroyed and only a part of the furniture was saved. The loss is about \$1,500 and Mr. Roberson carried insurance on the building for \$600 and on furniture for \$75 in the Pitt county branch of the Farmers' Mutual Fire Insurance Association.

New Jersey Governor Suited With Recess Plan.

Trenton, N. J., April 12.—The arrangement whereby the legislature took a recess today in order to take time to consider the vetoes by the governor, greatly pleases the governor. He has not felt constrained to hurry up his consideration of bills, and leisurely and calmly has decided. With an additional week at his command the governor has been able to dispose of a load of business that would have been too much for him to dispose of in the ordinary time. He will be able to dispose all within the five days limit.

Farmers' Institute to Establish a Cotton Gin.

The meeting was called for the purpose of taking action in regard to the establishment of a cotton gin and warehouse for the storing of farm products and to transact other important business.

President Roosevelt Delivers an Address.

Washington, April 12.—The president delivers an address today at the unveiling of a monument to the members of the First Volunteers Cavalry, or Rough Riders, at the Arlington cemetery this afternoon. A copy of Mr. Roosevelt's book, "The Rough Riders" was placed in a brass bound box in the cornerstone.

Preparing to Build Factory.

The old buildings on the lot, corner of Cotanch and Fourth streets, recently purchased from Mr. R. L. Smith, by the John Flanagan Buggy Co., are being moved off. About the first of May the company will begin the erection of a large brick building on this lot in which to carry on its buggy manufacturing and undertaking business. The building will be 65x154 feet, three stories. The John Flanagan buggy is not surpassed anywhere.

Indexing Records.

Register of deeds R. Williams has received the books for that purpose and is now at work re-indexing the records in his office. The indexing system adopted by Mr. Williams is one of the best known. It will take many months to get all the indexing completed on the new books, but after it is done any deed, mortgage or instrument recorded in the office can be referred to with ease.

Seeking Owner of Historic Sword.

The following appeared in the Richmond News-Leader of April 8th:

"In Pickett's charge at the battle of Gettysburg a fine Revolutionary sword was left on the field by a member of a North Carolina brigade that engaged in the charge on Pickett's left flank. It was picked up and delivered to Captain Winfield Scott, of the 126th New York, who was in the thick of the charge. It was a beautiful sword, with the name of R. E. Grant inscribed on the hilt. Captain Scott recognized it as a sword with a history, and having been in the Revolutionary war, consequently he prized it and kept it with care. A few years ago Captain (now chaplain) Scott saw the ordination of secession passed by Virginia and there saw the name 'R. E. Grant,' the same name in the same handwriting that was on the sword. Spending a day and night with me a few days ago, Chaplain Scott told me the story of the sword, and said if I could find the owner he would gladly restore it to such person. However, one of the peculiarities of this story is that R. E. Grant, or whoever lost this sword from the Southern army, was a relative of Chaplain Scott, of the 126th New York, into whose hands it fell; that is, presuming that R. E. Grant or a descendant of R. D. Grant lost said sword."

"I write hoping to be the medium through which this sword of two wars may be restored to its owner. The key to the situation is found in the fact that the R. E. Grant who signed the ordinance of secession was the original owner. I shall be glad to correspond with anyone in reference to this matter and will appreciate any assistance anyone will give in placing this sword where it belongs."

Happenings in North Carolina.

Strawberry shipments have started in the Wilmington section.

Morganton, N. C., April 11.—Miss Jessie Ball, of Detroit, Mich., who has been teaching at the deaf and dumb school here for the past three years committed suicide in some woods adjacent to the school grounds yesterday afternoon, by drinking carbolic acid. The body was found today.

While Mrs. H. S. Patterson and Messrs. C. C. and Will Collins, children of the late William Collins, were searching this morning to ascertain if he left a will, they opened an old trunk and found secreted in the bottom of it \$1,500 in gold. Continuing their search they found \$14.00 stuffed in an old vest pocket hanging in a closet. They could not find a will and it is presumed that the deceased did not leave one.—Greensboro Record.

Bithy Daughy, a white woman aged 35, was burned to death at the county home Tuesday night at 9:30. She had an epileptic fit to which she was subject and fell in the fireplace. In some way the body falling into the fire scattered the embers and the bedding on two beds was set on fire. A colored woman who slept in the same room in order to attend to the wants of the unfortunate woman was near to being cremated also. She raised an alarm and help arrived in time to save the building. The colored woman was not injured.—New Bern Journal.

ALL OVER THE HOUSE.

Suggestions as to the Proper Garnishing of Various Dishes.

In garnishing food one may exercise as much originality and ingenuity as one is capable of. There are only one or two limitations to this rule. One is that a certain harmony of colors and flavors should be observed. The other is that the overfanciful in the way of food ornamentation should be avoided.

Here are a few suggestions as to the appropriate garnishes for different dishes: With fish use lemon or parsley and potatoes cut in balls or latticed and fried. A platter of cold meat may be garnished with cubes of tomato aspic, parsley, crescents or thin slices of lemon. For fried foods lemon and parsley make the most attractive garnishes, while celery tops, stuffed olives and slices of raw tomato are also desirable. For lamb chops green peas are the usual garnish and are generally arranged in a border around the meat. Radishes cut in slices or in fancy shapes add to the attractiveness of a platter of steak, while for creamed dishes or dishes au gratin hard boiled eggs may be used in some form. Desserts may be garnished with nuts, candied fruits and bottled cherries.

To Clear Soup.

To clear soup put the stock to be cleared in a stewpan, allowing the white and shell of one egg to each quart of stock. Beat the white of egg slightly and add to the stock with the shell broken in small pieces. Place on the front of the range and stir constantly until the boiling point is reached; then let boil without stirring for two minutes. Set on the back of the range, where it may simmer for twenty minutes. Remove the scum and strain through a double thickness of cheesecloth placed over a fine strainer.—Woman's Home Companion.

Uses of Onions.

Onions chopped in small pieces and laid between thin slices of bread or crackers and eaten as a sandwich are most soothing and effectual for insomnia. Raw onions are more digestible than cooked ones and are especially good for complexion, liver and kidney troubles. A small quantity of onion is a decided improvement to baked tomatoes and squash, and an onion boiled with macaroni removes the pasty taste.

Herring Salad.

Herring salad is a veritable tidbit to those who like the fish flavor. Take two skinned, sound, boned herrings (smoked, of course). Cut into quarter inch squares. Mix lightly in a bowl with two cold boiled potatoes, medium size; two peeled raw apples, two cold hard boiled eggs and one pickled red beet, all cut in dice. Pour French salad dressing over this mixture, mix lightly, but thoroughly, and serve at once ice cold.

To Restore Gray Hair.

For restoring gray hair the following is recommended: Half a dram of sulphate of iron, half an ounce each of fluid extract of jaborandi and glycerin, quarter of an ounce of sulphure, two drams of extract of rosemary, the same of extract of thyme, half an ounce of rectified spirits and a quarter pint of elderflower water. Apply nightly to the scalp with massage.

THE STRAITS OF SPAIN.

The strain of Spaniards more easily get a grip of the true and ancient Spain than by acquiring the habit of traveling third class. The seats indeed are hard, but the company is usually excellent, charming in its manners and not offensive to any sense. Here a constant series of novel pictures is presented to the traveler, who may quietly study them at leisure. Perhaps it is a dozen merry girls on their way to a festival, packed tightly together and laden with packages. Some of the more sedate among them wear mantillas, some bright handkerchiefs on their heads or go with hair uncovered; but, however they are dressed, to whatever class they belong, they are all clean and sweet.

Or perhaps it is a less crowded carriage one enters. There are two middle class Spaniards and a peasant group of three—a fat, jolly middle aged man in a peasant's costume, but clean and new, almost stylish; a woman of like age, one of those free, robust, kindly women whom Spain produces so often, and a pretty, bareheaded girl, evidently her daughter, though the man seems a friend or relative who is escorting them on their journey. By and by, when we have been some hours on our journey, he lifts from the seat in front of him the large, heavy embroidered wallet—the alforja, which Sancho Panza was always so anxious to keep well filled—unwinds it and draws out one of the great, flat, delicious Spanish loaves and throws it on the woman's lap. Then a dish of stewed meat appears, and the bread is cut into slices, which serve as plates for the meat. But before the meal is begun the peasant turns round with a hearty "Gusta?" It is the invitation to share in the feast, which every polite Spaniard must make even to strangers who happen to be present, and it is as a matter of course politely refused, "Muchas gracias." Before long the black leather wine bottle is produced from the wallet, and the meal proceeds. At its final stage some kind of sweetmeat appears, and small fragments are offered to the two middle class Spaniards and then, with a slight half movement, expressing a fine courtesy restrained by the fear of offering any offensive attention, to the foreign caballero also. It is not improper to accept this time, and now the leather bottle is handed round, and the middle class Spaniards avail themselves of it, though with awkward unfamiliarity.—Atlantic Monthly.

A Lively Alarm Clock.

There was a new lodger at Mrs. Jenkins', and, like his fellow lodgers, he was a collier. The morning after his arrival he got up early to go to work and in the dark stumbled over a tin bath placed on the top stair. Bath and lodger rolled with a frightful clatter downstairs, and as he picked himself up he heard a sleepy "Right, oh!" and a heavy bump overhead from one of the other lodgers. The new lodger at breakfast complained of the criminal carelessness of the person who put the bath at the top of the stairs. "It was John," confessed another lodger. "He is such a heavy sleeper that only a noise like a lodger fallin' downstairs can wake 'im. That's his alarm clock."—London Queen.

The Bishop's Discomfiture.

There is an anecdote of a London bishop who, having read that story of John Wesley cutting out every word of his discourse that his servant maid did not understand, determined to preach to a country congregation the simplest sermon he could write. He chose an elementary subject and took as his text, "The fool hath said in his heart there is no God." On leaving the church he asked the parish clerk what he thought of the sermon. "Oh, my lord," said he, "it was very fine—very fine and grand. I've been talking it over with Mr. Beard, and we said how fine it was. But, after all, we can't help thinking that there is a God."—Chambers' Journal.

"The feelings of woman are far deeper and finer than those of man!" cried the lady orator in a fiery tone. "We are told by those who style themselves the stronger sex that we are much inferior. Is that so?" A loud chorus of "No!" from the ladies greeted this question, and the orator went on: "I say that woman feels where man thinks." "Is that the reason your husband is bald?" inquired one of the few male members of the audience. It was lucky for him that he got two seconds' start in the race for the door.—Liverpool Mercury.
