## Dark Tobacco Growers' Bill.

Nashville, Tenn. April 13.—Commissioner Yerkes explains the provisions of the dark tobacco growers' bill, which has aroused much speculation among farmers, the last provision especially. By this, Mr. Yerkes says that a farmer may sell the manufacturers without becoming a leaf dealer. There is absolutely no limitation under the proposed amendment, to the right of the farmer to sell his leaf tobacco to any person he pleases, the individual consumer, the dealer in leaf tobacco, the manufacturer, the exporter, the country merchant, or any one else. The farmer is also not debarred from selling his tobacco through an agent or employe without delivering it in person. In fact the farmer can dispose of his tobacco just as he does under the old law, with none to molest him or make him afraid.

## School Boards' Meeting.

## REASONS WHY THE CITIZENS OF PITT SHOULD VOTE IN FAVOR OF THE SCHOOL BONDS

It locates the school in the County. It gives us the first place in the East. It furnishes opportunities we must have. It costs no more than a trifle.

1. This school is certainly going to be located in some Eastern County. It is to get it now or never. It is the only chance in a lifetime.

2. Wherever it goes it makes that county for all the future the foremost county of Eastern Carolina. It makes it the county which shall receive contributions from all other Eastern counties. It makes it the center of educational and social influence—the center from which educational inspiration, effort and accomplishment shall go forth.

3. If located in any other county we become for all time contributors to its wealth instead of it contributing to ours.

4. If located here it connects this county directly with the State government because it will be a State institution and always hereafter supported entirely by the State.

5. We contribute but one time and every dollar we do give remains here in the county and continues to help build up the county through all the future.

6. The State will every two years be giving appropriations and these will be larger as the school grows. These will be spent here every year and invested in other buildings which go to build up the county.

7. If located in the county it will place an opportunity at our very doors to fit and prepare for a successful life at the least possible cost.

8. It will furnish us a thoroughly trained teacher for every country and town school in the county.

9. It will, therefore, make this county stand first, educationally, in the State, because as is the teacher so is the school.

10. Holding this position will increase the value of every piece of property in the county. It is an indisputable fact that wherever education is in the forefront these property has the best values.

11. It is now a contest between a number of counties as to where this school shall be located. Will Pitt county, with the prospect for the future it has allow some other county to come in and secure the prize?

12. To locate with us only needs the hearty co-operation of the people. It would be a calamity to the county not to have this now.

13. Whether we wish it or not this school will be established somewhere in Eastern Carolina. Wherever it is located we will have to pay the same amount of taxes for maintaining it that we would if we had the school. Is it not wise to have the school and get all the benefits that would come from it since we would pay the same for its maintenance if located elsewhere?

14. The East pays one half of the State taxes. There is not one dollar of the public funds appropriated to any institution for whites east of Raleigh. Is it not time we should have at least one of the State's Institutions? Some county gets one this year. Shall it be Pitt, or will we let it go elsewhere?

15. The question now is, and the decision of which decides whether we get the school or not, will the people of the county vote to authorize the County Commissioners to issue a small amount of bonds to make it positively certain that we shall get the school? If they should issue the \$50,000 a man who lists \$1,000 worth of property would pay 25 cents a year for his share of the locating money. If he lists \$5,000 worth of property he would pay \$1.25 per year, and if he should list \$10,000 worth of property he would have to pay only \$2.50 a year.

You can run no risk in voting for this bond issue because if the school is not located here no bonds can be issued even after we have voted to authorize it.

16. The citizens of Greenville will on the 7th day of May, 1907 vote on a proposition to authorize the Board of Alderman of that town to issue \$75,000 of interest bearing bonds. It is certain that the vote on this proposition will be in favor of issuing bonds to be used by the Board of Alderman as far as may be necessary in locating the school in the county of Pitt. The citizens of Greenville in addition to paying the annual interest on the town bonds will be taxed also for their share of the interest on the county bonds so that this is clearly a case where the interest of the town and county are the same and one in which they ought to work harmoniously together to accomplish this great result which will be alike beneficial to both. This would be what he would pay with the present valuation of property. As the valuation of the property increases his payments would decrease.

17. Those who have made such a stubborn and gloriously successful fight in getting the bill through the Legislature did so with full faith that our people would stand by us when it comes to locating this school. Will not every man rally now and let us make ours in truth and deed what has been so conspicuously begun? We wait with confidence your answer at the polls on the 14th day of May.

## TEACHERS' ASSOCIATION.

### Last Meeting for Present School Term. Prizes Awarded.

The Pitt County Teachers' Association held its monthly meeting today in the graded school chapel. The weather being beautiful and it being the last meeting of the association, for the present school term, the attendance was very large.

The program of exercises for the day, as previously published, was carried out and proved most interesting. After this had been completed several prizes were awarded.

The annual Grimes medal for the best paper on Pitt county history was won by Josephus Quinnerly, of Quinnerly school at Centerville. The second prize on same subject (gold pen) was won by Miss Arline Joyner, of Joyner school, near Greenville.

The Arthur medal, for best paper relative to education in Pitt county, was won by Miss Carrie Chapman, of Quinnerly school at Centerville, and the second prize was won by Miss Annie Whitefield, of the same school.

The \$25 prize offered by the Woman's Betterment Association for greatest improvement made in school building and grounds, was awarded to the Quinnerly school at Centerville, and the second prize (gold pen) was awarded to Ballard X Roads school.

The speeches in presenting these prizes were made by ex-Gov. T. J. Jarvis, Prof. G. E. Lineberry, Mr. F. C. Harding, Rev. M. T. Plyler, Supt. H. B. Smith and Rev. J. E. Ayscue.

It is a high compliment to Quinnerly school that four out of six prizes were won by that school and its pupils.

There were twelve papers in the medal contests and the committee who examined them say they all reflected high credit upon the authors.

The teachers of the county have had a good year's work both in their schools and in the association. They have sustained the high standard in Pitt county, educationally and socially, and are entitled to the gratitude and commendation of all our people. All the schools will soon close for the session. The Reflector wishes every teacher in the county a pleasant summer vacation and hopes to see them all back among us when the school open again next fall.

**British and American Justice.**

The trial of Rayner, who killed the London merchant, Whitley, for no sane reason so far as the evidence shows, was at first acclaimed both in the United States and in England as an example of the superiority of the British methods of justice. In five hours the man was tried and convicted, while in a parallel case in New York many more weeks have been spent and the end of the trial is not yet reached. But a New York paper observes that British opinion has suddenly developed doubts about the justice of the conviction and is signing monster petitions for the reprieve of the prisoner until his sanity can be determined. Wherefore it deduces that the American system may be best, after all.

Certainly, if British justice does not provide for the inquiry into mental responsibility for a homicide, American justice is superior in that it permits such an inquiry. But that does not stop criticism on the point whether American justice provides an intelligent method for determining responsibility when the act was committed during the period of consuming days in hearing expert witnesses retained to testify one way and then more days in hearing experts retained to testify the opposite way presents the real question. If the intelligent plan of selecting impartial experts, not to support one side or the other, but to get at the exact truth, were made the rule, it is hardly doubtful that another hour or two added to the Rayner trial would have determined the question of the prisoner's mental responsibility. —Pittsburg Record.

**MOUTH BREATHING.**

The Many Physical Ills For Which It is Responsible.

Nature intended us to breathe through the nostrils, and if for any reason this becomes difficult or impossible we suffer for it.

The nose not only warms or just tempers the air as it is drawn through it into the air tubes, but it also filters it in great measure, keeping back not only much of the solid matter in the form of dust, but also the bacteria carried by the dust particles or floating in the moisture of the air.

In mouth breathers the air strikes the back of the throat and rushes into the windpipe before the chill has been taken off and while it is still laden with dust and bacteria. In this condition it causes local irritation, which results in congestion of the mucous membrane lining the air passages. This congestion when long continued passes into chronic inflammation or catarrh.

The inflammation gradually spreads if the cause continues and often passes from the throat into the ears, where it produces a thickening of the delicate structures there and finally deafness. The mucous membranes throughout the air passages and all their ramifications become thickened, secrete phlegm and lose in great part their power of resistance to the germs of pneumonia, diphtheria and other diseases.

The causes of mouth breathing are numerous. Anything that obstructs or narrows the upper air passages—the nose and vault of the pharynx—forces the sufferer to breathe through the open mouth. A deformity of the nose, the presence of "adenoids" or enlarged tonsils may cause the trouble. Examination for such conditions should be made whenever a child is seen to breathe habitually with the mouth open, and as soon as the cause is discovered it should be removed. So many serious consequences may follow mouth breathing that it should never be allowed to go on a moment after its cause is ascertained.

One cause that is not often suspected is a deformity of the nose resulting from the use of improper nursing bottles by babies, but the most common is the presence of adenoids.

It is useless to scold or remonstrate with a mouth breathing child if the habit is caused by the air passages being blocked by growths that call for removal. He must breathe to live, and if the legitimate channels for air are closed by disease nature does her next best.—Youth's Companion.

A few days after he had become the happy possessor of the knife his father was startled by seeing two men bringing home the young hopeful in a very dilapidated condition.
