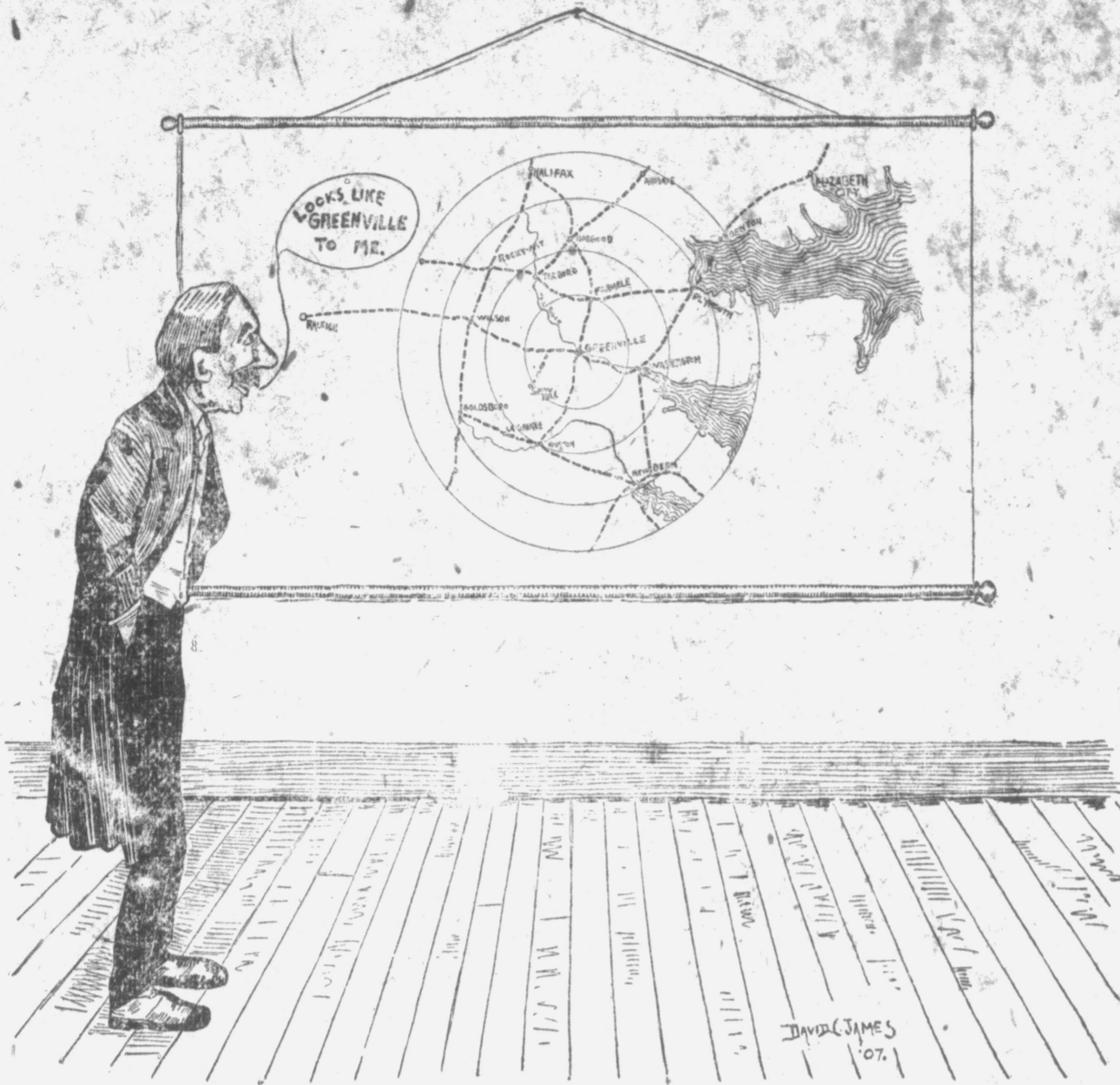
Crocchia's Italian band furnished delightful music for the occasion.

Business Secrets That Girls have Faithfully Kept.

Not long ago a Kansas City stenographer learned that the railroad for which she was working had determined to extend its line. She had a friend living in the town through which it was to run. A letter to him with her savings would have enabled him to buy at a low price the land the road needed, and the peculiar nature of the ground in that neighborhood would have enabled him to sell at a great profit. It would have been a business move on the part of the girl, but she would gain her money by the betrayal of the confidence of her employers. Operators Cutting Rates.

Special to Reflector. Columbus, Ohio, April 16.--Navigation opened on the lakes yesterday and the operators have been reducing the prices of coal. The reductions were from \$2 to \$1.50 per ton at the mines; three quarters screened lump from \$1.90 to \$1.35; run of the mine from \$1.65 to \$1.15; domestic nut from \$1.50 to \$1.05; pea from \$1.35 to 95 cents; nut, pea and slack from \$1.10 to 75 cents; coarse slack from 85 cents to 55 cents. Other reductions will soon follow.

ALL OVER THE HOUSE.

Suggestions as to the Proper Garnishing of Various Dishes.

In garnishing food one may exercise as much originality and ingenuity as one is capable of. There are only one or two limitations to this rule. One is that a certain harmony of colors and flavors should be observed. The other is that the overfanciful in the way of food ornamentation should be avoided.

Here are a few suggestions as to the appropriate garnishes for different dishes: With fish use lemon or parsley and potatoes cut in balls or latticed and fried. A platter of cold meat may be garnished with cubes of tomato aspic, parsley, crescents or thin slices of lemon. For fried foods lemon and parsley make the most attractive garnishes, while celery tops, stuffed olives and slices of raw tomato are also desirable. For lamb chops green peas are the usual garnish and are generally arranged in a border around the meat. Radishes cut in slices or in fancy shapes add to the attractiveness of a platter of steak, while for creamed dishes or dishes au gratin hard boiled eggs may be used in some form. Desserts may be garnished with nuts, candied fruits and bottled cherries.

To Clear Soup.

To clear soup put the stock to be cleared in a stewpan, allowing the white and shell of one egg to each quart of stock. Beat the white of egg slightly and add to the stock with the shell broken in small pieces. Place on the front of the range and stir constantly until the boiling point is reached; then let boil without stirring for two minutes. Set on the back of the range, where it may simmer for twenty minutes. Remove the scum and strain through a double thickness of cheesecloth placed over a fine strainer.—Woman's Home Companion.

Uses of Onions.

Onions chopped in small pieces and laid between thin slices of bread or crackers and eaten as a sandwich are most soothing and effectual for insomnia. Raw onions are more digestible than cooked ones and are especially good for complexion, liver and kidney troubles. A small quantity of onion is a decided improvement to baked tomatoes and squash, and an onion boiled with macaroni removes the pasty taste.

Herring Salad.

Herring salad is a veritable tidbit to those who like the fish flavor. Take two skinned, sound, boned herrings (smoked, of course). Cut into quarter inch squares. Mix lightly in a bowl with two cold boiled potatoes, medium size; two peeled raw apples, two cold hard boiled eggs and one pickled red beet, all cut in dice. Pour French salad dressing over this mixture, mix lightly, but thoroughly, and serve at once ice cold.

To Restore Gray Hair.

For restoring gray hair the following is recommended: Half a dram of sulphate of iron, half an ounce each of fluid extract of jaborandi and glycerin, quarter of an ounce of sulphure, two drams of extract of rosemary, the same of extract of thyme, half an ounce of rectified spirits and a quarter pint of elderflower water. Apply nightly to the scalp with massage.
