## THE QUESTION SETTLED.

No Bonds Will be Sold Unless the Training School is Located in Pitt County.

Some people have formed very erroneous ideas about the bond election to be held May 14th for the purpose of securing the location of the Eastern training school in Pitt county. One of these ideas that we have several times heard expressed is that if the election should be carried in favor of bonds and the school be located elsewhere than in Pitt county, the county commissioners would sell the bonds any way and proceed to use the money for other purposes.

In order to set the public right on this question and let those holding such an idea see the error of it, the following letter was addressed to Chairman R. W. King, and through him to the board of commissioners, asking a statement from them in regard to the matter. The answer from these gentlemen shows that the money will be used for no other purpose but the school, and if the school is not located in Pitt county not a dollar of the bonds will be sold and used for any other purpose. The letters follow:

Greenville, N. C., April 15th. R. W. King, Esq., Ch'm Board Co. Commissioners,

Dear Sir:—I hear that it is reported that if the people shall vote on the 14th of May in favor of issuing bonds that the board can and will issue the bonds and sell them, whether the school is established in the county of Pitt or not, and use the money for other purposes. Will you kindly give the views of the board on this question for publication?

Greenville, N. C., April 15th, D. J. Whichard, Esq., Editor of Reflector.

Dear Sir:—We are in receipt of yours of the 15th instant and in reply thereto we beg to say:

The act of the legislature which authorizes us to call the election which is to be held on May 14th, 1907, only authorizes us to issue bonds "to aid in constructing and equipping, at some point in the county of Pitt, the necessary building for a training school for the education and training of young white men and women to teach in the common schools of the State and to better discharge the duties of life, if such school shall be authorized and established by the State board of education at some point within the county of Pitt." We have made this quotation from the 8th section of the act itself.

It is therefore clear that before we can issue any bonds under this act that two things must happen. First, that a majority of the registered voters of the county must vote "For Bonds." Second, the training school must have been located in the county of Pitt by the State board of education. While we refrain from advising the people how they shall vote we want, in the most positive manner, to assure them they run no risk along this line in voting for these bonds. They may rest assured that if said school is not located in Pitt county there will be no bonds issued under this act. And we will further say that if said bonds are issued that it will be our duty and our pleasure to see to it that the money derived from the sale of these bonds is used to aid in erecting and equipping said buildings and for no other purpose.

## HID THE MONEY UNDER HIS HOUSE.

Mail Clerk Confesses Theft of \$10,000.

Wilmington, N. C., April 18.—The mystery concerning the disappearance of a packet containing \$10,000 in currency, in transit by mail from the Atlantic National Bank, of this city, to the Chemical National Bank of New York, was cleared up today by the arrest at the instance of postoffice inspectors of Edward A. Nelson, twenty-seven years of age, employed in the railway mail service. Nelson, whose home is in this city, made a confession. His run was between Wilmington and Rocky Mount. Most of the money was found under Nelson's house, where he had buried it. He was recently married and was preparing to leave the postal service and engage in business here. Altogether, \$9,400 was recovered. The theft was committed by slitting the canvas in the foot of the pouch near the top while Nelson was transferring the mail at Wilmington, two weeks ago.

Nelson had recently resigned from the service to engage in the confectionary business on one of the most prominent corners in the city, and accompanied by his wife to whom he was married fifteen months ago, and by his mother, he had gone to New York a short time after the package had disappeared. He was followed there by the inspectors and was located at the Imperial Hotel. Eleven hundred and seventy dollars being found in his overcoat pocket. The inspectors however, could get nothing satisfactory from him and he was shadowed by Pinkerton men until he returned to Wilmington. Certain of the currency on his person was of the denomination stolen. Upon the advice of District Attorney Skinner, at Greenville, N. C., a warrant was sworn out for his arrest. This was served on Nelson this morning and in explaining about some money that he had on his person with sealing wax on it, he said that he had found that in an envelope in the postal clerk's room in the Wilmington postoffice. With this entering wedge in an improbable story, he was then forced to the confession and told all. All but \$1,500 he had buried under his house on South Front street. The officers accompanying him there, he went under the house, scraped in the sand and unearthed \$8,500 of the currency in an old newspaper. Nine hundred dollars had been taken from him in New York by the inspectors, and under the impression that he might escape prosecution, the remaining \$600 was immediately made good from building and loan stock that he carried.

**ALL OVER THE HOUSE.**

Suggestions as to the Proper Garnishing of Various Dishes.

In garnishing food one may exercise as much originality and ingenuity as one is capable of. There are only one or two limitations to this rule. One is that a certain harmony of colors and flavors should be observed. The other is that the ornamental in the way of food ornamentation should be avoided.

Here are a few suggestions as to the appropriate garnishes for different dishes: With fish use lemon or parsley and potatoes cut in balls or latticed and fried. A platter of cold meat may be garnished with cubes of tomato aspic, parsley, crescents or thin slices of lemon. For fried foods lemon and parsley make the most attractive garnishes, while celery tops, stuffed olives and slices of raw tomato are also desirable. For lamb chops green peas are the usual garnish and are generally arranged in a border around the meat. Radishes cut in slices or in fancy shapes add to the attractiveness of a platter of steak, while for creamed dishes or dishes au gratin hard boiled eggs may be used in some form. Desserts may be garnished with nuts, candied fruits and bottled cherries.

**To Clear Soup.**

To clear soup put the stock to be cleared in a stewpan, allowing the white and shell of one egg to each quart of stock. Beat the white of egg slightly and add to the stock with the shell broken in small pieces. Place on the front of the range and stir constantly until the boiling point is reached; then let boil without stirring for two minutes. Set on the back of the range, where it may simmer for twenty minutes. Remove the scum and strain through a double thickness of cheesecloth placed over a fine strainer.—Woman's Home Companion.

**Uses of Onions.**

Onions chopped in small pieces and laid between thin slices of bread or crackers and eaten as a sandwich are most soothing and effectual for insomnia. Raw onions are more digestible than cooked ones and are especially good for complexion, liver and kidney troubles. A small quantity of onion is a decided improvement to baked tomatoes and squash, and an onion boiled with macaroni removes the pasty taste.

**Herring Salad.**

Herring salad is a veritable tidbit to those who like the fish flavor. Take two skinned, sound, boned herrings (smoked, of course). Cut into quarter inch squares. Mix lightly in a bowl with two cold boiled potatoes, medium size; two peeled raw apples, two cold hard boiled eggs and one pickled red beet, all cut in dice. Pour French salad dressing over this mixture, mix lightly, but thoroughly, and serve at once ice cold.

**To Restore Gray Hair.**

For restoring gray hair the following is recommended: Half a dram of sulphate of iron, half an ounce each of fluid extract of jaborandi and glycerin, quarter of an ounce of sulphure, two drams of extract of rosemary, the same of extract of thyme, half an ounce of rectified spirits and a quarter pint of elderflower water. Apply nightly to the scalp with massage.

**THE BOOMERANG.**

Even the Australians Know Little About Its Mysterics.

"The Australian boomerang," said a collector of queer weapons, "is formed of a bent stick, one side rounded, the other flat. The Australians make it from boughs of *acacia pendula* or from some tree of similar growth, giving to the green wood the desired curvature in the fire. It is necessary to choose a very hard, strong and heavy wood, and the best plan is to cut a piece from a natural bend or root of a tree and to let the curve of the boomerang follow the grain of the wood.

"One hardly ever sees two boomerangs of the same shape, for they vary from a slight curve to nearly a right angle. They differ also in length from fifteen inches to three and a half feet and in breadth from two to three inches. They should be about three-eighths of an inch thick, tapering toward the ends, which may be either round or pointed, while the edge must be sharpened all around. One side must be convex, the other flat, the sharpness of the edge along the convexity of the curve varying in different boomerangs.

"When thrown the boomerang travels forward for some distance and then generally returns in an ellipse to within a few paces of the thrower. If the boomerang strikes its mark it falls to the ground. In throwing it must be grasped at one end, stretched back behind the shoulder and then brought rapidly forward above the head, the inside of the curve facing the direction in which it is thrown.

"It may either be hurled upward into the air or downward, so as to strike the ground at some distance from the thrower. In the first case it flies from a rotary motion, as its shape would indicate, and after ascending to a great height it suddenly returns in an elliptical orbit to a spot near its starting point. When thrown downward to the ground it rebounds in a straight line, pursuing a ricochet motion until it strikes the object at which it is cast.

"To throw the Australian boomerang in such a way as to make sure of its doing exactly what one wants is one of the most difficult feats in the world. Alfred W. Howitt, who has seen the natives of Victoria practicing with the boomerang, mentioned that he questioned some blacks as to whether they thought it was possible to throw it so as to insure its returning to the hand of the thrower. Seven said no and characterized the statement as *fet bolla*—i. e., a falsehood. The eighth said he once made a boomerang that when thrown on a calm day with great care would gyrate around and around until it descended to the ground not far from him, moving as slowly as a leaf falling from a tree, and that he once ran forward and nearly caught it. He said also 'no kurni (black fellow) can catch a wunkan when he is flying—he would cut his hands open.' The throwing of boomerangs has always been carried on in the open air, and no Australian native has ever attempted to use them in a building."—Exchange.

**What Puzzled Him.**

It is said of the Marquis of Townsend that when a young man and engaged in battle he saw a drummer at his side killed by a cannon ball, which scattered his brains in every direction. His eyes were at once fixed on the ghastly object, which seemed to engross his thoughts. A superior officer observing him, supposed he was intimidated by the sight and addressed him in a manner to cheer his spirits. "Oh," said the young marquis, with calmness, but severity, "I am not frightened. I am only puzzled to make out how any man with such a quantity of brains ever came to be here!"

**His Peers.**

A distinguished lawyer of Indiana when a straggling young attorney had a client whose mental soundness was questioned. There was a lunacy inquiry, and the client was adjudged insane. The squire asked the lawyer:

"Do you wish to appeal this case which has been decided by a jury of your client's peers?"

"No," replied the young lawyer. "Since your honor says that the jurymen are his peers, I think we will let it go at that."—New York Sun.
