

JAMESTOWN EXPOSITION OPENS.

Great Naval Parade and Brilliant Pageant. President Presses the Button.

Jamestown, Va. April 26.—The great exposition opened its doors and welcomed the public to its celebration of the ter centennial of the landing at Jamestown, with everything in a state of pre-paration, and an ability to receive and provide for the guests drawn from the whole continent and the outside world. They have come in thousands, officially and individually from every State in the union, and from nearly every nation on the globe. The president of the United States arrived in ample time on the Mayflower, which he established as his headquarters. The governors of the several States are on hand, and have personally inspected the buildings that have been erected for their separate States. The crowds were early at work inspecting the buildings, with special interest in those from their own State and in wandering through the buildings erected by the exposition authorities.

Salutes from Admiral Evars' fleet of warships to the foreign fleets which presented a grand spectacle in the broad waters of Hampton Roads awoke the echoes at an early hour. The fleet consisted of the battleships Connecticut and Texas, and the cruisers Washington, Tennessee and Brooklyn, with the Maine, Indiana, Ohio, New Jersey, Louisiana, Missouri, Georgia, Rhode Island, Kearsarge, Kentucky, Illinois, Alabama and Iowa. The salutes of the American vessels were to the fleets of eleven nations: British, French, Swedish, Italian, Germany, Austria, Japan, Argentine, Brazil, Chili and Portugal. Never before has Hampton Roads, so admirably fitted to accommodate the navies of the world, had such a grand and imposing display, the fine vessels being all in holiday attire and presenting a very handsome and attractive appearance. The public were greatly interested in and impressed by the spectacle of so many and so fine a lot of war vessels. England's fleet was the largest, and was under the command of Rear Admiral Neville. Admirable Dewey was one of the distinguished naval men present and took great pride in the looks of the American ships.

President Roosevelt reached the exposition grounds about 11.30, the Mayflower passing through the columns of saluting foreign and American warships in Hampton Roads. He was escorted to the reviewing stand on Lee's parade in the rear of the auditorium building. The speech making feature of the celebration began at once. An invocation was made by the Right Rev. Alfred Magill Randolph, Bishop of the Diocese of Southern Virginia, and a brief address by Harry St. George Tucker, president of the exposition company, preceding the president's address. President Roosevelt delivered a lengthy address, at its close pressing a gold button, and immediately the machinery of the great show as in motion, a thousand flags were unfurled on the exposition buildings, and a salute to the nation was fired by the combined American and foreign fleets in the roads, and by the garrison at Fortress Monroe. At the conclusion of the salute the exposition bands played the "Star Spangled Banner," the

KILLED IN WRECK.

T. L. Royall Dreamed of Death That Was Soon to Follow.

T. L. Royall, a fireman on the Southern road, was killed in a collision at Spencer yesterday morning between 10 and 11 o'clock. He lived in Greensboro and was the son of Postmaster Royall, of Dunn.

The circumstances surrounding the death of the young fireman are such as to make one believe greatly in being fore-warned of danger. On Sunday and probably on a former occasion, so the report came to The Herald over the phone from Greensboro last night, Mr. Royall dreamed that he was in danger and near death. He awoke and tried to shake off the feeling but when he went to sleep again he dreamed that he was killed.

Yesterday morning he did not want to go on his run, at least he expressed fear on going out. Before leaving his boarding house in Greensboro he left there the names of his father and mother and others of his kindred, telling the landlady that there might be a time when this information would be needed. He also made a copy for himself, and this he placed in his pocket. When the collision occurred and he was killed this information as to his relatives and home was found.

Mr. Royall stood well in Greensboro, where he had resided for sometime. He left a number of relatives in addition to his father and mother. —Durham Herald.

Southern Memorial Day.

A novel feature of the parade, of which Capt Joseph F. Burke was grand marshal, was the participation of school children bearing red, white and blue streamers.

Jackson, Miss., April 26.—All the chief cities and towns of Mississippi observed Memorial Day today. In most places the exercises were held under the auspices of the Daughters of the Confederacy in affiliation with other Confederate organizations. Crosses of honor were presented to many of the veterans by the Daughters of the Confederacy.

The president reviewed the marching defenders of the country from a grand stand, where were gathered the honored guests of the occasion, including the diplomatic corps, the official committees of the senate and house of representatives and the governors of States. The day closes with a reception to President Roosevelt between 5 and 6 o'clock.

POISON IN FLOWERS.

Certain Death Lurks In Many of the Beautiful Plants.

Beautiful as flowers appear to the eye, there lurks behind their attractiveness certain death. They may be handled with impunity and their colors enjoyed without any danger, but let any one taste the juice of some of the sweetest, and with every drop he is taking deadly poison into his system. Even the bulbs of such dainty flowers as the snowdrop, narcissus, hyacinth and the jonquil are poisonous.

The oxalis also is not a safe thing to put between the lips, and all the lobelias will produce dizziness and general disease. The monk's hood and the beautiful foxglove are noxious affairs, from which powerful drugs are obtained, more than a few drops of their extracts being usually a fatal dose.

Certain of the crocuses if eaten, even if nothing is swallowed but the juice, produce vomiting. The bulb of the intricately beautiful lady's slipper poisons externally as the noxious ivy, dogwood and sumac. The quaint old jack-in-the-pulpit, although not a garden plant, is another enemy to health and life, and so also is the marvelous Queen Anne's lace, which now and then will creep in through the paling and looks so enchanting when far and wide it embroiders field and roadside.

The laughing little buttercup, that might be a drop of visible sunlight, is by no means as innocent as it looks. The cow in the pasture knows enough to avoid it. That and all its cousins, the rich, profuse peonies, the dazzling blue larkspurs and the rest, are full of toxic properties.

The oleander tree that is set outdoors when spring comes and that lines the streets of various of our southern cities is another hive of deadly poison.

The superb catalpa tree, towering with its great leaves and its masses of white and fragrant flowers, is a charming thing in the garden, but its bark is exceedingly injurious, and the laburnum, that looks like a fountain of gold leaping into the sun, is poison in leaf and flower and seed, and even the grass beneath it is best thrown away when cut instead of being fed to cattle.

The body of a baby wrapped in a bundle was found beside the railroad track between Tarboro and Rocky Mount. It was thrown from a car window, but investigation has failed to disclose the mother of the baby.
