

NORFOLK CONNECTION.

A Great Need for This Section.

We are at a loss to understand why the Atlantic Coast Line does not give this section better connection in their service from Norfolk this way.

There are at present three daily passenger trains leaving Norfolk for Rocky Mount. One of these trains leaves Norfolk at 8:40 a. m., one at 4 p. m. and one at 6:30 p. m., the two afternoon trains being only about two-and-a-half hours apart. Neither of these make any connection at Hobgood with trains on the three divisions of the Coast Line east and south of Parmele, and people wanting to come from Norfolk to any point on the Plymouth, Washington or Kinston branches are compelled to leave Norfolk at 8:40 a. m., stop over four hours at Hobgood or Tarboro and not reach their destination until 6 or 7 in the evening.

When these three branches of the Coast Line below Parmele had only one daily passenger train it was important to the business interests of the towns served by them that the one train arrive as early in the evening as possible. But now all three of the branches have double daily passenger service, the midday train bringing the bulk of the mails, hence the early evening train is not of such importance as before, and a connection at Hobgood with the first afternoon train out of Norfolk would be a great convenience to the towns on these branches.

Train No. 59 between Weldon and Kinston leaves Weldon at 3:08 p. m., making very close connection at Weldon with the Seaboard train from Raleigh, and if the latter is late the connection is missed. This train (No. 59) comes on by Hobgood about two-and-a-half hours before the arrival of the train leaving Norfolk at 4 o'clock, and at Parmele usually has a long wait for the train from Rocky Mount. It is scheduled to reach Greenville at 5:57 p. m., but owing to the delay at Parmele it is a rare exception when it comes on time.

The Reflector offers this suggestion as a remedy for the trouble and at the same time give this section connection at Hobgood with one of the trains coming out from Norfolk: Let the 4 o'clock train from Norfolk move up half an hour and leave there at 3:30. Then let train No. 59 be moved back enough in leaving Weldon to connect with this Norfolk train at Hobgood. This would always insure connection with the Seaboard train at Weldon, would give connection with the Norfolk train at Hobgood, and would give ample time for the Rocky Mount train to reach Parmele before the arrival of No. 59 and avoid delay there.

True this arrangement would put the evening trains about an hour and a half later in reaching Plymouth, Washington, and Greenville, but it would insure all important connections and enable trains to arrive on time scheduled, which is of far more importance and convenience than the present service.

The artistic side of the festival is entirely in the hands of Mr. Wade Brown, director of the choral society. The festival consists of three concerts, two nights and a matinee. The festival forces consists of the choral society, 150 voices selected, the best in Raleigh; a children's chorus of 200 voices from the city schools; the Raleigh orchestra of 29 players, with Mr. Gustav Hagerdorn, conductor; the New York symphony orchestra of 50 players, with Walter Damrosch, conductor and celebrated festival soloists as fine as can be secured and Mr. Wade Brown as director of the festival and conductor of the choral work.

Twenty Millions Starving.

Shanghai, China, May 2.—This is the day when the supplies on the ground are expected to be exhausted. They have been pitifully insufficient all the while, but now there is practically nothing to feed the poor wretches who are literally starving before the eyes of those who would benefit them if they could. Money will be needed on hand to last until the end of July, when the harvest will bring relief. The commissioner especially appeals for canned milk, and says there are 300,000 children in Samarsa province who have no milk and are forced to eat coarse bread made of acorns, powdered wood and cinders, resulting in thousands of deaths and much disease. The commissioner appeals to the Anglo-Saxons for two millions, five hundred thousand dollars to save twenty millions of human beings who are dying lingering deaths from starvation.

Adsit Took Charge at Norfolk.

STATE NEWS.

Happenings in North Carolina.

In a head on collision on the Seaboard Air Line, at Norlina, on Tuesday, an engineer and a fireman were killed, and two engines and eight cars ruined.

At Goldsboro Wednesday morning an engine on the Norfolk & Southern railroad was thrown from the track by a loose rail and was a total wreck. The engineer and fireman both received injuries that are thought to be fatal.

Two young men and three young ladies were crossing Catawba river, in Iredell county, returning home from church Sunday. The boat capsized and two of the ladies were drowned, the other young lady clinging to the boat until she was rescued. The men swam ashore and saved themselves, leaving the ladies to their fate.

Have no Need to Work.

The Greenville Reflector deplores the scarcity of laborers in that section, in which, it says there is plenty of work and no one to do it. The condition is very much the same around here, the only difference being a plenty of laborers that don't want to work. Wages are higher now than ever before. An ordinary, slovenly laborer with no skill whatever, one who needs to be overlooked and coached in the slightest details, demands \$1.25 to \$1.50 a day, and that day must include late arrival in the morning and certain tardiness about dinner time, perhaps a hand out dinner. All this expense and trouble for a laborer to dig a little in a garden, clean up a yard or patch a fence. Farm laborers are nearly as expensive, and equally unsatisfactory. The average common laborer here has no ambition, is utterly improvident and receiving such large compensation for a day's work is only compelled to work one or two days in the week to live. In the past their food consisted of the cheapest and coarsest kinds, the allowance was meager because the small wages received would not purchase more or better and now with greater prosperity less effort is required to obtain a like subsistence.—New Bern Journal.

The Name Missing.

A news letter from Black Jack received a day or two ago, was not printed because the name of the writer did not come with it. A hard lesson for people to learn, though it ought to be an easy one, is that newspapers do not print articles unless the editor knows who sends them. The name of the writer should be sent with every letter, not for publication, but as an evidence of good faith.

DRAMATIC SCENE IN ONSLOW COURT ROOM.

Tried and True Heroes of the War Clasp Hands and Renew Their Old Friendshin.

When the case of State vs. Capps was called to the Superior court of Onslow county a few days ago, there came forward an old man plainly dressed, white hair and flowing beard, but in bearing every inch a man, in the person of the defendant Capps. The defendant's counsel not being present, the professional services of Hon. Frank Thompson and Hon. E. M. Koonce, of the local bar, was proffered him by these gentlemen, and being accepted, the trial proceeded. The charge was assault and battery upon one P. Russ, the latter being the State's only witness. He, bearing the marks of old age, but yet vigorous, came upon the stand and told how he and his old neighbor had had a falling out and came to blows. The State rested its case and the defendant went upon the stand and gave his version of the fight, which was substantially as told by the prosecuting witness. In his charge Judge Long told the jury if they believed the evidence of the defendant himself they should find their verdict guilty, which was promptly done by the jury.

Then came the grand climax. Judge Long called both of the old men up in front of him within the bar, and speaking to the defendant, said: "You are an old soldier, perhaps." "Yes," said he, "I am sixty-four years old. I was a member of the 3rd N. C. State troops during the civil war. I was at the battle of Chancellorsville. I remember the charge made on that memorable day." "My brother," said Judge Long, "was killed in that charge." "Yes," said the old veteran, his eye kindling as he seemed to live over again the events of that terrible onslaught. "Yes, I remember the young soldier, falling with the battle flag in his hands at the foot of the enemy's breastworks which we immediately captured. I was one of the soldiers that bore the body of the wounded Stonewall Jackson off the field, where he was shot down by mistake by his own troops."

"Were you in the war?" asked Judge Long of the prosecuting witness. The old veteran stood at attention, and promptly replied: "I was a member of the old 18th regiment." "How old are you?" asked His Honor.

"I am 77 years old," said he. Judge Long then, with voice tremulous with emotion, said: "Old veterans, the war is over. You should not fight each other. One in this case is just as guilty as the other. Only one, however, is indicted." Turning to the defendant, Judge Long said: "I shall suspend no judgement over you. When you leave this world to join your comrade on the other side, not at my hands shall a suspended judgement be on the records of this court against you." Then looking the old veterans kindly in the eye, he continued: "Won't you old veterans shake hands and be friends?" For a moment, like two old prime game cocks, they faced each other, but for only a moment; the spirit of reconciliation set in motion by the kindly words of the judge stole over and wreathed those old battle-starred, wrinkled faces with the smile of comradeship and brotherhood; in paths of deep sympathy and with a mighty hand grasp, these battle-scarred heroes looked in the face of each other, while tears trickled down the faces of the immense throng in the court room.
