## TOWN MATTERS.

### Proceedings of the Aldermen.

The board of aldermen met in regular monthly session Thursday night, all the members being present.

The regular committees had no reports to make. The street committee stated that the embankment on Fourth street approaching the railroad was being widened and the cemetery is being cleaned out.

It was ordered that persons already doing business in that portion of the town taken in by the boundary extension may continue to carry on their business by paying the prorata part of the license tax required up to June 30th.

The chief of the fire department was ordered to have all the fire hose in town tested during the month of May, and that hereafter the hose at two of the reel stations be tested each month.

The mayor reported that the \$15,000 previously arranged for had been borrowed from the three banks of the town. The money was ordered placed to the credit of the sewerage fund.

The interest coupons on bonds for the graded school and town improvements from July 1st, 1904 to January 1st, 1907, which had been paid and cancelled, were burned in the presence of the board.

An election was ordered to be held in the several wards of the town, as required by the charter, on Monday, June 3rd, 1907, to elect aldermen.

The following registrars, poll holders and voting places were appointed for said election:

First ward—Registrar, W. E. Goolsby; Judges, J. D. Garden and Chas. Cobb. Voting place grand jury room in court house.

Second ward—Registrar, L. W. Lawrence; Judges, J. White and W. D. Pruett. Voting place Winslow's stables on Fourth street.

Third ward—Registrar, R. A. Tyson; Judges, J. S. Tunstall and J. C. Lanier. Voting place the Forbes store on Five Points.

Fourth ward—Registrar, H. A. Timberlake; Judges, T. R. Moore and W. L. Brown. Voting place Turnage's store on Five Points.

Fifth ward—Registrar, D. S. Smith; Judges, H. L. Coward and Ollen Warren, Jr. Voting place King's stables near Five Points.

Orders were drawn on the treasurer amounting to \$1,800.82.

The officers made their reports of collections during the past month.

We have called attention several times to the method in various cities of allowing law-breakers of a certain class, especially worthless vagrants, to go free on condition that they leave town. It seems to us that this shifting of the burden to other communities is not right and the tendency in this direction should be checked. If a person commits a crime in a town and is not able to pay a fine, and if imprisoning him will only have the effect of entailing extra expense it is still the duty of the town in which the man is arrested to handle the case and not to transfer the undesirable citizen to some other town to give trouble there because it is easier.—Winston Sentinel.

### WORK THIS OUT.

#### The School Should be in Pitt County.

Suppose the Eastern training school should be located at some town in this section of the State situated 50 miles from Pitt county and you sent your daughter there for a term of four years. Of course you would want her home with the family during the Christmas holidays, and this would mean the cost of railroad fare four times each year, or sixteen times during the four years. After July 1st the fare will only be 24 cents per mile, but even with this low rate the total fare would amount to \$18. This money would pay the taxes of a man listing property valued at \$1,000 for seventy-two years, for a man listing \$2,000 thirty-six years, and for a man listing \$3,000 twenty-four years. Voters of Pitt, don't you see the wisdom of having the school located in your own county? Vote for the bonds and get it here.

We have no idea that the election will go against bonds to secure the Eastern training school, but if that should be the result it will be the worst day's work Pitt county has ever done.

While laboring under a spell of "brainstorm" the cashier of a Birmingham bank imagined that he could corner the cotton market. When the storm blew over it was found that \$100,000 of the bank's funds had gone up in the wind.

Two of the most prominent gentlemen of Greensboro had a street fight growing out of a discussion about the greatness of Marion Butler, and Spencer Adams, each siding for one and claiming superiority for his man. And such a subject to fight over! A scrap over a copper cent would have been about as reasonable.

President Roosevelt has received additional fame. Two gentlemen recently returned from a trip abroad tell him that in their travels through Egypt they found at least ten thousand camels named after him. Camels were always known to be beasts of burden, hence may be able to carry this additional load.

The whiskey business in North Carolina, and in other States as to that, has been dealt another blow. Where prohibition has been established in towns or counties in the State, manufacturers of whiskey in border States have been securing agents to take orders for whiskey which the manufacturer would ship into the prohibition territory. This was done under the claim of being allowed under the interstate commerce law, and a large business of this kind has been carried on between Virginia distillers and several North Carolina towns. A recent decision of the United States Supreme court on a case from South Dakota knocks out this business. The decision is in effect that the place of delivery is the place of sale and the party securing the whiskey is the seller, and where the whiskey is made in prohibition States it is a violation and is not permitted.

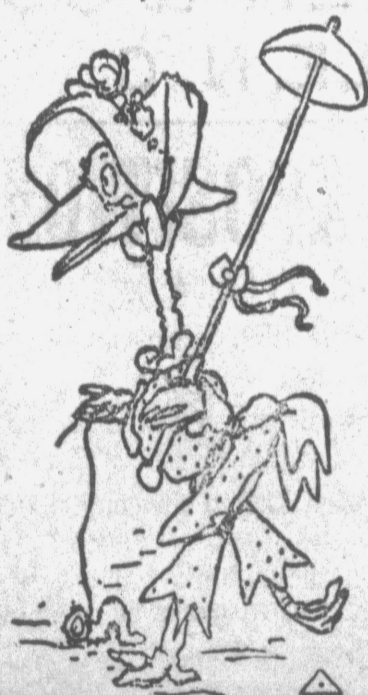
