DURHAM HAS BAD FIRE.

Hotel Carolina Burned Last Night. Other Damage.

Raleigh, N. C., May 2.—A telephone message received here at 11:30 tonight from Durham, N. C., says the Hotel Carolina is in flames and the block adjoining it (the business centre of the city) is threatened. Assistance has been asked for from the fire department of the city and arrangements are being made for a special train to take fire companies there at once.

The Hotel Carolina is the principal hotel of Durham, situated near the depot and centre of the town, and is a large wooden structure.

At 12:45 the hotel was consumed and the fire was not under control. A closely built block containing many stores and two banks is separated from the hotel by a narrow alley and these are in danger. The immense plant of the Blackwell Durham Tobacco Company is across the street from the hotel. Several firemen have been hurt but none seriously.

At 1 o'clock a message was received from Durham just as firemen and apparatus were about to leave this city on a special train saying that the Durham firemen would be able to handle the fire.

The hotel is a four story structure. The loss is \$125,000 fully covered by insurance. There were 50 or 75 guests, all of whom escaped without injury. Some of them escaped in their night clothes, losing all of their possessions.

Appeals to Canada to Help out Shortage in Cotton Goods.

New York, May 4.—Many retail buyers have questioned the statements made this season by selling agents and jobbers regarding the shortage of staple cotton goods, and the fact that it is impossible to make the deliveries called for. That these statesmen have not been exaggerated, in fact, have been under rather than overdrawn, is shown by the position in which one of the largest concerns, namely, the Richmond Underwear Co., with New York offices in Wooster street, and factories at Richmond, Va., and Scranton Pa., manufacturing muslin underwear, now finds itself. This concern which does an enormous business, has been unable to obtain since the year opened, sufficient supplies of cambrics and other goods with which to turn out the orders now on their books, notwithstanding the fact that the orders for goods were placed unusually early. Failing to obtain supplies from American manufacturers, selling agents, jobbers or retailers, an effort was made to obtain supplies of cotton goods from Canada. That these efforts were unsuccessful was revealed by answers from all parts of Canada stating that cotton goods could not be furnished. Some of the firms state that the mills are behind. Some firms submit a few samples subject to the fact that the goods may be sold out before the New York concerns final order may reach them.

For Bonds Only.

Some few people in town thought that in the election next Tuesday the town would vote for aldermen at the same time of voting for bonds. The election on Tuesday will be for bonds only and the election of aldermen will not take place until the first Monday in June.

ROBBERY AT STOKES.

A Store and the Postoffice Broken Into

Thursday night the store of Mr. W. G. Stokes, at Stokes was broken into and robbed of a lot of clothing and various articles of merchandise. The postoffice was also broken into, the same parties supposed to have committed both robberies. Mr. W. C. Hines went over to Stokes with his blood hounds Friday morning, and tracked the robbers up to near Bethel. Word had been sent ahead to the police of Bethel to look out for the robbers. Two negroes—Ernest Young and William Young, claiming Rocky Mount as their home, walked into Bethel a little ahead of the dogs and posse pursuing them and were immediately arrested. They had in their possession two suits of new clothing, several pairs of shoes and various other articles of merchandise and some money.

The negroes were given a preliminary trial before Justice Roberson at Bethel who bound them over to court. As the negroes could not give bond they were turned over to Mr. Hines who brought them to Greenville on the evening train and they were placed in jail. Mr. Hines also took a lot of keys off the negroes that had been filed in different shapes and used for entering houses.

NAME IN THE PAPER.

Jim St. John, of Wilkes, Hears of a Kinsman Who is a New One on Him.

The revenue officers have been pretty busy for the last week or two serving papers and looking for blockade coppers. One night last week, they went down into the mountainous section of Hunting Creek, between Windy Gap and Spurgeon, and yanked up an "innocent" citizen by the distinguished name of Jim St. John and brought him to jail. Along the way, things lagged and got dull, and then it was that one of the officers remembered that the prisoner's name was a new one on him; he had never heard of it except the instance related in the Bible. He called the attention of his companions to the matter and related something of the story of St. John on the Isle of patmos, and turning to the prisoner asked: "Was he your kinsfolk?" "Well," said the prisoner, "I reckon we all the same family, but I never node afore that one of us had gone and got his name in the paper." —Wilkesboro Chronicle

GREAT SCHOOL CLOSING.

Quinners School Completed Third Year.—County Superintendent Presented With Gold Watch.

It has come to be recognized that Pitt county is leading the State with her public schools, and the Quinners school at Centerville stands at the head of rural schools in the county. This is no disparagement of other schools, for there are a number of fine schools in our borders that are the pride of the county and the communities in which they are located, but if a challenge was thrown down to the entire State to show a rural school that would surpass the one at Quinners, we do not believe it could be met.

The third session of this school closed Friday night with appropriate exercises, which were held in the splendid new building that takes the place of the one burned some over a year ago. In planning for the closing exercises it was hoped to have Governor Glenn to deliver the address, but as the time drew near it was found that he could not come. Nor is it any reflection on our able governor to say that his place was excellently filled, for Pitt county is resourceful in men who even on short notice are equal to any occasion, so instead of having one speech by the governor the large audience at Quinners heard three as good speakers as any one could wish to listen to.

The exercises of the school under the direction of the splendid teachers—Messrs. Bettie Wright, Lily Parr and Huldah Morris—were highly creditable to both themselves and their pupils. The speeches interspersed the usual numbers of the program. The first speaker was Prof. G. E. Lineberry, principal of the Winterville High school, who is always eloquent and entertaining.

Rev. W. E. Cox was the next speaker. By request his address related to the bond issue and the Eastern training school for teachers. His argument for the school and bonds was the best we have heard during the entire campaign. The eloquence and force of his words carried the audience with him. We do not see how any man could hear him and not favor the bonds.

County Superintendent W. H. Ragsdale, who is always ready with a good word, spoke of the work of Quinners school, and referred to the hearty co-operation the school, the teachers, the committee and the community had given himself and the board of education in pushing educational work of the county.

A climax came at the conclusion of the program in an incident so unusual as to be profoundly impressive. Prof. G. E. Lineberry again arose and invited all to attend the commencement of Winterville High school on the 16th and 17th.

Following this the audience discovered that he was making another speech, and his subject was of such a nature as to awaken keenest interest. He referred to Superintendent Ragsdale and his work in Pitt county and paid him as beautiful a tribute as ever fell from the lips of one man for another. In conclusion he drew a handsome gold watch and fob from his pocket which he presented to Prof. Ragsdale as a token of esteem from Quinners school and the people of the community.

If accounts in the papers are true, the North Carolina man who thought he was buying a bank building in Norfolk is not the only 'easy mark' found around the exposition.

It is conceded all over the State that the efforts of the citizens of Pitt county secured the passage of the bill by the legislature establishing the Eastern training school. It is also conceded that this school will be located in Pitt county if the people want it. Do they want it? They will show this by their votes on May 14th.

A big majority of the large tax payers of the county favor the bonds to secure the Eastern training school. This being so, it looks like every man who has little or no property to be taxed should also favor it. In fact we do not see how any man who wants to see the children around him have better educational advantages and the county be more prosperous, can be opposed to the bonds.

That man is indeed short sighted who cannot see that the Eastern training school in Pitt county would be the greatest up-buider of the county, intellectually, morally and financially, of anything the county ever has had or ever will have. The idea should not be entertained a moment by any right thinking man of voting against a measure that means so much for his county. If the school should be kept out of Pitt by the vote of her citizens, other sections would look upon us as a people who love ignorance more than intelligence, who love inactivity better than progress, who would rather be led by others than be leaders themselves. Are the people of Pitt county ready for this to be said of them? Your vote on the 14th will decide the question.

The decision of the United States Supreme court establishing the authority of the North Carolina corporation commission to regulate matters pertaining to railroads in the State, should not be followed by everybody rushing to the commission with requests for unreasonable requirements of the railroads. On the contrary let the commission and the railroads come together in a business way and work such reforms in traffic and schedules as are just both to the public and the transportation companies. Let the railroads stop contesting and fighting when orders for reforms are sent them by the commission, and let no unreasonable demand be made of the railroads. While the railroads are servants of the public and should

be under State regulation, they are at the same time promoters of progress and upbuilders of the State. Let differences between the railroads and the public be adjusted on a common sense basis and put a stop to the disposition to take advantage of each other.

Must not Overdraw.

The bankers and other business men the city are very much interested in the decision of the United States Supreme court and several state courts concerning overdrafts are absolutely illegal and that all officers and directors of any bank honoring such a draft are liable for misapplying funds. It also holds against any person or firm issuing a check without funds in the bank. The American and English Encyclopedia of law is quoted as saying: "A bank has no right to allow a customer to overdraw." Comptroller of currency and a large number of State departments denounce it and are preparing to enforce the law in regard to the practice.

Heretofore the law in regard to overdrafts has been loosely construed and more loosely enforced, and goodly numbers of business concerns have taken advantage of the conditions, to the discomfiture of a number of banks. The new decisions make it imperative that all banks use every precaution to keep beyond the danger line, if there should be a panic the banks will suffer the less because their account will be balanced.--Greensboro Record.

A MOST PITIABLE CASE.

Young Girl Found Drunk and Asleep in a Field.

A young white girl 15 years of age, who says she is an orphan from Sampson county, is now in Cumberland county jail, and what to do with her is a problem Sheriff Watson and Deputy Sheriff Pate are trying to solve. She is certainly an object for charitable attention, and we would suggest that some of our numerous charitable organizations take her in hand.

Yesterday Sheriff Watson learned that a young white woman was misbehaving herself on the Wilmington road, and sent Deputy Sheriff Pate to investigate. He found a young girl with but a few stitches of clothes on her back, fast asleep in a corner of Bevil & Vanstony's field having plainly fallen there in drunken stupor.
