Hanging of Negro Caused Death of S. C. Sheriff.

Greenville, S. C., May 6.--Sheriff R. F. McCasian, of Greenwood county, died today, following a general collapse, incident upon the hanging of Joe Evans, a negro rapist.

Evans was the first man ever to hang in Greenwood county and his crime was particularly atrocious.

He assaulted his brother's wife and then shot his brother to death when his act was discovered.

As the time for the hanging approached the sheriff, usually a man of splendid nerve, began to show signs of physical collapse and when the day of the execution approached he dragged himself from his bed and pulled the trap that sent Evans into eternity.

After the man had been pronounced dead by the county physician the sheriff went back to his bed and died this morning less than three weeks after the execution.--Charlotte News.

Pittsburg Expects Very Dear Pig Iron.

THIS SETTLES THE QUESTION.

THE TOWN AND COUNTY STAND TOGETHER AND WILL BOTH DO THEIR PART.

It is strange what statements people will sometimes make in their eagerness to turn sentiment. It reached the ears of The Reflector that some people were trying so hard to defeat the proposed bond issue to secure the Eastern training school in Pitt county, they have been telling that Greenville did not propose to apply any of the town bonds toward the school but was going to use them all for town improvements, and would depend upon the county bonds to get the school. Of course such a statement is absurd, and that no one might be deceived by it we addressed a letter to the board of county commissioners while that body was in session Monday, to get an expression from the members that will settle the matter. The letter and reply are published below:

ALMOST UNANIMOUS.

Out of 329 Registered Voters, 321 Cast for Bonds.

Greenville voted Tuesday on the question of the town issuing \$75,000 bonds to help secure the location of the Eastern training school in Pitt county. Out of 329 registered voters, 321 were cast for bonds, and not a single vote in the entire town was cast against bonds. Of the eight registered who did not vote, two were sick and three were out of town. The vote by wards was as follows:

This was truly a remarkable election and we believe it is without precedent that out of a registered vote this large not a negative vote was cast. It shows that Greenville is practically unanimous for the bonds and for the training school.

Serious Trouble Feared at the Moyer-Haywood Trial.

Washington, May 8.--The trial of Moyer and Haywood, in Idaho, is set for today, and serious trouble is feared, so that martial law is by no means improbable. The murderers of ex-governor Steunenberg are defiant, and act as though they are trying all law-abiding citizens, instead of being under indictment themselves. Senator Borah, who is an attorney for the State in the prosecution of labor leader, sends word that there is noticeable in Boise a great influx of unattached men, whose presence is taken as a menace, and it is expected that as the trial progresses they will make some demonstration intended to intimidate the town and influence the result of the trial.

Greenville and Pitt county are all one and the same people, but it seems right hard for some folks to realize it.

Tuesday's vote in Greenville on the question of issuing bonds, shows plainly to the county what the town of Greenville proposes to do toward securing the Eastern training school in Pitt county.

The way Greenville and the entire county stand together is going to work wonders in the progress of old Pitt. Look what Greenville did in the town bond election Tuesday, and then watch for the big majority the county is going to give in the county bond election next Tuesday.

In one year's time after its organization, The Home Building and Loan Association has made loans amounting to \$20,400. All this money is invested right here in helping people to own their homes. This is an excellent record for a young association, and shows what people can accomplish when they come together to help each other. This association is the most helpful institution the town has.

This has been said before, but will bear repeating, and every voter in the county should stamp it on his mind. The Eastern school for teachers is going to be located in one of these Eastern counties. It matters not where it goes, every man in Pitt county must pay his part of the taxes to keep the school going. No getting around that. Then it is the part of wisdom for every man to vote for bonds so the school can be brought to Pitt county. Think seriously over this when you go to vote on the 14th.

Some towns are putting in for the Eastern training school actually don't know what to call it. They refer to it as industrial school, normal and industrial college, and almost every other way but the right way, all of which goes to show that they did not have enough interest in it at first to know what kind of a school the East was after. Pitt county is going to get it, and after awhile she will send the others invitations to come over to Pitt and see the Eastern training school for teachers.

Some people complain that the bonds to secure the Eastern training school would put a little more tax on the bonds. If they would think about it a little such a school in the county would save them enough every year on the item of school books alone to more than pay their part of the interest, to say nothing of the

other advantages. Under the present condition of the rural schools having to take such teachers as they can get, every time there is a change of teachers there is a change more or less in books, and this takes considerable money. With the training school the teachers would all be trained practically along the same lines, and when they went out to take charge of schools there would be system in teaching, system in work and system in the books used. This in itself would be a big saving.

Notice is hereby given to the voters of Pitt county that the board of county commissioners, at their meeting on the first Monday of April, 1907, it being the first day of said month, ordered that an election be held at the various voting places in said county on Tuesday, May 14th, 1907, for the purpose of taking the sense of the qualified voters of said county on the proposition to confer upon the board of county commissioners of said county the authority to issue and sell interest bearing coupon bonds, of said county, not to exceed the sum of fifty thousand dollars to run for thirty years and to bear interest at a rate not to exceed six per cent. WILD TOBACCO OF COLORADO.

Professor Fritz Knorr of the Colorado Agricultural College has found tobacco growing wild in greatest profusion in the Montezuma valley of Colorado. Professor Knorr is a native of Kentucky and knows tobacco culture all the way from planting the seed to breaking the necks of the big green worms. While attending the farmers' institute at Cortez, in the Montezuma valley, Professor Knorr was asked to suggest a method for eradicating a very troublesome weed. He took a sample of the weed to examine and was amazed to see in it a very fine specimen of wild tobacco. It seems that none of the farmers there was familiar with the tobacco plant and did not recognize the obnoxious weed as the ancestor of the cigars they were smoking. It is believed that tobacco was raised extensively in the Montezuma valley ages ago by the cliff dwellers, the lost race that left so many evidences of their civilization and yet not a line of their history. The wild tobacco plant flourishes there in greatest profusion in vicinities thought to have been cultivated by the mysterious race and along what are believed to have once been their irrigation ditches.—Kansas City Star.

'Twas Hetty Green.
"Who on earth is that woman?" asked a depositor of one of the clerks in the New York Chemical National bank the other day. He nodded in the direction of a shabbily dressed elderly woman who was behind the railings examining one of the ledgers over a bookkeeper's shoulder. "That woman?" whispered the clerk. "Why, she's Hetty Green." "Isn't she a good deal of a nuisance?" continued the depositor, who was lacking in the bump of reverence for money as typified in the person of the richest woman in America. "I don't suppose I should say so," replied the clerk, "but, between ourselves, she is. But then, you know, she keeps a balance here of something like \$5,000,000, and people with accounts like that can be any kind of a nuisance and no one will think it advisable to remind them of it."—Pittsburg Dispatch.

Gun Play Wins Poker Game.
"He overplayed his hand." This is the inscription on a gravestone in a local cemetery, and it recalls a poker game in which the late Charles Folk once played. Folk was a remarkable man and participated in games of various sorts during his eventful career. He did the playing. The other fellow generally was a spectator. Several months ago he entered a sitting with several men from Indian Territory. They played well, but were as novices with Folk. He kept on winning hand after hand until finally one of his opponents grew suspicious and, following a show of four kings, demanded a count of the cards. Unfortunately for Folk, it showed fifty-four cards. There was some gun play, and Folk was buried soon after.—Platon (Ark.) Cor. Philadelphia North American.

Wood as Strong as Iron.
Recent official tests of the many valuable hard woods native to Western Australia have made known the extraordinary properties of yate, believed to be the strongest of all known woods. Its average tensile strength is 24,000 pounds to the square inch, equaling that of good cast iron. But many specimens are much stronger, and one was tested up to seventeen and one-half tons to the square inch, which is equal to the tensile strength of wrought iron. The sawed timber of yate is probably the strongest in the world. The tree grows to a maximum height of 100 feet and has sometimes a diameter of two and one-half or even three feet.

A New State—Lincoln?
There is at the present time in the northwest a movement that promises to assume respectable proportions, looking toward the remodeling of the three states of Washington, Idaho and Oregon in such a manner as to create a new and fourth state out of what is now ordinarily termed in that section of the country "the inland empire." So far there seems to have been three possible names suggested—Lincoln, Jefferson and Whitman, with a preponderance in favor of the first.
