

BETHEL'S GREAT DAY.

Closing of The Graded School.

There are several excellent schools in Pitt county, and Bethel possesses one of them in her splendid graded school, the closing exercises of which took place on the 7th and 8th.

Prof. H. McCall is superintendent of the school and the faculty numbers six teachers. The enrollment the past session was 225.

The closing exercises began Tuesday night with a concert in which a most interesting program was rendered. A feature of this concert was recitations by nine girls in competition for a gold medal. Each girl acquitted herself with marked credit, but Miss Lottie Cherry excelled the others and was awarded the medal by the judges.

Wednesday morning Hon. Lee S. Overman, of Salisbury, junior United States senator for North Carolina, delivered the annual address after an eloquent introduction by Hon. J. L. Fleming, our State senator. Senator Overman's address charmed the large audience. His subject was "Individualism against Socialism and Paternalism" but he said he was not going to confine himself strictly to the subject. He said he was once a school teacher and could readily see the difference in communities where the people were willing to be taxed for schools and where they were not willing. In the one there is culture, refinement, enterprise and prosperity, while in the other there is illiteracy, indifference and poverty of mind and body. Good school houses and good roads indicate that enlightenment of a community.

Individualism, he said, is the growth of men, the growth of men makes the State, the growth of the State makes the country. No country can be greater than the aggregation of its people. Education, character, grit, courage, patience, toil, these are the marks of individuality that bring success. There is no real success without toil. Take education and the Christian religion away and we have socialism and anarchy left.

Senator Overman covered a broad field in his address. His appeal to the young to be ambitious to reach the pinnacle of success and let no obstacle discourage them was inspiring.

Following the address interesting essays were read by the young ladies of the graduating class. A fountain pen was offered as a prize for the best essay and this was awarded to Miss Maud Barnhill.

Diplomas were then presented to the graduating class by County Superintendent W. H. Ragsdale. The class was composed of Misses Ruth Whitehurst, Addie Rollins, Maud Barnhill, and Paul E. Jones and Willis R. Jones.

In the afternoon there was a debate on the query "Resolved that the government should own and operate the railroads of this country." The affirmative was represented by Thomas B. Bryan, Marvin K. Blount and Paul E. Jones, the negative by Willis R. Jones and Willie C. Whitehurst, each of the young men acquitting himself with much credit. A gold medal for the best debator was awarded to Willis R. Jones.

Naval Men Watching Japanese Battleship.

Norfolk, Va., May 9.--American naval officers are watching with great interest the appearance and movements of the Japanese armored cruiser Tsukuga.

Their interest is explained by the facts; first, that this ship with a speed of natural draught of about 22 knots, which is better than any of our own cruisers can do, was turned out from a Japanese shipyard workmen, who are just beginning naval construction; yet, according to naval experts, the ship is perfect in every detail; second, that the Tsukuga was under commission and on the high seas within two years from the time her keel was laid down in Japan. No such speed of construction as this has ever been attained in American shipyards, at least where naval work was concerned, and the best British record, namely, in the case of the dreadnought, is only slightly better than that made by the Japanese shipwrights in the building of the Tsukuga.

Both Sides Working Hard in Miners Trial.

Boise, Idaho, May 9.--Both sides have been working hard in the trial of Moyer and Hayward, who are arraigned today. Attorney J. H. Nugent, who has been in active charge of the preparation of the case for the defense established an office here soon after the arrest of the prisoners, and has spent much of his time in this city. Also, and of large importance is the fact, that Boise has been headquarters for the detective employed in the case. They have been employed by flocks and shoals by both the prosecution and defense. Numbers of them have been encamped here ever since the beginning, to keep tab on the main figures in the case and to learn the business of strangers coming here as prospective witnesses for consultation with the lawyers. Even in Russia, has ever been more completely under the eye of secret service agents. There has been no lack of funds the preparations of the case. The legislature appropriated \$50,000 for the prosecution, and the bill that is accumulating against the state will crowd the capital when it is carried in. The prisoners have been provided with funds by the workmen of the country. There was an uprising of the workers when the prisoners were kidnapped from Colorado, and it has not subsided. The workmen have reinforced their resolutions by contributing money sufficient to enable the prisoners to meet the tremendous resources. Secret lawyers and agents have been engaged in the hunt. They have visited every mining camp in Idaho, Utah, Colorado, Wyoming and Montana, that offered the slightest hope of evidence. They not only prosecuted original research but, so far as possible trailed the agents of the opposition.

Bad Condition of Malta.

London, May 9.--The presence of the colonial premiers from all quarters of the globe has set some of them thinking that Great Britain has one colony that is in rather a bad way. Nobody stops, generally, to think about it, even when the King and Queen have been spending some time there. We have a very vague idea of Valletta, and also of the existence of problems arising out of the mixed nature of the population of the little island that is all. To Maltese, Malta must have a rather sad appearance. An increasing population find its cultivable area continually reduced for purpose of defence. Port Said is now the coaling station for all vessels coming home through the canal, and only vessels from the Black Sea and Asia Minor need coal at Malta; and moreover, an unenlightened fiscal policy encourages corn-growing in an island that should be devoted to other things.

Concealed Weapons--a Farce.

Under the law of this State it is a common occurrence for a man arrested for carrying a concealed weapon to be fined, the weapon restored to his keeping and he be permitted to sally forth with the pistol again concealed on his person. What a farce! But one equally as silly has developed in New York since the beginning of the crusade against concealed weapons. It seems that the public department collects all the deadly weapons that are seized--knives, pistols and dirks--and once each year disposes of them at public auction. These weapons are bought by the pawnbrokers by whom they are sold for a song. Thus, the police department is itself guilty of arming the people it is arresting on charges of carrying concealed arms. This development has brought about the sensible suggestion that a law be passed requiring all confiscated arms to be destroyed and this reform probably will be soon accomplished.--Charlotte Chronicle.

NOTICE TO THE VOTERS OF PITT COUNTY.

Notice is hereby given to the voters of Pitt county that the board of county commissioners, at their meeting on the first Monday of April, 1907, it being the first day of said month, ordered that an election be held at the various voting places in said county on Tuesday, May 14th, 1907, for the purpose of taking the sense of the qualified voters of said county on the proposition to confer upon the board of county commissioners of said county the authority to issue and sell interest bearing coupon bonds of said county, not to exceed the sum of fifty thousand dollars to run for thirty years and to bear interest at a rate not to exceed six per cent. The registration books will open on Thursday, April 11th, 1907, and close at sunset on Saturday, May 4th, 1907. Only those who register can vote.

For Swollen Feet.

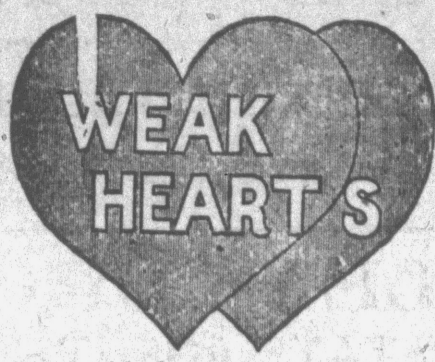
A bath that quickly relieves tired, swollen feet is to mix half an ounce of powdered alum, an ounce of sea salt and one of borax and put a teaspoonful in a foot tub. Soak the feet a quarter of an hour. Dry, pass a white ribbon under the foot, bring it over the instep and pass around the ankle. This prevents swelling and is a great relief.

Cleaning Chamois Skins.

To clean dirty chamois skins rub them with soft soap and allow them to stand for a couple of hours and then rub thoroughly till clean. Rinse them in a weak solution of warm water, soda and yellow soap and dry quickly. It is necessary to have a little soap in the rinse water, or the chamois will be stiff and wry.

To Remove Mildew.

Put the things to be cleaned into a pail of warm water until they are completely soaked, then take out soaking wet and hang on clothes-line in sun and put a thick layer of common brown soap on, then thick layer of salt. Let hang until dry and repeat next day in sun. Be sure to use plenty of soap.

ALL OVER THE HOUSE.

Directions For Dry Cleaning Delicate
Laces—Domestic Gossip.

Delicate or fine old laces may be dry cleaned at home if they have not been allowed to get too soiled by means of breadcrumbs or a mixture of equal parts of flour and magnesia. When using bread, rub the crumbs in with a soft cloth, changing crumbs and cloth directly they look soiled. In the method of using flour and magnesia rub the mixture well in with cloth and allow the lace to stay a few hours before shaking and brushing it. Pull into shape, tack down on a piece of white paper and leave under a weight.

Lace handkerchiefs may be finished successfully on the window pane. Pull into shape and lay on the glass, pressing out every wrinkle. They will dry smooth and ready for use.

Renovating Ostrich Plumes.

The whole secret in renovating feathers is starch, raw, not boiled, as that would act like glue. Take three tablespoonfuls of raw starch to one pint of cold water, into which put the feathers. After they have been washed and rinsed press in a dry cloth with the hands, squeezing as dry as possible, then hang in a draft to dry. When quite dry, shake thoroughly. As the starch flies off in a cloud every flue will rise, and the plume will be just as full and rich as when new. Hang over steam of a boiling kettle. Do not curl near the stem, as it gets too narrow that way. When curling have the forefinger of the left hand parallel with the stem.

To Remove Moles.

Moles must be very carefully touched. They are apt to turn into troublesome sores if tampered with. Mix equal parts of white vaseline and salicylic acid and apply to them at night. In a few days they will become a little sore and in time drop off. If very prominent, tie a bit of white silk thread tightly around close to the face. This takes all nourishment from the mole, and it will dry up and drop off. Do this only one at a time. Be careful not to pick them.

Scorched Woolens.

Treat a scorch precisely as you would any other stain. Sponge the stain with a mixture of equal parts of alcohol, ether and naphtha or benzine, changing the sponge several times. It is possible to remove it by washing with good suds made of lukewarm water and white soap. Wipe dry.
