

The Danger of Summer Separations.

Long summer separations between husband and wife are unnecessary divorces that often leave a long trail of sorrow, grief and misunderstanding. They do not actually wreck home and happiness, but they are an unnecessary risk, like "roeking a boat," a foolish experiment that may overturn and swamp it.

When one member of the home firm takes a long solitaire vacation and the other stays at home in loneliness, Cupid, though blind, sees trouble ahead. With two who love each other the temporary separation may be the thin edge of the wedge of a permanent growing apart. These solo vacations force each into a new environment in which the other has no part; they lessen the sweetness of mutual dependence; they break the continuity of living conference and constant confidence, they make it easier for each to face life's problems alone instead of hand-in-hand.

The regular annual exodus of the wife, because she has a restless desire to get away somewhere, because she has friends who insist on her accompanying them, or because she fears the neighbors will think she cannot afford to go away these are the forms of voluntary separation for weeks and months that are dangerous and sometimes even prove a short cut from matrimony to alimony.

The theory that husband and wife should be separated occasionally so that they may appreciate each other the more is a dangerous doctrine. Vacations with each other may be new miniature honeymoons, bringing renewed love to both, but long vacations from each other are what the insurance companies term "extra-hazardous risks."—William George Jordan in the June Delineator.

Where Lawyers Do Wrong.

Hon. W. J. Bryan is a lawyer himself but he did some plain talking to 300 Chicago lawyers Friday night. The subject of his address was "The Price of the Soul," and in the course of his remarks he said:

If anything is said about the sharp practice, the answer is, "Oh, that is an attorney's privilege." In other words, a lawyer can—and often does—do things which a layman would be harshly criticized for doing, but the lawyer's conduct is excused on the ground that he "is an attorney." Mr. Bryan hopes to see the day when it will be no less disgraceful for a lawyer to do wrong than for other people. Speed the day!—Statesville Landmark.

Rise in Southern Farm Values.

The rise in value of all farm lands will continue as long as there exists the telling argument in such a fact that with a net value of farm products upon the capital invested of 25 per cent. in the South and 16.2 per cent. in the whole country, it is seen that for every dollar received by the farmers of the whole country on the capital invested, Southern farmers received one dollar and a half. But this is not the only strong point in the case. The intensely cold winters of the North make out-of-door work impossible for several months of the year. They add largely to the cost of keeping live-stock and to family expenses for fuel and heavy clothing. The mild weather of the South enables the farmer to work 12 months in the year. It reduces the cost of live-stock raising to a minimum, as cattle can find good grazing for a large part of the year; it makes the fuel bill for farmers an inconsiderable item, and it obviates the necessity of heavy clothing and many other expenses absolutely necessary in all cold countries. Thus the Southern farmers' capital in 1900 not only yielded to them a dollar and a half for every dollar returned to the farmers of the whole country by their capital, but, added to this, there was a difference in the cost of living, which is so great that it must command wide attention as it becomes more fully understood.—From Manufacturers' Record, May 9.

FRANC JONES SURRENDERS.

He Furnishes \$10,000 Bond.

The expected happened yesterday morning when Mr. Francis H. Jones the defaulting assistant cashier of the Charlotte National Bank, suddenly appeared in the city and voluntarily surrendered himself into the custody of the United States officers to answer the charge preferred against him, that of embezzlement. Mr. Jones arrived on Southern passenger train No. 44, which came in a few minutes before 6 o'clock. He was accompanied by his wife and his attorney, Mr. C. D. Bennett immediately upon their arrival, Mrs. Jones was driven home and Mr. Jones and Mr. Bennett called upon United States Commissioner J. W. Cobb. United States District Attorney A. E. Holton was summoned from Winston by phone and the preliminary hearing was held in Mr. Bennett's office in the Piedmont building last night. Mr. Jones waived examination and was bound over on a \$10,000 bond. This bail he gave with the following-named as sureties, Messrs. B. D. Springs, F. H. Andrews, Jeremiah Goff and George W. NOTICE TO THE VOTERS OF PITT COUNTY.

Notice is hereby given to the voters of Pitt county that the board of county commissioners, at their meeting on the first Monday of April, 1907, it being the first day of said month, ordered that an election be held at the various voting places in said county on Tuesday, May 14th, 1907, for the purpose of taking the sense of the qualified voters of said county on the proposition to confer upon the board of county commissioners of said county the authority to issue and sell interest bearing coupon bonds, of said county, not to exceed the sum of fifty thousand dollars to run for thirty years and to bear interest at a rate not to exceed six per cent. The registration books will open on Thursday, April 11th, 1907, and close at sunset on Saturday, May 4th, 1907. Only those who register can vote.
