

MR. RICHARD S. EVANS.

Another Excellent Man Called From Earth.

Mr. Richard S. Evans died a little past 2 o'clock, Friday afternoon, at his home in South Greenville, after an illness of about a week with pneumonia.

Mr. Evans was 39 years of age. He was raised on the farm, four miles from town, but came to Greenville not long after the tobacco market was established here and engaged in the warehouse business. He conducted the warehouse for several years, and since the building he occupied was destroyed by fire he has been a tobacco buyer and also continued his farming interests.

Mr. Evans was a member of the Methodist church and one of its stewards. He was a faithful, conscientious Christian, an upright man in every walk of life, and a good citizen.

In December, 1897, he married Miss Maggie Smith, and the wife and two little sons survive him. He also leaves an aged mother, Mrs. Caroline Evans, two brothers, Messrs. L. F. and W. J. Evans, and one sister, Mrs. A. H. Critcher. Much sympathy is expressed for all of these sorrowing ones.

The funeral will take place Sunday afternoon at the family burial ground, 4 miles west of town, leaving the residence here about 1:30 o'clock.

The story says that a bouncing baby boy just nine days old suddenly began talking and astounded and alarmed all who heard it or heard of it. The story writer shut off an influx of the curious to see it by reporting the subsequent death of the wonderful baby.

Both Were Collectors.

A local newspaper artist got a in Indiana who said he was making a collection of sketches. "I have drawings from well known newspaper artists in nearly every State in the Union," the Indiana man wrote, "but I have none from Ohio. I have seen some of your work and I think it is good. If you will send me some little sketch for my collection I shall have it framed."

The artist noticed from the letterhead that the Indiana man was connected with a bank in one of the small towns over in the State of literature. That gave him a hunch, and he wrote back as follows: "I am making a collection of \$10 bills. I haven't secured specimens from every State in the Union, but I have several tens and a few twenties, and I am particularly anxious to have a ten dollar bill from Indiana. I notice that you are employed in a place where ten dollar bills are kept, and if you send me one for my collection I shall be glad to have it framed."—Cleveland Plain Dealer.

Newspapers are catching it on the price of paper now. A good grade of paper, such as The Landmark is printed on, has been selling for years at an average of 2 1/2 cents a pound. Since January 1st the price has advanced to 3 cents and just where it will stop we don't know. Some of the papers which have yearly contracts, especially the big dailies which buy in large lots, will suffer little from the advance, but in North Carolina, for instance, the great majority of papers don't buy over a three months' supply at a time and many of them buy only for a month or a few weeks ahead. In short, the newspapers which can afford it least are hit hardest, and the worst of it is the advance is a dead loss to them. In the mercantile, manufacturing and almost all other businesses the price to the consumer is changed as prices fluctuate and in this way the dealer can take care of himself as a rule, when prices are advanced to him. But it is almost impossible for a newspa-

per to change an established subscription rate and almost as difficult to advance an advertising rate, once it is established. The average newspaper in this State, therefore, which finds the price of material or other things advanced, simply loses that much in profits and in most cases the profits are short enough at best—Statesville Landmark

We think it would be a good thing if the legislature would make a law requiring parties anticipating matrimony to file their intentions with the register of deeds in the county where they reside; let the bans be published in some paper in the county say a week or ten days previous to the event. In the meantime if there should be any lawful impediment why the parties applying for license should not be united the register should be notified who would refuse to issue license. If there should be no objection raised during the limited time of publication then the old time complaint - my daughter or son is not of legal age - would cut no figure.—Wilson Messenger.
