NIGGER UP NORTH HAS A HARD TIME.

Never a Friendly Word no More'n a Dawg.

Greensboro, N. C., June 12.—The negro question, which at one time seemed prospective of automatic solution by the gradual distribution of large numbers of them North, is getting to be a live one again. Just as the South had become reconciled to the negroes leaving because of the conviction that this gradual migration North had a compensatory value, the nigger like, has bucked. He is evidently getting as tired of the North as that section is of him.

Instead of the usual fever among the more competent negroes here at this season of the year to go into service in some northern city, at reported fabulous wages, several who left in previous years have been able to get back, and others are trying to come. An old negro woman who was a notable cook and all round good servant and family friend, who left a white family here three years ago, is now happy with her old white folks, and their children. They are happy too. The others of her family will return as soon as they can work out of their debt in Haverill, Mass. The old woman says "foax sho have to work dare and never have a friendly word from a white person no more'n a dawg, not as much as er dawg, fur day rides in deir laps and feeds on de best, while day white and black servants mostly has to eat scraps, and not lowed Sunday's for preaching." She also declared that where she was "the law don't notice negroes excusing when dey git in debt they has to work it out or de white police will sho put em in jail."

Only yesterday one of the most prominent merchants here received the following significant, pathetic and instructive letter from a colored man, well known, and highly regarded here, before he left. Upon reading the letter the merchant wrote his former faithful and industrious drayman to come back and take his old job. Enclosed was a check for railroad fare. The letter reads:

"Hoboken, N. J., June 7.
"Mr. — Dear Sir: I thought I would wright you and ask you if you think I could make a living for myself in Greensboro, for I cannot here in the North Nobody cares nothing for you and there is no Pleasure for any one here that loves decency and Respectability. My wife when in Greensboro was one of the greatest Leaders of the colored Women's W. C. T. U. and in the Church and among all respectable folks, both white and colored as you know. The North have turned completely back on us all. It have completely turned her head and My Home Life is a Ill to me. I have worked for Mr. — for four years at \$4.00 per week I have lort but five days in all that time, never got a Sunday off so you see I am a werset slave than my father was in 1860, so I am coming home if you can give me worke if you know eny one that I can get work of Please let me know and tell my Colored friends to stay in the South, for the North is no Place for a christian intellagent colored person, hoping that this will find you and your family and friends enjoying the best of health, I Remain.

AN OLD DEED TO CHURCH SITE.

It Sets Forth Declaration of Religious Principles.

Register of Deeds R. Williams, who is having all the records of his office re-indexed (and when it is finished Pitt county will have a system of indexed records not surpassed in the State) occasionally comes across some rare and interesting old instruments. One of these is a deed for an acre of land on which to build a Baptist church. A remarkable thing about this deed is that it contains a preamble setting forth the principles of belief of the denomination. It reads as follows:

"Whereas it is highly and indispensibly necessary that all people who profess religious principles should have houses of worship in the different neighborhoods to convene and meet at all times when convenient to serve the Lord by prayer, etc., and we the members of the Baptist church holding and professing the following principles, viz: of three equal persons in the God head, eternal election, original sin, particular redemption, free justification by the righteousness Christ imparted, and the perseverance of the saints in grace, &c., of the State and county aforesaid, have thought proper to constitute and appoint our brother, viz., James Hancock and Frances Bond, commissioners and in trust for the members of the Baptist church who profess and hold forth the aforesaid principles, to purchase, receive by gift or secure in any other lawful manner, one acre of land in the county aforesaid on the waters of Swift Creek Swamp for the purpose of building one or more houses thereon at any time when it shall be deemed and thought necessary by the members as aforesaid for the purpose and use of the people who profess and hold the above mentioned principles as aforesaid."

Then follows the deed conveying one acre of land to the church from Thomas Hardee, Sr., the consideration being fine shillings. The boundaries set forth in the deed show it to be the site on which Hancock church, in Swift Creek township, is located. The deed is dated September, 1798, and the record shows that it was exhibited in open court at January term, 1799, and proven by the oath of Josiah Hancock, a witness. The order for it to be registered is signed by George Evans, clerk of the court.

All Criminals "Insane" These Days.

The insanity plea is becoming the favorite one for lawyers to employ in defense of "speckled" or bloodthirsty clients; but in not a single case has there been a commitment to a lunatic asylum of any offender under the plea. It is pretty near time the courts were defending themselves against the contempt judicial proceedings are in such cases coming to be regarded by the people. The smart lawyer seems of late to have increased his facilities for making a travesty of the law. A man in Boston the other day was acquitted of fraud on the plea that he had concealed his assets in a bankruptcy proceedings because of "financial insanity." Every kind of crime now has its "mani" excuse and the worst of it is the laws seem to be helpless against the plea. — Chattanooga Times.

A Member of Co. A, 3rd N. C. Regiment Plowed Up in Maryland.

Last week a farmer near Sharpsburg, on Antietam creek in Maryland, while plowing in his field plowed up human bones, upon further investigation the entire skeleton of a man was un-

earthed and with it a sword bearing the inscription "Arch W. Speight, Co. A 3rd N. C. Reg. C. S. A." This find was on the battle field known as Sharpsburg, or Antietam, where Lee and McClellan fought one of the great battles of the Civil war, Sept. 17th, 1862.

Lieutenant Arch W. Speight, a son of Abner Speight, of Speights Bridge township, this county, was killed in this battle and buried upon the battle field, receiving a soldier's burial, being rolled in a blanket with his sword and thrown in a hole. He was a member of Co. A, 3rd N. C. Regiment which holds its re-union here every 10th of April. We understand that some of his relatives are talking of having his remains removed to some cemetery. His request when he left for the war, if slain on the battle field, was that his remains be allowed to remain where first interred.—Snow Hill Standard Laconic.

EARLY THEATERS.

London's First Playhouse and New York's Oldest Theater.

Few of the comedians who heap contumely upon Philadelphia with jokes built upon her alleged slowness realize the fact that the Quaker City furnished New York with its first theatrical company. This was on Monday, the 5th of March, 1750 at a theater on Nassau street. The play was "Richard III." with Thomas Keen for Richard. The actor was billed as "the Philadelphia company in New York" and played a highly varied repertoire. They came over from England two or three years before and opened in Philadelphia, then the chief city in the British colonies, where they had the honor of presenting the first tragedy ("Richard III."), the first comedy (Dryden's "Spanish Friar") and the first musical piece ("The Beggars' Opera") ever given in America—or in English speaking America, at any rate—by a regular troupe. They were forced to leave Philadelphia for New York owing to an ordinance which called the attention of the authorities to "certain persons taking upon themselves to act plays." The site of their Philadelphia theater was Little Dock street, lying between Chestnut and Walnut and between First and Second streets.

London's first playhouse was called simply the Theater and was erected outside the city walls, on Finsbury fields, in the year 1576. Its builder was James Burbage, an actor, father of the more famous player, Richard Burbage, the original Hamlet. It was taken down some eighteen years later, and the materials were used in the erection of the Globe, Shakespeare's house, opened around 1598. The Curtain, London's second theater, in what is now Gloucester street, near Hollywood street, was so called, strange to say, not from the drop, but from the name of the manor house on the site of which it was put up a few months after the Theater was inaugurated.

The oldest theater now standing in New York is the Thalia, on the Bowery. It was first opened on Oct. 23, 1823, under the name of the Bowery theater, and as such became one of the most famous playhouses in America. The building was three times destroyed by fire—once on May 26, 1828; again on Sept. 22, 1836, and a third time on Feb. 18, 1838. On all three occasions the house was rebuilt and reopened in a remarkably short time. This theater has been the home of every form of amusement, from circus to Shakespearean performances, and upon its stage some of the greatest players America has seen made their debut.—Scrap Book.

THE IRISH CODE.

Dueling as it Flourished Years Ago in the Green Isle.

In the Green Isle dueling flourished years ago as much as it did in France. When a Trinity college student asked the provost what books he had better bring to college the latter said: "Never mind the books. Bring a case of pistols." The students were in the habit of settling those little affairs either just before or just after morning prayers. All the distinguished Irishmen of the eighteenth century were duellists. Curran, Grattan, Sheridan, Barrington, Fitzgibbon, Flood, O'Connell, were often "out," and later the O'Gorman Mahon had twenty-two affairs to his credit. The bar led the list.

Lord chancellors and masters of the rolls fought like cornets of horse. Lord Norbury fought "fighting" Fitzgerald and two others, besides "frightening" Naper Tandy, as the Irish historians tell us. Galway was great with the pistol, Tipperary with the sword. Two English "fines lames," Major Park and Captain Creed, went to Ireland to find foemen worthy of their steel and found them in Mr. Matthew and Mr. Macnamara, who fought with them in a private room at an inn, wounded them nearly unto death, nursed them back into health and were rewarded with their friendship. Colonel Barrington and Mr. Gilbert, two middle aged married men, had a desperate duel in 1759 because they did not wish to leave an unsettled quarrel as a legacy for their children. They fought on horseback with sword, pistol and "skeen," or Irish bowie knife. First the pistols were fired, Barrington receiving some of the charge in his face, but he rushed on Gilbert, killed his horse with his broadsword, dismounted and, putting his "skeen" to the other's throat, called upon him to "ask for his life on pain of death." Gilbert agreed to shake hands and be friends, but without condition or apology. Barrington consented.

"Fighting" Fitzgerald, a well known character, a cousin of the Earl of Desmond, an Eton boy, an Oxford graduate and an officer in the Sixty-ninth foot, fought eighteen duels and was thought by many to be mad. He hired a gang of ruffians, waylaid and killed a gentleman on the king's highway and was hanged at Castlebar. Among others he encountered Martin of Galway, the Rev. Richard Bate and Captain Harvey Ashton, afterward killed at Madras in a duel with Colonel Allen. The Ashton duel and another fought by Clive with a Calcutta civilian indirectly helped British arms to many victories. The first made way for a Colonel Welleley, afterward better known under another name, to an important command before Seringapatam. The second had, by displaying the desperate courage of Clive, secured him a military appointment in a time of emergency.—Cornhill Magazine.

Lives of Animals.

Domesticated animals as a rule live longer than their wild kindred. A dog may live twenty years. Wolves, foxes and cats live to fifteen years.

Pigs attain forty years. Horses reach twenty-six to twenty-seven years. But there is an instance on record of a mare attaining the ripe old age of sixty-two. Street car horses rarely ever last longer than twelve to thirteen years.

Despite his cheerful disposition a squirrel rarely ever lives to be older than seven, while, on the other hand, the sober minded camel manages to live 100 years.

Bears die at twenty, lions a little older, but the patriarch of them all is the elephant. He is in his prime somewhere near 100 and only begins to feel the effects of age when he gets to be 300 or 400 years old.

A Passion For Buttons.

Louis XIV., the "grand monarch," had a positive passion for buttons. In 1685, when his craze was at its highest, he spent no less than \$600,000 in this strange form of indulgence. Among the items of which this expenditure was made up are the following: Aug. 1, 1685, two diamond buttons, value 67,866 francs; 75 diamond buttons, value 586,703 francs. On the buttons for a single vest he spent \$200,000. Of the 354 "boutonnieres" used 102 contained five diamonds each. It is estimated that during his lifetime this foolish monarch spent no less than \$5,000,000 on buttons alone.

FRICTION MATCHES.

At First They Were Looked Upon With Fear and Distrust.

It was not until about the year 1833 that the friction method of obtaining a light began to be developed and friction matches came into use. These matches were looked upon with some distrust at first because of the fire with which they might "go off" of their own accord and burn people out of house and home. The conservative still scraped away with his steel and flint holding the sulphur dipped stick in fear and trembling.

One Robert Gibbs tells the story of the first match he ever saw. A schoolfellow who had visited London brought back with him, besides his stories of that wonderful town, a box of the newly invented matches. He exhibited them to his wondering mates and as a great favor presented one to Gibbs. The boy took his prize home, struck it in the chimney piece and gleefully watched the surprise of his mother.

"Now you may throw away the tinder box," he said.
"No such a thing," responded the prudent woman. "Matches which light themselves will find no place here. Why, some night we might be burned in our beds! Give me the tinder box."

A Salem (Mass.) newspaper of June, 1836, speaks approvingly of one of the inhabitants of its town:

"Notwithstanding the convenience of those dangerous little articles which are in almost everybody's hands, but which, with all their charms, bid fair to prove a heavy curse on the community, we learn there is one man in Salem, a respectable tradesman, who keeps a store where we should generally expect to find such things, but who has never sold them or allowed them to be used on his premises. He sticks to the flint, steel and tinder. He shows his wisdom in so doing. How many more can say as much?"

A New One on the Kaiser.

An excellent story is repeated of the kaiser, whose power of being enthusiastically interested in every function he attends was once commented upon by a foreigner, who inquired of one of the younger princes how it was that his father was able to display such unbounded enthusiasm about such everyday occurrences as births, marriages and deaths. "Ah!" was the answer. "That is part of father's wonderful character, for whenever he attends a christening he thinks he is the baby. Whenever he honors a wedding with his presence, he imagines that he is the bride, and whenever he attends a funeral somehow or other he invariably manages to get hold of the idea that he is the corpse."--Town and Country.

The Rare Old Grizzly.

The grizzly has now become so rare that even his habits and history are frequently misstated, and by those, too, who should speak with authority. It is a very common supposition that he is an animal of seclusive and solitary nature, who wanders alone along the snow line of the Sierras and the Rockies, descending only occasionally upon predatory visits to the valleys, as Thomas S. Mosby points out in Harper's Weekly. But the grizzly is solitary only because he is now facing extermination, and he inhabits the snow line because he has been driven from valley and plain, and there is nowhere else to go.

Bradstreet to-morrow will say for Richmond, Va., and vicinity: "Wholesale dealers in and jobbers of shoes continue active; in some localities sales show a falling off, but on the whole business shows an increase. Wholesale dealers in dry goods had a good season in first ordering, but re-ordering has been very light, due to unseasonable weather. Stocks in the hands of retailers in practically every line are larger than usual at this season. The crop of tobacco of 1906 has practically all been marketed, prices continuing high through the season. Tobacco plants are scarce, and with continued unfavorable weather conditions the crop this year will be light. Present prospects for the peanut crop are not good, the stand is not good and considerable re-planting has been necessary. The cotton crop in most sections of North Carolina is late. Continued unseasonable weather depresses retail trade, and has resulted in backward collections in practically every distributing and manufacturing line."
