WHOSE FAULT IS IT?

Does this Justify a Re-opening of the Matter.

If mistakes, discrepancies, or ambiguity appear in the bids of any town filed on the 5th of June, the town filing the bid with such mistakes, discrepancies and ambiguity alone ought to be held responsible for such mistakes etc. The board received and examined these bids on the morning of the 5th of June before the delegations from any town were admitted in the executive office where the board was holding its sessions and we humbly submit that if such mistakes, discrepancies, or ambiguity were found in the bid of any town, then and there was the time and place to have had such mistakes, discrepancies or ambiguity corrected. It seems to us that it was certainly the duty of the board to have had clear cut and unmistakable propositions before them before they commenced their tour of inspection. Certainly it must be admitted that a town that did submit a proposition without these mistakes, discrepancies and ambiguity ought not to suffer on account of these things occurring in the proposition of some other bidding town.

We believe that when the board meets on the 10th of July and goes over these propositions again that when it finds a clear cut, unmistakable proposition made by any town on the 5th of June it will not allow said town or towns to suffer on account of any mistakes, discrepancies or ambiguity that may appear in the sealed bids of any other town or towns, filed on the 5th of June or any additions, changes, or corrections which any town has made in these sealed bids or any NEW proposition which they may submit.

And we further humbly submit that when the board ascertained at its meeting on the 27th that such discrepancies did exist in some of the bids that it did not justify the board in re-opening the whole matter and allowing the towns which filed these defective bids to submit new and different propositions at this late day. That would be allowing a man to take advantage of his own wrong, a thing that is never done in a court of equity. In these comments it must be understood that we are speaking of the bids made in writing, sealed and delivered to the Board. When the board publishes its rules requiring this class of bids we understood that these alone would be considered and we confidently believe that such is, and will be its final action.

BOYS WANTED.

"Boy Wanted" is a sign that is seen more frequently in the windows of business places now than for many years, according to the Philadelphia Record. Business men of all classes and conditions are complaining of the scarcity of boys of a suitable age who are willing to work, and a bright, active lad of the legal age will find no trouble in securing his choice of any number of good offers. The reasons advanced for the scarcity are varied. Some men of business say it is a direct result of the labor laws, which keep a boy from working as young as was formerly possible. There are many offices in which a boy is required to act only as messenger, and the wages are not sufficient to attract a boy of the age required by law. Others say that the lack of working boys is due to the prosperity of the masses of the people, making wage earning by the younger members of the family less a matter of necessity than it was years ago.

History of Creased Trousers.

"Did you ever hear the history of the crease now uniformly worn in trousers and occasionally extending to the sleeves of coats? No. Well, it's a funny one. In former years creased trousers were the signs of a hand me down suit," says a fashionable tailor. "One day while on his way in a carriage to the Goodwood races, in England, King Edward happened to spill a glass of red wine on his light fawn colored broadcloth trousers, and, unwilling to return to the palace, he stopped at a ready made clothing store and bought a pair. In his haste he could not wait to have the creases ironed out. As a consequence he was seen at the races with creased trousers. The fashion was set, and it has stayed ever since. Yes, we're all—that is, all men—subjects of King Edward in a sartorial sense. Fortunately he is a careful dresser or the consequences might be serious."—Philadelphia Record.

Tobacco in Colonial Days.

The Jamestown exposition brings to mind many incidents showing the important part which tobacco played in the early history of the country. It was the famous James Rolfe, the husband of Pocahontas, who first adopted from the Indians the idea of cultivating tobacco, and he sold his first crop in London for \$2.50 a pound. Shortly afterward it became a form of currency in the colony, and before the century was out the women went trading, followed by a cart of green tobacco in charge of their servants. On one occasion anyway this tobacco currency exercised a transcendently important function. In 1619 there came to Jamestown a shipload of maidens as wives for the settlers, and the price set upon each damsel was 120 pounds of tobacco.—Exchange.

A Young Man's Essay.

About forty years ago the adjudicators of the Arnold historical essay prize at Oxford university were wearily plowing through the usual lot of commonplace compositions when they suddenly lighted on one which was not commonplace. The subject was "The Holy Roman Empire," and it is not too much to say that the cynical dons were electrified to enthusiasm. Hastily awarding it the prize, they opened the sealed envelope and found that it was the work of one James Bryce, then twenty-five, who is now British minister to the United States. His essay has been reproduced in several languages and to this day is a standard on the subject.

WHY SUCH CONFUSION?

The last legislature passed a law providing for the establishment of the "Eastern Carolina Teachers Training School," and placed the selection for the location of such school in the hands of the State Board of Education. It was known that several eastern towns wanted the school, and some time after the legislature adjourned the board sent out notices that sealed bids for the location would be received at Raleigh on the 5th day of June. With this notice was sent the rules governing the bids. Eight towns had representatives present on the date designated and bids from these were deposited with the board in accordance with the regulations stipulated by that body.

It was also designated by the board that it would after receiving the bids go in a body and personally inspect the sites offered by the towns before making a decision as to where the school should be located. The bids were filed, the tour of inspection made, and the board met in Raleigh on the 26th to make up a decision. The following resolution adopted at the meeting is all that was done:

"That the selection of the site of the East Carolina Teachers Training School be postponed until 10 o'clock Wednesday morning, July 10, 1907; that, on account of a variance and discrepancy in the offers made by the different bidders for the location of the school and a misunderstanding by the members of the Board as to these offers made at the meeting on June 5th, the Board decided that, in fairness to all and that there might be no misunderstandings and no advantage given to any bidder, all be allowed, if they see fit, to state in writing what they are willing to do, allowing them to add to or explain the bids heretofore made; that, confusion having arisen on account of the ambiguity of the bids heretofore made, no alteration or increase shall be considered except as clearly made in writing; that no further oral argument is requested by the Board but each bidder so desiring may appoint one representative to be present on July 10th when the bids are submitted to the Board."

If there was any variance, any discrepancy, any misunderstanding, any confusion, any ambiguity in any of these bids, The Reflector is ready to declare that Greenville and Pitt county are in no way responsible therefor. Sealed bids were called for, and the impression was that these bids were to be explicit and final. Acting on this understanding our people made a clear cut, straight forward bid, setting forth clearly and exactly in writing just what was offered. This bid was properly signed by the persons appointed by the governing boards of the town and county to make it. The bid showed that both the town and county had under authority of the legislature voted bonds for this purpose. Accompanying the bid were options on sites offered upon which to locate the school, said options being signed

by the owners of the land and duly certified by the proper officials. Every detail of it was set forth clearly, legally, and in strict compliance with the rules laid down by the board.

This bid was deposited with the State Board of Education and will remain in their hands. It is so clear that it cannot be misunderstood in the slightest detail. Not a sentence in it bears the least confusion. Not a vestige of ambiguity can be found in a word of it. Should the board so desire it can publish this bid, and we venture the assertion that no person who reads it will fail to understand every syllable it contains.

The bid was made in good faith, and since it was made Greenville and Pitt county have made no effort by word or act to influence the members of the board in their decision. Our people have rested upon the merits of their bid, determined to wait patiently the verdict of the board, and this will be their course to the end of the matter.

When the board visited Greenville on the tour of inspection, in deference to the wishes previously expressed there was no demonstration, no banqueting, no public reception, nothing whatever that could be construed as intended in any way influence the members, nor was a word spoken in disparagement of any other competing town. Yet every courtesy was shown the members of the board as they were quietly and without ostentation taken in carriages by a committee of citizens to view the different sites offered here. Had a demonstration been desired here, Pitt county could have easily turned out thousands of the best people on the face of the earth to meet the distinguished guests, and who would have done full credit to such an occasion.

As said before, Greenville and Pitt county are in no way responsible for the misunderstanding and confusion which the board claims to have found in some of the bids. Ours is clear, to the point, and unmistakable. Greenville and Pitt county entered the contest determined to win on merit only, and as has already been asserted in this paper, if we cannot get the training school because we merit it we do not want it.

The first half of the year has been good for Greenville in the way of progress. Let's all do our best to make the last half better.

Major John W. Powell, whose right arm was shot off during the civil war, undertook and brought to a successful issue one of the most daring feats of modern times. While making his explorations of the canyons of the Colorado river in 1869, says the author of "The Masters of Fate," he was called upon to face great dangers and toils. His own account of his explorations gives some idea of the difficulties encountered.

"I have a barometer on my back, which rather impedes my climbing. The walls of the fissure are smooth limestone, offering neither foot nor hand hold, so I support myself by pressing my back against one wall and my knees against the other, and in this way lift my body in a shuffling manner a few feet at a time until I have perhaps made twenty-five feet of the distance, when the crevice widens a little, and I cannot press my knees against the rocks in front with sufficient power to give me support in lifting my body, and I try to go back. This I cannot do without falling. So I struggle along sidewise farther into the crevice, where it narrows.

"I find I can get up no farther and cannot get back, for I dare not let go with my hand and cannot reach foothold below. I call to Bradley for help. He cannot reach me. Then he looks around for some stick or limb of a tree, but finds none. The moment is critical. Standing on my toes, my muscles begin to tremble. If I lose my hold I shall fall to the bottom and then perhaps roll over the bench and tumble still farther down the cliff. "At this instant it occurs to Bradley to take off his trousers, which he does, and swings them down to me. I hug close to the rock, let go with my hand, seize the dangling legs, and with this assistance I am enabled to get to the top."

Mme. Marchesi.

In my opinion the greatest living teacher of singing is Mme. Marchesi of Paris. Begin the head notes on F sharp, and once on the head notes always sing pianissimo." While with her I took only three short lessons every week. But I worked eight hours a day studying theory, tradition and technique—the old Italian technique that tells a pupil how to "fiar il tuono"—to spin a tone as subtly and delicately as a spider spins its almost impalpable web of silk.—Nellie Melba in Century.
