

**THE PEONAGE CASE**

**E. A. Kline Held Under \$2,500 Bond.**

At the instance of Special Agent Hoyt of the Department of Justice a warrant was sworn out before United States Commissioner King, of this place, against Mr. E. A. Kline, a contractor on the Raleigh and Pamlico branch of the Norfolk and Southern railroad, for peonage; that is violation of Section 5526 of the Revised Statutes of the United States, which reads as follows.

"Every person who holds, arrests, returns, or causes to be held; arrested, or returned, or in any manner aids in the arrest or return of any person to a condition of peonage shall be punished by a fine of not less than one thousand nor more than five thousand dollars, or by imprisonment not less than one year nor more than five years, or by both."

The basis of this prosecution was the arresting and returning to a state of peonage on four different occasions a number of foreigners who were at work under the said Kline in the construction of the said railroad.

It appears for some cause these several alleged peons at different times desired to leave their work whereupon Mr. Kline consulted a Justice of the Peace and warrants were issued for their arrest. They were arrested by the sheriff of the county, committed to jail, and it seems that the sheriff was instructed to release them from the bail when they made up their minds to return to work under Kline. It seems that this choice was given the peons either to return to their work or else to be tried before a justice of the peace and be fined or imprisoned. Under these circumstances, through an interpreter, they indicated a preference to return to work rather than to be put on the roads.

This seems to have been rather a loose manner in administering the law, as Kline was given the processes of the court for the purpose of holding these men in servitude, the basis of Kline's right to hold them being an alleged indebtedness for their transportation from New York to Pitt county, where they were placed on work. It turns out that for some of the men who were arrested and committed no warrants at all were issued, but they likewise, believing that they were rightfully arrested and committed, returned to work rather than to continue in imprisonment.

The trial was had Saturday in the court room before King, United States Commissioner, and while the government had twenty or thirty witnesses subpoenaed it made out its case on the testimony of Major Harding, Justice of the Peace, with the warrants which were issued by him in the cases, which were offered in evidence by the government.

District Attorney Skinner and Special Agent Hoyt represented the government in the matter and Col. F. G. James represented the defendant Kline. The defendant introduced no testimony. The court held the defendant to bail in the sum of \$2,500 for his appearance in the next term of district court at New Bern.

Also at the instance of Special Agent Hoyt and District Attorney Skinner, eleven of the alleged peons were held to bail for their appearance as witnesses in the case at the New Bern court, and in default of bail were committed to jail. The district attorney however, stated that this commitment would work no hardship, as they would be cared for at the expense of the government and in addition would be paid \$1 per day while they were held in jail, and also permitted under the custody of the sheriff to do any other voluntary work as they desired, and at such prices as they might agree to take for such service for their own use.

This case is novel and interesting in this section for the reason it is the first warrant for peonage that has ever been issued in the Eastern District of North Carolina. The president and department of justice is taking much interest in the prosecution of the crime of peonage to prevent, if possible, the growing tendency

**NEGRO KILLED.**

**Officer Shoots With Fatal Effect.**

There was a negro minstrel show here Saturday night in a tent near the court house. Chas. Barnes, a colored man from Williamston, was raising a disturbance around the tent. Chief of Police Smith arrested Barnes for disorderly conduct and started with him to the station house. When they were passing the alley between the stores of Fleming & Mooring and J. R. & J. G. Loye, the negro broke away and ran in this alley. Officer Smith fired three shots in the air thinking they would make the negro stop, but such was not the result. Assistant Police Clark, who was not far away, was attracted by the pistol shots, and hurrying to the scene made chase after the negro.

The race went through the alley out to Third street, then around the corner into Cotanch street, and down this street to Fifth street. Officer Clark was gaining on the negro when the latter suddenly turned and fired a shot at him but did not hit him. Officer Clark at once returned the fire, his shot striking the negro in the right breast. The negro turned to run when the officer fired a second shot which struck in the upper part of the shoulder. The first shot that struck the negro was a fatal one and after going a few feet he fell dead in the street.

Coroner Laughinghouse held an inquest Saturday afternoon, the verdict of the jury acquitting Officer Clark from blame, on the ground that the shooting was justifiable.

to create a condition of involuntary servitude and to prevent the growing tendency to imprison for debt. This particular case involving helpless foreigners who cannot speak the English language, is of special interest and has caused the attorney general to instruct vigorous prosecution of the same, the matter having been called to his attention from several different sources.

Special Agent Hoyt will remain in this field for some time and give special attention to developing all the facts in connection with peonage existing along the line of the construction of this railroad where foreigners have been placed in this condition.

There are rumors of very harsh treatment toward some of these people at the camps where they lodged and around their work but as none of these were brought out at the preliminary hearing and are to be investigated in the trial at the higher court, no comment is made upon this feature of it.

It has also been charged against these foreigners that they are trifling people and will not work, but this is not borne out by the facts. True there may be some sorry ones among them, but others who have been tried are found to the contrary. When the first bunch of them were arrested on a warrant sworn out by Mr. Kline, one of them who had some money paid himself and a companion out of jail. One of them was afterward employed by the town of Greenville as teamster, and the other by Mr. G. T. Tyson to work on his farm. Both of these have proven good workers and are entirely satisfactory to their employers.

We heard Mr. Tyson say he would like to have more hands like the one at work for him. "Jake," as the one employed by the town is called, is making himself useful and cares for the horses better than any one who has previously had charge of them.

Some others of the foreigners who came here, seeing what had befallen their comrades, wrote to friends North for money with which to return, and the money was promptly sent them. This does not indicate that they are people of no standing.

**Change in Board of Aldermen.**

This being the beginning of a new fiscal year in the affairs of the town, the old board of aldermen held a short meeting this morning to turn over the administration to their successors. Mayor F. M. Wooten submitted a condensed report of the work done during the past year which will be published later with comment.

The newly elected aldermen appeared and the oath of office was administered by Superior Court Clerk D. C. Moore. The board is composed as follows:

Alderman Carr was elected mayor protem and took charge of the meeting.

A hitch came in the proceedings over the election of dispensary commissioner. Two of the board—J. C. Lanier and W. L. Hall—were chosen by acclamation, when Alderman Flanagan offered the motion that the selection of the third member be deferred to the August meeting. His reason given for this was that from what transpired in the caucus he felt confident the third commissioner could not be elected at the present meeting. His motion was carried.

Some discussion followed as to the result the election of only two commissioners would have on the conduct of the dispensary until the third commissioner could be chosen. Alderman Carr, who had voted for the Flanagan motion, moved to reconsider it and go into the election of the third commissioner.

The names of B. J. Pulley and E. B. Ficklen were presented and several ballots taken without a choice being reached. While the board was equally divided between the two candidates, they were careful not to make a tie vote so as to throw the decision on the mayor.

Later the name of T. M. Hooker was presented, and after a few more ballots he received a majority and was elected third commissioner.

The first regular business meeting of the board will be held Thursday night. There is a year of much work before them, and they want to make it a good year for the town.

If the town officials had been compelled to wade through the oceans on Eighth and Ninth street Saturday, they would feel like taking some steps to divert the water and prevent such floodings.

The State Board of Education and sealed bids in hand by which to reach a decision as to the location of the Eastern training school. If the gentlemen allowed themselves to be confused, when on their tour of inspection, by outside statements not included in the sealed bids, they departed from their legal duty in giving such outside statements consideration. Greenville and Pitt county made a clear, straightforward, sealed bid, one that any man can readily understand, and from here have emanated no outside statements that could in the least confuse the import of the bid.

The State Board of Education called for sealed bids for the Eastern training school, and sealed bids were presented on June 5th. After these bids had been in their hands fifteen days the board went on a tour of inspection of the sites offered. Returning from their tour of inspection, twenty two days after the bids were in hand, the board announced that there is so much variance and ambiguity about the bids that they are misunderstood. What it is about the bids that confuses the gentlemen of the board we are not prepared to say, but we can say with absolute certainty that there is not one iota of the Greenville and Pitt county bid that can not be readily understood. Just read that bid again, gentlemen, and you can clear up the muddy waters.

Just now there is an epidemic of ministers getting into trouble. The South Carolina case, mentioned elsewhere, is a little the worst yet. The pity of it is that the few men of the cloth who dishonor the Master and bring reproach on His cause do more harm than ten times the number who have lived upright lives. The general public, always critical of ministers and always ready to believe evil, does not stop to think that there are comparatively few ministers who dishonor their calling; that where one goes wrong there are hundreds who have lived upright and godly lives. Rather, the disposition is, when one sins, to say that all are but wolves in sheep's clothing. This is wrong, of course, but it is the way of the world. The minister must necessarily be a better man, a more consecrated man, than his fellows, but it would be well if all of us would remember

that the minister is human and subject to like temptations as ourselves; he has his weakness, his errors of judgment and his shortcomings, just like other folks. We don't mean that conspicuous wrongdoing is to be excused in the minister, or that he should engage in wrong-doing of any sort, for he must know that unless he walks the straight and narrow path of duty his usefulness is impaired if not destroyed. But we do mean that we should be more charitable and less critical toward the minister, remembering always that he is human; always, as the slave constantly whispered to Scipio in the hour of his triumph, that he is but a man. - Stateville Landmark.

Cleaning the Hands. The best cleaning agent for the hands is to take one tablespoonful of cornmeal (yellow) and four tablespoonfuls of vinegar, rub well into the hands for about two minutes, then wash off in clean cold water, dry carefully, and the hands will be soft, clean and velvety. Sour milk can be used in place of vinegar with just as good results.

Wash Clotheslines. When your clotheslines get black and sooty, as they are sure to do, wind them around the elbow and hand, then tie a common twine around through the loop, shake them out and lay on the washboard in a tub of hot suds. Take the scrubbing brush and scrub it, brushing always downward.

Washing Handkerchiefs. For washing handkerchiefs that have been used when one has had a bad cold make strong salty water in a basin, place the handkerchiefs in and put them on the stove and gradually heat. Remove them and rinse in clean water, and they can be put in with the rest of the laundry.

Thread and Needles. To prevent thread snarling thread the needle with the first end of the thread that comes from the spool. To save labor keep two needles threaded always (one with white, other with black thread) to mend at once the just discovered rip or sew on a button.

Cleaning Sponges. To clean an old and foul sponge first soak it for several hours in a solution of permanganate of potash, then squeeze it and put it into a weak solution of hydrochloric acid, about one part acid to ten parts water.

A Sewing Wrinkle. When stitching thin silk or other gauzy material on the machine if it shows a tendency to pucker place a sheet of tissue paper between the material and the feed of the machine and it will sew without puckering.

For Blood Stains. Soak in cold soapsuds to which a little kerosene has been added. For tickling and thick goods cover with a thick paste of starch and water, leave in the sun until dry and then brush off.

**THE TIPPING NUISANCE.**

Sway Within and Without the Theaters of Paris.

"When a Parisian hits on the unhappy idea of going to the theater," writes one of them, "he has to run the gantlet of a rare collection of nuisances and plunderers. First there is the crowd outside the theater, and then there is another gang inside.

"He must give one tip to the coachman who drives him and another to the nimble person who springs to open the carriage door, even if he opens it himself. Then come the flower girls and the ticket speculators and the programme vendors. They stand in his way and importune him. He has almost to use violence to rescue his coat tails from their clutches.

"At last the theater foyer swallows him up. He is saved from one lurking pack, but new persecutors are ready. There is, first, the refreshment counter attendant. Won't he buy oranges? No, he won't. Then won't he buy candy for the lady? No. Then maybe a sandwich to eat between the acts, and so on. Next to this plague comes, second, the programme peddler—only authorized and official programme, of course—and, third, the opera glass man."

There is a fourth, too, but the fourth interior plague of the theater takes a great deal of space and ill temper to describe it. She is the ouvreuse, the official box opener and seat finder, the counterpart of the usher in New York, but displaying an itching palm and a very unpleasant disposition when not paid to be genial. The ouvreuse is the worst parasite of the Parisian theater, and few indeed are they from whom she fails to draw blood.

Her hand is not extended until the close of the performance, but she begins to get her fine work in at once. Not that she makes any pretense of finding the boxes or seats that the tickets presented to her call for. The kicker defies any one in Paris to come forward and swear that she ever found his place for him. Nobody could make such an affidavit without committing perjury, he says. But what she does is grab his hat and overcoat and walking cane. These she locks up in a chamber of horrors which she calls the cloakroom, and thenceforward the victim is at her mercy. He can not escape without paying tribute.

It is no wonder that the ouvreuse devotes more attention to collecting her revenue than to seating the audience. It is a serious matter for her. Not only has she to make her living out of it, but she must also make up the quota of "the house." In one theater the ouvreuse pays 7 francs, or \$1.40, a night for her privilege. Sometimes it is more or less, but always somewhere between 5 and 10 francs, except in two or three of the best theaters, which have tried to reform the system. One or two go so far as to pay a salary, but even in these there is such a pleading look in the poor woman's eyes as she surrenders one's light baggage that no man with a tender heart can keep his hand out of his change pocket. He knows the woman is under heavy expenses. She must be expensively dressed in up to date style to keep her job.

But occasionally a man will revolt. One tells how one June evening he went to a variety theater alone. He dodged the ouvreuse at a busy moment, slipped down the aisle, found his seat by himself and sat down in it with an expression of unconscious innocence. As it was warm, he had no overcoat, and he hid his hat under the seat. All the same, toward the end of the performance the ouvreuse appeared with outstretched hand.

"What for?" he asked.  
 "For service," she answered.  
 "What service?"  
 "The customary service."  
 "But you gave me none. Why should I give you anything?"  
 "Oh, pardon," she explained in a good audible tone. "I did not recognize that monsieur was a dead-head!"

This brought him to time, and he gave her a franc.—New York Sun.

**Making Panama Hats.**

The panama hat industry is carried on in the departments of Cundinamarca, Tolima, Antioquia and Santander, in the republic of Colombia, but mostly in the last named department, where it is the breadwinner to more than one-half of its population. There are no regular factories, but the hats are hand woven by thousands of peasant women in almost as many households and old or traded in the local stores in exchange for provisions or articles of clothing, the hat being in these regions a convenient medium of exchange, the housewife exchanging the product of her labor for so many pounds of flour, sugar, etc. Panama hats are made with the veins of fibers of a palm leaf, the tissues of which are scraped off or combed in much the same way as hemp.—Baltimore Sun.
