MUSIC TO THE TUNE OF

CHAIN GANG THIRTY DAYS FOR ASHEVILLE AGENTS

Ticket Punchers "Catching It" in all Quarters—Green, in Raleigh, on Trial Today—Other Agents Have Been Arrested

Defying the federal court and its writs of habeas corpus issued the day before, Police Justice Reynolds at Asheville yesterday morning tried J. H. Wood and O. C. Wilson, representatives of the Southern railway, for violating the new state passenger rate law, and sentenced them to thirty days on the county roads or "chain gang" of Buncombe county. The justice first fined them and when the defendants refused to pay a fine he ordered them to the county roads. Their terms are to begin today.

Judge Pritchard hurried home last night from Raleigh, where he had gone yesterday morning to take a hand in the matter. Another writ of habeas corpus is expected when he gets to Asheville. Judge James E. Boyd, of the United States District Court for the Western district of North Carolina, was also called from Toxaway to take a hand in the proceedings. Interest in the case is at fever heat in Asheville.

Wilson is city ticket agent and Wood is district passenger agent there. These two men were arrested Tuesday and released Wednesday morning to avoid Judge Pritchard's writ of habeas corpus. Judge Pritchard left town Wednesday evening, the two men were re-arrested and spent the night in custody of an officer, in default of bond, and carried before the court yesterday morning.

At Raleigh yesterday the Superior court proceeded with the trial of Agent Green, and the taking of evidence was concluded. The argument of counsel will be made today and the case is expected to go the jury this evening. Judge Pritchard was in Raleigh yesterday but took no action, thus avoiding the predicted clash.—Greensboro Industrial News

Raleigh, N. C., July 18.—Today has seen the prosecution of the Southern Railway Company and Ticket Agent Green pressed without interference from the federal court to the point of all the evidence being in and conceding counsel agree that argument shall begin at 9:30 o'clock tomorrow morning with two attorneys to speak on each side, speeches limited to half an hour each. The empaneling of the jury consumed the morning session and the testimony for the prosecution this afternoon. This was merely proving sale of tickets at old instead of the new 24 cent rate, with the point scored by the Southern that the sale included the rebate coupon as a special contract which the defense claims makes no violation. Many and sharp legal tilts characterized the sessions.

Judge Pritchard, of the United States Circuit court, arrived on an early morning train and there was intense interest as to any intervention on his part in the trial. He held conference with District Judge Purnell in the Federal court offices, General Counsel Thom and other counsel of the Southern railway, being present much of the time. But he left on the afternoon train for Asheville without issuing any process or making any apparent move in the case at all. There was an intimation that the cases would be allowed to proceed to the conviction and sentence, but habeas corpus or other process would probably issue in the event of imprisonment.

Charlotte, July 18.—The case against City Ticket Agent T. J. Witherspoon, of the Southern Railway here, charged with violation of the new rate law, was withdrawn today in the Recorder's court, for the reason that similar cases are being tested at Asheville and Raleigh.

Ashboro, July 18.—The grand jury today returned a true bill against the agent of the Southern Railway at this place charging violation of the 24 cent passenger fare law.

Greenville Gets the "Plum."

Wednesday, July 10th, the State Board of Education voted to locate the Eastern Carolina Training School at Greenville. The vote stood three for Greenville and three for Kinston, finally a Kinston supporter went over to Greenville and then the vote was made unanimous. Greenville has put up a game fight for the school from the beginning. There are no better builders for the future than the men who are now directing the affairs of Greenville and Pitt county. Only time can measure the value of such service as they are now giving their town and county. Greene county is glad the school is so near. We trust that with this school at Greenville it is only a matter of a few years before the scarcity of teachers now felt in Greene county will be a memory. With all our heart we congratulate Greenville.—Snow Hill Standard Laconic.

ACROSS THE STATE.

Interesting Items Gathered Here, There and Everywhere

Washington is moving to secure the location of the shops of the Norfolk & Southern railroad.

Dr. Henry W. Battle has resigned the pastorate of the First Baptist church in Greensboro and accepted a call to the church in Kinston.

Mt. Airy, July 18.—It is now a certainty that a monument will be erected to the lamented Joseph Easter, who was assassinated by moonshiners several months ago.

R. P. J. Carroway, the oldest member of the North Carolina Conference, died in Greensboro Wednesday. He was 82 years old and had been preaching for 58 years.

It is claimed that the mother of Mrs. Carrie Nation was born and reared in the Clio section of Iredell county and that she moved west, was married twice and her last husband was the father of Mrs. Nation.

In Ironton Township Lincoln county, Sunday afternoon, Price Ramsaur, colored, shot and killed his uncle John Briggs, who was protecting Charley Ramsaur from his brother. The murderer was endeavoring to kill his brother.

Charlotte Chronicle: Franc H. Jones, sentenced to serve a term of six years in the Federal prison at Atlanta for embezzling funds of the Charlotte National Bank, is at work in the bookkeeping department of the penitentiary. A citizen of Charlotte went to Atlanta recently and paid Jones a visit.

Greensboro, July 18.—The Southern Railway Company has decided to purchase fifty new locomotives, seventy-five passenger coaches four dining cars, six combination passenger and two hundred cabooses. The new coaches not only will supply immediate needs, but anticipate future needs. The locomotives are to be of the lighter type for use on other than main lines.

Wilmington Star: The "Thaw White Tragedy" is being reproduced by the moving picture theatre at the Casino, Wrightsville beach. The sensational offering is being advertised quite extensively in the city. This is the film that was suppressed sometime ago at the Bijou in this city but it will probably run its course at the beach as the exhibition is beyond the jurisdiction of the city authorities.

Raleigh, July 18.—A telegram received from Judge Chas. M. Coker, this evening is to the effect that he has arranged for Associate Justice Connor, of the State Superior Court to be here Monday morning at 11 o'clock and hear the petition for writs of habeas corpus in the cases against Dr. David S. Rowland and Mrs. Rowland, being held on the charge of poisoning Mrs. Rowland's former husband, Chas. R. Strange.

Raleigh, July 18.—State Treasurer B. R. Lacy, who spent several months in Arizona a year ago, has received an invitation to a "legal hanging" to be held at Solomonsville July 12. It is a regular printed card with the name of the state treasurer written in ink. It is from A. A. Anderson, sheriff, and the prisoner to be hanged is Willam Baldwin, colored. Mr. Lacy is showing the invitation as a great curiosity.

The R. & P. Road Encounters a Problem.

We regret to learn that the Raleigh & Pamlico road are having some difficulty in securing a substantial foundation for their track at a point called Summit Hill, near Rogers' Cross Roads. It seems that after cutting through a hill, and removing 135,000 square yards of dirt in order to secure a proper grading, that they struck quick sand with a number of small springs.

This is giving their civil engineers a very difficult problem to solve, especially since it has already cost so much in securing the proper grade. It is possible they may have to drive a good deal of piling, if not cut around the hill. We trust the officials may soon be able to overcome the trouble. This will prove a valuable road for Wilson and we hope it will soon be in operation.—Wilson Times.

Even two and three quarter cents would have been a great deal better than three and a quarter. If the legislature had been a little less radical the people would no doubt at this moment be enjoying the half-cent reduction, but in trying to grasp too much at one time it looks mighty like we have lost all—Charity and Children.

Editor Johnson in writing the above, must have overlooked the fact that in the legislature of 1905 Representative Laughinghouse, of Pitt, introduced a bill providing for 2 1/2 cent passenger fare. This bill passed the house by an overwhelming majority, but the railroad lobbyists succeeded in getting it killed in the senate. If that bill had passed and gone into effect there would have been no passenger fare bill before the last legislature. The failure of the bill at that time made it an issue in the next campaign and when the legislature of 1907 took up the matter the cat was deeper than in 1905. The railroads have only themselves to blame for the situation, and if they showed a disposition of fairness with the people they would find the people ready to be fair with them.

We have no desire to butt into this mess anent the conflict of jurisdiction between the State and Federal Courts, but we feel constrained to ask if any one ever before heard of a governor of a great State issuing an open letter of instructions to the Superior Court judges? It may be all right and proper; we are just asking if the like was ever before done—Greensboro Record.

Whether it was done before or not, what is the odds? Must there be a precedent for everything that is done? Every principal had to have its beginning somewhere, and if Governor Glenn wants to make a good move, as he did in this instance, we are unable to see why there should be any objection raised to it.

The man who is filling Editor King's place on the Durham Herald, while the latter is taking in the press convention at Morehead and going a fishing, is putting some mighty good stuff in place of King's spicy paragraphs.

The July term of criminal court in Wilmington, beginning on the 22nd, has five murder cases for trial. But when it is recalled that Wilmington has about sixty bar rooms, there need not be much surprise at this murder record.

There are various reasons given for people committing suicide, but the Chicago man who killed himself because he was tired of raising potato bugs is the latest. A Chicago paper suggests that he might have raised turnips.

It was rather a dull day this week on which some railroad agent was not indicted for violating the passenger rate law.

The Anson county lynching case now on trial at Monroe, does not draw interest like the railroad matter at Raleigh.

The trouble between the telegraph companies and the union operators is about to be settled without a strike. That is good for all concerned.

Counsel in the Haywood trial have actually grown tired of it. The public has been that way for some time.

LUMBAGO

Diet and Treatment For This Distressing Affection.

This distressingly painful affection is muscular rheumatism located in the large muscles of the loin.

The attack usually comes on quite suddenly, sometimes seizing the sufferer in the middle of a walk without the slightest premonition. The pain is intense and is increased by the slightest motion of the body.

The victim of lumbago or any other form of muscular rheumatism becomes painfully aware of the fact, which perhaps he had not before realized, of the great flexibility of the body and of the intimate relation between the different parts of the body, for it seems impossible for him to make any motion whatever of the head or of the arms without feeling a sharp twinge in the back. He dare not turn in bed, lift his head or even raise his arms, for every movement seems to be originated and performed by the sore back muscles.

There may be a little swelling of the affected region, but usually there is no external sign of the great well of misery lying just beneath the skin. The pain lasts a few days or a week and may then disappear as rapidly as it came, although there is often considerable soreness or an occasional twinge for a day or two.

Lumbago may be distinguished from pain in the back due to other causes by the fact that the agony is extreme whenever the slightest movement is made and is absent or at least bearable when the patient lies perfectly quiet in bed, and also that the muscles are tender when gently squeezed. The affection is more common in men than in women and attacks adults chiefly, the muscular rheumatism of children taking the form usually of wryneck. Why this should be so it is difficult to say.

Lumbago occurs more frequently in gouty persons, although that is no explanation, since we do not know why the loins should suffer in gouty individuals more than the muscles of the neck.

In mild cases the drinking of an abundance of water to which some baking soda is added may give a measure of relief. Gentle rubbing of the parts with a cloth dipped in ammonia and hot water will often mitigate the suffering, and after the rubbing a cloth wet with this solution may be laid on the parts and covered with a hot water bottle.

The diet should be light, without meat or highly seasoned food and especially without beef tea or meat broths of any kind. The bowels should be kept open.

One who is subject to lumbago should be careful to avoid a chill and should live frugally, drinking only plain water or milk.

Sometimes the attacks are prevented or made less frequent by the wearing of a broad flannel belt over the underclothing.

THE BREADFRUIT TREE.

Many Ways in Which This Strange
Tropical Plant is Utilized.

The breadfruit tree is a native of
southern Asia, the West Indies, the
south Pacific islands and the Indian
archipelago. In appearance it re-
sembles somewhat the wild chest-
nut. It grows to the height of forty
or fifty feet and has dark green
leaves, many of them two feet in
length, which are deeply divided
into pointed lobes.

Hidden among the great leaves
the breadfruit grows. It is nearly
spherical, often weighs four or more
pounds and has a thick yellow rind.
This fruit is the chief food of the
south sea islanders. They seldom
eat a meal without it. The eatable
part lies between the rind and the
core and when fully ripe is yellow
and juicy. The fruit is better be-
fore it has fully matured, and the
natives gather it while the pulp is
white.

Before it is ready for table use it
must be roasted, when it looks like
wheat bread and is both palatable
and nutritious. Usually the fruit is
cut into three or four slices and
roasted or baked in an oven.

Frequently the people of a village
join in making a huge oven, in
which several hundred breadfruits
may be baked at one time. Thus
they are all supplied with bread
without its costing any of them
much labor. Prepared in this way
the bread will keep for weeks.

The breadfruit is in season eight
months of the year. When the sea-
son finally draws to a close the last
fruits are gathered and made into a
sour paste, called "mahel." This
paste will keep good for months and
is made into balls, wrapped in
leaves and baked just as needed.

Bread is not the only product of
the breadfruit tree. From it ce-
ment, cloth, tinder and lumber are
also obtained. A glutinous, milky
juice oozes from the trunk of the
tree, which makes an excellent ce-
ment when boiled with coconut oil.
From the fibrous inner bark a kind
of coarse cloth is made, and the big
leaves make good towels. The lum-
ber is used for building houses and
many other purposes. Besides all
this, the dried blossoms are used as
tinder when fires are kindled.—Bal-
timore Sun.

An Optical Experiment.

An interesting optical experiment
may be made with the ordinary in-
candescent light. Gaze steadily at
the light for a few seconds, then
suddenly extinguish it. The ex-
periment is best performed in a
very dark room. In about half a
minute you will see the perfect im-
age of the light, with the fine
strands of wire plainly visible. It
will be red at first. In a few min-
utes it will turn purple and then a
bright blue. Later it will apparen-
tly move to the right. As you turn
your gaze it will continue moving
to the right. If you keep your gaze
fixed it will come back. It is sur-
prising how long the illusion will
last. It will be seen for fully five
minute, perhaps longer, and if you
turn on the light and look away
from it you will see the old image
for several minutes, though more
faintly than in the darkness.—Bal-
timore Sun.

The Balloon Plant.

The balloon plant is one of the
most curious devices of nature for
scattering seeds. The fruit is yel-
low and a little larger than an egg.
It has the appearance of an empty
bag, but it contains a watery sub-
stance, which evaporates or dries up
when the fruit matures, a sort of
gas taking its place. This gas is
lighter than air, and the fruit sways
back and forth in the wind until it
finally breaks loose from its slender
stem, rises into the air to a height
of from 75 to 100 feet and sails
away to fall in some distant spot
and thus extend the growth of its
kind.

that janitor.'"—New York Press.

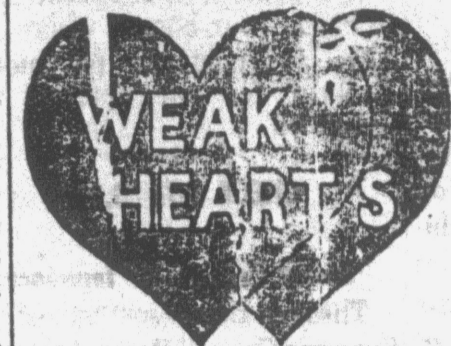
