Ayden N. C. September 13, 1907
That Ayden is manifesting a spirit of enterprise and thrift is evident from the fact of the many changes and additions constantly arising in and among us. The handsome sale and livery stable almost complete, belonging to J. E. Winslow, of Greenville, built on the most modern plan with brick walls and these lined on the outside with slats of steel, present a very handsome appearance, with large windows and all necessary ventilation for the comfort of stock, spacious storage rooms for feed, driveways and shelters for the protection of carriages and other vehicles is by no means a small affair. This fall he will handle many thousands of dollars in horses and mules, and at an early date he anticipates building a huge brick store 60x90 feet in which next season to conduct a mercantile business. And then a mercantile firm from a neighboring sister town has rented a large store and will commence business here at once. Again a prominent firm from a still larger town is negotiating for the renting of two stores in which to do a wholesale and retail hardware business. These and many other evidences in sight are truly gratifying and evince a prospect not imaginary but realistic, that destiny has in store for our beautiful little city, things that are glowing and indications that point to a large and a prosperous town.

The first bale of new cotton was sold here Wednesday at 13c by Calvin McLawhorn to J. R. Turnage & Co. It weighed 452 pounds and amounted to \$70.46.

The Spirit in Which You Work.

It ought not be necessary to ask a man if he likes his work. The radiance of his face should tell that. A test of the quality of the individual is the spirit in which he does his work. If he goes to it grudgingly, like a slave under the lash; if he feels the drudgery in it, if his enthusiasm and love for it do not lift it out of commonness and make it a delight instead of a bore, he will never make a very great place for himself in the world.

The man who feels his life-yoke galling him, who does not understand why the bread-and-butter question could not have been solved by one great creative act, instead of every man's being obliged to wrench everything he gets from nature through hard work, the man who does not see a great beneficent design and a superb necessity in the principle that every one should earn his own living—has gotten a wrong view of life, and will never get the splendid results out of his vocation which were intended for him.

The man who does not look upon his vocation as a great unfolding, enlarging, cultivating, educative, elevating process—the results of which could come in no other possible way—has made a very poor guess at life's riddle.

Multitudes of people do not half respect their work. They look upon it as a disagreeable necessity for providing bread and butter, clothing and shelter—as unavoidable drudgery instead of as a great man builder, a great life university for the development of manhood and womanhood. They do not see the divinity in the spur of necessity which compels man to develop the best thing in him, to unfold his possibilities by his struggle to attain his ambition, to conquer the enemies of his prosperity and his happiness. They cannot see the curse in the unearned dollar, which takes the spur out of the motive. Work to them is sheer drudgery—an unmitigated evil. They cannot understand why the Creator did not put bread ready-made on trees. They cannot see that the best thing in man has ever been developed by the necessity of labor. They do not see the stamina, the grit, the nobility, and the manhood in being forced to conquer what they get.

What a pitiable sight to see one or God's noblemen made to hold up his head and to be a kin to be cheerful and happy, and to radiate power, going about whining and complaining of his work, apologizing for what he is doing, deploring the fact that he should have to work at all!—Orison Swett Marden in "Success Magazine."

The Paper Trust.

In referring to the greatly increased cost of getting out newspapers and magazines within the last five or six years the Concord Tribune says:

"The truth of the matter is that the papers are standing for an enormous increase in everything that enters into the count in their making, and it is a fact that present prices are not going to leave the publisher-enough to settle with the sheriff in many cases. The only thing for them to do is being to raise the price of subscription and advertising. It is unfair to ask or expect the papers under dollar conditions to print and distribute a \$2.00 paper. To increase 50 per cent would not be out of proportion to the increase in everything else within the past six years. It would be interesting, and no doubt astonishing, if the readers of this paper, for instance, could see the difference in cost of various items entering into the making of the Tribune, the increase of today over six years ago when we got \$4.00 a year for the Evening Tribune."

So this time it is the luckless newspaper publisher that has to pay tribute to the trusts. So far as the publisher is concerned the paper trust is perhaps the greatest offender. Recently practically all grades of paper have advanced and in some cases this advance has been very considerable. Not only the newspapers but every branch of the paper stationery business is effected. The publishers are forced to stand these advanced prices and still their output will not command a higher price than it did formerly.

Verily the paper trust is a hard master.—Kinston Free Press.

Why Do We Yawn?

There can be little doubt that one of the objects of yawning is the exercise of muscles which have been for a long time quiescent and the acceleration of the flow of blood and lymph, which have in consequence of this quiescence become sluggish; hence its frequency after one has remained for some time in the same position—for example, when waking in the morning. Co-operating with this cause is sleepiness and the shallow breathing which it entails. As in the case of sighing, the deep breath which accompanies the act of yawning compensates for the shallow breathing that is so apt to excite it.

STOESSEL'S TIMIDITY.

General Smirnov writes of General Stoessel's conduct during the siege of Port Arthur: "The timidity of Stoessel was such that he never appeared in the fighting line, but he abused the population a 'petroons' and 'rascals.' When in September several shells fell near our lodgings, Stoessel moved to the house of General Volkoff, in another part of the town. His flower and part of his household things had been moved when a shell struck Volkoff's house. The things were then taken back to the old place. Toward the end of November the enemy began shelling us from eleven inch mortars, and Stoessel again removed, this time to the vicinity of the barracks of the Tenth regiment, which was out of range. There he lived in perfect safety until the enemy was able to shell this quarter also. Thereupon he hastened to surrender. Such pusillanimity made him the constant laughing-stock not only of the officers, but of the rank and file and civilians as well; but whenever he caught any one ridiculing him he took the cruelest vengeance."
