TWO OLD VETERANS FIGHT.

Have Bloody Scrap Over Possession of Three Hens.

Greensboro, N. C., Oct. 1.—There was a very strenuous old time fight here this morning between two highly esteemed old Confederate veterans. Capt. John Rankin and Major W. W. Allen. The two were neighbors for some months, Major Allen renting an adjoining lot to the one owned by Capt. Rankin on the street. Major Allen had rented another place and was moving this morning when Capt. Rankin went over and informed the major that several chickens, which were in the coop to be moved, were his. Major Allen denied this declaring that it would take law to get them from him. This raised Capt. Rankin's ire. So he told the major that he would rather fight it out, than to go to law over three chickens. The two went at it and were having a first class knock, bite, scratch and gouge fight when the ladies of the community gave the alarm. It took three male passersby to separate the contestants. Both men were very bloody their faces looked like the hens had had a scratching bee on them and there are knots on foreheads as big as an egg.

Died.

Mr D. H. Moore, an excellent citizen of the Station mill section, about 8 miles from Greenville, died Wednesday morning of typhoid fever. He leaves a wife and two children, both of the latter being grown. One of them is Mrs. S. I. Dudley, of Greenville. In his death the county loses a good and upright man.

A Mother Hen at the Age of 4 Months

Mr. J. H. Guyer, who lives about four miles northeast of Elkin, tells us that he had some chickens hatched out in April and that some of the pullets from this brood began laying the early part of August. After laying about a dozen eggs one of them decided to hatch out a brood of her own. She went about the work as patiently as an old hen. About the first of September the work was completed and she now has a brood of eight young chickens which she is looking after. Being a mother hen at a little more than four months old beats the record.—Elkin Times.

The Only Woman Confederate Veteran.

The only woman who is a full member of a Confederate Veterans' Camp, and who marches for miles with the camp at reunions, joining them also in the solemn funeral processions, is Miss Mary A. Hall of Augusta, Ga. No matter where she goes, Miss Hall invariably wears somewhere about her, but never obtrusively, a tiny Confederate flag. For a long time the flag she affected was made of silk, which she rolled in her hair, or tastefully arranged in her hat. Now it is worn in a Confederate badge.

Miss Hall is the recognized custodian of the Confederate flag. She has personally placed no less than 600 of the silken emblems on the graves of the departed soldiers.

Dressed in her walking skirt, and wearing the plain coat with its brass buttons, and the campaign hat, with her close cut crisp curls, the only woman veteran looks not unlike her veteran brothers.—Philadelphia Record.

TEACHERS' MEETING.

Saturday, Oct. 12th, 1907.

The beginning of another school year is now upon us. We are planning to make it the greatest year in the educational history of the county. Heretofore there has been no more powerful factor in our progress than the Teachers' Association which now has a splendid history of six years duration. Last year was the best of the six. The average attendance during the entire year was more than 150 with only 122 teachers in the county.

At the meeting on Oct. 12th, we propose to organize for the present year's work. There will be no regular program. Some of the prominent citizens of the county will be present and show their interest in us and in our work by a few words of encouragement.

With a magnificent training school for teachers soon to be built in our very midst, with life and enthusiasm along educational lines in almost every district in Pitt county, with the best corps of teachers of any county in the South, with the people ready to move if we will only lead, it does seem there is incentive enough to stir the soul of every true teacher and patriotic citizen in the county to renewed interest in everything that makes for our good.

We cannot have great, enthusiastic meetings without the presence of the teachers. I am writing this to appeal to every teacher in the county, whether you have begun your work or not, wherever you may be teaching and in whatever department of the work, to be present on Saturday, Oct. 12th, at this first meeting of the year. I believe I express the sentiment of everybody in charge of the educational interest of the county when I say that we would prefer not having any teacher in the county who fails to show any interest in these meetings. I would like at the close of this year's work to publish a list of all those who teach in the county with the number of meetings they attend so that the people may see who are bearing the burden of the work in this county. I shall make to the Board of Education some recommendation as to your salary next year based upon your record of attendance upon these meetings.

The Woman's Betterment Association will also have a meeting the same day and organize for the year's work. Last year their efforts resulted in raising and spending in the improvement of school grounds and school houses the sum of \$2,175.50. Let's move a step higher this year.

We cordially invite the people of the county, whether you live in town or country, to meet with us in these gatherings. We are not doing this as a mere matter of courtesy, but because we really want you with us.

Teachers, I beg you to show your interest in the work, and what you propose to do in your school this year by being present at this first meeting. We desire to meet at 10:30 a. m., and adjourn at 1 p. m. Let's show to the people of the county that we are in earnest in our work and our profession by making this meeting the largest and best that the association has ever held.

You know my faith in you and therefore I shall surely look forward with pleasure to meeting each and every one of you on Saturday, Oct. 12th.

ALL OVER THE

Hints on Cleaning Waxed Furniture.—Dust with a soft brush.

Since there is danger of staining paint or varnish, wash it with clean water. It has become a habit that, then, when you get the best quality of cloth in your house, until almost dead, wipe dry with a piece of leather. The paint will look like new and will not be harmed in the least. For cleaning natural woodwork nothing is better than grade petroleum oil. Moisten a piece of flannel or clean cloth with it and rub on the wood; the wipe with a clean cloth until all the oil is rubbed off. It is also excellent for furniture. Since much of the furniture nowadays is upholstered with leather, it is well to know that if it has become discolored or greasy looking it can be greatly improved by rubbing it with the white of an egg. Beat the egg well and put in a few drops of kerosene. Leather bound books can be treated in the same way.—Housekeeper.

Cement For Mending China.

Over a heaping tablespoonful of quicklime pour the white of an egg. It is ready a whey made of equal parts of vinegar and sweet milk; add a small quantity of the whey and beat the mixture thoroughly. Continue adding the whey, a few drops at a time, until you have a rather thin cement. When desiring to use, warm slightly and apply to the heated edges of the china, then press the china firmly in place. This is very durable, and a dish thus mended will stand constant usage.

Cottage Cheese.

Put thick sour milk in a pan and cover with boiling water from the teakettle. Let stand on the back of the stove a few moments until the curd separates from the whey, then pour into a bag and let it drip until dry. Salt well, sprinkle with paprika or add a tablespoonful of pepper grass cut fine. Add a little cream and melted butter to moisten and make into pats or pile lightly on a pretty dish. Mincied olives or ground nuts are also nice mixed with the cream cheese.

Kerosene For Silverware.

Kerosene will remove discoloration of long standing from silverware quicker than any preparation ever tried. Wet a soft cloth with the fluid, rub gently till the surface is bright, which will be very soon; then wash in hot soapsuds. If the article cleaned is not in everyday use, however, it is preferable to put it away unwashed, as the kerosene remaining on it will help prevent a return of the discoloration.

To Dye Small Fur Skins.

Small skins with the fur on, such as those of rabbits, etc., may be dyed black in this way: Boil one ounce of logwood, a quarter of an ounce of sumac and a dram of copperas in four pints of water. Put your fur into the liquid, give it a boil, rinse it and pass it through alum water. Rinse it again and hang out to dry.

The Jamestown Ter-Centennial Exposition was unfortunate in allowing itself to be seen long before it was ready for inspection. It is not colossal, but it is beautiful and it is instructive. Visitors going there in the mood of willingness to discover the attractions of the exposition will not be disappointed. The eight or ten weeks that remain of the fair ought to bring hundreds of thousands of visitors from all parts of the country. The region itself is full of historic and present-day interest. Norfolk, Newport News, Hampton, and Fortress Monroe are at hand, and water excursions may be made to Jamestown Island and in every direction. The architecture of the exposition is the trained observer more charming than that of almost any other in a long series of expositions. If the exhibits are not of a bewildering extent and variety, they are at least thoroughly illustrative of recent progress. Some of the special exhibits, like that contained in the negro building, for instance, are worthy of great praise. The United States Government has expended much money and ingenuity in its various efforts to represent in this fair what the Government departments are doing, and the management of the enterprise has achieved wonders in the overcoming of difficulties that have arisen. The weather on Hampton Roads during the remaining months of the exposition ought to be very agreeable for visitors. From "The Progress of the World," in the American Review of Reviews for October.

THE SHOEMAKER SAINTS.

Story of the Roman Brothers Who Perished by the Sword.

St. Crispin and his brother, Crispinian (always associated together in the calendar), were two natives of Rome who, having become converts to Christianity, set out for Gaul to preach the faith about the middle of the third century along with St. Quintin and others. The brothers settled at Soissons, where, in imitation of the apostle Paul, they preached publicly in the daytime and worked with their hands at night, earning their own subsistence by making shoes, though nobly born. They supplied the poor at a low price, and a legend tells us that an angel supplied them with leather. The heathen listened to their instructions and were astonished at the charity, disinterestedness, piety and contempt of glory displayed in their lives, and many were converted to the Christian faith.

After they had been thus engaged for several years the Emperor Maximianus Herculeus came into Belgica, and a complaint was made to him against the brothers. He, desiring to gratify their accusers as well as to indulge his own savage cruelty, gave orders that they should be brought before Rictius Varus, the most implacable enemy of the Christians of that time. The saints bore with patience and constancy the most cruel torments and at length finished their course by being beheaded with the sword about 287 A. D.

According to a Kentish tradition, their remains, being cast into the sea, were washed ashore at Romney marsh. In the sixth century a great church was built in their honor at Soissons, and St. Eligius richly ornamented the shrine.

From their martyrdom to the present time they have been regarded as the patron saints of shoemakers, who were accustomed to honor their day (and are yet in some towns) by great festivity. One special ceremony was a procession of the brethren of the craft with banners and music, while various characters representing King Crispin and his court were sustained by different members.—St. James' Gazette.

The Laurel and the Sunflower.

The laurel and the sunflower have been found, according to Country Life, to be of the greatest use in damp situations. People who live in such spots, especially near undrained land, think there is no help for them but by removal. Successful experiments have shown that it is possible materially to improve the atmosphere in such neighborhoods by the planting of laurels and sunflowers. The former give off an abundance of ozone, while the latter are potent in destroying the malarial conditions. These two, if planted even on the most restricted scale in a garden or any ground close to the house, will be found to increase speedily the dryness and salubrity of the atmosphere.

Food For Canaries.

The best of food for young canaries is hard boiled egg mixed with a little wheat bread. Cut up the egg fine and add to it a part of a roll that has been soaked in water for a few minutes and then squeeze dry. Great care must be taken that the food be fresh, for if it be the least sour it will kill the birds. The young ones are nearly always fed by the male bird, but in about two weeks they will feed themselves. When they are a month old put them in a cage by themselves. Feed them on the egg and bread mixed with some of the seed that you give the old birds, and, having continued this diet for four or five weeks, you may treat them as you do the old ones. Keep your cage perfectly clean, give the birds plenty of light and fresh air and keep them out of drafts. Sudden changes of temperature will be sure to make them sick.—Scotsman.
