There have been many improvements made in the interior of the Baptist church here. It has been reseated, the walls papered and new carpeting put down.

North Carolina Historical Exhibit at Jamestown Exhibition.

The North Carolina historical exhibit in the palace of history at Jamestown exposition is an illustrated story of the settlement, growth and development of the state. Complete in every detail the story it tells is of great interest to citizens of other states, as well as to North Carolinians because of the prominent part the Old North State has ever taken in the affairs of the country at large.

Forming a kind of frieze around the walls of the exhibit are the famous John White pictures, painted for Sir Walter Raleigh in the latter part of the sixteenth century, and shown generally through England to give the people an idea of the resources of the new world and induce them to take passage to the colonies. This collection of pictures thus show the first step in the state.

The second stage is illustrated by King Charles II, and Lords Proprietors collection Edenton, rich in historical associations, is well represented. Among other things of interest here are Governor Johnston's silver, a communion service presented to the church by Edward Moseley in 1725; a model of the Edenton "Tea Party House," in which the patriotic ladies of the town signed an agreement (Oct. 25, 1774) not to drink tea taxed by England. There is also a picture of this assemblage. A number of quaint pieces of silver from the Cameron collection may likewise be seen.

George Durant, the first man to settle in North Carolina, is represented by a plate once used by him. Bath, the oldest town in the State, has sent a brick from her old church. As is the case with the materials of all these old churches the bricks were brought from the "mother country."

The Wachovian Historical society has an unusually fine collection, representing as it does the industry of the Moravians from the date of their settlement 1753.

Of interest is the exhibit showing the development of lighting appliances from the wooden candle bracket to the incandescent made in 1861, The clico printing block, the pewter plate mould, the wooden egg beaters, the candle-dip wheel and the first engine brought to this country are worthy of attention. Then the oldest printing press in North Carolina is shown. This press was used by Lord Cornwallis during the Revolutionary war for printing proclamations. Again there is the piano which was in the tavern in Salem in 1761 when George Washington visited the town.

The bell used at the battle of Alamance, in lieu of the drum, is also on exhibition. The battle of Alamance was the first armed resistance to royal authority. It was fought May 16, 1771. In connection with this bell, the proclamation issued by Governor Tyrone, of North Carolina, providing for the pardoning of all who took part in it, is shown.

Among the portraits are those of the three North Carolina signers of the Declaration of Independence, General Joseph Graham, Governor William Graham, James Iredell, William Gaston, Alfred Moore and Theodosia Burr-Alston. Four pieces of silver once belonging to Flora McDonald recall the bravery and devotion of that fair Colonial lady, and are evidence of the grati-

tude of Prince Charles.

Other objects of great interest are the cologne bottle and writing desk of Dolly Hadison, a table of Andrew Jackson, and also a challenge penned by that worthy gentleman in which a "speedy re-creation" is claimed "this evening after court adjourns."

A picture of John Paul Jones, the adopted son of North Carolina is shown, together with a picture of the house in which he lived. Davy Crockett, of Alamo fame, is represented by a beautifully carved powder horn. A picture of the house in which Pirate Teach, or Blackbeard lived is also to be seen.

There are numerous famous documents and historic signatures of men whose names will long live in the history of their state, and form one of the most important features of the exhibit.

The exhibit is in charge of Miss Annie A. Vaughn, who is always ready to point out many interesting things to the visitors. It was collected and installed by Miss Schenk and Miss Mary Hinton. All three of the ladies connected with the exhibit are patriotic representatives of North Carolina.

DWELLING BURNED.

Mr. J. A. Wilson Loses His House.

A little past 10 o'clock this morning an alarm of fire threw the town into much excitement. It came from the home of Mr. J. A. Wilson, on the corner of Cotanch and Eleventh streets in South Greenville. The fire department and a great crowd of people hurried to the scene, but owing to the distance the house was burning briskly when it was reached.

The fire started in the roof of the kitchen and quickly communicated to the main part of the building. The nearest hydrants are on the corner of Cotanch and Tenth streets and on the corner of Evans and Eleventh streets, both a little more than a block from the fire. Lines of hose were run from each of these, but the pressure from the stand-pipe was not sufficient to put a stream on the building at such a distance. Before direct pressure could be put on from the pumps at the station, the fire had gained such headway that the building could not be saved and it was a total loss.

The fire spread so rapidly that there was time to save but little of the furniture. Mr. Wilson's loss is fully \$2,500, on which he had \$1,500 insurance part in H. A. White's agency and part with Moseley Bros.

The Free Will Baptist church, just across the street from the fire, caught several times on the roof but was put out without any damage of consequence to the church.

This fire should be a warning to those having supervision of the water works to take such steps as will maintain sufficient pressure to all parts of the town within reach of the water mains.

Vesuvius is reported to be getting in an ugly mood again.

The panic among Wall street speculators is not getting much sympathy from the country at large.

Some of the papers keep on calling for a look at the books, not withstanding Judge Pritchard has said they are closed.

The death of John Charles McNeill, of the Charlotte Observer staff, is indeed a loss to the Observer and to the State. He was a brilliant writer, and one of North Carolina's brightest young men. His death is cause for deep regret.

According to some of the pictures in the papers Mr. Bryan is not a day older than he was ten or twelve years ago—Durham Herald.

Perhaps those pictures you see are the same ones the papers had ten years ago, and have been pulled out from hiding to use over again.

Mr. Bryan overstepped the bounds of propriety in his Richmond speech when he said "the large metropolitan dailies are controlled by the trusts, and their columns are open to the highest bidders." That is a sweeping charge to be made by a man as great as Mr. Bryan, or by anyone as to that, and is wide of the truth. There may be now and then a newspaper that would come under the charge, but the generality of them are above being influenced by the money of any man, trust or corporation. Mr. Bryan should have weighed his words before making such a broad charge.

Assistant Postmaster General DeGraw, who addressed the postmasters of this State at their convention in Raleigh Wednesday said that a recommendation would be sent by the postoffice department to the next session of Congress to establish the parcels post. It looks like the postoffice department should wait until the postal service gets something nearer self-sustaining before adding such a burden as the parcel post would cause. Already there is complaint of paying the railroads enormously for hauling what mail is now carried, but just add miscellaneous packages of merchandise at cheap rates to this and it will take several mints coining money to keep up with the expense. The parcels post is only a movement in the interest of the city department stores that do mail order business, and will be of no benefit to the people at large. Away with the parcels post idea and let rural delivery extension and one cent letter postage come instead.

MAGICAL CURES.

Idols of the Orient That Are Appealed to in Case of Sickness.

Of magical methods used to cure disease a writer in the Scientific American says: "Powerful aid is believed to be rendered by the various gods and goddesses in China, India, Java, Korea and other countries in exercising disease. The Hindu goddess who had a superintending power over smallpox, for example, was approached with solemn ceremonies and presents to propitiate her. She was represented as standing with two uplifted fingers, threatening to strike on the right and left. Before her was a band of the executors of her vengeance, two of them with red grinning masks, black shields and naked scimiters. White lines, like rays, issued from the bodies of the others to indicate infection. On the right was a group of men with spotted bodies afflicted with the malady. Bells were hung at their cinctures, and a few of them waved black feathers. These were preceded by musicians with drums, who supplicated the pity of the furious deity.

"From behind her advanced a bevy of smiling young women, gracefully carrying on their heads baskets with thanksgiving offerings, in gratitude for their lives and beauty having been spared. A little boy with a bell at his girdle conveyed something emblematic of inoculation from the arm of the goddess. By such means and humble intercession the benign goddess gradually stayed her fury, and the diseased were thus made whole or were at least supposed to be cured, which appears to have answered just as well. In Java some idols are provided with bells for calling the attention of the god and goddess to the need of their exercising sacred powers in behalf of the sick and unfortunate.

"Akin to this blind faith is the credulity of some classes of Japanese, whose doctors know very little more of anatomy and physiology than the patients themselves, and for purposes of diagnosis they rely mainly on the pulse. Three pulses are found to be in each wrist, they explain—viz, the heart, controlling the right upper pulse; the lungs, the left upper pulse; the stomach, the right middle pulse; the liver, the left middle pulse; the right kidney, the right lower pulse, and the left kidney, the left lower pulse. Thus by a careful examination of the six pulses the doctor at once discovers what is the matter with the patient and proceeds in his own way to effect a cure.

"In Korea and among the North American Indians images are made out of various materials, each kind having a peculiar power over some special form of disease. Thus the Zuni Indian makes a clay image to represent a mountain lion, and the spirit of that animal, which is the guardian of the northwest and the master of the gods of the hunt, comes to dwell in that object, protecting the owner from injury by accident and helping him to success in the chase. A Korean sorcerer's image, stuffed and covered with buckskin, is used to avert calamity and death."

Mars.

Mars possesses about one-half the earth's diameter and one-seventh its volume. It is some 140,000,000 miles from the sun and consequently at a mean distance of nearly 50,000,000 miles from us. It receives less than one-half the sunlight and heat a square foot that we do, has an atmosphere less dense than ours and possesses water and ice. The planet exhibits two ice caps at its poles and orange and greenish tints between these poles. Those peculiar lines or markings, the "canals," concerning which there has arisen much discussion, form a sort of faint, inexplicable network over the surface of ruddy Mars.

Tramways.

The word tram is derived from a man's name, Outram—Thomas Outram. Outram lived in Derbyshire, England, and in the beginning of the last century he invented a peculiar sort of track that diminished the friction between wheels and roadbeds. These tracks of Outram's, though nothing like a trolley track, were called at first outtramways, then tramways, and when street lines and street cars came into existence they were dubbed respectively tramways and trams.

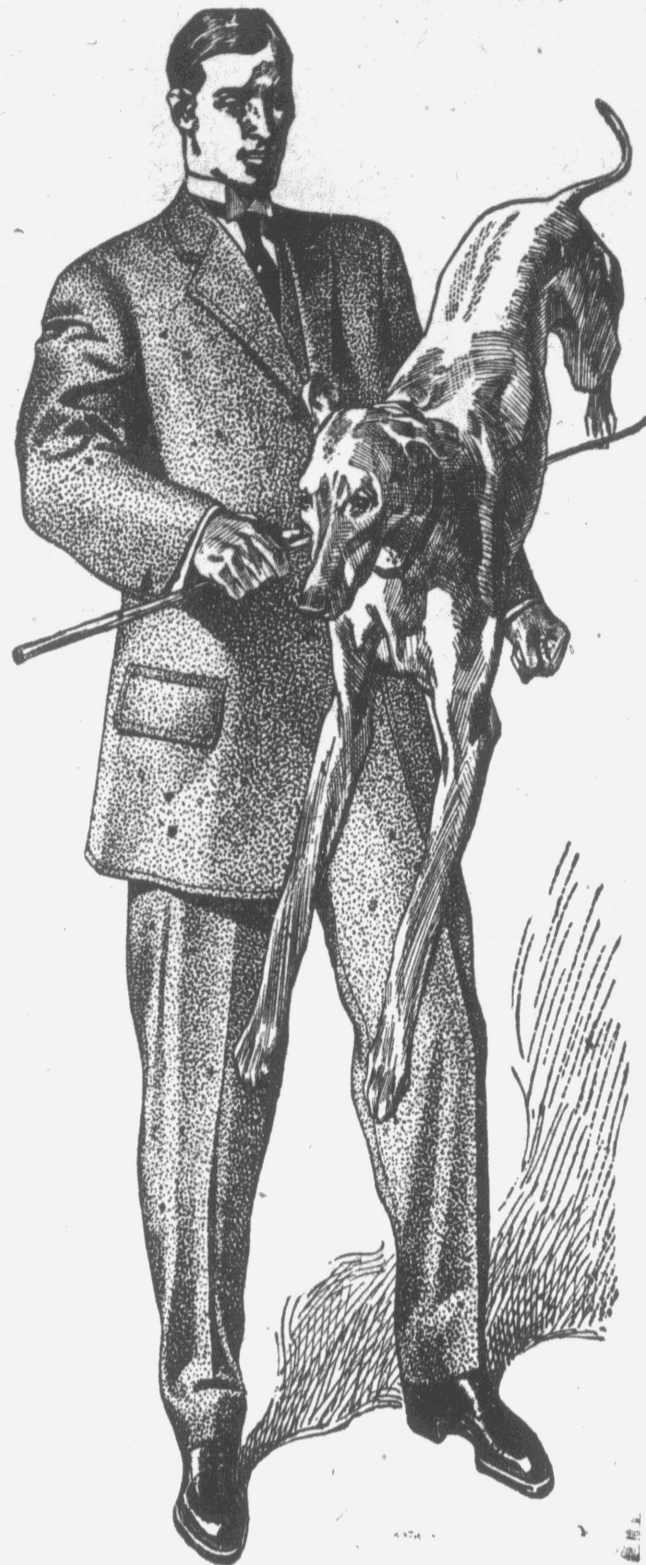
Historic Texas Oak.

It is king of a grove of large and stately oaks. One peculiarity about these and all other trees in this locality is that the prevailing wind has bent their branches so that they lean toward the northwest. — San Antonio Express.
