## Paying Your Bills

As another newspaper said in reproducing the article below, we do not intend it as a preaching, but as a business necessity, in directing attention to debt paying just at this time. The following story from the *Leavenworth Standard* illustrates the subject well:

"A well-known business man baffled us today with:

"Come here, I want to interview you."

"The idea of a merchant in reviewing a newspaper man was so odd that the call was answered right away."

"What made you put that article in the paper headed, 'Pay Your Bills'?" he asked.

"Because," we replied, "it appeared to be the proper thing."

"Well," said he, "you are right; it was the proper thing to do. Now let me tell you that I have been in business here several years, and before in other places, too, and I believe I know what I am talking about when I say if everybody would pay the bills he owes to his neighbors once in thirty days, or upon presentation, there would be very little of what we call 'hard times.' The man who owes a dollar and has got it to pay, but hangs to it, prevents the payment of a great many debts. The journey that a dollar travels the first week of the month, and the time it makes, as we say when we talk of race-horses, would surprise the man who never investigated. I worked a dollar once and kept track of it a few days, requested each man to keep a record of it when it was received by him, and to whom paid. Before it disappeared, about the end of the first week of the month, it had paid between twenty-five and thirty dollars in debts. Not long ago I presented a bill of about forty dollars to a man who was apparently able to pay it. He looked scared, and said 'I can't collect my bills, and so I can't pay you now; wait awhile.' Now, that forty dollars belonged to me, but he had it in his possession, and of course I could not take it away from him. If he had paid it to me, as he ought to have done, I should have paid it out almost immediately, and the chance are that it would have kept going, and by this time would have paid ten times its value in debts."

"You are right," he continued, "when you said that if everybody will pay his bills next week, in three months' time business will be good and money plentiful. We can make courage and confidence if we will. Some men who are chronic dead beats put on a great deal of style. I could point out a man who speaks up and down Delaware Street behind a hired fast horse, and his creditors are thicker than hens. He stands them off and wags, while they have to take wind and walk. He is 'king' now, but he is sure to come down in dishonor and disgrace. Let every honest man who can do it square up with his neighbors to whom he owes a few dollars, and times will ease up at once. There is a plenty of money, plenty of everything except honesty and courage. Honesty and courage will restore confidence. The banker, whether it be a newspaper man or business man, will not quit his croaking, and we will remain with a worse feeling about hard times except the professional dead-beat, who is always looking for an excuse for dishonesty."

## Why the Panic Came.

American farm crops are selling this year for an aggregate sum of \$6 500,000,000, the largest amount that agriculture has ever returned to the people of any country in any year. The mines are working at a high rate of productivity. More coal will be unearthed, more pig iron smelted, more steel plates rolled this year than ever before. In the South the cotton crop is bringing twice what it did ten years ago. The New England mills are running busily. Everywhere wages are high and employment easily obtained.

If this were a time of business failure, of lack of employment, of poor crops, of general poverty, financial depression would be expected and a lowering of values would be inevitable. But why should there be a panic in New York when the community is prosperous? "Why should values be shaken when legitimate business is earning such profitable returns?"

The answer is simply because certain New York banks and trust companies abandoned their legitimate functions to become gambling institutions. Instead of confining themselves to the business of sound banking, their officers took their depositors' money for use in private speculation. As well might they have taken the bank's cash to Canfield's gambling house or to the bookmakers at the race track.—New York World.

## Go to Farming.

A good living is what comparatively few men succeed in making in village or city life, and yet nothing is more easy of accomplishment on the farm. Besides, there is a pleasure in cultivating and embellishing the earth, improving and increasing its products and thus adding to the aggregate of human happiness. Why, then, should young men hesitate to be farmers? It is both profitable and honorable.

It is the nearest approximation to independence that a man can make. A gentleman farmer—and all farmers are, or should be, gentleman—belongs to an order of nobility that is not indebted to place holders for installation, and may, if he chooses, be ranked among the greatest benefactors of the human race. ## THE HURRYING MAN.

And the Man Who Keeps Cool and Does Things Without Hurrying.

"I like to see a man quick about his work," said Mr. Quilkinton, "but I don't like a man who habitually hurries."

"The hurrying man gets on my nerves. He grabs things up and slams things down and makes a great show of doing things. For that matter, the earnest hurrying man may actually do things, but he does them at the cost of an unnecessary expenditure of nervous force on his own part, and I am sure he must wear on the nerves of other people around him."

"Now, the hustler is a very different proposition from the hurrying man and so also the man of energy. The hustler is indeed a man of energy, but he is one working comparatively narrow compass or along some special line of work. He is a bull sort of man, a driver, who makes it his business to get things done and to keep on getting them done and always with the least possible waste of time or force. There are other sorts of hustlers, men who make a great to do and don't accomplish much. But the one I have described is the hustler of the best type."

"The man of energy is a man of strength and momentum who gives also an impression of reserve power. He is likely to be the head of the enterprise, and he communicates his strength to the hustlers and diffuses power all around. Everybody within range of his influence feels his strength and works better for it, and he puts his own shoulder to the wheel on occasion."

"But neither the hustler of the best type nor the man of energy ever hurries. The hustler rushes things; he crowds 'em hard and keeps crowding, but he doesn't hurry, for hurry means impairment of strength, and on a big job hurry is likely to mean confusion worse confounded."

"The real hustler first lays out the work to be done clearly in his own mind, and then, with no false moves, with no waste of time or effort, he crowds the work forward to its conclusion, all without the turmoil of hurry. And the man of energy diffuses strength always steadily, ever contributing to the highest results."

"So I don't personally fancy the individual man who, however efficient he may really be, does things in a hurry. I like the cool man, the man who keeps his head and who is easy and deliberate in his movements. In him and in his work you feel full confidence, and the effect of his presence is good in every way on all around him."

"Give me cool men, not men who work in a hurry."—New York Sun.

**LEARN WHAT TO EAT.**

Study Your Needs and Select Your Food With Discretion.

In our ignorance of what the various tissues of the body require for doing their work we crowd the system with a great mass of unnecessary food, only an infinitesimal part of which can possibly be of use in strengthening us for our occupation.

There are about a dozen different kinds of tissue cells in the body, each one requiring a special food, and those which are especially active in our line of work require a much larger amount of food, particularly adapted to their use than the other tissues, which are almost wholly inactive in our vocation.

Thousands of men are forcing their brains to do work by stimulants which only exhaust and do not nourish, and then they wonder that they have nervous breakdown or paresis. Other thousands, in their ignorance of scientific feeding, force their brains to do work every bit of which is abnormal, because they do not have sufficient nourishment.

An active brain worker requires a great deal of albuminous foods, foods which contain phosphorus—like fish, oysters and other kinds of shellfish and eggs. Meat is distinctly muscle food. It is suitable only for those who do physical work.

The locomotive engineer studies fuels. He does not throw all sorts of combustible things into his fire box just because they are combustible. He finds out the best kind of fuel for his engine, that which will give him the greatest possible amount of combustion with the least waste. He makes a profession of his business and studies the requirements of his engine. But most people seem to think that they can run the most complicated machinery in the world—the great human engine—without any special study. The result is that we use all sorts of fuel without reference to the particular work we are doing. —Success Magazine.

SERVANTS' LIVERIES.

Had Their Origin During the Reign of King Pepin of France.

So far as the present writer is aware, the earliest mention of "liveries" made in history was during the reign of King Pepin of France, who flourished about the year 750 A. D.

A form of amusement to which King Pepin was partial was that were termed cours pléniers. These were assemblies at which, upon the king's invitation, all the lords and courtiers of France were expected to be present. They were held twice in each year—at Christmas and Easter—and generally lasted for about a week at each time. Sometimes these gatherings took place at the king's palace, sometimes in the neighborhood of one of the larger French cities and sometimes in some rural district. While the festival lasted the king took all his meals in public, bishops and dukes alone being privileged to sit at the royal table. A second table was provided for abbots, counts and other leading men, and at both tables there was shown more profusion than delicacy, both in the quality of the meats and drinks and the manner in which they were served. Flutes, hautboys and other musical instruments were played before the bearers of each course as it was removed from the tables. When dessert was served twenty heralds, each holding aloft a jeweled goblet, shouted "Largesse, largesse from the most potent of kings!" As they shouted they scattered among the crowds handfuls of gold and silver coins. Then the trumpets were blown, while the better class spectators shouted and the men of lower rank scrambled and often fought vigorously for the money scattered by the heralds.

Charles VII. of France put a final stop to the cours pléniers, alleging that the expense attendant upon his wars with England made it impossible for him to continue them. One of the severest causes of expense, it was explained, arose from the fact that, beginning with King Pepin's time, etiquette and custom alike demanded that the king should upon these occasions give an entire suit of new and gorgeous clothing not only to his own servants and retainers, but also to those of the queen and all the princes of the blood royal. These garments were said to be "liveries"—that is, "delivered" at the king's expense—and from this word the English word "livery" was derived, as was the custom of providing servants with "livery" from the above mentioned practice of certain of the French kings.—London Standard.

A Ready Reply.

It was on a P. and O. liner, and the stewards were being drilled in waiting at table. In the course of the drill they lined up outside the saloon with empty dishes, supposed to contain curry and rice, and on a bell being rung marched to their respective tables and proffered the dish to each seat containing an imaginary diner. The eagle eye of the purser noticed that one steward, a corky named Bill, deliberately passed one of the seats without proffering the dish. He strode up to the table, and his manner betokened trouble for Bill.

"Hi, you! What do you mean by missing that seat?"

"Oh, that's all right, sir," replied Bill, not a bit put out. "That gent don't take curry."—London Illustrated Bits.

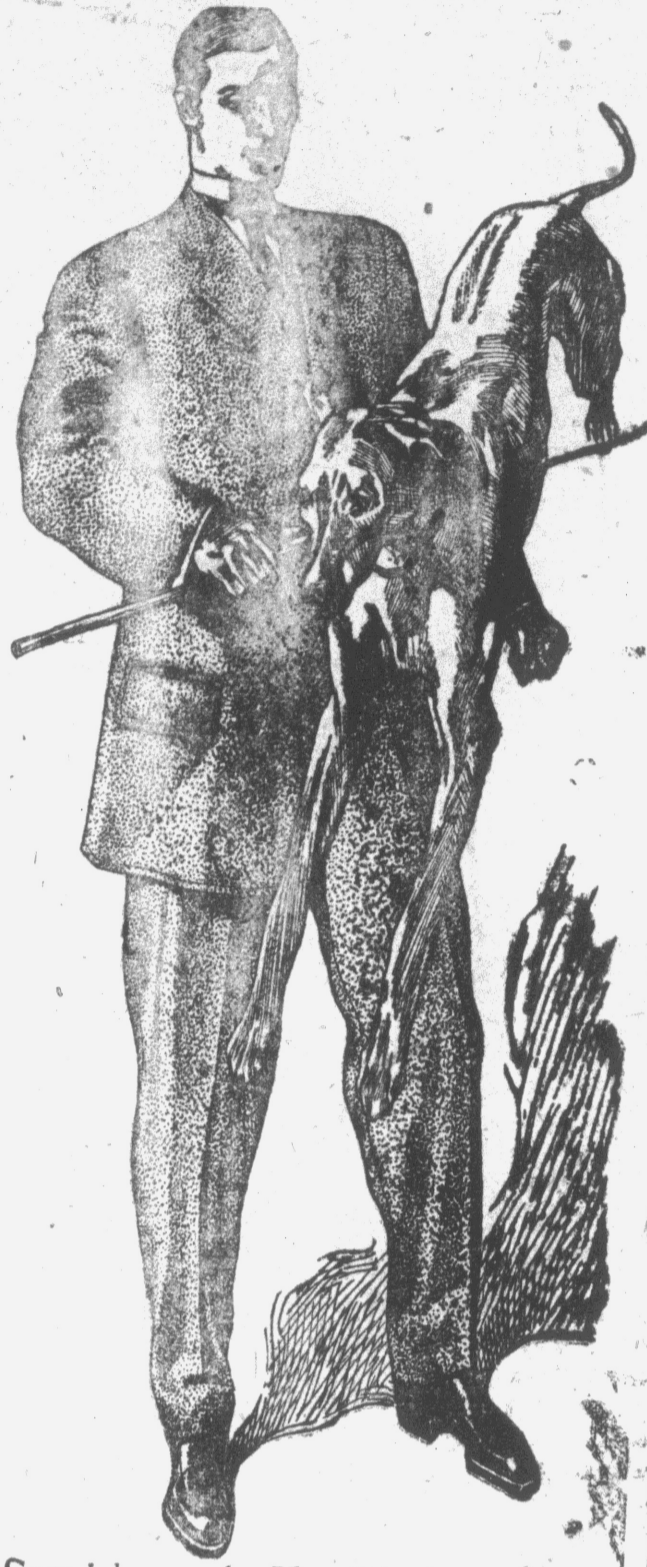
