

CHARGED WITH DOUBLE CRIME

Teacher With Two Wives Ruins a Girl Pupil.

Richmond, Va., December 26. —C. H. James, a school teacher from the Old North State, has been placed under arrest at Shenandoah Court House charged with the double crime of bigamy and of having ruined Miss Lillie Midyette, one of his pupils, whom he induced to leave her home by the offer of a position as his assistant.

James is, according to the information on which two indictments were returned against him, the possessor of at least two wives in North Carolina. He is also charged with the abduction as well as ruin of the young girl. Miss Midyette is also in Shenandoah county, being with James when he was arrested. She will be taken back to North Carolina and made to testify against him.

At Manteo, in Dare county, N. C., in the summer of 1906, James was engaged in teaching school. Among his pupils was Miss Midyette, with whose youthful beauty James soon became infatuated. He induced the girl to accompany him to Atlantic, N. C. obtaining the consent of the girl's parents to the project by promising them that their daughter was to become his assistant. After leaving her home the young woman became completely under the influence of the man. Their relations were such that longer concealment soon became impossible. In July of the present year James and the girl disappeared.

Sheriff D. J. Hayman of North Carolina, arrived in Richmond this morning with requisition papers on the Governor of Virginia for the delivery of the man to him. The man will be called upon to face the double charge of being a bigamist as well as that of dishonoring Miss Midyette.

The officer left Richmond this afternoon for the purpose of taking possession of the prisoner. —Raleigh News & Observer.

White Stem, Orinoco and other sorts, which they will put in the hands of the Greenville Warehousemen and drug stores to be given to all farmers who may ask for them who have been raising what is known as the Cobb Tobacco as well as other kinds. None of the buyers like to buy Cobb Tobacco and the Tobacco Board of Trade has ordered seed to give away to farmers in order to induce them not to raise any more Cobb Tobacco. So when you get ready to sow your plant bed, do not use the Cobb seed, but come to Greenville and get free of cost a better kind.

A DARING MOVEMENT.

Executed in a Notable Battle of the Mexican War.

Long odds mean little to the average United States soldier. Zachary Taylor and his little "army of occupation," after marching into the heart of Mexico against overwhelmingly superior numbers, achieved the apparently impossible time after time and scored victory after victory.

One night while his exhausted soldiers were taking their well earned rest General Worth was planning a daring movement for the capture of the heights above the bishop's palace. The strength of that position was great and all its approaches so carefully guarded that the only hope of success appeared to lie in a secret and rapid move during the quiet hour just preceding the dawn.

Lieutenant Colonel Childs, with six companies and 200 carefully selected Texas rangers, was chosen for the dangerous honor of opening a way to the heights above. At 3 o'clock on the morning of the 23d (September, 1846), their movements effectually veiled by a dense fog and the sound of their advance deadened by the constant patter of a cold rain, the little column moved forward, guided by Saunders and Meade, who knew the exact location and character of the narrow path which they were to follow up the steep declivity.

They reached the summit to find the works in the possession of Colonel Childs. CARRYING UMBRELLAS.

Few People Manage Them to the Best Advantage.

"Curious about how some people carry umbrellas," said Mr. Stormelton. "We think the ostrich is a stupid bird because with its head buried in the sand it thinks its whole body is hidden from everybody. But plenty of men are quite as stupid as that in their manner of carrying an umbrella.

"They carry it in such a way as to protect the front of their bodies and appear to think they have themselves wholly protected, while all the time the water is gayly dripping down their backs. The fact is that not many men know how to carry an umbrella when it rains.

"If it rains and blows then instinctively they hold the umbrella toward the wind to keep the umbrella from being blown inside out as well as to protect themselves from the rain. This is proper. But when the rain is coming down straight they carry their umbrellas in all sorts of ways, in which they reveal more or less of their personal characteristics.

"Here, for instance, is a man who carries his umbrella held in his right hand with the hand straight in front of and in line with his elbow and upper arm, this being the easiest way to carry it. Held in this manner the umbrella really shelters completely only his head and the right side of his body. The rain drips from it on his left shoulder and down his left side. He is either lazy or thoughtless. He is probably both.

"Again we may meet a man carrying an umbrella at the cost of considerable effort around in front of the center line of his body, which is correct as to that position, but carrying it there too far forward, with the result that while he keeps perfectly dry on his face side, yet more or less water drips down his back—a man finicky and particular about the front he presents, about appearances, but not so mindful of the substance.

"And then we meet the man who carries his umbrella with fore arm straight in line with his elbow, for the greater ease of that position of the arm, but with the hand slightly turned so as to make the umbrella more completely cover him or with that end in view, which end, however, it does not accomplish, for with the umbrella top tilted it does not cover so large an area as it does when carried in a horizontal plane. This is a man who is lazy, but trying by that twist of the hand to get something for nothing or without much effort.

"And then we may occasionally meet a man who is carrying his umbrella in the best possible position for the purposes of the best possible protection to be gained from it, this being square in front of him, with the umbrella handle all but touching the center of the front edge of the rim of his hat, carried so as to protect him as far as may be both back and front, while he carries the umbrella as low down as can be without touching his hat on top, thus giving himself also protection as far as possible down around toward his feet. And here we find a man who knows intelligently what can be done with the means at his command and who is willing to put forth the effort required to bring those means to their utmost efficiency." — New York Sun.

IN THE WINDPIPE.

What You Should Do if a Foreign Body Enters There.

A most alarming accident and one which is often as serious as it looks is the sucking into the windpipe of a morsel of food or some other substance. This is not a very rare accident, especially with children, whose hold all, after the pockets are crammed, is usually the month.

The articles which have been drawn into the larynx through the sudden taking of a deep breath are of the most varied character, such as jackstones, nuts, marbles, coins, buttons and pins, not to mention burs, corks, tin whistles, brooches, shawl-pins, hairpins, false teeth and even a real tooth which slipped from the forceps just as it had been extracted. Pieces of food are sometimes inhaled through hearty laughing or excited talking while eating.

The entrance of the foreign substance, even if it is only water, causes violent coughing and a spasmodic closing of the larynx, which almost amounts to suffocation. If the body has passed through the larynx into the windpipe or has been thrown out this suffocative attack passes off and the sufferer may think his trouble is over.

Sometimes it is, if the coughing has expelled the intruder, but if this has fallen below the larynx the condition is very serious. The body may be expelled during another violent fit of coughing, but often it can be removed only by the operation of opening the windpipe, known as tracheotomy.

The danger of the accident depends much upon the size and nature of the substance inhaled. If it is a hard, smooth and rounded body, such as a melon seed, a small marble or pebble or the like, there is a very good chance that it may be expelled in the same way it entered.

To favor this expulsion the patient should lie down, with the head lower than the feet, or he may be held up for a minute or two by the heels in order to get the assistance of the force of gravity. This, however, should only be done if the doctor is at hand to perform tracheotomy as a last resort, because the foreign body may become fixed in a narrow part of the larynx and so cause suffocation.

Where Opium Is Used.

The smoking of opium began in China and is peculiar to the Chinese. The Hindoos and Malays eat it. Complicated and widespread as the smoking habit is today, it is a modern custom as time runs in China. There seems to be little doubt in the minds of those "Sinologists" who have traced the opium thread back through the tangle of early missionary reports and imperial edicts that the habit started either in Formosa or on the mainland across the straits, where malaria is common. Opium had been used generations before as a remedy for malaria, and these first smokers seem to have mixed a little opium with their tobacco, which had been introduced by the Portuguese in the early seventeenth century. From this beginning, it would appear, was developed the rather elaborate outfit which the opium smoker of today considers necessary to his pleasure. — Samuel Merwin in Success Magazine.
