To Delinquent Subscribers.

Under the ruling of the post-office department of the government, newspapers cannot carry on their mail lists persons who are long in arrears on subscription. Newspapers are given second class rates of postage to legitimate subscribers, and as the postoffice department does not want to handle any more papers than necessary at this rate, the ruling is to prevent newspapers from carrying dead heads or padding their subscription lists. The postoffice department construes that a man who will not pay for his newspaper in a reasonable time is not a legitimate subscriber of the paper and his name must be dropped or a higher rate of postage charged for mailing the paper to him.

Under this ruling newspapers will be compelled to drop the names of delinquent subscribers, as they cannot afford to pay the additional postage to send papers to them. It is not a matter of choice with the newspapers, but they must act in accordance with the ruling.

In order to comply with this rule The Reflector will begin early revising its subscription lists and cutting off the names of those far enough in arrears to come under the ruling. Before dropping such names notice will be given by placing a blue cross mark on the paper. Those who see the blue mark should pay promptly in order to keep their names on the list.

We shall print this article a few times so as to be sure that none fail to see it. In the meantime if you see the blue cross mark on your paper do not delay to act on it. If it is not convenient for you to call at the office, send a remittance by mail and receipt will be promptly returned.

Tobacco Seed Free.

The Greenville Tobacco Board of Trade has ordered a quantity of the best varieties of bright Tobacco Seed. White Stem, Orinoco and other sorts, which they will put in the hands of the Greenville Warehousemen and drug stores to be given to all farmers who may ask for them who have been raising what is known as the Cobb Tobacco as well as other kinds. None of the buyers like to buy Cobb Tobacco and the Tobacco Board of Trade has ordered seed to give away to farmers in order to induce them not to raise any more Cobb Tobacco. So when you get ready to sow your plant bed, do not use the Cobb seed, but come to Greenville and get free of cost a better kind.

IS IT WISE FOR LEGISLATURE AT SPECIAL SESSION TO PASS GENERAL PROHIBITION LAW

Governor Jarvis, in an interview with Reporter of Reflector, says Yes.

Our reporter sought out Governor Jarvis and asked him this question:

If the Legislature shall be called together in special session, do you think it wise for it to pass a general prohibition law for the whole State? The governor answered, yes, and gives his reasons as follows.

While it is true that no law is worth much unless it has a strong, healthy sentiment behind it to enforce its execution, it is likewise true that when that public sentiment manifests itself it is well to respond to it. It must be manifest to all who take note of passing events that the people of North Carolina have made up their minds to try prohibition. Whatever one may think of the wisdom of prohibition as a remedy for the evils of the liquor traffic, he must admit, if he be not blind, that the people are determined to give it a trial.

If the legislature shall be called together in special session it will be political wisdom to pass a carefully prepared act making it unlawful to manufacture or sell liquor in North Carolina after the 30th day of June, 1908. If this is done, prohibition will be an accomplished fact and a harmless issue when the time comes to nominate and elect candidates for the legislature, and this disturbing question cannot be injected into politics in the campaign of 1908. Prohibition is now an acute question in this state and it cannot be silenced by anything short of an act of the legislature which shall give it a fair trial, and it is likely to become still more acute till such an act is passed. If the selection of candidates shall take place, in the present disturbed and unsettled state of feeling on the whiskey question, it will be impossible to keep the prohibition question out of the politics of the state in the coming campaign candidates will be compelled to declare themselves and no matter which side they take the other side will be angered, and thus you have the question in politics whether you want it or not.

There is another reason why it is better to have this question settled at once if it can be done. These whiskey election tend to bring the negro back into politics. When we have one of these elections my observation is that both sides, with rare exception, get on a brisk hunt for votes. I heard that in more than one of these elections negroes have been registered under the "Grand father clause."

Conditions are very different in this State from what they were in 1880 and '81 when the legislature passed an act submitting the question of prohibition to the voters of the State, but there is danger, if this question gets into politics in 1908 of bringing back some of the conditions of 1882. There is danger, in some localities at least, if this whiskey question is not settled before, of having a good deal of independent mixing and trading in the coming campaign. If the legislature assembles it will be better to wipe the whole thing out and be done with it. I therefore sincerely hope that if an extra session of the legislature is called that it will settle the "rate question" and the "whiskey question," before it adjourns, by the passage of equitable, enforceable laws.

ALL OVER THE HOUSE.

Hints on the Renovation of Old Laces.
Domestic Notes.

The fortunate possessor of very fine laces cannot be too careful in washing them. Even the gentlest rubbing must be avoided if laces are to be preserved.

Lace should always be soaked before washing, more especially if it is much soiled, in water in which a teaspoon of borax has been dissolved. The water should be boiling, the usual proportion being one pint of water to every teaspoon of borax. Then make a lather with some good soap and hot water.

Take the lace from the water in which it has been soaked, place it in the soapy water and squeeze it exactly as if it were a sponge till it is clean.

This will prevent the lace from being torn, more especially if it is of a fine make. Repeat the process, if necessary, in another basin of soapy water. Then rinse in clean cold water till all the soap is removed. If the lace is white a little blue in the rinsing water will improve the color.

Transferring Pictures.

Take a small, cheap brush and a little bottle of ordinary turpentine. Paint the picture you wish to transfer with the turpentine and blot with a blotter so that the ink will not run. Turn face of the picture down on paper you wish to transfer it to and rub the entire surface quite hard with a smooth instrument, and the transfer is complete. It can be transferred on fabric as well as upon paper if a little care is taken. This recipe is excellent for transferring designs on wood for pyrography or scroll saw work.

Dainty For an Invalid.

Toast a slice of bread a delicate brown and dip it into a small quantity of hot water to which has been added a generous piece of butter. Remove from water, pile on top of toast the beaten white of an egg, placing the yolk squarely in the center. Salt lightly and set in a hot oven until firm, but not hard.

For Enlarged Pores.

There is nothing known to science that will remove enlarged pores unless the skin is kept scrupulously clean. A warm, soapy facial bath must be taken every night, the face then rinsed in several clear waters and a good skin food applied. A mere wiping of the face with a wet cloth is not washing it.

Brightening Gilt Frames.

Take sufficient flour of sulphur to give a golden tinge to about one and one-half pints of water, and in this boil four or five bruised onions. Strain off liquid and when cold apply with soft brush to any gilding which needs restoring. When dry, it will be as bright as new.

Pressing Seams.

When making up woolen goods that have to have seams pressed open, soap them lightly on the wrong side of the goods and press in the usual way. They will be found to lie perfectly flat and stay so. This can be used on smoothly finished worsteds to advantage.

Croup and Hoarseness.

A lump of fresh lard or butter the size of an English walnut rubbed in with sugar the same as you would prepare butter and sugar for a cake and rolled into small pills, giving one at intervals of every twenty minutes, is excellent for croup or hoarseness.

Homemade Lemon Extract.

Cut off carefully the yellow rind of three lemons and put into a half pint of alcohol. In four days pour off into bottle and add one ounce of oil of lemon. This makes a fine, strong flavor at less than half price. Orange extract can be made in the same way.

Grape Shrub.

Four quarts of grapes to one quart of vinegar; let stand four days, then strain. To each pint of juice add one pound of sugar; boil twenty minutes, bottle and keep in a dry, cool place. Red raspberries or black are also nice.

An Ironing Wrinkle.

When ironing a starched garment and a part of it becomes dry, do not dampen with water, but with a cloth wet with a little cold starch. This will keep all parts of the garment of equal stiffness.

Freshening White Clothes.

White dresses and waists may be made to look as fresh as new by making a thin raw starch and dampening with a clean muslin cloth. Let set a few minutes and then press with a hot iron.

Skirts Kept Shapely.

To keep skirts in good shape, fold evenly at the belt several times, put a large safety pin through this and hang it up by safety pin on a hook in the closet.

Ho Rested

A clergyman who has a small farm was walking round superintending when he came up to his plowman, who was resting his horses. The clergyman said: "John, could you not bring an old sickle and cut away the weeds in this corner while you rest the horses?"

John said: "Master, couldn't you take a bag of them mixed seeds into the pool-pit w' you and sort 'em while they're singing?"

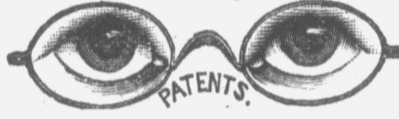

ALL OVER THE HOUSE.

Instructions For Fumigating a Room Domestic Notes.

Nearly every housekeeper finds it necessary at some stage in her housekeeping experience to fumigate a room. The old-fashioned method, which still is as effective as any, was used for sickness and for ridding the home of bugs as well as vermin. The rooms must first of all be sealed. Strips of newspapers, 4 inches thick, are pasted to either side of the door and windows of the room with the same gum arabic. This paper is removed easily afterward with soap and water. In a large kettle of boiling water place a smaller vessel, which is sufficiently deep to come well up over the water line in the large kettle and containing a handful of sulphur. On the sulphur pour wood alcohol and light. The room should be left shut for twenty-four hours, and at the end of that time neither bugs nor disease germs will remain alive.
