NO MONUMENT IN PITT.

First day of January 1908. Editor Reflector:

There was organized a military company known as the Marlboro Guards in 1860 in Farmville township, composed of the young men of that section of the county. It was assigned to the 27th N. C. troops which performed valiant service in the war between the States.

At the roll call at Appomattox, at the surrender of Gen. Lee, out of about one hundred and twelve who originally enlisted, there were but few left to answer when their names were called. Most of them had fallen in battle or died of disease.

Those who escaped the ravishment of war returned to their ruined and desolate homes with sad hearts to contend against poverty for existence. In the dreadful and almost hopeless struggle many of that little band have yielded to the cares and trials of life and have joined their comrades across the river. There are now left only a small remnant, who are fast approaching three score years and ten. Would it not be well for these gray haired veterans to have a reunion and once more behold the faces and shake by the hand their old comrades of the late war? There are scarcely one from the captain down who does not bear upon his person scars of battle, and yet there is no enduring monument in the county to commemorate the memory of this band of patriots. County after county, throughout the state have reared statue after statue to their heroic dead, but Pitt county, which surpasses most of them in wealth and material enterprise, has made no effort, known to us, to perpetuate the memory and service of as brave and noble body of men as ever marched to battle.

ENDORSES STOCK LAW CONSOLIDATION.

Winterville, N. C., Jan. 3, 1908 Editor Reflector

Winterville would like to endorse what Ayden "Citizen" says about consolidating the Greenville, Winterville, Ayden and Grifton stock law territory by having one fence from Tar to Neuse rivers.

As the territory now is, it takes about 60 miles of fence to enclose it, while about 12 miles of fence could give us a better protection from stock and there would be a great saving in the cost of gates and fence.

It occurs to me that the fence should start at Tar river, a few miles from of Greenville, and run in most direct route to Neuse river, so the boundary fence would be as far as possible from the towns on either side. This would place the gates so far from the towns there would not be so much passing through them.

Let us hear from our Greenville and Grifton citizens, and we hope some one will name the proper territory for the fence to pass through. Another Citizen.

TENDRILS.

Moving Parts Which Are the "Brains of Plant Life."

There are two classes of plants which are incited by man's presence to describe certain definite movements. One class, the sensitive plants, retract their leaflets as we approach them, as if they resented any attempt at closer intimacy, while the other class, comprising all those vines which develop climbing organs called tendrils, will reach out toward us if we place our hands in contact with them and will even use a finger as a support to climb upon. We know that these tendrils will wind just as readily about a twig or a grass stem, but as one feels these sensitive strands multiply their encircling coils about one's fingers there almost seems to be established between us and the vegetable world a more intimate relationship than has ever existed before.

Tendrils are indeed capable of exhibiting faculties and going through evolutions more wonderful perhaps than many of us realize. It is only after we have seen them at work, after we have seen their sensitive tips the objects they come in contact with, apparently considering their suitability as a support and then accepting or rejecting them, as the case may be—it is only then that we realize how justly they have been called the "brains of plant life."

The thoroughness with which these wandering tips explore their surroundings is illustrated by an instance I observed in a grapevine tendril. A cherry branch whose leaves had been variously punctured and scalloped by insects hung near the tendril, and a particular leaf had just one small hole in its blade, not over three-sixteenths of an inch in diameter. So careful had been the exploration of the leaf's surface that this one small hole had been discovered by the tendril, which had thrust itself nearly three inches through the opening. — Harper's Magazine.

Almost a Second Niagara.

The Whitney Reduction company announces the completion of the great cofferdam, undoubtedly the largest in the southern states. More than \$1,500,000 has been spent in spanning the Yadkin river thirty-one miles from Salisbury. The dam is forty-six feet high and 917 feet long. The minimum flow of water gives 46,000 horsepower, second only to Niagara. On Jan. 1 next year the water will be turned on the turbines, and all the industries within forty or fifty miles will be supplied with electrical power. The Whitneys have contracted for 20,000 horsepower. The plant will cost \$7,500,000 complete.—Salisbury (N. C.) Dispatch to Baltimore Sun.

A Famous Pianist's Work.

Paderewski frequently sits at his instrument until well into the small hours of the morning, says Tit-Bits; hence he seldom rises until 9 or 10 a. m., and immediately he is dressed he gets to work, generally practicing on the piano, but often composing. He keeps to his task until 1 o'clock, and not a minute earlier does he break his fast. By that time, however, his appetite is keen, and the feeling that he has already earned his breakfast helps to make the hour of his first meal by far the most enjoyable of the day. The meal itself never occupies long. He follows it with a quiet game of billiards played against himself. He is an enthusiastic devotee of the game.

Frozen by Heat, Melted by Cold.

In Germany, the land of scientific curiosities, a substance has been produced by chemical experiment which seems to contradict the law that heat melts and cold solidifies. The substance is called "cryostaz" and is formed by combining equal quantities of phenol, camphor and saponine with a little turpentine. When its temperature is lowered below the point at which water freezes it becomes liquid, but when it is heated it turns to the solid state.

Growth of City Population.

In 1790 the population of the country was 3,929,214, with 131,000 living in cities. In 1900 the country's total population was 75,477,467, with a city population of 24,992,199. In other words, the percentage of city population in 1790 was 3 1-3 per cent, while in 1900 it was over 33 per cent. The next census will probably show an urban population of at least 40 per cent.—New York American.

FOR THE LITTLE ONES.

Naming Musical Compositions is a Novel Game For a Party.

An interesting and novel game for an evening party is naming compositions.

Each guest is provided with a small card and pencil. A person possessing some musical talent then plays two or three measures from some well known or popular composition on the piano. Each guest writes down what he thinks is the name of the piece. If the player selects two or three measures from the middle of the composition, there will be some difficulty and a great deal of amusement in determining upon the name. About ten selections are played, allowing two minutes for the writing of each name.

To the person having the greatest number of correct answers a book on some musical subject is given as a prize. A pair of doll's slippers marked "For de feet" (de-feet) is an appropriate booby prize.

Game of Shouting Proverbs.

This is rather a noisy game, but none the less fun on that account. One of the company goes outside the door, and during his absence a proverb is chosen and a word of it given to each member of the company. When the player who is outside re-enters the room one of the company counts "One, two, three," then altogether they shout out the word that has been given to each one from the chosen proverb.

If there are more players present than there are words in the proverb, two or three persons must have the same word. The effect of all the company shouting out together is very funny. All that is necessary is for the guesser to have a sharp ear. Then he is pretty sure to catch a word here and there that will give him the key to the proverb.

Tom Tiddler's Ground.

This is an old game, but may come out new to some of our boys and girls. A line is drawn to separate "Tom Tiddler's ground" from the rest of the playground or field. Tom Tiddler takes up his position in this space and tries to touch any one who intrudes upon it. Any player he touches becomes a prisoner and must stand behind Tom Tiddler until a comrade comes to rescue him. To release the prisoner the rescuer must touch him without being previously touched by Tom. If, however, Tom touches the rescuer first, he also becomes a prisoner. The whole spirit of the game lies in there being plenty of invaders and in the prisoners being rescued quickly.

How to Make a Paper Fish Swim.

Cut out of ordinary paper a fish. In the center of the body must be a circular opening, communicating with the tail by a narrow canal. Place water in an oblong vessel and lay the fish carefully on the water, so that its underside will be thoroughly wetted, though its upper surface remains dry.

Pour delicately one or two drops of oil within the circular opening. The oil will strive to spread itself over the surface of the water, but by doing so it can only travel along the little canal that leads to the tail. By a reactive effect the fish will be impelled in a direction opposite to that in which the oil will go. The movement will last quite long.

The Lone Fisherman.

This is a variation of the donkey party. A square of muslin upon which is drawn or pasted a fisherman, with rod in hand, is fastened against the wall at one side of the room. A fish made of crape paper and stuck through its gills with a pin is given to each player, and one by one they are blindfolded and told to attach the fish to the hook on the fisherman's line. The one who comes nearest to doing this receives a prize.
