## The Law As to Sign Posts.

Most road overseers are perhaps not aware of the fact that the law requires sign posts to be put up at the forks of their respective roads, but such is the case and the fine for failure to follow the law is ten dollars. Sign posts are a great benefit to the traveling public, and especially to strangers. In years past the law was observed far more than at the present time.

Section 2722 of the Revisal of 1905 roads as follows:

"Sign-posts put up. Overseers shall cause to be set up, at the forks of their respective roads, a post or posts with arms pointing the way of each road, with plain and durable directions to the most public places to which they leave and with the number of miles from that place as near as can be computed, and every overseer who shall for ten days after notice, his appointment, neglect to do so and keep the same in repair shall forfeit and pay for every such neglect ten dollars."

There is also a statute against defacing mile-posts, and this reads as follows:—

"Injury to sign boards or mile-posts. If any person shall needlessly remove, knock down or deface any public sign posts, arms or any mile marks, he shall be guilty of a misdemeanor."

## TEN REASONS AGAINST

Accepting the Proposition the Governor Will Recommend

To the Editor:

Ten reasons against the railroad offer of compromise:

1. We now have Democratic equality. We have always denounced discrimination. This proposition is a contract for discrimination of the worst kind. The offer is 1-2 cents to the poor man, comprising 95 per cent and 2 cents to the rich or the remaining 5 per cent. The poor man who feeds the world in time of peace and fights its battles in time of war is to pay 25 cents in the \$1 (\$2.50 for 100 miles ride) against \$2.00 per 100 miles. Here before it was 3¢ for the first class and 2¢ for second class.

2d. This proposition is an attempt to buy the classes at 2 cents to allow them to extort 2¢ out of the masses.

3d. It is a contract by which we are to bargain away our right to regulate railroad rates in the future.

4th. The bargain provides that the railroad commission may raise rates a year hence, this puts that power in the hands of 3 men with the Federal courts to supervise them if the railroad commission puts rates up, and to force them if they do not.

5th. It is a complete back down by the State—an admission that the majority was wrong and the minority was right.

6th. It is an admission that we are whipped without giving the United States Supreme court a chance to decide. If we go on the worst the court can decide is that 2¢ is too low and we preserve the right to fix rates and if the times improve we may fix the 2 cents. But this bargain gives away our birthright; our right to regulate rates, and we are asked to sell it to the railroad for \$17,000.

The court may decide in our favor. We are hollering "enough" before we are whipped. By going on with the suit we may win and cannot lose as much as the railroad by this offer asked us to surrender.

7th. The proposal of the railroad is a contract for discrimination against the poor in favor of the rich giving away for \$17,000, our right of future regulation of rates and putting the matter in the hands of the Corporation Commission who (we like the State) can be sued in the Federal Court and is a surrender before we can be whipped.

8th. Virginia holds even to her 2 cent rate.

9th. The Atlantic Coast Line holds aloof and why should we accept proposals of a part of railroads.

10th. In short it is showing the white feather as I said and lowering our State flag at railroad dictation.

### PTOMAINE POISONING.

Treatment to Give While Waiting For the Physician.

Food poisoning is uncommon if we consider the number of persons who eat more or less heartily from two to four times a day. Yet it occurs with more frequency than is ordinarily supposed, the symptoms in the majority of cases being very slight and the poison being thrown off by a single attack of vomiting or a slight diarrhea.

Even in cases of severe and widespread poisoning, such as are mentioned occasionally in the papers as occurring at picnics or church festivals from the eating of sandwiches or ice cream, the number of fatal cases is small.

The greatest mortality is from mussel and mushroom poisoning and also from sausage poisoning, the number of fatal cases in epidemics of this sort being sometimes as high as 30 per cent.

The first thing to do in case of food poisoning, if seen early enough, is to get rid of the offending material. Vomiting may be induced, if it has not already occurred through nature's effort to cure, by a drink of mustard and water or tepid salt and water or by tickling the back of the throat with a feather or a rod of paper.

As soon as the stomach has been emptied, or immediately if the patient is not seen until some time after the meal of poisonous material, the bowels should be moved by salts and by an enema. If diarrhea is present and excessive a single dose of salts may be given and after that remedies tending to quiet the action of the bowels.

No food should be given, but the patient may be allowed plenty of water, and at the same time free perspiration is induced by hot bottles or hot bricks in the bed, in which he lies covered with several blankets. In short, the treatment is directed to the removal from the system as rapidly as possible of the poisonous matters.

Of course these directions for treatment are for the guidance of the family of the sufferer while waiting for the physician, for so serious a condition as food poisoning calls for the doctor's care just as soon as it can be secured.

Collapse is to be treated by warmth, by rubbing of the extremities and by stimulation. Very strong black coffee, as hot as it can be drunk, is an excellent stimulant of the heart in these cases, and one or two small cups may render great service.—Youth's Companion.

### Waiters' Tips in Paris.

The old familiar problem of how much to tip the waiter at a restaurant has puzzled most people at one time or another, so possibly the following system of reckoning the amount, which is practiced by a good many experienced Parisians, may be found useful.

The principle is to reckon a penny a head for each person in the party plus a penny for every shilling in the bill. Of course if the party dines very economically the waiter will not come off very well. But it is found in Paris that a tip calculated on this basis works out very well in the majority of cases.

For dinner in a private room the same scale holds good, except that twopence per head is paid for each member of the party. The extra length of the bill in this case insures the waiter his additional pour boire.—London Modern Society.

### Stronger Than His Oath.

They were cross examining in a Chicago court a bookmaker who had been caught in the toils for playing some other game than his own. The third subassistant district attorney was intent upon a conviction, however, and was doing his best, none too successfully, to shake the testimony of the defendant.

"You're sure of that?" he yelled as the bookmaker stuck to an assertion that did not suit the case of the state.

"Sure! I am certain," came the answer.

"You remember that you are under oath?"

"I do that."

"And you'd swear to this statement of yours?"

"Swear to it? Why, Mr. Lawyer and judge, your honor, I'd bet a hundred on it any day."—Saturday Evening Post.

### A Whistler Snub.

The "Butterfly," as Whistler was called, was not inclined to be cordial when, disguised as a Spanish cavalier in black, with a big sombrero, at a fancy dress ball he found himself alongside of Mr. Crane as Cimabue, all in white. Crane says, "I had met him previously at one of his own private views and said to him by way of greeting that I thought I had had the pleasure of meeting him before, but he only said dryly, 'Very likely,' and we didn't get any further."

## The Pyramids of Egypt.

The Egyptian pyramids stand near the city of Memphis, Egypt, and are four sided structures, the sides facing the cardinal points of the compass. Within them are chambers that were used as the burial places of kings, and it is thought that the great piles were built for that purpose.

The largest and most famous of the three is the pyramid of Cheops, that being the name given by Herodotus, the historian, to the king that built it. His right name, however, was Khufu or Khufu, and, although Herodotus speaks of him as a bad ruler, he made Egypt rich and great. He was buried in the great pyramid.

Modern Egyptologists—that is, students of Egyptian history and legends—say that the pyramids were built 4,000 years ago, perhaps even longer than that. They have ascertained that the hard stones used in their construction were sawed into shape by means of bronze saws set with jewels, probably corundum or diamonds. The hollows (for tombs) were drilled with tools like the modern rock drill, and small articles were turned in lathes fitted with mechanical tool rests and jewel pointed tools. But no one knows how the gigantic stones, some of them weighing thirty tons each, were brought to the spot and lifted into position. Probably no one ever will know that.

The pyramid of Cheops is 450 feet in height. Originally it was 479 feet. The sides are 746 feet in length, originally 764 feet. It is estimated that at least 100,000 men were employed for thirty years in building it. The exterior of the pyramids was formerly covered with a casing of highly polished stones, but they have nearly all been removed, and the present appearance of the exterior is that of a series of great rough steps.

The chambers where the kings were buried are in the middle of the structures, to which long passages lead from the outside. The bodies have all been removed, but some of the coffins may still be seen there.—Chicago News.

### Making Believe.

### A Number Guessing Puzzle.

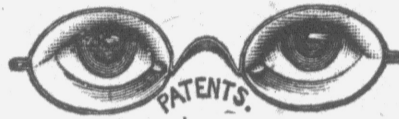
