THE ALDERMEN BUSY.

Changes in the Board—No Election Called—Street Paving and Other Matters Discussed.

The board of aldermen had quite a busy adjourned meeting, Thursday night, and considered several important matters.

Mr. F. C. Harding, who was previously elected to fill the vacancy in the first ward, qualified and entered upon the duties of alderman. Mr. A. M. Moseley, who was elected to fill the vacancy in the fifth ward, declined to accept and there is still a vacancy in that ward. Alderman T. R. Moore again tendered his resignation as a member from the fourth ward, and ex-alderman F. J. Forbes, formerly of the fifth ward and who had removed to the fourth ward, was elected to succeed him.

The committee consisting of Aldermen Bowen and Woodward appointed to canvass the registration books of the town and investigate the petition for a local prohibition election, made the following report, which was adopted:

We, your committee appointed and directed to canvass the registration books of the town and ascertain the number of registered qualified voters thereon and compare therewith a petition addressed to this board asking that an election be called to vote on the question of prohibition for Greenville, and which petition was referred to this committee, beg to submit the following report:

We find upon the registration books 341 names. We also find that of this number 19 have died and removed, leaving upon the books 322 registered voters.

And of the petition presented we find after removing therefrom those who were not registered and those who directed the removal of their names therefrom, that there remains thereon 86 registered voters. It requiring 108 registered voters to call an election, there being a deficiency of 22, we recommend no election be called.

The committee previously appointed to investigate the claim of Sallie Hopkins for damage sustained, in November, by driving into an excavation on Dickinson avenue left open while water connections were being made, recommended that she be paid \$100 damages and the cost of repairing her buggy. The committee was continued and instructed to collect this sum from L. H. Pender, the contractor who was doing the work and left the excavation open.

The matter of street paving was taken up and discussed at some length, resulting in the adoption of the following:

The board having had in consideration for some time the subject of permanent street improvements, and it now appearing to the board that the time has come when the town should enter upon a system of permanent street improvement, and it further appearing to the board that this experimental work can be advantageously done by the board purchasing the material and employing an expert street engineer to superintend the work.

It is now on motion of G. J. Woodward ordered that the work of permanent street paving begin on Evans street at Third street at the earliest practical day and continue to Fifth street, and then by some route to be hereafter determined to the A. C. L. depot, and that vitrified

brick be used as the material for the roadway.

That the abutting property owners be required to pay for the cost of putting down the granolithic sidewalk and curbing which shall extend the full width of the sidewalk on the property line to the driveway; on Evans street from Third to Fifth street, as the board may direct the same to be done.

That the granolithic pavement and curbing shall be so put down as to form one contiguous uniform sidewalk.

That if any property holder shall fail or refuse to pay for such granolithic pavement and curbing for the full extent of the front line of his property, the town shall charge the actual cost against such property which shall be collected at the same time and in like manner as the tax on such property is collected.

That J. F. McGuire is hereby selected as such street engineer and supervisor of said work, and the mayor is hereby authorized to enter into a contract with him on the part of this board for such work, and to sign and file the paper writing which is now read and adopted by the board as such contract and which the clerk is directed to spread upon these minutes.

That the purchase of the material and the conduct of the work be especially under the control and direction of the mayor and Aldermen Bowen, Johnson and Carr, who shall see that proper bills and vouchers are taken for all material purchased and work done and who shall make detailed reports to this board at each regular meeting of the progress of the work and the cost of the same.

A contract in accordance with the foregoing was made with Mr. McGuire, he to furnish satisfactory reference of his ability to do the work required.

Alderman Carr submitted a proposition from the owners of Greenville Heights and property owners on Fourth street, agreeing to pave the sidewalk on the north side of Fourth street from Davis street in Greenville Heights to Evans street, provided the town will pave the street crossings. This proposition was referred to a committee consisting of Aldermen Bowen and Flanagan.

The board recommended that the water and light commission purchase and install an additional water filterer as soon as possible, the present filtering plant not being sufficient to meet the needs of the town.

E. A. Kline submitted a proposition for constructing the roadway or street from Third street to the water and light station, and a committee consisting of Aldermen Woodward and Harding, was appointed to enter into contract with him for the work

When State Will Vote on Prohibition.

The House yesterday afternoon concurred in the Senate amendment to the Long-Dowd prohibition bill fixing May 26th as the date for the general election for State prohibition. The House passed the Senate bill prohibiting traveling salesmen from soliciting orders for intoxicating liquors in prohibition territory. This bill, having passed the Senate, is now a law.

The bill advocated by Judge Shaw before the Senate and House Judiciary committee to amend section 1635 of the Revisal so as to allow a wife to testify in slander cases against her husband, where the husband has been charged with slandering his wife, to apply to pending cases, was passed on its second reading in the House. The question of whether it would be a post facto law or not was raised, but irresistible arguments were uttered in behalf of it before the committees and in the House.

Among the important general bills passed by the House were those limiting the amount of stock and bonds railroads may issue without the consent of the Corporation Commission, the object of the law being to prevent watered stock; prohibiting the discontinuance of local trains without the permission of the Corporation Commission, a necessary law, as a railroad has during the past few weeks flagrantly violated their obligations to the public in this respect; and giving certain representatives of the State the authority and power to inspect and examine the books of railroads;

The Pine Level dispensary was abolished, and Raleigh was given the power to dispose of its dispensary liquors to either dispensaries in other towns or to wholesale houses in bulk.—Raleigh News and Observer.

SWEEP THE STATE.

Chairman Oates on Prohibition Election.

Chairman Oates of the Anti-Saloon League Committee was happy yesterday afternoon when the State Prohibition bill had finally passed both Houses. He has been in Raleigh since the day the Legislature met, looking after this general bill and also other temperance legislation.

When asked about the situation he said:

"We have a good bill and the people will ratify it on Tuesday, May 26th, by a large majority. North Carolina has had enough of the rule and ruin of the liquor traffic and it will now put it out completely.

"I have been gratified at the kind treatment of the legislature. The members have heard us patiently and given us a bill and a date for voting that will enable us to sweep the State.

"The people are with us and they will show it on election day. It is their own fight—it involves their own firesides and their own offspring and they will settle this question once for all. Every man who loves humanity and wants to see his State freed from the heavy burden of the liquor traffic is invited to join in the fight at once and not let up till the battle is over."—Raleigh News and Observer.
